UNITED AMERICAN LINE A "JEWISH FIRM".

WARSAW, Jan. 4, (Jewish Telegraphic Agency) The United American Line is included among "Jewish firms that are not known as such", in a list published today by the DWA GROSZE, the list being published to draw attention to the fact that while boycotting Jawish concerns the Poles should bear in mind there are many houses that are not generally known as Jews.

WARNS AGAINST SPECULATION AND INTERMARRIAGE IN WILL LEAVING LARGE FORTUNE.

LIVERPOOL, Jan.5, (Jewish Telegraphic Agency) An admonition to his sons not to engage in speculation on the stock exchange and the earnest wish that no son while engaged in his firm will hold any public office, are contained in the will, admitted to probate yesterday, of Louis Cohen, former Lord Mayor of Liverpool, who died in September leaving a fortune of £1,192,700. Money made by speculation is sure to be lost and lead to disaster, Mr. Cohen advised his sons, and it is improper for one to be a candidate for or member of Parliament or to hold any office in a Municipal District Council, or any other local authority, while engaged in business.

The "strong conviction" is also voiced in the will that inter-marriage between members of different religions tends to bring great unhappiness, and it is the earnest wish of the decessed, which he was "confident will be regarded", that no child, grandchild or remoter descendent will forsake his or her religion and marry a person of another religion.

Mr. Cohen expressed also the hope that no grandchild or remoter descendent will marry a person who is not a citizen of the British empire or of the United States of America. Mr. Cohen is survived, among others, by a son, Brunel Cohen, who is a member of Parliament. ROUMANIAN PRINCE PROTESTS AGAINST ANTI-SEMITISM, RESIGNS.

BUCHAREST, Jan.4, (Jewish Telegraphic Agency) Declaring that the Government, particularly the Minister of Education Anghelescu, is conducting a "two-faced policy" with reference to the agitation for the exclusion of Jewish University students, Prince Mathei Contcuzina, Professor of Givil law, and formerly director of the Jassy University, resigned his professorship.

Prince Contourina intends his resignation, he asserts, to serve as a protest against the anti-Jewish violations and against the Government for supporting the anti-Semitic Professor Cuza, who is held responsible for the incitement of the student body, while pretending to oppose the limitation of Jewish admissions.

Deputy Lupu, a former Minister, while addressing Parliament, strongly attacked what he referred to as the anti-Jewish policy of the Government. He declared that public opinion in America was following the Jewish situation in Roumania with interest, and that during his recent lecture tour he always heard references to Roumania as the "country of petroleum and persecution of Jews".

Evidences are not wanting that the authorities are anxious to make an end to the students' recalcitrance. Proposed student meetings at Jasey and Czernowitz were prohibited in consequence of the Government order declaring all assemblies on university campus as illegal.

A warning that the student agitation may penetrate into the villages, causing anarchy among the peasants is sounded by Nemu L'Edmanescu, a liberal organ, which urges the Government to take all measures for the suppression of the students' activities.

WEIZMANN HAS HOUR'S TALK WITH MUSSOLINI.

ROWE, Jan. 4, (Jewish Telegaphic Agency) Many misunderstandings surrounding the Zionist position in Falestine are believed to have been cleared up as a result of the interview Dr. Chaim Weizmann had yesterday with Premier Mussolini. The Prime Minister received the Zionist President very cordially, the conversation centering around the attitude of the Fascisti Government towards the Zionist movement. Dr. Weizmann is understood to have been particularly anxious to ascertain Premier Mussolini's attitude, in view of the recent statement of the latter that the British Mandate for Palestine may not survive the Lausenne Conference.

During his visit here Dr. Weizmann had conversations with a number of politicians, including former Prime Minister Luzatti and Di Gesaro, founder of the pro-Israel Society. The Zionist leader also addressed a successful Zionist gathering here.

TORONTO JEW ON TWO CITY COMMITTEES.

TORONTO, Jan. 3, (Jewish Correspondence Eureau) Joseph Singer has been elected to the Board of Control and a Factor to the Board of Education in the Municipal elections held yesterday. This is the first time that Toronto Jews will have representation on these two important committees.

JEWS FIGURE IN HYLAN'S JUDICIAL APPOINTMENTS.

NEW YORK, Jan. 3, (Jewish Correspondence Bureau) Judicial appointments announced by Mayor Hylan yesterday include Henry M. Goodman, who since 1920 has served as Deputy Assistant District Attorney, to serve out Magistrate Nolan's term, who was appointed to succeed Justice Collins. Hyman Rayfield, Brooklyn, formerly a clerk in the Magistrate's Court was appointed a Magistrate to fill the unexpired term of Alexander Geismar, who becomes First Assistant District Attorney of Brooklyn. James J. Golden of Brooklyn will fill the unexpired term of Chas. J. Dood. Herman Doctor, a manufacturer of the Bronx, has bee appointed Second Deputy Secretary of State, succeeding Chas. W. Taft.

REPORT ROTHSCHILDS RENOUNCED AUSTRIAN CITIZENSHIP.

PRAGUE, Jan.4, (Jewish Telegraphic Agency) The Vienna branch of the Rothschild family has renounced Austrian citizenship in favor of Czecho-Slovakian, says a report in the local TRIBURA. The paper suggests that this move was inspired by apprehension felt for some time among the Rothschilds that the protection Austria is able to give them and their interests is inadequate.

FAVORS JAMES ROTHSCHILD AS WEIZMANN'S SUCCESSOR.

LONDON, Jan. 4, (Jewish Telegaphic Agency) Adverting to the rumors that Dr. Weizmann wishes to resign as President of the World Zionist Organization, the JEWISH WORLD says it thinks it would be "a good thing if Dr. Weizmann would now lay down the charge, at least for a while. "It is bad for any organization to be led indefinitely by one man or the same men" the paper asserts. "Although the JEWISH WORLD doesn't altogether see eye to eye with James de Rothschild, it must confess that in the circumstances a much better successor would be dirficult to find"... "But would Rothschild accept the ofrice and will Dr. Weizmann resignf," the JEWISH WORLD asks.

PROVIDENCE JEW CHOSEN SPEAKER OF LEGISLATURE.

PROVIDENCE, R.I., Jan. 3, (Jewish Correspondence Bureau) Mr. Philip C. Joslin, a prominent attorney and conspicuously associated with Jewish activities of Providence, was today chosen Speaker of the House of Representatives of the State of Rhode Island, the highest office ever conferred upon a Jew in this State.

Mr. Joslin, who is a relatively young man, served for two years on the Committee of the Georgetown Law School, whence he was graduated. He was then elected as representative of the Fourth District to the State Legislature. His ability as a speaker and leader was recognized by both his own party, the Republican party as well as by the opposing party and he held important Committee positions. He was very active as a member of the Judiciary Committee.
