ANTI-JEWISH RIOTING RENEWED IN ROUMANIA.

BUCHARRET. Jan. 19, (Jewish Telegraphic Agency) Anti-Jewish riots have broken out anew in Barlad and Husi, Jewish students at these places having been routed and three injured.

In consequence of the recurrence of cutrages and of thefear of attacks in the villages, military order has been proclaimed in parts of Moldavia, the local police being reinforced by special patrols from the cities.

Deputy Lupu, Peasant Party leader, declared after visiting the scenes of the disturbances, that there are indications of a recrudescence of the pogrom wave of 1907. The convention of the Union of Roumanian Jews, scheduled to be held January 19, 20 and 21, has been postponed as a result of the anti-Semitic outbreaks.

### JEWS HALF OF JERUSALEM POPULATION.

JERUSALEM. Jan. 19, (Jewish Correspondence Bureau) Jerusalem Jews constitute little more than half of the total population of Jeru salem, according to figures supplementary to the general census numbers recently published. Jews number 54,000 out of a total population of 62,000. The same ratio obtains also in the Jaffa district where Jews constitute half of the population of 40,000. A slight decrease is reported in the Jewish population of the agricultural colonies. Halfa is the only city in Palestine where the Christians predominate.

The orange trade of the Jaffa district is in a bad way owing to the fall of price of the Falestinian orange in the English market , from 16 to 6 shillings.

# TWO ROUMANIAN TEACHERS AS INSTIGATORS arrested.

BUGHAREST, Jan. 19, (Jewish Correspondence Bureau) Following an investigation into the recent anti Jewish agitation at Barlad, Moldavia, two teachers of the local high school, Professors Tutoceanu and Slobodzinau, have been taken into custody.

BAVARIAN JEWS URGE PROTECTION AGAINST POGROMS.

LONDON, Jan. 18, (Jewish Telegraphic Agency! Reports arriving here from Munich convey the alarm felt there in connection with Adolph Hittler's preparations to review Saturday 200,000 armed Bavarian Fascisti. The danger of massacres of Jews is plainly depicted in these reports, urging Jews abroad to intervene in an effort to avert a pogrom wave.

Liberal German newspapers confirm the prediction of a general uprising engineered by Hittler and his National Socialist followers, to establish the dictature of the Fascisti by Saturday.

# ARAB DELEGATION SECRETARY COMING HERE.

IONDON, Jan. 18, (Jewish Correspondence Bureau) Shibley Jemal, Secretary of the Arab Delegation, who spent many months in London and other European capitols in a campaign against Zionism, has sailed for New York on the Celtic January 15. It is Mr. Jemal's purpose to conduct in the United States an agitation against the British Zionist policy and to collect funds among Arab and Syrian residents in America.

# WEIZMANN HINTS AT ARAB FEDERALISM, TELLS ZIONISTS TO PREPARE.

BERLIN, Jan. 18, (Jewish Telegaphic Agency) The important acknowledgement that the idea of a Federation of Arab states, including
Palestine and Transjordania, is gaining ground, and the advice to
Zionists to be prepared to fit into the new scheme and derive the
greatest possible benefit to the Zionist movement, was made by
Dr. Chaim Weizmann, President, at the semi-annual meeting of the
Greater Actions Committee of the Zionist Organization in session here.
Dr. Weizmann denied that he had negotiated regarding

Zionist participation in the proposed Federation of Arab States. He declared he had not seen Emir Abdullah, the Transjordanian ruler, since the latter's visit to London a few months ago.

Confidence in the leadership of Dr. Welzmenn and Nahum

Sokolow was proposed and passed The Committee bringing in this recommendation proposed also that separate action by individual members of the Zionist Executive Committee should not be countenacted, thus disapproving of the individual acts of Vladimir Jabotinsky, who announced that despite his opposition to phases of the leaders' work, he proposed to remain a member of the Executive.

Jurisdiction over the financial institutions of the Zionist Organization will be vested in the future in members of the Executive Committee, the various members being placed at the head of the administrations of the different Zionist Funds such as the Palestine Foundation Fund, the Jewish National Fund, the Jewish Colonial Trust, etc.

# POLAND PROHIBITS KEREN HAYESOD.

WARSAW, Jan. 18, (Jewish Correspondence Bureau) The general legalization of the Keren Hayesod notwithstanding, collections for the Fund have been prohibited in the Lublin district.

### JEWS DEMAND ABOLITION OF CZARIST DISABILITIES.

WARSAW, Jan. 18, (Jewish Telegraphic Agency) A draft of a law abolishing the disabilities from which Polish Jews are suffering and which have been in force since the Czarist regime will soon be submitted by Deputy Apolinary Hartglass. Dr. Hartglass has been chosen to present this bill by the Legal Commission of the Lower House.

An urgent demand for the introduction of percentage norm against Jews is expected to be made by the so-called People's Democrats Deputies. The same wing announced its intention to contest the legality of the law prohibiting political agitation on the part of the Rozwoi.

Reports from Lemberg and Lodz say that the local police has successfully put down attempts to introduce economic boycott of Jews.

### CLUB OF JEWISH DEPUTIES IN LATVIA.

RIGA, Jan. 18, (Jewish Telegraphic Agency) Four Jewish Deputies in the Latvian Sejm have been constituted as a special group to ensure harmonious action on questions affecting Jews. It is intended that the group will be in the Latvian Sejm what the Jewish Sejm Club is in the Polish National Assembly.

The fifth Jewish deputy who is a Zeire Zion was not included in this group.

### JUDGE MAX LEVY REELECTED.

PROVIDENCE, R.I., Jan. 19, (Jewish Correspondence Bureau) Hon. Max Levy of Newport, R.I. was today reelected Judge of the First Judicial District, Rhode Island, at one of the stormiest sessions ever held by the State Legislature.

Judge Levy lives in Newport which he represented in the House of Representatives for a number of years and later was its spokesman in the Senate. He is identified with a number of Jewish organizations and is a former President of the Towro Syna gogue in America.

# UKRAINE IMPLORES ASSISTANCE.

LONDON, Jan. 19, (Jewish Correspondence Bureau) Cables describing the situation in the Ukraine and imploring the assistance of Jews and others in combatting hunger and exposure, which is spreading again at an alarming rate have been received here by the Federation of Ukrainian Jews. Epidemics are said to result from the famine, and appalling mortality is witnessed in consequence of the epidemics. It is imperative to provide immediately medical treatment and sanitary measures to save the surviving, advices add.

JABOTINSKY QUITS EXECUTIVE AND ZIONIST ORGANIZATION

Founder of Jewish Legion Resigns Following Disagreement With Weizmann and Adverse Vote On Petlura Affair.

Berlin, January 19 (Jewish Telegraphic agency). Vladimir Jabotinsky, founder of the Jewish Legion and for three years member of the Executive Committee of Zionist Organization, resigned from the leadership as well as membership of the Organization at the last session of the meeting of the Greater Actions Committee Thursday.

hr. Jabotinsky communicated has resignation to a special committee before which he was to explain the mature of the negotiations he had with agents of Petlura, the Ukrainian insurrectionary. The committee is said to have passed an adverse vote on his connection with the Petlura-Slavinsky affair. Simultaneously, a letter from Jabotinsky was read by Deputy Gruenbaum of Warsaw, who presided, in which he declared that the Executive Committee, having decided in favor of identical action on the part of all members, he felt it was best for him to resign and reserve for himself freedom of action and criticism of the Zionist leaders' polities.

Mr. Jabotinsky's resignation has not come as a surprise to circles acquainted with the internal events of the Zionist Organization. There has been a serious conflict between Dr. Weizmann and Mr. Jabotinsky ever since the former accepted, on behalf of the Zionist Organization, Winston Churchill's interpretation of the Balfour Declaration, as set forth in the white Paper of June 1920.

Jabotinsky has been demanding a free hand in the political negotiations, without being bound in each case by the majority vote of the Executive. Particularly, Jabotinsky desired changes in the Palestine administration, a firmer attitude towards the British Government and different dealings with the arab leaders. Above all, he favored that the Zionist leaders should put forth the greatest effort to secure the establishment of a Jewish Legion as part of the Palestine Garrison. Dr. Veizmann did not support heartily hir. Jabotinsky in any of these demands.

While friends and opponents elike consider that it had become impossible for Jabotinsky to remain on the Executive, they regard it as a grave mistake on his part to have left the Organization entirely. It is maintained that by withdrawing from membership in the Zionist Organization he vitiated whatever changes he might have had for constructive criticism, had he remained a soldier in the Zionist ranks.
