UNELPLOYMENT SUICIDES REPORTED BY POST FROM BALESTINE

London, January 30 (Jewish Telegraphic Agency). Dealing with statements made by Dr. Chaim Weizmann in Palestine that Zionism is passing through a financial crisis, the Jerusalem correspondent of the Morning Post gave a lengthy description of the situation as he sees it. Immigrants, he said, are suffering through unemployment. The building activity at Tel-aviv having been suspended and the dement factory at Jaffa working part time, the correspondent's estimate is that there are 600 unemployed in Jaffa. The coloniats and merchants are also feeling the pinch of the money stricting. During the last year there were fourteen cases of suice by Jewish immigrants caused by "poverty and starysmion".

Despite this situation, immigration into the country is continuing at the rate of 600 males monthly, the correspondent asserts, adding this admonstrant that unless immigration is suspended until the economic crisis is passed, there are dangerous times shead.

The Pelestine correspondent reports also that Bolshevist activity is again becoming very noticeable.

HITLER THREATENS JEWS, AMERICANS, ENGLISH

launich January 30 (J. T. A.). Adolph Hitler, the Bavarian Fascisti leader, made bold by his over the Bavarian Government in having demonstrations of the National Socialists permitted while the country was in a state of martial law, has been making speeches threatening Jews, English and Americans.

With reference to the Jews, he said that no member of that Faith will ever be permitted to touch the National Socialists' banner.

Addressing Fascisti meetings Herr Hitler declared that unless England and America intervene to stop France's action in the Ruhr, the "presence of British and Americans in Bavaria will not be tolerated" This threat was very enthusiastically received by Fascisti hordes.

A gang of Nationalists raided the Negima Hotel seeking Jews. The diners were terrorized and it was due to the intercession of the manager that actual violence was prevented.

The charge that Reichs wahr is supporting Hitler's forces occurs now and again in the liberal German newspapers. The Vorweerts; Socialist organ, reports that Chancillor Cuno personally ordered the release of 300 Ritler men who had been taken into custody.

## REPORT POGROLI IN KURSK

London, January 30 (J. C. B.). Quoting the dispatch to the Sanomat at Helsing fursthe Morning Post reports serious pogroms took place on January 19 and 20 at Kursk. Workmen, peasants, and socialists of the Red army participated in the rioting, the report continued, resulting in the murder of "Mundreds of thous-ands".

# CLAIM INFRACTION OF JEWISH RIGHTS IN MALESTINE

Jerusalem, January 30 (J. T.A.). A menorandum enumerating cases of infraction of Jewish rights in Palestine and requiring a radical change in the present Government policy has been submitted by the Council of Palestine Jews to Sir Herbert Samuel. These representations on behalf of the Jewish inhabitants of Palestine follow somewhat Similar criticism submitted by Lieut. Colonel Kish on behalf of the Zionist Executive during Dr. Weizmann's recent visit to Palestine. The principal Jewish grievance is that activities of an indisputable public character are recreded by the Government as private enterprises, and it is charged that education, medical and sanitation work, maintained out of Zionist funds, are receiving no aid from the Government despite the fact that it is claimed that the Jews contribute about 30% of the taxes.

Jerusalem, January 29 (J. C. B.). Mewish communities thruout the world are urged by the head office of the Jewish National Fund here to arrange special collections on Furim for the Garden City in memory of Max Nordau.

#### AMALGAMATED BANK TRANSMITS MONEY TO RUSSIA.

NEW YORK (Jewish Correspondence Bureau) The Russian American Industrial Corporation has made final arrangements for the immediate transmission of money to Russia, through the offices of the Amalgated Trust and Savings Bank of Chicago, transmissions now being accepted by the foreign Exchange Department of that bank.

The contract for transmissions between the United States and Russia was concluded with the Industrial Bank of Moscow, and the Russian-American Industrial Corporation was made the agent for this enterprise. It is said to be the first concession to be granted officially to an American Corporation. It makes possible transmission at the premium of 7%, with a minimum charge of one dollar, to all points in Soviet Russia and paid in American dollars.

The Russian-American Industrial Corporation is incorporated in Delaware and is capitalized at \$1,000,000 which is to be invested in Russian clothing industry. Sidney Hillman, Joseph Schlossberg and J. S. Potofsky, all officers of the Amalgamated Clothing workers of America, are the president, vice-president and secretary-treasurer, respectively of this Corporation.

NATHAN STRAUS HONORED ON 75th BIRTHDAY.

War Relief Collections in many Cities.

NEW YORK Jan. 30 (J. C. E.). The birthday of Nathan Straus, seventy five years old to morrow, will be celebrated in many cities throughout the country by Jews emulating his example of giving without stint. A special effort will be made to collect the outstanding pledges from the last Jewish War Relief Campaign, in honor of the "Grand Old man or American Jewry," the day being designated as Nathan Straus Relief Remittance Day.

The esteem in which Nathan Straus, venerable philanthropist, is held by this country, is shown by the tributes paid him as "Great Merchant, Great Philanthropist, Great American", in a special number of THE JEWISH TRIBUNE and THE HEBREW STAMDARD, dedicated to him on his seventy-fifth birthday to-morrow.

Beginning with President Harding, the nation's leaders have written congratulatory letters to Mr. Straus through which they emphasize the good work he has accomplished by his pure milk work, in which he was a pioneer, and his many other philanthropies. Particular emphasis is laid upon the fact that his philanthropies, world wide in their extent, have always been carried on irrespective of race or creed.

#### PRESIDENT HARDING'S MESSAGE.

President Harding in his letter to Dr. Nehemiah Mosessohn, Editor of The Jewish Tribune and the Hebrew Standard, wrote: I am obliged to you for your note calling my attention to the fact that Nathan Straus is to celebrate his seventy-fifth birthday anniversary on the last day of this month and that a special tribute is to be paid to him. Mr. Straus' public services and private and public philanthropies have deserved very much of his fellow citizens, and I hope he may live through many more years of similar usefulness.

CHARGES CANADIAN CLUB BARS JEWS, But President says charge is result of "Foolish Members Talk."

NEW YORK, Jan. 31 (J C. B.) The charge made in a letter of resignation written by Rube R. Fogel, a manufacturing jewler, that the Canadian Club of New York, at the Hotel Belmont, is "determined to exclude Jews" was denied in a statement published today from the president of the club, Albert Oliver, head of Albert Oliver & Son. Mr. Oliver dismissed the matt as "just the result of a foolish member's talk." Mr. Fogel had said that A. A. Mathewson, chairman of the membership committee, at a meeting Jan. rose and said he wanted to hear the views of club members as to the admission of Jews and that he would vote against any Jew who applied.

Mr. Fogel also charged that others rose and spoke to the same effect and that the president of the club then said that the hearty appla which greeted these statements showed the club's "determination" to excludes.

Mr. Oliver has asked Mr. Fogel to reconsider his resignation.
