RELATIONS BETWEEN SIR SAMUEL AND ARABS STRAINED.

JERUSALEM, March 26, (Jewish Telegraphic Agency) A possible change in the policy of Sir Herbert Samuel, High Commissioner of Palestine, towards the Arab Executive is seen by Zionist leaders in the denial yesterday by the High Commissioner of two demands of the Executive.

The Arabs asked that those arrested in the demonstration of March 14th to celebrate the success of the Arab boycott of the Legislative Council elections be released and that the Jerusalem chief of police be placed on trial for causing their arrest.

Sir Samuel categorically denied both of the demands and went to the length of intimating to the Executive that unless they cooperate in the maintenance of order, "he would not be responsible for the developmente."

Hitherto Jewish leaders in Falestine have complained that the High Commissioner's policy towards the section of the Arabs opposing the Jewish Homeland plan was to conciliatory. Jews charged that all requests of the Jewish element were denied, and those of the Arabs were consistently favored.

ROHMANIAN JEWS DISPLEASED WITH PARTS OF NEW CONSTITUTION.

BUCHAREST, Merch 26, (Jewish Telegraphic Agency) The new constitution for Roumania which has been finally ratified does not show the improvement as regards Jewish rights which had been hoped for. The fight of the Jews for the substitution of the word "citizen" for "Roumanian" was lost.

This means that officials will have greater lattitude in denying the vote to Roumanian Jewish recidents, who they may decide may be citizens but not Roumanians and therefore not entitled to all governmental privileges.

The new constitution, too does not contain the clause recognizing the legality of the Jewish language for which Roumanian Jews contended.

IDGESCOM CHALLENGES "JOINT" ASSERTION.

NEW YORK. March 23, (Jewish Correspondence Bureau) The Joint Distribution Committee had no authority to issue its recent appeal to landsmanschaften desiring to send money for the founding of oredit institutions in their native towns in Russia, according to a statement issued by the Idgescom today.

The appeal of the JDC stated that it would see that proper committees were appointed in Russia to administer the money for the purpose intended. The Idgescom contends on the basis of a cable it has received from Odessa that the JDC does not enjoy the right in Russia to appoint such committees.

The Odessa office of the Idgescom also denies the recent report cabled from Russia, telling of the arrest of Professor Jacob Schwartzman and Solomon Leizerovitch, relief workers of the London Federation of Ukrainian Jews. The report is characterised as "absolutely false" by to the Idgescom cable.

RESUMES MONEY ORDER SERVICE TO RUSSIA.

NEW YORK, March 25, (Jewish Correspondence Bureau) The American Expresss Company will immediately resume the sale of foreign money orders to Russia, payable in American dollare. Officials of the company declared that recent investigations in Russia had shown that new banks have been organised and that remittances can now be sent with entire safety through these banks and the Soviet Postal authorities in the form of U.S. dollars.

CHICAGO'S JEWISH POOR VICTIMS OF BANK CLOSING.

CHICAGO, March 23, (Jewish Telegraphic Agency) The poor of the Jewish quarter are the principal sufferers of the closing of the Sixteenth St. State Bank and throngs of them still surround the bank in hope of having their savings restored.

Samuel Maltz, president of the bank, is being held for action by the grand jury. Maltz was a railroad brakeman before he became associated with the bank.

SCHWARTZ TO PLAY "ANATHEMA" IN ENGLISH.

NEW YORK, Merch 25, (Jewish Correspondence Bureau) Maurice Schwarts, director of the Yiddish Art Theatre, will appear in an English version of Andreyev's "Anathema" at the Forty-Eighth Street Thetre, the Equity playhouse.

An invitation to Schwartz to produce an English version following his long presentation on the Yiddish stage was presented to him by the Equity players and other noted actors.

NEW YORK, March 25, (Jewish Correspondence Bureau) The state law punishing the fraudulent labeling of products not in conformity with the Jewish law as "Koeher" was held constitutional by the U.S. District Court. In the decision, which was rendered by Judge Manton, the suit of a group of provision merchants to have the law declared invalid was dismissed.

The provision dealers who fought the "Kosher Act" contended that the Jewish religious authorities differ among themselves as to the precise meaning of the term "Kosher" and that it is therefore so speculative as to be incapable of practical application. Furthermore, they contended, the whole legislation was an illegal interference by the State in Interstate Commerce.

Judge Manton pointed out in denying the suit that the complainants themselves admit that they have built up a large business in the sale of food products as "Kosher" and that they therefore must have found the standards sufficiently definite to be followed in practice. As to the contention that the "Kosher" law is an illegal interference with Interstate Commerce, the court held that a state police regulation is not unconstitutional simply because it may indirectly affect interstate commerce.

The state, which defended the constitutionality of the "Kosher" Act was represented by Deputy Attorney General Samuel H. Hofstadter.

LITHUANIAN ELECTIONS CONTINUED FOR THE BENEFIT OF JEWS.

KOVNO, March 26. (Jewish Telegraphic Agency) The elections for the Lithuanian Parliament which were scheduled to have been held on Saturday and Sunday May 12th and 13th will be extended through Monday, the 14th to accommodate Jewish voters. Following a plea that the election on Saturday would deprive a number of Jewish residents from the opportunity of voting, the Premier consented to an extension through Monday.

MARSHALL HONORED AT DINNER BY BEOOKLYN CHARITIES.

NEW YORK, March 23, (Jewish Correspondence Bureau) Louis Marshall was the guest of honor at a dinner given by the Brooklyn Federation of Jewish Charities at which campaign plans of the Charitieswere discussed.

UNIVERSAL DEPORTATION OF JEWS BEFORE ANTI-SEMITIC CONGRESS.

MUNICH, March 26, (Jewish Telegraphic Agency) Universal deportation of Jews of all countries to Palestine will be urged at the Anti-Semitic Congress of Aryan Peoples to be held in Budapest soon under the auspices of the Awakening Magyars, accrding to Captain Beamisch, one of the leaders of the anti-Jewish agitation in England.

Beamisch recently arrived in Munich to escape prosecution in London for alleged libelling of Sir Alfred Mond, a former member of the cabinet of Lloyd Jeorge.
