SAYS HITLER MAY SPOIL GERMAN LOAN IN U.S.

BERLIN, April 27, (Jawish Telegraphic Agency) The chances of floating a German lean in the United States are "enormously injured" by the activities of Adolph Hitler, the Bavarian Fascisti leader, according to the New York correspondent of the FRANKFURTER ZEITUNG in a discatch today.

The correspondent asserts that the balligerent mationalist, anti-Semitic and monarchies tendencies are likely to affect adversely public opinion in the United States, causing American bankers to hesitate about Launching the loan.

## RABBI EISENSTADT UNDER ARREST.

RIGA, April, 27, Jewish Telegraphic Agency) Eabbi Eisenstadt, leading Jewish dignitary of Petrograd, has been placed under arrest charged with violating the Soviet decree ordering the separation of church and state, says a Moscow dispatch. The offense of which the Habbi is accused is not stated.

#### FINLAND PROHIBITS SCHECHITA.

HELSINGFORS, April 27. (Jewish Telegraphic Agency) "Schechita", the killing of cattle and fowl according to the Jewish ritual, has been prohibited by the Government of Finland. The prohibition comes as a distinct shock to the Orthodox Jews, despite the many intimations from the prevention of cruelty quarters that the prohibition would be sought.

Finland is probably the only country where the ritual has been prohibited, although agitation favoring the abolition of the practice, said to be more humanitarian than the usual method, has been urged from time to time in various countries.

REMNANT OF KOLTCHAK ARMY EXHAUSTS BALANCE OF RUSSIAN QUOTA.

WASHINGTON, April 27, (Jewish Correspondence Bureau) The augmentation of the Russian quota by the recent ruling of the Labor Dept. adding the Bessarabia quota to it, will not bring more Russian and Ukrainian refugees to these shores. President Harding decided to permit the transportation to the United States of the 500 Russia refugees, who recently landed in the Phillipines after a stormy voyage in their own ships from Vladivostok.

Plans to bring the refugees to this country on an army transport were mapped out at the conference of the President. Secretary Weeks, and John Barton Payne, chairman of the American Red Cross.

The Red Cross will have charge of relief measures for the Russians upon their arrival in their country. Admission will be possible under the immigration law, inasmuch as the Russian quota has not been exhausted for the year ending June 30.

Secretary Weeks said the refugees who are remnants of a band opposed to the Soviet regime, would make desireable citizens. Most of them, he said, are skilled workers, professional or technical men. Arrangements to bring them to this country have been virtually completed and the work will be undertaken immediately.

\$800,000 INVESTED BY THE JEWISH NATIONAL FUND IN 1922.

NEW YORK, April 27, (Jewish Correspondence Bureau) The total expended in Palestine by the Jewish National Fund during the year 1922 reached £158,864 or approximately \$794,320, it is learned.

This amount compares very favorably with that spent in 1920 when the investments of the National Fund totalled the highest figure for any one year since its foundation, namely, £161,300. The present sum was expended as follows:

For land purchases \$E100,483.563; for land improvement £E34,901.454; afforestation and planting £E7,254.242; buildings £E5,295,952; loans £E6,9,7,146. Total £E154,892,327.

The sums spent on purchasing and improving land are thus 87% of the total as compared with 84% in 1924 and 37% in 1920. This is in accordance with the policy of th National Jewish Fund to concentrate more and more on land acquisition and its preparation for immediate colonization. SE 40,000 was paid on account of the land purchases in the Valley of Jezreel where most of the improvement works were carried out. At a time when other Funds had run low and the condition of the settlers was critical, the National Fund was able to employ hundreds of workmen on its Drainage schemes and Water Installation works. Had these essential works not been carried out the Emek colonies could never had recorded their present progress. it is stated.

The Head Office of the Jewish National Fund, it is learned. views the future with some concern as it is now spending its reserve resources and its present income is not adequate to enable it to continue to discharge its great responsibilities. A serious effort must be made, in the opinion of the Directors, to augment the revenue of the Jewish National Fund.

SULZEERGER ATTAINED HIGHEST HUMAN PERFECTION, IS LOUIS MARSHALL'S TRIBUTE TO GREAT JEWISH JURIST.

NEW YORK, April 27, (Jewish Correspondence Bureau) "It may be truly said that Mayer Sulzberger was one of the geat men of his generation and of the Jews of all time", Louis Marshall, life-long friend, declared in a brief estimate of the character and achievements of the great man. "His vast knowlege, humanized by his warm heart, directed by his extraordinary insight and his rare wiedom, and enriched by the originality of his intellect, created a reservoir from which flowed generously ideas that fructified the thoughts of his contemporaries. The potency of influence which he exerted upon hosts of affectionate and faithful disciples is inestimable. He embodied and illustrated every virtue making for good citizenship and the emoblement of mankind.

"Loyal to every obligation, gifted with the vision of genuine statesmanchip, astounding in his versatility, a lover of learning and a hater of shams, simple and irreproachable in his life, his was a glorious existence.

"His achievements as a lawyer, a judge, a student of literature, a philosopher, a thinker and a builder of institutions, have been so manifold as to defy enumeration. Today we think of him only as one who has attained the highest stage of human perfectability".

#### POLISH CONSUL WITHOLDS JEWS' VISAS.

RIGA, April, 26, Jewish Telegraphic Agency) Lithuanian Jews wishing to proceed to Poland will not be granted the Polish visas, the local representative of the Warsaw government announces. This action, he declares, is being taken because the Lithuanian Jews refuse to include in the minorities bloc, deputies of Polish origin in the Lithuanian Parliament.

#### COL. BRAMLEY MAY LEAVE PALESTINE FOST.

JERUSALEM, April 27, (Jewish Telegraphic Agency) Mr. Norman Bentwich, the Attorney-General in Palestine, and Colonel Bramley, the Director of Public Security, are proceeding shortly to England where they will spend their Leave.

Colonel Bramley has handed over his duties to Mr. Mavrogordato. It is probable that he may decide while in England to retire from the service of the Palestine government.

# DR. MAGNES HEADS HADASSAH IN PALESTINE.

JEPUSALEM, April 2, (Jewish Telegraphic Agency) Dr. J. L. Magnes has accepted the position of temporary head of the Hadassah medical organization in Palestine, in succession to Miss Henrietta Szold, who has left for America.
