LLOYD GEORGE DEFENDS VIGOROUSLY JEWS AND ZIONISM.

Says Jews Are Blamed Whatever They Do.

LONDON, July 14, (Jewish Telegraphic Agency) "No good ever came to any nation from crucifying the Jews" Lloyd George declares in a vigorous attack on anti-Semitism and an equally-spirited defense of Zionism appearing in an article by him in the London "Daily Telegraph" of today.

The Jews, says Lloyd George are blamed for whatever they do or are. "If they are rich, the Jews are called vultures, if poor, vermin. If they favor war, they are pro-war profiteers, if against war, pro-peace cowards and traitors. If labor is oppressed Jewish capital is held responsible, if on the other hand, labor revolts as in Russia, it is also the Jews' fault".

"In strange countries, the Jews are pogrommed and in our own country, they are barred from returning."

Passing to the Palestine question, Lloyd Gerge says "under the Jews, the country once numbered five millions, while under the Turks, the population was less than seven hundred thousand. The once glorious state has been spoiled by centuries of neglect but the country still has immense possibilities."

"The restoration of Palestine" he declares was started not by the Balfour Declaration but by Moses Montefiore."

"The Jews have turned the swamps of Palestine" the article continues "into valuable lands and by irrigation and reservoiring the rainfall, have converted a desert into a garden."

"The Arabs share this prosperity. Arabs have neither means, energy or ambition necessary to do this, and the British are too burdened to undertake it."

"The Balfour Declaration" he concludes "was not intended to expropriate Arabs but to enable Jews to come back. The Jews demand no privileges not enjoyed by the other inhabitants of Palestine. They ask only equality and an opportunity to peacefully upbuild a national home by their own exertions."

COUNTER-REVOLUTIONIST SAYS RED ARMY IS ANTI-SEMITIC.

BERLIN, July 14, (Jewish Telegraphic Agency) Charges that the Red Army is permeated throughout with anti-Semitism are made in a local Russian paper, "Rul".

The writer, a counter-revolutionary general named Frisne, quoting from alleged Russian army official records, asserts that the Soviet General Worosilow was forced to withdraw appointments of Jews as army officers because of the opposition of Red troops.

OFFERS PRIZE FOR NOVEL ON PALESTINE LIFE.

BERLIN, July 14, (Jewish Telegraphic Agency) The Berlin "Acht Uhr Blatt" carries a report that James Rothschild has offered a prize for the best novel dealing with life in the new Palestine.

The paper suggests that the competition be open to non-Jews as well as Jews.

SWEDISH KING AND EINSTEIN ENJOY CHAT.

GOTTENBERG, SWEDEN, July 14, (Jewish Telegraphic Agency) Professor Einstein delivered an address here before a scientific body on his theory of relativity. Among those present was King Gustaf. Following the lecture the Swedish monarch engaged in a long chat with the Jewish scientist.

PROHIBIT WEARING SWASTIKA EMBLEM IN MUNICH.

BERLIN, July 14, (Jewish Telegraphic Agency) The Munich police department has issued an order prohibiting the wearing of "provoking political emblems".

The move is understood to be directed against the Hakenkreuzler display of the anti-Semitic "swastika" emblem.

The National Socialists and the Fascisti are very much wrought up over the order.

NEW EDITION OF "PROTOCOLS" IN BERLIN.

BERLIN, July 14, (Jewish Telegraphic Agency) According to reports in anti-Semitic circles, the new edition dealing with the fictitious creation of anti-Semites, the "Protocols of the Elders of Zion" will soon be off the press.

The author of the new volume is Alfred Rosenberg, said to be a Jewish apostate.

In this book, the claim is made that Achad Haam is the author of the Protocols and that the late Drs. Herzl and Nordau were associated in the authorship.

CHARGE ANGORA GOVERNMENT HOSTILE TO JEWS.

LONDON. July 14, (Jewish Telegraphic Agency) Turkey, under the Angora government. is becoming a hotbed of anti-Semitism, according to reports to the London "Jewish Chronicle", which declare that Jews are being prohibited from traveling about the country. Those Turkish Jews who do leave, says the Chronicle, are forbidden to return to their native towns.

Jews are also being forced to close their places of business on Friday, the Moslem Sabbath. Synagogues in several of the towns were plastered with anti-Semitic signs, and in Brus, Jewish tradesmen were compelled to return merchandise which they had paid for to the Turkish sellers.

Politically too, the report says, Jews in Turkey are worse situated than under the old Turkish regime. There is at present no Jewish representative in the Angora Parliament.

The ban on Jewish participation in the market fairs of Adrianople, was lifted only when the peasant farmers themselves complained that they and not the Jews would suffer from the ban.

The wave of persecution has led to the exodus of many Jews from some of the principal towns of Turkey, particularly Smyrna.

WEAKENING OF AGENCY FAVORED BY BRITISH LEADERS.

Change Due To Judge Mack, Is Rumor.

LONDON, July 14, (Jewish Telegraphic Agency) A changed attitude toward the Jewish Agency for Palestine is reported here to have developed among some of the leaders of British Jewry.

Ab. Goldberg of the American Zionist Administration has held conferences with Sir Robert Waley Cohen, D'Avigdor Goldsmith, Nathan Laski, and others. Some of these notables are said to have modified their position to the Agency, favoring a weakening of the body and proposing that it become after a fashion a clearing house for all bodies working in the economic sphere for the upbuilding of Palestine.

According to reports, the change in the attitude of these notables is due to representations of Judge Julian Mack of New York, president of the Palestine Development Council, who has been in London recently.

James deRothschild, whom Mr. Goldberg also conferred with, is said to be sympathetic to the original Agency idea. He would join, if his father, Baron Edmond deRothschild consents, in the opinion of Goldberg, who is proceeding to Paris to confer with the Baron.

1,064 JEWISH IMMIGRANTS IN CANADA IN FIVE MONTHS.

MONTREAL, July 14, (Jewish Telegraphic Agency) Immigration to Canada is exceeding last year's records, a total of 39,907 having come in during the last five months, representing an excess of 10,000 over the same period last year, according to figures in the Canadian Jewish Eagle here.

Of these immigrants, 1064 are Jews; 2,072, Italians, 1,272 Poles; 1,532 Russians and Fins.

JEWS IN CONSULAR SERVICE PROMOTED.

WASHINGTON, July 14, (Jewish Telegraphic Agency) David C. Berger, of Virginia, and Maurice W. Altaffer, of Ohio, are among those of the American Consular Service listed as promoted by an order of the State Department just issued.

Berger who is now vice consul and interpreter at Shanghai is appointed to same position at Tientsin. Altaffer who is now vice consul and clerk at Stuttgart is promoted to be vice consul de carriere of class 3 and assigned vice consul there.

DR. MARMOREK, ZIONIST AND SCIENTIST DEAD.

PARIS, July 14. (Jewish Telegraphic Agency) Dr. Alexander Marmorek, noted physician and distinguished Zionist, died at his home early Friday morning. According with his last wishes no eulogies were delivered at the funeral which was held Sunday. The only services to mark the obsequies was the recital of the Kaddish by his brothers.

The Pasteur Institute of Paris was represented at the funeral by the Provost Mesnil. The World Zionist Organization was represented by Leo Motzkin.

Others at the funeral included M. Sliosberg, Hillel Zlatopoleki, M. Allienkoff, M. Fischer, of Holland and M. Ornstein, representing the Belgium Zionists.

The Zionist Executive today telegraphed the widow of Dr. Marmorek offering condolences. "The whole Zionist world", the message reads, "will long cherish your husband's pioneer services and ceaseless devotion to the Cause."

TILLINGER TURNS UP IN NEW ORLEANS.

Unfrocked Rabbi, Self-Confessed Renegade, Attached to Presbyterian Church.

Discovered and Exposed, He Sues Editor Silber for Libel.

IS SEEKING RABBINICAL POST IN BRAZIL.

New Orleans, July 16. (Jewish Telegraphic Agency). Judah Elfer being Tillinger, former rabbi of Jacob Schiff Center, The Bronx, who was unfrocked by a committee of Orthodox rabbis in New York February 19th last, following sensational disclosures that in Austria previous to his arrival in the United States, he had turned priest, and had written a series of articles supporting the medieval blood-libel against Jews during the famous Leopold Hilsner trial, has made his appearance in New Orleans and has again leaped into notoriety.

Tillinger is suing Dr. Mendel Silber, New Orleans rabbi and editor of THE JEWISH LEDGER, for libel following the publication by this paper of the story of the unfrocked rabbi.

The discovery of Dr. Tillinger's presence in New Orleans was made by Dr. Silber, whose suspicions were aroused when he was informed that a man claiming to be a rabbi was a regular attendant at services in a Presbyterian church and was closely connected with the minister of that church.

Dr. Silber's investigations revealed that the rabbi was none other than Tillinger. At the time of the investigation, Tillinger was trying to obtain a passport from the Brazilian consul here, claiming that he had the assurance of obtaining a rabbinical position in the South American republic.

When the minister of the Presbyterian Church learned that Dr. Silber was investigating the matter, he called on the editor and admitting Tillinger's identity, sought to convince him that Tillinger was innocent of the charges of which he had been convicted at the rabbinical trial in New York. A meeting was arranged between Dr. Silber, the Presbyterian minister and Tillinger himself. At that meeting, Tillinger flatly denied that he had ever forsaken the Jewish religion or that he had written articles justifying blood accusations, or that he had ever known anything of the Hilsner case, in which a blood allegation was involved.

When Dr. Silber confronted Tillinger with copies of Austrian newspapers in which the charges against Tillinger were contained, he mumbled confused and unintelligible phrases, declaring that the articles were untrue.

When asked about his New York trial, he charged that it was all a frame-up by atheists and Bolsheviki to ruin him because of his deep devotion to the Jewish faith.

Dr. Silber then pointed out to him that his trial had been conducted by a committee of the Union of Orthodox Rabbis who represented "the very antithesis of Atheism and Bolshevism", and informed Tillinger that he was not satisfied with his defense, adding that he would continue his expose of him. The exposure will appear in THE JEWISH LEDGER for Friday, July 20, and is as follows:

"For some time past New Orleans has had the distinction, though unbeknown to the community, of harboring the most contemptible, the most despicable creature on God's earth. To imagine that any Jew would for a moment heed the enticing voice and words of a bogus priest-rabbi is the height of absurdity. To suppose that an individual whose flagrant rascality has been proven in public could fetch Jewish souls into the Presbyterian fold is to be blinded by missionary zeal to the point of criminal credulity.

"We have not the least desire to protect our Presbyterian friends against the villainous designs of their new missionary. We think it only right to let their own experience convince them of their folly. ~~We~~ And we doubt not that it will, for, even now, while mulcting them of their good shekels, their missionary, we are reliably informed, is planning to go to South America and once more attempt to cheat and swindle some Jewish congregation in the guise and garb of a rabbi.

"In the meantime, the great stir that was caused by Tillinger's exposure in New York five months ago is now re-echoing in New Orleans and the priest-rabbi, now without a beard but still in the garb of a minister, is continuing to play his deceitful and hypocritical role with the aid and under the protection of a Presbyterian pastor."
