POLICE STATIONED IN JEWISH CEMETERY.

WARSAW, Sept. 3. (Jewish Telegraphic Agency) Policemen have been stationed in the Jewish cemetery at Warsaw to guard against hooligan attacks.

Lately the hooligans have taken to the practice of attacking Jewish mourners while at funerals. They also have mutilated many of the tombstones.

Six police guards will watch the cemetery day and night.

HITLER URGES ECONOMIC BOYCOTT AGAINST JEWS.

MUNICH, Sept. 3. (Jewish Telegraphic Agency) Adolph Hitler is now advocating an economic boycott as the latest weapon to down the Jews.

The "Volkische Beobachter", a Fascisti organ, in its current issue proposes the launching of such a boycott against the Jews. The article goes on to attempt to prove that the solidarity of the foes of the Jews is now such to make the boycott feasible.

REQUEST OF JEWISH FRONT LINE SOLDIERS IS SCORNED.

BERLIN, Sept. 3. (Jewish Telegraphic Agency) Even Jewish soldiers of Germany who weathered the horrors of war for their country in the front line trenches are not exempt from anti-Semitic scorn.

The National Union of Jewish Front Soldiers recently sent a letter to the "Bismarck Bund" requesting that the organization seek to influence its members to refrain from molesting Jewish passersby on the streets. The only reply from the "Bismarck Bund" to the Jewish veterans was that it saw no necessity to refrain its members from curbing Jewish "freshness".

CUZA CALLS ANTI-SEMITIC CONCLAVE.

War and Justice Ministers Arrive in Jassy.

JASSY, Sept. 3. (Jewish Telegraphic Agency) The Roumanian anti-Semite leader, Professor Cuza, has sent out a call for a gathering of his student disciples in Jassy.

The forthcoming meeting taking place so soon after the recent anti-Jewish excesses in Jassy has aroused the fears that it may lead to new disturbances. Both the Minister of War and the Minister of Justice have come here to nip in the bud the proposed disturbances.

ALIEN JEWS START EXODOS FROM HUNGARY.

BUDAPEST, Sept. 3. (Jewish Telegraphic Agency) The Minister for Foreign Affairs has sent out an order to police departments throughout Hungary directing that the leaves to reside in the country of Jewish aliens not be extended further, unless special permission is obtained from the Ministry of Foreign Affairs.

As the result of the order, an exodus of Jews who are not Hungarian citizens has commenced. Many of them are established business men and manufacturers. They are facing the necessity of quickly disposing of their buildings at virtually any price.

NEW YORK "TAG" BANNED FROM POLAND.

WARSAW, Aug. 31, (Jewish Telegraphic Agency) All copies of the "Tag", the Yiddish newspaper of New York, were confiscated by government agents. An order has also been issued forbidding the bringing this Jewish daily by mail into Poland. No reason is cited for the ban.

DEATH OF RABBI BLOCH.

BRUSSELS, Sept. 1, (Jewish Telegraphic Agency) Rabbi Arman Bloch, Chief Rabbi of Belgium since 1891, died here yesterday.

A scholar of distinction, the rabbi, who presided over the Jewish Community for 32 years, rose to prominence in Europe by his resistance of the German Occupation authorities during the war. He refused to sign a document demanded by Germany that the Belgian Jews would obey the occupation authorities.

Later he was sentenced by a German Military Tribunal to six months' imprisonment for a patriotic sermon.

UNTERMYER ATTACHES FORD MONEY IN BERNSTEIN'S LIBEL SUIT.

NEW YORK, Sept. 3, (Jewish Telegraphic Agency) The attachment of \$115,000 belonging to Henry Ford in the Corn Exchange Bank and an instruction to the Sheriff of the State of New York to seize all copies of the "Dearborn Independent" coming into New York, are the latest developments in Herman Bernstein's suit for libel against Ford and the Dearborn Publishing Company.

Speaking of the progress of the suit, Mr. Bernstein, editor of The Jewish Tribune, said:

"Mr. Ford continues to evade the jurisdiction of the Courts and to occupy the 'enviable' position of a quasi-fugitive from the justice of this State, but I believe that we are gradually closing in on him so that he will either have to 'face the music' or pay the damages and confess himself a libeller not only of me but of an entire race. It seems amazing that any man can do what he is doing in this case and still hold up his head in the community, no matter how big a money bag he may be.

"Mr. Untermyer's office reported to me today that as a result of the warrant of attachment served on the banks, he has attached \$115,000 belonging to Henry Ford in the Corn Exchange Bank and that there is a likelihood of attaching considerable other property, although no real estate in the State of New York has been unearthed in Mr. Ford's name.

"New developments are shortly expected in connection with the sale of the Dearborn Independent in this State. The Sheriff has been directed from now on to seize whatever copies of the Dearborn Independent make their way into the State."

J.W.R.C. JOINS INTERNATIONAL UNION FOR CHILD RELIEF.

PARIS, Sept. 3, (Jewish Telegraphic Agency) The International Union for Child Relief has approved the Jewish World Relief Conference of Paris as one of its affiliated members.

This acceptance of the J.W.R.C. is considered noteworthy in view of the general policy of the International Union in accepting only official government institutions.

400 PALESTINE EMPLOYEES TO LOSE THEIR JOBS, REPORT.

LONDON, Sept. 3, (Jewish Telegraphic Agency) More than 400 employees of the Palestine Administration stand to lose their jobs, according to a report in the "Express". The reason given for the proposed dismissal of this large number of employees is the necessity, in view of the Government's deficit, to reduce expenses.

Most of the employees to be dismissed are native Palestinians, the correspondent asserts. A large number of the positions which will be left vacant are among senior posts of the administration.

WOULD DEPORT IMMIGRANTS IN 15 SECONDS TOO SOON.

NEW YORK, Sept. 3. (Jewish Telegraphic Agency) Five hundred Jewish immigrants who arrived from Russia on the Esthonia, many who came on the Braga and two other steamers may be deported because their ships came in a few minutes or a few seconds before September 1.

Coming in during the last quarter of a minute of the month of August, according to the Immigration Department's interpretation of the law, the Esthonia's passengers belong to the August quota which is already filled. Under the regulations, they cannot come in under the September quota.

Commissioner Curran, commenting on the situation declares that the law by which these immigrants are barred is "fiendish". The Bureau of Immigration in Washington however has ordered that the law be strictly enforced.

An effort will be made to intervene with higher officials at Washington to set aside the harsh ruling of the Immigration Bureau.

"Times" Scores "Fiendish" Ruling.

The New York Times today comments editorially on this ruling which would bar immigrants arriving a few seconds too soon. The editorial in part is as follows:

"Commissioner Curran uses restrained language when he calls "fiendish" the ruling that the thousand or two immigrants who crossed the line at Quarantine a few minutes - in one case only 15 seconds - before midnight on Aug. 31 must be deported because they do not fall within the September quota... Besides being so cruel, the decision flies directly in the face of common sense that it seems as if a way must be found to set aside or get around it..."

The incident, like others less flagrant that have preceded it, cries aloud for a revision of our Immigration laws, especially as regards the details of its administration. Without departing from the percentage basis for the admission of aliens, much greater discretion could be given to the officers charged with the duty of enforcing the law. It ought always be possible to rearrange and adjust the monthly quotas in a way to prevent extreme hardships..."

PEOPLE'S RELIEF DEFENDED AT CONVENTION.

BOSTON, Sept. 3, (Jewish Telegraphic Agency) Representing 13 cities and 20 Jewish labor organizations 138 delegates began the annual convention of the People's Relief Committee here Sunday.

The attacks on the organization made by a New York Jewish daily charging that the Committee has not raised as much money as its report shows, the bulk of the money recorded having come to the Committee in the form of "credits" for participation in American Jewish Relief Administration drives, is being warmly discussed.

Alexander Kohn, of New York, president of the organization, declared that the attacks were really directed at the Jewish labor movement than at the organization itself.

The chief topic before the convention is the proposal to amalgamate on reconstructive work in Europe with the "Ort".
