HOLIDAY SERVICES UNDISTURBED FOR FIRST TIME IN SOVIET RUSSIA.

MOSCOW, Oct. 1, (Jewish Telegraphic Agency) A possible change in the attitude of the Soviet Government toward religion is seen by some here in the passive policy pursued by the Soviets during the recent Jewish High Holldays.

For the first time since the communists have been in power, no attempt was made by either the government or by quasi-governmental organizations to interfere with the celebration of the holidays.

None of the burlesquing of the Jewish religious festivals, nor the carnivals which in the past had been deliberately staged on the Jewish sacred days took place recently.

Some theatrical performances, river excursions, and frolics were indulged in by the Communists but all of these were of a mild character and nothing was done to interfere with the religious observances of others.

According to the "Emmes", the organ of Jewish Communists, many would—be worshippers applied to the Communist organizations to intervene and force the synagogues to reduce their ticket prices. The Jewish Communists however refused to intervene.

AMERICAN FIGHTS ANTI-SEMITES: MOB SEEKS VENGEANCE.

EERLIN, Oct. 1, (Jewish Telegraphic Agency) A mob of twenty anti-Semites sought to break into the room of a hotel at Huschaid, Bavaria, occupied by Leo Koral, an American Jew.

During the afternoon, Koral quarreled and came to blows with a Bavarian on account of the latter's remarks of Jews. Following the fight, when Koral retired to his room, a mob drew up at the hotel. They were dispersed by the police.

NATIONAL POGROM PLOT THWARTED BY OVERHEARING OF CONVERSATION.

General Attack Planned For Yom Kippur.

BUCHAREST, Sept. 28, (Jewish Telegraphic Agency) A chance hearing of a conversation between two pogromists in Transylvania was the means of thwarting the nation-wide plot against the Jews which had been planned for Yom Kippur in connection with the "putch" against the government.

Samuel Gruen, Jewish proprietor of a tavern in Marmarosziget, the ghetto of Transylvania, overheard a government clerk, named Machalache, who is also a correspondent for the Bucharest daily "Universul". giving a young fighter, Varga, instructions regarding the execution of the pogrom plot. Gruen informed the police. The two were arrested and the wide ramifications of the plot were revealed.

A police detail was rushed to the synagogue and two students were found walking in front who, when arrested confessed that they had been designated to murder Chief Rabbi Teitelbaum. In view of the shortage of hooligans in Marmorosziget,

sixty armed students were entrained to that place from another point. Upon learning of this, 100 Jewish young men armed themselves and accompanied the police who awaited the train and arrested the students.

PALESTINE NOT READY FOR NATIONAL GOVERNMENT, DELEGATION TOLD.

JERUSALEM, Sept. 29, (Jewish Telegraphic Agency) The Arab Delegation was informed by Sir Herbert Samuel that Palestine was not ready for a national government, the Delegation in a statement made here declares.

The Arab delegation again emphasized the fact that they will not be satisfied until Palestine was placed under a national form of government.

JEWS FORCED REMOVAL OF CRUCIFIX, SAYS ANTI-SEMITIC PAPER.

BERLIN, Sept. 30, (Jewish Telegraphic Agency) Jews of Baden, the famous bathing resort who participated in a Herding memorial excercise at a Baptist church there forced the removal from the church of a cross, according to a story which appeared in the "Deutscher Zeitung".

According to this paper, American Jews who were in the majority in the church insisted on the removal of the crucifix despite the vigorous protests of the Evangelists.

ARAB DELEGATION STILL PLANS TO VISIT U.S.

JERUSALEM, Sept. 30, (Jewish Telegraphic Agency) The plans of the Arab delegation to visit the U.S., which were abandoned owing to the illness of Mousa Kazim Pasha, will be carried out shortly, according to the Delegation here.

ROUMANIA REFUGEES PIN HOPES IN LEAGUE OF NATIONS.

PARIS, Oct. 1, (Jewish Telegraphic Agency) Jewish refugees in Roumania are now pinning their last hope in the League of Nations. According to reports received here, the treatment of

the refugees beggars description. They are being seized in the streets and placed under arrest and carted away without a chance to make any preparations to the border.

The fact that these expulsions should be taking place now in view of the promise made by the Roumanian Government to stay same until December has aroused great indignation.

Jews here hope that the League of Nations will step in and hold Roumania to her promise.

TO PROSEUTE ALLEGED DISLOYAL JEWS OF CORFU.

LONDON, Sept. 29, (Jewish Telegraphic Agency) Some of the Jews of Corfu were disloyal to the Greek government and sympathized with the Italian invaders, the Greek prosecutor in Corfu informed the Government at Athens, according to a dispatch received here.

The Greek Government, the report continues, gave

instructions to prosecute the guilty parties.

ANTI-SEMITISM SWEEPING GERMANY LIKE PLAGUE.

Fear Worst If Hitler Gets Power.

PERLIN, Sept. 30, (Jewish Telegraphic Agency) German Jewry is now facing one of the most severe crises in its history.

Reports from Munich state that the anti-Semitic

agitation has now reached an unprecedented climax. Posters are to be seen throughout the city condemning Jews and urging violence on them. The propaganda is continuous.

Dr. Van Kaar, the new military dictator, is himself no friend of the Jews. In the event, however, the present regime falls and Hitler succeeds to power, it is taken for granted that the Jews of Germany will be visited by the most severe persecution in the nistory of the country.

JEWISH OWNER OF ANTI-SEMITIC DAILY DEAD.

WARSAW, Sept. 16. (J.T.A. Correspondence) Mme. Hortense Levinthal, for many years owner of the extreme anti-Semitic dahly here, "Kurjer Warszawski" died here September 13.

Mme. Levinthal, a convert to Catolicism, was a daughter of Mattathias Berson, for a long time the president of the Wareaw Jewish community. All her children, one son and four daughters, have left the Jewish faith. Cardinal Kakowski, the Archbishop of Warsaw sent a warm message of condolence.

Deputy Wladislaw Rabski, of the National Democratic (anti-Semitic) Party, a son in law of the deceased, is taking ever the editorship of the paper.

MATZ CONDEMNS LITHUANIA PRACTICES.

Many Jews Leaving for Palestine.

NEW YORK. Sept. 30, (Jewish Telegraphic Agency) Conditions as regards the Jews in Lithuania are going steadily from bad to worse, Israel Matz, who returned from Europe on the Levisthan, said today.

Despite the fact that the Jews played a prominent part in the establishment of the Lithuanian Republic and had received various glittering promises of equality at the time for their work in that direction, they are being harassed in every way, Mr. Matz said.

"There is an agrarian law, for instance, under which Jews who till the soil are being driven to the cities and when they get to the cities, the outcry against them is why they persist in crowding in the cities.

"Almost all of the tax burdens are shifted onto the backs of Jewish business men, the non-Jewish escaping with but little taxation.

"As a result of the multifold oppressions. Jews in large numbers, Mr. Matz said, are leaving for Palestine."

JUSTICE LEHMAN NAMED BY BOTH PARTIES FOR HIGHEST BENCH.

NEW YORK, Oct. 1, (Jewish Telegraphic Agency) Justice Irving Lehman of the State Supreme Court has been named by both Democratic and Republican parties for the place in the Court of Appeals succeedig Associate Judge John W. Hogan.

The nomination of Justice Lehman to the State Appelate bench, which is the highest in the state was first made by the Democrats. Opposition arose at first in view of the fact that one Jewish Justice, Judge B.N. Cardoza, is already a member of that court.

The press generally commends the nomination of Judge Lehman, speaking in high terms of his exceptional qualifications. The New York Times referring to the nomination says

"His fitness for that eminent post by temperament and character, by learning, intellect and experience is known to the bar and the public. He went on the bench at 33 and is now but 47. So the State has every prospect of enjoying the benefit of his faithful service for his full term."

Judge Lehman is very active in Jewish affairs. He is the chairman of the Jewish Welfare Board and is also one of the directors of the Jewish Theological Seminary.

LONDON "JEWISH TIMES" CELEBRATES 10TH ANNIVERSARY.
