## ARAB AGENCY PLAN EMBARRASSES WEIZMANN

Resignations of Executive Members Possible As Protest Against Britain.

London, October 25 (Jewish Telegraphic Agency). The meeting of the Actions Committee of the Zionist Organization opening here today has brought together a larger number of members than was expected in view of the short notice given of the meeting.

The large attendance is due primarily to the expectation that this meeting will witness a general review, if not a revision, of the Zionist policy, growing out of the recent events in the movement.

The principal question is whether Dr. Weizmann, President of the Organization, knew and expected that an official pronouncement would be made regarding the establishment of an Arab Agency in Palestine, similar to the Jewish Agency provided for by the Mandate. If he did not know, members of the Actions Committee are desirous of ascertaining who is responsible for this step by the Colonial Office.

It is not unlikely that owing to differences of opinion with regard to the further tactics towards the British Government, as a result of the latest concession to the Arabs, that one or two members of the Executive will resign.

Dr. Weizmann's attitude has not been stated clearly, although a recent speech of his in Paris indicated that he was unable to understand the alarm caused in the Zionist camp by the Arab Agency proposal.

## ----- POGROMS PERIL, GERMAN JEWS, FRONT SOLDIERS HERE

Berlin, October 25 (Jewish Telegraphic Agency). The peril of pogroms hangs over the Jewish population throughout Germany, delegates to the conference today of the Jewish Front Soldiers reported.

East Prussia, Pomerania, Upper Silesia, and Bavaria are among the districts represented at this conference.

Following presentation of reports by delegates in the various districts, a resolution was adopted directing the attention of the authorities that "the honor, property and blood of German Jews" are imperilled by the anti-Semitic agitation, and demanding the Government take steps to safeguard Jewish life and property.

## SAY BEUTHEN JEWS "MOLEST HAKENKREUZLER"

German Party in Upper Silesia Appeals to Military To Suppress Jewish Guard.

Beuthen, Upper Silesia, October 25 (J. T.A.). The situation throughout Upper Silesia and, particularly, here continues threatening as far as the Jews are concerned. The anti-Semites, taking their cue from the German Party insist that Jews are in complete control of Beuthen, occupying the best residences and, organized under the very eyes of the police, maintain a well-equipped and well-paid Jewish guard, which "molests" the Hakenkreuzler.

Basing themselves upon this incredible accusation, the German Party appeals to the military authorities to take the situation in hand before "the seething German national soul resorts to self-defense".

## WARBURG DEPLORES GERMANY LACKS BRITAIN'S POLITICAL SENSE

Professor Otto Warburg Scores Assertion That Zionists Are British Agents.

Berlin, Oct. 25 (J. T.A.). Professor Otto Warburg, former President of the Zionist Actions Committee in a statement to the Boersenzzeitung retorts to the recent assertion in the same paper by the political leader Herr Koehrer, a former Socialist, that Zionism serves British interests. Under the circumstances Herr Koehrer suggested that the German Zionists should take no part in the public life of Germany but emigrate to Palestine.

Professor Warburg declares that Zionists are not English agents, being above politics. England, however, by recognizing the moral and material implications of the Zionist movement showed the fine political sense it possesses, which Germany unfortunately lacks, Professor Warburg concludes

## POLISH SEJIM VOTES FOR PASSPORT SYSTEM

Warsaw, October 25 (Jewish Telegraphic Agency). Notwithstanding the opposition of deputies representing the minority groups, in particular that of deputies Gruenbaum and Prilutzky, the Polish Sejm adopted with a majority upon its first reading a bill providing for the introduction of a compulsory passport law.

The Jewish deputies protested that the proposed passport system is aimed against the few hundred thousand citizens belonging to the minority nationalities whose citizenship continues to be questioned despite their residence in Poland. They urged that the right of domicile of these citizens be recognized once and for all and that the citizens belonging to the non-Polish nationalities should not be exposed to discriminatory passport laws.

**"GOD OF VENGEANCE" BANNED IN LONDON**

London, October 25 (Jewish Telegraphic Agency) The licensing authorities have prohibited the production of the "God of Vengeance" a play by Sholom Ash, noted New York playwright.

The drama which was suppressed after several weeks on Broadway, the suppression being followed by the arrest and conviction of the producer and the cast headed by Rudolph Schildkraut, was performed here by a company of Jewish players from Vilna, Poland.

The Sunday EXPRESS drew attention to its alleged obscene character calling it a "Zoul spectacle".

**U.S. MENACED BY NEGRO, JEW AND CATHOLIC, KU KLUX KLAN WIZARD INSIST**

Dallas, Texas, October 24 (J. T.A.). The Ku Klux Klan's attitude toward Negroes, Jews and Catholics was explained here today by Dr. H. W. Evans, Imperial Wizard, in a speech announced as outlining "fully for the first time the policies of the Ku Klux Klan regarding restriction of immigration and its program in this respect".

"We already have at least three powerful and numerous elements that do now and forever will defy every fundamental requirement of assimilation", said the Wizard, referring to the Negro, Jew and Catholic.

"First, there is the Negro - 10,500,000. They have not, they cannot attain the Anglo-Saxon level. Both biology and anthropology prove it.

"Another absolutely unblendable element is the Jew. To him patriotism as the Anglo-Saxon feels it is impossible. Already a fifth of the Jewish race is in this country. They are people apart from all other peoples. Were the melting-pot to burn hundreds of years Jew and Gentile would each emerge as he is today, only the Gentile would have been affected by many other elements and the Jew would not. As a race the Jews are law-abiding. They are of physically wholesome stock. They are mentally alert. They are a family people. But their homes are not American but Jewish homes, into which we cannot go and from which they will never emerge for a real intermingling with America.

"No nation can long endure that permits a higher temporal allegiance than to its own Government. The hierarchies of Roman and Greek Catholicism violate that principle. To them the Presidency at Washington is subordinate to the priesthood of Rome. The parochial school system is sufficient proof of a divided allegiance, a separatist instinct."

## EUGENE MEYER TO RELIEVE FARMERS' DISTRESS

Washington, October 25 (J. T.A.). Eugene Meyer, Jr. has become the Administration's adviser on relief for agricultural distress. Mr. Meyer is a native of California. He is one of the few American financiers who have been educated for their profession rather than merely grown up in it. After graduation from Yale, Mr. Meyer spent his early life in Europe, mastering the banking practices of Germany, Great Britain and France. The vast scheme of rural credits carried out by the War Finance Corporation has been virtually planned and administered by him.

New York, October 24 (J. T.A.). A group of men and women yesterday announced the formation of the American Committee for Relief of German Children. Major-General Henry T. Allen who was commanding office of the American Forces on the Rhine, is Chairman.

Among the members of the general committee are Bernard M. Baruch, Henry Morgenthau, Paul M. Warburg and fifty others.

If no answer or appearance of notice is filed by the defendants within twenty days Bernstein will be entitled to a judgment by default.

L. Franklin, Honorary Organizing Secretary of the Parents' National Educational Union.

Mrs. Franklin is the daughter of the late Lord Swaything and sister of the former Secretary of State for India, Lord Edwin Montagu and of the Hon. Lily Montagu. In addition to her notable work in the educational field and as a publicist on behalf of international relations, Mrs. Franklin is an outstanding figure in Jewish Liberal circles in England, being one of the founders together with Claude Montefiore and Dr. Israel Abrahams, of the Jewish Religious Union.
