GERMANY MAY PAY POGROM DAMAGES

Special Jewish Commission Investigating Damages Damses, oy Disasters

KUNZE, NOTORIOUS AGITATOR, ARRESTEE

Berlin, November 12, (Jewish Telegraphic Agency). The prompt and apparently effective suppression of the Hitler-Ludendorff putch has strengthened the Stresemann Government and there is every hope that complete order will be restored in the Reich.

Berlin is quiet, experiencing the calm following a storm. The Government has promised to take measures to prevent further anti-Jewish disturbances.

Reparation to the victims of the looting is being considered by the authorities and a special Jewish Commission has been authorized to investigate the disorders and submit an estimate of the losses.

Persons suspected of leadership and direct participation in the anti-Jewish riots will be arrested, it is announced. The arrest here of Richard Kunze, notorious anti-Semitic leader, and inventor of a special cudgel known as "Knuppelkunze", a weapon popular with the rioters, is regarded as a step in the direction promised by the Government.

POLAND DEMANDS SATISFACTION FOR HER JEWISH CITIZENS

Warsaw, November 12 (Jewish Telegraphic Agency) Indemnity for damages sustained during the anti-Jewish rioting in Berlin last week by Jewish citizens of Poland, is being demanded by the Polish Government. Poland's diplomatic representatives in Berlin, Munich, Breslau and other places have been instructed to demand satisfaction for past grievances and safeguards for the life and property of Polish citizens in Germany.

The expulsion of Polish citizens from German soil has also been made a subject of the representations, the Warsaw Government threatening to institute similar repressions on Polish soil against German citizens in the absence of adequate assurances.

HITLER-LUDENDORFF PUTCH DIRECTED AGAINST " JEWISH GOVERNMENT"

Munich, November 12 (Jewish Telegraphic Agency). The socalled Nationalist revolution in Bavaria which was ended so abruptly, was directed "simply and solely against the Jewish Government of Berlin", according to the Fascist leader Hitler's chief officer, who addressed the crowd assembled outside the brewery house where the short-lived putch was planned. Following the reading of the insurrectionery proclamation, Hitler's chief of staff explained that what was aimed by the Fascisti revolution was the destruction of the "Jewish Government".

It is understood that several anti-Jewish decrees had been prepared by the Hitlerists and that if not for its miscarriage the "revolution" would have writnessed unprededented acts of repression against the Jewish citizens of Germany

JEWISH CORRESPONDENT ARRESTED FOR REPORTING POGROMS

Berlin, November 12 (Jewish Telegraphic Agency). Jakob Lescinsky, Berlin correspondent of the "Jewish Daily Forward" of New York, was arrested Friday charged with having exaggerated the extent of the pogrom in the cables dispatched to his newspaper.

On Saturday Lescinsky was released and placed under police surveillance. The affair took an unexpected turn Sunday with the rearrest of the correspondent and his confinement in a solitary cell.

Lescinsky's rearrest was ordered by Lieutenant General Horn, Military Commandant of Berlin, who alleges that Lescinsky exaggerated in his American dispatches the facts concerning the events of last week, therebt discrediting Germany's name.

HITLER ORGAN SUPPRESSED

Munich, November 12 (Jewish Telegraphic Agency). The "Voelkisher Beobachter" of Munich, organ of the Bavarian Fascist leader Lieutenant Adolph Hitler, has been suppressed by the authorities. The "Beobachter" has been a consistent advocate of the anti-Jewish frightfulness which was always the policy of the Fascist leader.

What is still left of the Fascisti public opinion in Bavaria is at present engaged in reviling Dictator vonKahr for his alleged betrayal of Hitler by means of the "Jewish Judas kiss".

GERMAN STATESMEN DEPLORE POGROMS

Conscienceless

DESpuding Masses Misled By SERNIERESPEE Anti-Semites, Says Union For Combatting Anti-Semitism.

Berlin, November 12 (Jewish Telegraphic Agency). An appeal signed by ex-Chancellor Fehrenbach, ex-Ministers Gottheim, Fischer and Suedakun and others representing the Association for the Combatting of Anti-Semitism in the Reich deplores the recent pogrom in Berlin whereby "the"blackest page in German history" was written. "The despairing masses misled by the conscienceless anti-Semite Hitler attacked our Jewish fellow-citizens, looted Jewish shops, thus writing down the blackest page in German history", says the appeal. "To continue further on this road would mean that Germany is lost. German honor and its future make it imperative for us to combat the blind Jewish agitation which is besmirging the German name."

EINSTEIN FLEES TO HOLLAND

Berlin, November 12 (Jewish Telegraphic agency). Menacing letters from anti-Semites received by Professor Albert Einstein, of theory of relativity fame since his return from Russia semeral days ago have convinced the scientist of the advisability of leaving Germany for Holland.

The letters contained clear intimations that attempts would be made upon his life.

FRANKFURT KEHILLAH APPEALS FOR STARVING POLISH AND NATIVE JEWS

Warsaw, November 12 (J. T. A.). The Kehillah here is in receipt of an appeal from the Kehillah of Frankfurt-am-Main urging that potatoes, flour and other articles of food be dispatched immediately for the starving Polish Jews of Frankfurt as well as for German Jews, who are also in desperate need.

A committee has been formed here by the Kehillah to provide relief for Polish Jews in Germany who will endeavor to come to the aid of those of Frankfurt.

AUSTRIAN PREMIER AND ARCHBISHOP FIGHT ANTISEMITISM

Vienns, Nov. 8 (J. T.A.). The support of Prime Minister Seipel and of Cardinal Piffel has been pledged to Rector Doeller, in his attempt to irradicate anti-Sembtism from the University.

Rector Doeller in restoring order on the campus, insisted that Professor Kappelmacher, who was recently put to flight by anti-Semitic rowdies, resume his lectures.

The retiring Rector Diener, declared, while he was taking leave, that the "numerus clausus" was essential, and expressed the conviction that eventually it will be enforced.

COOLIDHE FOR STRICT IMMIGRATION LIMIT

Washington, Nov 12 (J. T.A.). President Coolidge believes Congress will extend the present restrictive immigration law at the expiration of the time limit next June 30. He favors restriction and is convinced that a majority of the members of the Senate and House do.

The opposition to some provisions of the immigration law is widespread, but not strong enough to compel a revision.

DRIVE FOR \$1,000,000 SEMINARY FUND BEGUN

New York Has Already Pledged \$200,000 of \$500,000 Quota

Louis Marshall and Sol kosenbloom wive \$25,000 Each.

New York, Nov. 12 (J. T.A.). The opening of a \$1,000,000 endowment fund for the Jewish Theological Seminary was announced yesterday. New York's quota is \$500,000.

The Young People's League of the United Synagogue of America has pledged \$50,000; Congregation B'nai Jeshrun, \$50,000, Temple Anshe Chesed, \$30,000, Louis Marshall and Sol Rosenbloom, \$25,000 each; Mr. and Mrs. Morris Lourie, \$10,000; Samuel Untermyer and Louis Stroock, \$5,000 each.

A conference will be held today in the auditorium of the seminary at 531 West 123rd Street, which will be attended by members of the Young People's League and representatives of seventeen fraternities composed of college men and women.

VIGILANTS CHARTERED TO FIGHT KLAN

National Prominent Men to Obtain State Laws Against Hooded Organization,

New York, November 12(J. T.A.). The enactment of laws to prevent the wearing of masks and hoods and to provide for the punishment of those who participate in mob violence is the purpose of a countrywide Arganization, the National Vigilance Association, which

has just been incorporated in Washington to combat the Ku Klux Klan and kindred organizations.

With a national committee composed of men prominent in education, husiness and professional life, the Wigilance Association has been working quietly for the last several months perfecting its organization to prosecute its campaign.

The organization will seek the cooperation of all military and social organizations, enlist the aid of three minute speakers all over the country and broadcast literature by radio in its fight against the "invisible empire".

COUNTRY LIFE ASSOCIATION HEARS ABOUT JEWISH FARLERS

St. Louis, Mo. Nov. 11 (J. T.A.) "Despite restrictions designed to uproot the Jew from the soil, there never was a time when Jews were not engaged in agriculture to some extent, declared Gabriel Davidson, General Manager of the Jewish agricultural Society in an address "The Jewish Farmer In The United States" delivered at the Sixth Annual Conference of the American Country Life Association, on November 10.

"Jews have been farming almost from the very time that white men set foot on this fertile soil," Mr. Davidson declared, tracing the agricultural attempts made by Jews from the time of Abraham de Lyon and Mordecai Emanuel Noah. "Today," Mr. Davidson said, there is no state in the Union that has not its Jewish farmers, and no branch of agriculture thathas not its Jewish yotaries.

"Within the short space of twenty years, or less, during the very period when the general drift was away from the farm and during the second half of which our foreign born farm population declined by 88,488, well nigh 15,000 Jewish families comprising 70,000 souls have returned to the soil, and a million of America's fair acres spread over every state of the Union, representing a valuation of a hundred millions of dollars, have been made to respond to the toil and to the genius of Jewish husbandmen. If the number is still not imposing, we must keep in mind the difficulties inherent in the change from city occupation to farming and from urban to rural living in the cases of a people so long prescribed from the land."

JEWISH VOTE NOT NEW TO AMERICA RABBI DECLARES

New York, Nov. 12 (J. T.A.). Declaring that a Jewish vote as the organized expression of Judaism and Jewish idealism is not unprecedented in America, Rabbi J. Max Weis in his sermon in the Heights Free Synagogue defended Israel Zangwill against his critics, particularly Louis Marshall.

"Judaism", Rabbi Weiss said, "must function as an organized religion. Following the genius and vision of the Federal Council Churches, and of the National Catholic Welfare Council, American Jewry must also act as a unit of spiritual and ethical influence. Shall we stand aside as the Churches of Christendom organize for world peace, for the fight against the drink evil, for the investigation of stell trusts, and for the liberation of political prisoners?.....When the Central Conference of American Kabbis votes, at its session, for the world Court and for the liberation of political prisoners, its Rabbis publish to the world "a Jewish vote' on these political questions. When the Council of Jewish Women, in accord with its ideals, announces its support of Legislative measures affecting the welfare of women and children, its action is unchallenged by Mr. Marshall. Yet, the pronouncement of the Council of Jewish women Emxmxqummahimmamahxquadhimimahx is, essentially and completely, a vote of Jewish women on a question of political import."
