## CANADA ASKED TO ADMIT JEWISH DEPORTEES

New York, Nov. 26 (Jewish Telegraphic Agency). Jewish leaders in Montreal have agreed to lodge an appeal with the Canadian Government for the temporary admission of several hundred Jewish immigrants ordered deported from the United States because they came in excess of the Russian quota.

Word was received at the office of the American Jewish Congress requesting representatives be sent there to accompany Jewish representatives of Canada who are proceeding to Ottawa to urge the admission of the deportees. The message from Canada is signed by Dionel Cohen, representing the United Jewish organizations of Montreal, according to an announcement made by Bernard G. Richards, Secretary of the American Jewish Congress.

Following Mr. Louis Marshall's visit to President Coolidge and the Jewish Congress delegation's appeal to the Secretary of Labor, the Department of Labor Saturday issued a statement that the appeal sent to the President in behalf of the excess quota immigrants had been referred to the Department and that "Every case will be individually reviewed and endeavor made to grant relief in cases where extreme hardship is apparent insofar as it is possible to do so within the limitations of the immigrant law".

The same day 142 immigrants were placed on board the White Star liner Majestic and deported. The pier was crowded with relatives and friends who were prevented from taking leave of the deportees, whose only "crime" was being above the Russian quota. Six of the deportees were saved by a writ of habeas corpus signed by Judge Augustus Hand in the Federal Court.

Governor Smith, in a forceful address Sunday morning before the Society for Ethical Culture attacked the immigration restriction. He said: "Finally, I would protest against our immigration restrictions. A sorry nation we would be now had we adopted our exclusions fifty years ago. Education is highly desirable, but if a man can't get it, it is not the greatest thing. My idea of what makes a good citizen would let in a lot of fine, capable stock that can't write its own name. Our prisons are full of men who can write their own names - and some one's else, for that matter. The only way to correct evil is to recognize it, then if we are men we must abolish it".

Reports from Washington today told of a vigorous protest filed with President Coolidge against basing the immigration quotas for the fiscal year on the census of 1890 as proposed by

Chairman Johnson of the House Immigration Committee. The protest is signed by six prominent citizens of Cleveland who attack the heads of the Department of Labor for the attempts "to place a brand of undesirability upon the race stock of Americans who are not of British or Teutonic origin".

The President's attention is drawn particularly to Secretary Davis' book as indicative of the attitude of a mind which qualifies immigrants of non-British or non-Teutonic origin as undesirable.

In the face of the deportations of hundreds of humble immigrants, Prince Youssouppoff, self-confessed slayer of Rasputin, his wife and Baroness Wrangel were admitted Friday as "diplomatic representatives" of a nation that does not exist. Prince Youssouppoff's passport was signed during the regency of the late Czar, and the three who have come to prepare the way for the coming Master of other impoverished monarchists were admitted regardless of the exhausted Russian quota.

#### ORTHODOX YOUTHS RIOT IN WARSAW KEHILLAH HOUSE

Warsaw, Nov. 26 (J. T.A.). A group of young students of Talmud Torahs and Yeshivath outraged because of the construction of a students' home in close proximity of a synagogue caused a riot yesterday at the Jewish community house when officials rejected their protest and plea to have the students' house located elsewhere.

On receiving the Kehillah's leaders' negative reply, the youths cut the telephone wires, invaded the offices of the Kehillah, broke all furniture, destroying part of the library and cut up the oil paintings of departed Kehillah presidents. The aged cartaker Bregman, who tried to interfere was badly knocked about, and the staff of the Kehillah was similarly attacked. Order was restored upon the arrival of the police, only to break out anew as the police withdrew. Six persons are said to have been seriously injured in addition to scores who got off with lighter wounds.

The attack on the Kehillah house caused the wildest excitement among the Jewish population, Jewish deputies, newspapermen and leaders of all intellectual circles visiting the office to express their sympathy.

#### GIRL SHOTS HER ARAB ASSAILANT IN COURT

Jerusalem, November 26 (J. T.A.) A fifteen year old Jewish girl of Kinereth took the law into her own hands when she shot and killed her Arab assailant just as the court in Tiberias sentenced him to fifteen years hard labor.

The crime took place some months ago near Kinereth. The girl was in court during her assailant's trial and hearing the verdict she whipped out a revolver and shot the prisoner. She has been taken into custody.

## POLAND BLAMES BERLIN POLICE FOR POGROM

Berlin, November 26 (J. T.A.). An official protest against the mistreatment and the plundering which Jewish citizens of Poland together with other Jews suffered during the pogrom in Berlin has been lodged by the Polish Ambassador with the Chancellor. More than 100 individual claims are cited by the Polish authorities showing that the police authorities far from defending the Jews that had been attacked went so far as to encourage the plunderers.

The intervention of the Consul General having been in vain, the Polish Government desires to know if the officials guilty of neglect had been punished. In conclusion the Polish Government demands reparation for the damages sustained.

## MAURICE MARCUS LEAVES 3,000 POUNDS. BRITISH GOVERNMENT GETS HALF

London, Nov. 26 (J. T.A.) The British Government is richer today by nearly one and a half millions pounds in death dues, the windfall resulting from the will admitted to probate yesterday of Maurice Marcus who died in September at the age of 78, leaving nearly three million pounds from which the Government may claim almost half.

Publication of the will caused a sensation because Marcus' wealth was an absolute secret and even his closest friends are astonished at the vastness of the fortune.

Marcus was unmarried. He made his fortune in South African diamonds and is said to have done his own bookkeeping to prevent knowledge of his fortune.

He was a friend of Cecil Rhodes. Numerous small bequests made to charities include 1000 pounds to the Jewish Board of Guardians.

## OUTNUMBERED FORTY TO ONE WHITECHAPEL CHURCH HOLDS LAST SERVICE

London, November 26 (J. T.A. Saint Jude's Church at Commercial Street, Whitechapel, adjourning Toynbee Hall, held its last service last night.

The church was being closed, the Rector said, not because of lack of devotion, but because the Gentiles are outnumbered by the Jews forty to one. Like other churches in the East End, the St. Jude's Church was suffering from lack of attendance. In this Parish, he said, there were 8,000 Jews and 200 Gentiles, with the Jews steadily increasing in number. The Rector said that the last vicars complained of the same "heart-breaking experience."

# DUNCAN'S HUSBAND SAYS HE CRITICIZED "JEWISH PROFITEERS" BUT IS NOT ANTISEMITIC.

New York, November 26. (Jewish Telegraphic Agency). Serge Essenin, husband of Isadora Duncan, has been released from jail, where he was held with three companions on a charge of insulting and subversive anti-Semitic conversation, cañes the Moscow correspondent of the NEW YORK TIMES.

Essenin is no longer Isadora's husband, if his own statements and those of his friends are to be trusted. Without awaiting the formality of a divorce a few days ago he selected a new partner, a young actress from the Kamerny Theatre.

The facts of his arrest, as Essenin alleges, are these:

"The four poets were in a beer saloon, when they noticed a prosperous-looking citizen who appeared to them to take an undue interest in their conversation. Whereupon they told him what they thought of him, adding some general remarks about Jewish 'Nepmen' as chalk from cheese."

## READING OF BIBLE IN SCHOOLS UPHELD.

Portland, Me., November 26. (J.T.A.) Under a decision of the Maine Supreme Court, written by Judge John Appleton in 1854, the constitutionality of the new state law requiring the reading of the Bible in the public schools is upheld, according to Ralph O. Brewster, state Senator, in answer to attacks which have been made upon the measure.

The issue in 1854 arose from action taken in behalf of a Roman Catholic pupil in Ellsworth, in the public school of which the reading of the Protestant Bible was required, a violation of the religious rights of the parent and child being claimed.

## OKLAHOMA GOVERNOR MOVES AGAINST SECRET SOCIETIES.

Oklahoma City, November 26. (Jewish Telegraphic Agency). Governor Trapp announced that he would recommend to the Legislature today the passage of a law definitely regulating secret organizations in Oklahoma and providing for the making public of membership rolls, says an Associated Press despatch.

"I do not propose to go to the Legislature and force an anti-Klan law," said Governor Trapp. "I do not want a Klan or anti-Klan statute. I advocate a measure that will apply to all secret organizations. The people have a right to this protection."

# **KLAN PROPAGANDISTS AFTER BAY STATE SOLONS.**

Boston, November 26. (Jewish Telegraphic Agency). The first attempt on the part of the Ku Klux Klan and its sympathizers to sway the minds of the Massachusetts legislators cropped up Saturday when members were flooded with circulars mailed in New York, attacking President Coolidge, Secretary Hughes, former President Wilson, his former Secretary Joseph Tumulty, the "anti-Christian Jews" and the Roman Catholic Church. The circular was signed simply "100 Per Cent American."

"President Coolidge," reads the circular, "is lacking in any real Americanism because of his attitude toward the reparations conference. You legislators are warned to beware of the influence of the Roman Catholic Church and the Jewish people."

After attacking the League of Nations and the World Court, a circular says:

"The same tireless alien influence has been at work recently striving to get America into the so-called reparations conference."

## **RAPS NORDIC THEORY AS UNAMERICAN.**

New York, November 26. (Jewish Telegraphic Agency). Dr. Samuel Schulman, in a Thanksgiving sermon at Temple Beth-El, Sunday, assailed those persons who would limit the title of "American" to people of any particular creed or to the Nordic or Anglo-Saxon element.

"All views," he said, "which would monopolize Americanism for a particular race, for a particular church or for a particular demeanor or manners are altogether un-American. They are today the greatest menace to the dignity, to the freedom, to the humanity of men for which the American life stands, insofar as they tend by fostering hatred and misunderstanding to impair the unity and independence of the American nation."

## **WEIZMANN TO CONFER WITH NEW KEREN HAYESOD COUNCIL.**

New York, November 26. (J.T.A.) Dr. Chaim Weizmann, who is due to arrive on the Aquitania Friday, November 30, will deliver his first address here Sunday evening, December 9, at the Hotel Astor, when the newly organized National Keren Hayesod Council will hold its first meeting. The delegates, including many persons prominent in national affairs, will be drawn from all parts of the United States.

The following evening Dr. Weizmann will again speak at the Astor where a reception will be tendered him by a committee of one hundred.

## OBSERVE 8TH ANNIVERSARY OF DR. SCHECHTER'S DEATH.

New York, November 26. (Jewish Telegraphic Agency). The eighth anniversary of the death of Professor Solomon Schechter was observed yesterday at the Jewish Theological Seminary, of which he was president from 1902 until his death on November 19, 1915. Professor Moses Hyamson and Rabbi Max Drob delivered memorial addresses at a special service held by the faculty and students in the chapel of the Seminary.

During the course of his address on the life of Dr. Schechter, who was called from Cambridge University, where he had been Professor of Rabbinics, Rabbi Drob said that Dr. Schechter's personality and scholarship had strengthened traditional Judaism in America, and his erudition had wielded a potent influence conceded by the leaders of that branch of the faith in this country.

TEMPLE SISTERHOODS RAISE \$269,000; CAMPAIGN COST \$5,000.

New York, November 26. (J.T.A.) National Federation of Temple Sisterhoods has just made public a report of its drive to raise \$250,000 for the erection of a dormitory to house rabbinical students at the Hebrew Union College in Cincinnati. \$269,000 was raised at a campaign cost of less than \$5,000, it is reported. The small campaign cost, according to the announcement, is expected to be defrayed by contributions which are still coming in.

Except for three checks for \$1,000 each and one for \$2,600., there was a noticeable absence of large donations, the statement says. The majority of gifts were of \$5. and \$10.

HADASSAH GREET MRS. ZANGWILL, SPEED MISS SZOLD.

New York, November 26. (J.T.A.) A luncheon was tendered today to greet Mrs. Israel Zangwill and to bid farewell to Miss Henrietta Szold by Hadassah, the Women's Zionist Organization, at the Hotel Astor. Miss Szold is leaving for Palestine.

Members of Hadassah of the New York and Brooklyn Chapters and surrounding cities in Connecticut, New York State, New Jersey and Pennsylvania were invited.

Miss Szold, the president and founder of Hadassah, and one of the pioneers of the Zionist movement in the United States, will leave in a few days for Palestine, where she is planning to spend three months in the interests of the Governing Board of the Hadassah Hospitals in Palestine and as a representative of Hadassah.

Last April Miss Szold returned from three years spent in Palestine where she acted as co-director of the Hadassah Medical Organization, and developed the Nurses' Training School in

Jerusalem. During Miss Szold's stay in America she has worked out a plan of infant stations for mothers to be made possible by the gift of \$10,000 of Mr. and Mrs. Nathan Straus, and a similar sum which Hadassah expects to raise.

### DANIEL P. HAYS, PROMINENT REGENERATOR, DEAD.

Prominent Lawyer Was of Old New York Jewish Family.

New York, November 26. (J.T.A.) Daniel Peixotto Hays, one of the best known members of the New York City bar, who at one time or another had been connected with nearly every Jewish charity in the metropolis, died at his home, 260 West 86th Street, on Saturday, after a short illness, at the age of 69. Mr. Hays was senior member of the law firm of Hays, Hershfield and Wolf, 115 Broadway. He was a member of an old Jewish New York family who have lived in New York City and Westchester County for nearly 200 years. He was a great-grandson of Mendes Seixas, one of the founders of Columbia College. His great grandfather sold cattle to Washington's army.

He was a grandson of Dr. Madur Peizetto, at one time President of the New York County Medical Society. His paternal grandfather was Benjamin E. Hays, who gave to the town of Mount Pleasant the land for the site of its first High School.

Mr. Hays was Chairman of the Executive Committee of the Isaac N. Wise Centenary, New York Campaign. The campaign was launched throughout the country in 1919 to raise \$300,000 for the furtherance of the work of the Union of American Hebrew Congregations and the Hebrew Union College in Cincinnati.

Daniel Peixotto Hays was born at Pleasantville, March 28, 1854, the son of David and Judith S. (Peixotto) Hays. He was graduated from the College of the City of New York in 1873 and was awarded an L.L.B. degree by the Columbia Law School in 1875. He was married on April 7, 1880, to Rachel Hershfield, daughter of the late Aaron Hershfield, descendant of another old American Jewish family that traced its origin back to Revolutionary times.

He was Treasurer of the Harlem Federation for Jewish Communal Work, Trustee of the Jewish Publication Society, Governor of The Judeans, President of the Young Men's Hebrew Association, Jewish Theological Seminary. At various times he had served as a member of the ~~XXXXX~~ boards of the Hebrew Orphan Asylum, Mount Sinai Hospital, Home for Aged and Infirm Hebrews, Bani Brith, the Educational Alliance and the Guild for Crippled Children with a school in Montgomery Street.

He was President of the Harlem Democratic Club, a delegate to a number of Democratic State Conventions, President of the Municipal Civil Service Commission of New York City, a member of the Lawyers' Club. Mr. Hays is survived by his widow, five daughters and a son.
