BUDAPEST JEWS ACCUSED OF RITUAL MURDER

Budapest, December 21 (Jewish Telegraphic Agency). During a Parliament session, the Jews of Budapest have been accused of ritual murder by the anti-Semitic deputy Lendwai, who declared that a soldier named Tremmel had been attacked by Jews in the Budapest Ghetto and slaughtered, for ritual purposes. Jewish deputy Fabian interjected that the accusation was a lie.

Minister of Interior Rakowsky replied that the affair is being investigated, and that a Jew named Loebel had been arrested and will be tried. Me refused, however, to make any statements on the merits of the case.

The Jews of Budapest are greatly alarmed that the Government should not have refuted the ritual murder charge which is being spread by anti-Semitic circles with the purpose of inciting the masses against the Jews.

J.D.C. OFFICE IN POLAND TO LIQUIDATE.

Warsaw, December 21 (Jewish Telegraphic Agency). Owing to the decision of the Polish Government not to allow foreign organizations to do work in Poland, the offices of the America: Joint Distribution Committee will be closed December 31st.

Local officials have received notice, while the American officials have already left the country.

BRITISH AIR PILOT KILLED

Cairo, December 21 (Jewish Telegraphic Agency). Joseph Catz, British air pilot was killed near Cairo. The airplane crashed.

Mr. Catz was a lieutenant in the Jewish Legion which fought MAXIMIX in Palestine during the war. He was later secretary to Vladimir Jabotinsky.

SOVIET REPRESENTATIVE GRANTS VISAS IN RETURN FOR ANTIZIONIST STATEMENT

Constantinople, Dec. 21 (Jewish Telegraphic agency). Twenty-eight families who are proceeding from Palestine to Russia have applied for Russian visas and have been informed by the Soviet representative here that they will receive visas if they write to NAKANUNE, the Soviet organ in Berlin; that they are leaving Palestine because they are dissatisfied with the Ziorist situation and with the administration of the country. If they make this statement, the representative declared officially, and if they undertake not to participate in Ziorist activities in Russia, visas will be granted to them.

REVOLUTIONARY CONSPIRACY SUPPRESSED

Munich, December 21 (Jewish Telegraphic Agency). The opera singer Hans Bartell from Sazony has been arrested here on the charge of conspiring against the life of Dictator vonkahr, of Bavaria. Bartell has confessed.

The performance of La Tosca which was scheduled to be held in the National Theatre of Lunich, has been postponed because of rumors prevailing that during the second act of the performance the orchestra would play a revolutionary hymn which was to act as a signal for a Bavarian revolution.

TWO YIDDISH TRADE-SCHOOLS INSTALLED IN ROUMANIA

Bucharest, November 22 (Jewish Telegraphic Agency by Ma...) At technical school was opened in Benderi, which is the first in that city, and its opening aroused great interest among the entire population. Representatives of all Jewish organizations as well as representatives from the local government, were present.

Another "Ort" school for the making of ladies garments was opened in Jassy on November 18th: Forty girls attend this school.

HOUSE IMMIGRATION COMMITTEE DECIDES ON 2% QUOTA

Will Hold Hearings Only For the Sake Of Form.

Washington, Dec. 19 (J. T.A.) As a result of the second Executive Committee session today, all the main features of the immigration bill to be reported to the House are practically decided upon. Though decisions and votes taken officially are only supposed to be tentative yet judging from the attitude revealed, it is very unlikely that the Committee will change its mind when the final vote is taken. It has been decided to embody the decisions in forms which the tentative committee will print for the use of its members when the final vote is taken. These decisions are as follows:

A two per cent quota based on the 1890 census for all immigrants except relatives of citizens as a husband or a wife. A father or mother over fifty-five years of age and unmarried children under eighteen will be exempt from all quota restrictions.

Congressman Samuel Dickstein, Democrat, of New York, a new member of the Committee made a strong fight against the xixkt 1890 census, urging at least the retention of the three per cent. quota based on the 1910 census. This plea being without avail, he proposed the three percent quota based on the 1890 census to be operated as follows: Preference up to one per cent is to be given to the wife, husband and unmarried children under eighteen years of declarants, resident in the United States for two years; the remaining two percent to be allotted to all other aliens.

Conflicting statements were made to your correspondent regarding which plan was accepted. Congressman Dickstein declared the Committee adopted the latter scheme whereas a spokesman for the Committee who usually makes official announcements of the Committee's decisions, stated that the tentative worte was simply an acceptance of the two percent quota based contents to the 1850 census. In any event, Dickstein will make a strong the 1850 census. The Committee also decided in favor of immigration certificates by consuls, the possession of which will admit certificates by consuls, the possession of which will admit certificates by consults for far as quta restriction is consumed thereby avoiding hardship of excess quota upon arrival cerned thereby avoiding hardship of excess quota upon arrival here. The Committee rejected the proposal of a physical inspection abroad on the ground of international objections despite Congressman Raker's unceasing efforts to obtain its acceptance.

Congressman Dickstein was the only friend of immigration fighting in the Committee today as Congressman Sabath left washington for Chicago at this most crucial time.
