DR. KLEE, GERMAN ZIONIST LEADER, ARRESTED

Berlin. August 18. (Jewish Telegraphic Agency). Dr. Alfred Klee, well known lawyer and Zionist leader in Germany was arrested by the police aughorities here and sent to jail in Bautzen, on a charge that he had conferred with one of his clients, Heinrich Sklurz, at the time when a warrent was issued for his arrest. It is alleged that Dr. Klee transgressed against the law bh no delivering the client to the police. The arrest of the well-known lawyer caused much comment and construction in the press.

CHALUZIH IN VIENNA BARRED FROM PALESTINE. PROTEST AGAINST PALESTINIAN GOVERNIENT

Vienna - August 18; (Jewish Telegraphic Agency) A strong protest gaminst the limitation of Jewish immigration into Palestine was adopted here at a meeting of a considerable group of Chaluzin, who are unable to concede groups to the fact that their passports have not been visud.

The resolution is drafted in sharp terms, protesting strongly against the closing of the doors of Palestine and harring from the country the Jews who are striving to uphild their country by the sweat of their brow. This is not only a violagion of the Dalfour Becluration, but a disregard for the elementary principles of justice. The resolution asserts that unemployment does not warrent closing of the doors both the country because the workers create new openings in the country. The resolution further protests against the attitude of the Palestinian administration to twards irraignation and states that the present policy of the administration shows inconsideration for the feelings of the Jewish people and is an insult to the Jewish masses. It impeals for the opening of the doors of Erez Israel. It asks for the "correcement" of free irraignation to those whose aim is to devote their entire strength for the reconstruction of the Jewish national house."

Mrss AMUEL UNCENIVER DIES AT AGE OF 65.

New York. August 18 (Jewish Telegraphic Agency). Irs. Samuel Untermyer, wife of the wellknown Layer, died here, at the age of 65 after a prolonged illness, which she contracted while visiting with her husband in Carlebad two years ago.

Mrs. Unternyer, who was before her impriage Hiss Hinnie Curl, daugher of Herlius and Dauline Curl, was throughout her life interested in music and flowers and in social activities. Their home at Graystone Yorkers had open doors for writers, poets and musicians.

The funeral took place today. New. John Haynes Holmes of the Community Church, officiating.

WILL BREAK AWAY FROM DEMOCRATIC PARTY IF DAVIS WILL NOT DEMOUNCE KLAN, DECLARES SAMMEL UNTERHYER.

Has Admiration for Senator La Follette and Expects Same Attitude From President Coolings.

New York, August 11. (Jewish Telegraphic Agency). If John W. Davis, Democratic mominee for President, fails to annowne hinself against the En Klux Klun, I shall feel impelled to break away from my life-long allegiance to my part, for I should then regard hin as unworthy to be a leader of a great party, declared Samuel Untermyer in an exclusive statement issued today to the Jewish Telegraphic Agency in connection with the symposium of opinion gathered by the Agency concerning the attitude of American Jewry towards the K.K.K.

"The symposium of opinion you have guthered," stated in Sauriel Unterpyer, "on the important question of the policy to be followed by the Jews in combatting the activities of the despicable, lawless, un-American for Klux organization is most interesting and instructive. It is, of course, gratifying to me to find some well-nigh unanimous support in the position I have consistently taken as to the way in which we should deal with this excreacence upon the body politic of American life, as I felt sure there would be after mature consideration.

"The question is not one of feeling, about which there can be no difference of opinion among the decent citizenship of this country, but purely one of policy for the Jaws. It is easier to plunge unthinkingly into a fight than to restrain oneself, especially where the provocation is so overwhelming and well-nigh irresistable, but it is not always the part of widdom.

"This is not our fight. It is the fight of the Protestant churches, and of the tens of millions of patriotic, haveablding clergmen and citizens of the Protestant faith, whose love for their country and its cherished institutions will not permit them to sit idly by whilst those institutions are being undermined and flouted.

"If you will examine the record of my public utterances- wherever and whenever the opportunity has presented itself- you will find that faw men have been more outspoken in their denumciation, of the Klan. But I have always kaunched the attack from the point of view of an American citizen rather than from that of the Jew that being not only the most patriotic, just and legitimate, but the most expedient and effective.

"I regret, for the same of the Jawish cause, to which I have throughout my life devoted my hest energies, that my position on this crucial question has been missinderstood and misrepresented. And this notwithstanding my frequent public expressions of contempt for and denunciation of the miscreants who are seeking to poison the wells of American life and to spread higotry and hat he

"When Dr. Wise, whom I esteen highly as a public-spirited citizen, an outstanding teacher in our faith and a priceless asset to the Jewish people, gave expression to his point of view of my attitude, I conformed before penning my reply with my friend and partner, Hr. Louis Hurshall, found him in full agreement with me and upon the wisdom of the policy to be adopted as outlined in my letter to the American Jewish Congress.

"The pretext offered for these misrepresentations concerning my attitude upon the Klar was my support of the pre-Convention nomination campaign of Ir. McAdoo, who has been my life-long friend for and whom I know to be about as much of a sympathizer as I am with this odious hooded order that has dured to rear its venomous head in our political life. There was no more reason for his making public his personal views on that subject in anticipation of his choice by the Convention than there would have been for Ir. Davis or President Coolidge to have done so at that time, and no more reason than for him to have announced his views on the general issues that would be involved in the campaign - which is not custorary and which none of the men did whose names were before the Convention. There were over thirty candidates before the Convention. They were not asked for expressions of their wiews. I do, however, know that, if nominated, Ir. McAdoo would have been as outspoken in his demunciation of the Klan as any decent citizen could desire. His closest friends and most staunch supporters throughout his public and private life have been among the people of our race.

"My admiration for the courageous, outspoken utterances of Senator LaFollettes on this subject is boundless. I expect the same unequivocal stand from Mr. Davis and have faith that his courage and American spirit will require him to express himself regardless of consequences. Nothing less will satisfy me - not as a Jew but as a citizen. If he fulls to amounce himself I shall feel impelled to break away from my life-long allegiance to my Party- for I should then regard him as unworthy to be the leader of a great party.

"If, as I hope and believe, President Coolidge joins his opponents in a like frank expression of his position, this extruneous issue will have been happily eliminated from our political life; and our people of all faiths can thereafter proceed, hand in hand, at the proper time, by effective legislation, to suppress the activities of this outlaw band.

"Homentous issues are involved in the impending campaign: The suppression of the Trusts and combinations and of private monoply that infest the country in almost every line of industry and firence and that are largely responsible for the increased cost of

"Tiwing, has been rightly characterized as the chief issue. It is to be hoped that American citizens of all fufths and creeds will be permitted to concentrate their attention upon this and other real issues that are to be decided at the polls and that the misfortune of a division upon racial and religious lines will be averted."

HISTREATHENT OF JEWS BY KLAN IS CAMPAIGN ISSUE IN OKLAHOMA.

Oklahoma City, August 11. (Jewish Telegraphic Agency). "If the Ku Klux Klam wins again in Oklahoma this year, the masked purades, the midnight whipping parties and the business boycotts no doubt will continue," says an election circular issued by ex-Governor Walton of Oklahoma in his commainn for re-election.

The circular contains photographs of a mutilated Jew and a Catholic who were flogged and branded by the Klan.

"Former Governor Walton, running on an anti-Klan platform, sacrificed the highest office in this State headuse of his fight upon this organization. Two Oklahoma oil nillionaires are seeking, through aid of the Klan, to defaut the former Governor in the race for the Senate.

JEWISH HOSPITAL IN NEW YORK ENLARGED WILL BE DEDICATED.

New York, August 11. (Jewish Telegraphic Agency). The Hospital for Joint Diseases, which will be the best hospital in the world especially devoted to the lame, will be dedicated on October 5th after considerable enlargement. The equipment of the hospital, which has a capacity of 275 beds and facilities for treating 1500 patients daily, costs 32,000,000. The hospital was established in 1906 and since then it has given treatment to 126,285 patients. The number of treatments given inthe last month is 19,472. The hospital is relationed by the Federation for the Support of Jewish Philanthropia Societies in New York.

JEAN GOLDSIY, JEWISH JOURNALIST RELEASED PROI PRISON IN FRANCE.

Paris, August 11. (Jewish Telegraphic Agency). Jewn Goldsky, Jewish journalist who was imprisoned for seven years on the charge that he was conducting anarchist propaganda in France during the war, was released by the Herriot government. A revision of the trial is to follow.
