

HENRY FORD SUPPORTS ROUMANIAN ANTI-SEMITIC FASCISTI ORGANIZATION, ESTABLISHES JASSY CHIEF OF POLICE MURDER INVESTIGATION

(Jewish Telegraphic Agency)

Jassy, Nov. 14.—Henry Ford, American millionaire and author of the libelous book, "The International Jew," is indirectly involved in the murder of the Jassy Chief of Police, Montchu, who was shot by a member of the Roumanian students' anti-Semitic Fascisti organization.

Investigation conducted in connection with the murder, established the fact that the Roumanian Fascisti organization has been receiving support from Henry Ford, according to statements made today in the local Roumanian press.

Montchu was murdered in the District Court of Jassy on October 25, during court proceedings which were started against him by the students' organization. The charge brought against the Chief of Police was that during the recent anti-Semitic students disturbance in Jassy he suppressed these disturbances in a cruel manner.

During the proceedings many anti-Semitic students were in court. Among them was Cornelli Zelia Cadriani, a son of the well-known anti-Semitic leader, Professor Zelia Cadriani. After the prosecuting attorney, Dumbrovo, brought the charge against the Chief of Police, the judge closed the session, stating that the verdict would be issued in a few days.

As the people and the Chief of Police were leaving the courtroom, Cornelli Zelia Cadriani walked up to Montchu and fired at him. The bullet penetrated his head and he died instantly. The murderer endeavored to escape, firing at the policemen who attempted to arrest him. He was arrested after wounding two policemen.

DELEGATION CALLS ON POLISH PRIME MINISTER; COMPLAINS AGAINST ANTI-JEWISH TERROR IN POSEN

Warsaw, Nov. 14.—The plight of the Jewish population in Posen, the province formerly belonging to Germany and now a part of the Polish Republic, was described today by a delegation which called on Wladyslaw Grabski, Polish Prime Minister. The delegation, consisting of representatives of the Jewish Merchants Association in Warsaw, the Union of Jewish Merchants in Posen and the Union of Jewish Communities in Posen, complained bitterly against the terror and attacks carried on by bands organized by the anti-Semitic leader, Sekretarchik, against the expulsion of Jewish children from the Posen government and private schools and against the action of the Polish authorities in that territory, who confiscate Jewish synagogues and cemeteries.

In reply, Prime Minister Grabski stated that the Polish Government is considering the situation of the Jewish population in Posen and realizes that the present state of affairs is harmful to the interests of the Polish Republic. He promised to take action in the matter.

GERMAN GRAND LODGE OF I. O. B. B. ELECTS DR. TIMENDORFER PRESIDENT

Berlin, Nov. 14.—Dr. Berthold Timendorfer was re-elected president of the Independent Order B'nai B'rith in Germany at a general meeting of the lodge, held for the first time in four years. Dr. Timendorfer is 70 years old.

ARTHUR DINTER, GERMAN ANTI-SEMITIC LEADER, TRIED TO MARRY RICH JEWISH GIRLS

Sensational Trial in Berlin

Berlin, Nov. 14.—Arthur Dinter, leader of the anti-Semitic Voelkische Party and author of several pseudo-scientific books of an anti-Semitic nature, is an anti-Semite only in theory. In practice he had particular preference for rich Jewish girls.

This was made known today at a sensational trial here. The "Berliner Tageblatt," in one of its recent articles, declared that "Arthur Dinter's books, 'Blood Crimes' and 'Light on the Talmud,' are dirty pamphlets issued for speculation purposes." Dinter took exception to this definition of his literary career and started proceedings against the publishers of the "Tageblatt."

Dr. Alfred Klee and Dr. Samuel Gronemann, attorneys for the newspaper, submitted evidence that Dinter was an immoral person and that in spite of his anti-Semitic preachings, he had endeavored to marry rich Jewish girls. The trial was postponed because the Talmudic expert, Bischoff, whom Dinter called as a witness, did not appear.

TOWER OF SOLOMON UNEARTHED ON MOUNT OPEL

Jerusalem, Nov. 14.—An important national monument, dating back to the times of King David and King Solomon, was added to the antiquities of Palestine as a result of excavations carried on by the Palestine Exploration Fund under the leadership of its acting president, Reverend Garrow Duncan.

Excavations carried on by the Fund on Mount Ophel on the site of the ancient "City of David" brought to view the Tower of Solomon. The tower, which is 40 feet high and has two step castions, one on each side, forms a striking picture. The architecture of the Tower includes David's masonry with Solomonic repairs.

The Tower has been declared a national monument and will be taken care of by the Palestine Government.

HEAD OF VIENNA POLICE ISSUES STATEMENT PROVING ABSURDITY OF RITUAL MURDER ACCUSATION

Vienna, Nov. 14.—The ritual murder tale in connection with the death of the boy, Grusch, which was spread by the "Arbeiter Presse," the organ of the Hakenkreutzler, was supported by the press of a monarchistic tendency.

Hofrat Wahl, head of the Public Security Bureau of the Vienna Police Department, issued the following official statement: "The anti-Semitic press intentionally perverts the facts. The police, as well as the official medical examination of the body, established beyond the shadow of a doubt that there were no cuts on the body of Grusch. It was established that the wounds resulted from bites of dogs; the imprint of dog's teeth was found on the body. This was substantiated by a veterinary."

YEVEKSTZIA OPENS CONFERENCE IN MOSCOW

DEARBORN INDEPENDENT CALLS DISMISSAL OF CHARGE AGAINST CAPTAIN ROSENBLUTH END TO RACIAL INTERFERENCE IN COURT

Any Decent Man Would Prefer to Be in Rosenbluth's Than Ford's Shoes, Louis Marshall Replies.

The dismissal of the case against Pothier and Captain Rosenbluth was interpreted by Ford's "Dearborn Independent" as "an orderly end to a long and sensational attempt to block the processes of the United States court and to prevent the trial of a man indicted for high crime." The "Dearborn Independent" further stated, "The shameful interference of racial organizations and the hysterical efforts to make of Captain Rosenbluth an American Dreyfus were amply illustrative of the length to which an alien type of mind will go to neutralize the safeguards which have been set up for the people in our laws and courts."

This brought a reply from Louis Marshall in a statement issued by him to the Jewish Telegraphic Agency.

"The editorial on the Rosenbluth case published in the recent number of the 'Dearborn Independent', is an illustration of the disgraceful methods of that publication, under cover of which Henry Ford manifests his fanaticism. For weeks and months its columns reeked with vile falsehoods, wicked and insane imaginings, and cunningly contrived appeals to passion and prejudice, in order to compass the destruction of a fellow-being. In spite of Rosenbluth's exoneration by the public authorities of the State of Washington and by the United States District Court, Ford still indulges in insinuations and innuendoes against him and in reflections upon the Jews. He is incapable of ridding that pitiable mind of his of the monomania that has taken possession of it.

"The fact that Captain Rosenbluth's friends came to his rescue, is referred to as 'the shameful interference of racial organizations.' Their efforts to prevent Ford and other enemies of Captain Rosenbluth from virtually 'railroading' him, are declared to be 'illustrative of the length to which an alien type of mind will go to neutralize the safeguards which have been set up for the people in our laws and courts.' What that 'alien type of mind' did was to resort to these very safeguards. The statement of this piratical publication, that it expressed no opinion as to the guilt or innocence of the two accused men, is belied by the disgraceful vilification which it unceasingly employed while the case was awaiting the action of the courts.

"Even now Ford is attempting to minimize Rosenbluth's judicial exoneration by saying that the trial has not 'cleared up the mystery of Major Cronkhite's death.' There never was the slightest

DAILY DIGEST OF WORLD PUBLIC OPINION ON JEWISH MATTERS

Welcomes Jewish Policemen's Club

The "Jewish Morning Journal" of Nov. 14, welcomes the "Shomrim", the organization of Jewish policemen of New York which was formed last week. The paper points out that

"Such organizations as the 'Shomrim', (the Watchmen) which devote attention to matters of the spirit and mind, are very desirable.

"Outside of his special occupation, the Jewish policeman is a wide awake, intelligent person, with an influence in certain spheres and possibilities of advancing and becoming a considerable personality. It is therefore highly important to bring him closer to Jewish life and to awaken in him an interest in Jewish ideals and movements, so that he will be prepared at all times to give an intelligent reply when confronted with questions on Jewish subjects. In this direction the 'Shomrim' can accomplish a great deal."

A Friend of the Jews

The sermon delivered last Sunday by the Catholic priest, Dr. James Gillis, at the Church of St. Paul, on the subject of the Jews, has given rise to the following editorial comment in the "Jewish Daily News" (Nov. 12):

"We do not see the Jewish future in America in such dark colors as Dr. Gillis. America is not Europe. There is a certain amount of Jew-hatred here, but it will never come to actual persecutions. We have faith in the spirit of America.

"But it is certain that Dr. Gillis is a warm friend of the Jewish people, as he showed by expressing his hope that 'if ever the rights of the Jews in America are assailed, 850,000 Knights of Columbus will spring to their defense.'"

Secretary Davis' Resignation and the Immigration Policy

Apropos of the resignation of Secretary of Labor Davis, which has been officially announced from Washington, the "Day" of Nov. 11 asks: "Will Mr. Davis' leaving the cabinet bring about a change in the immigration policy of the Administration?" and then answers its own query thus:

"Truth to say, there is very little hope for this. Yet the fact that the man who was the proponent of the most rigorous immigration restrictions is leaving the cabinet makes the prospects for more humaneness in the immigration policy just a bit brighter.

"It is especially to be hoped that Mr. Davis' pet idea of registering all aliens and immigrants in this country will now be shelved. We know that the Republican party backs this scheme, which would set up a bureaucratic system of passports in the United States. We know that the big corporations and the American Federation of Labor endorse this reactionary proposition. But it was Secretary Davis who championed it and agitated for it more than anyone else and we like to hope that his departure from the cabinet will mean the abandonment of this anti-American scheme."

Conservative Politics in Europe and the Jews

The bearing of the wave of conservatism in European politics on the Jewish situation is analyzed in the "Jewish Daily Courier" of Chicago.

"Conservatism in the politics of Anglo-Saxon countries has little relation to the Jewish problem. But in Europe generally anti-Semitism is the twin of conservatism. In a conservative Germany the Jews are actually in danger of their existence, of their very lives. The same is true of Poland and Lithuania. So that, on the whole, Jews have little ground to feel pleased with the growing tendencies toward conservatism in Europe."

Mexicanization of Jewish Immigrants in Mexico

Mexico City, Nov. 8.—Nationalization is the key-word of the policy put into practice by the B'nai B'rith House in Mexico, where are received all the Jewish immigrants. During the past few weeks the influx of newcomers has swelled perceptibly, increasing from an average of fifty on a boat to even a hundred and over.

This is accounted for to a great extent by the publicity given the invitation of President-elect Calles, to the stranded Jews, for colonization in Mexico; while the fact that 80 per cent of the immigrants were not stranded in European and Asiatic ports but came directly from their home countries, points to the conclusion that the thing that brings them is the favorable reports of their friends and relatives already established in Mexico. The immigration of Jews into Mexico, while steadily growing, still is not the sudden inrush of thousands which was feared and was opposed by part of the Mexican press. It is recognized that the logical method is a constant small stream, since thus there is time for them to adapt themselves, and Mexicanize themselves, and thereby aid in adapting the newcomers. Jewish teachers for Jews is the solution of most of their difficulties, and the key to a future prosperity for them and the assurance of value to the country.

Recognizing the necessity of nationalization, the same process of Americanization that has been thoroughly put in practice in the United States is being begun here, but with a Mexican point of view. The B'nai B'rith and social workers for the Jews are devoting themselves to two big things: first, attending to the material necessities of the immigrants, giving them food and a place to sleep, but most of all procuring them a way to get these things for themselves. The employment branch is by far the most important, since it has the grave charge of finding work for the immigrants in their trades and professions, to keep them from all becoming peddlers and small merchants, a thing dangerous and undesirable.

Recognizing that the desirable thing is to spread the newcomers, to find them work in their own lines so that they can thus more consistently adjust themselves to the country and aid in building it up, the employment bureau works along these lines, and has thus far succeeded in placing tailors, carpenters, shoemakers, electricians, mechanics, dentists—for it is a universal error that the Jewish immigrants are not industrial workers but commercial men. The majority of them have been trained under the European apprentice system, and the desirable thing for them would be the establishing of more industries, a thing predicted for the next year, already an admitted coming boom period.

Secondarily, however, but still important, to the necessity of work, is the necessity of making Mexican citizens out of the settlers. Instead of coming with the hope of eventually reaching the United States, as used to be the case with the majority of arrivals, they now come here with the intention of settling, of making a home. They are helped to become acquainted with the country by being taught Spanish, another highly important branch of the work of the B'nai B'rith. Little by little they learn the laws and customs of the country, and they are encouraged and taught to accept them, just as in the United States the same is done in the schools. Mexicanization, after ministering to the material welfare of the Jewish colonists, is the intentional work of the immigration agencies, and in this they are encouraged by the government, anxious and willing to bring in new blood to give an impulse to the old.

JEWISH WOMEN'S ORGANIZATION IN JUGO-SLAVIA CELEBRATES ITS FIFTIETH ANNIVERSARY

Belgrade, Nov. 1.—The Jewish Women's Organization of Jugoslavia has just celebrated the fiftieth anniversary of its formation. The celebration was preceded by a special service in the chief synagogue, at which the Queen was represented by Mme. Hodzic, one of her Ladies-in-waiting. Representatives of all the women's organizations in Jugoslavia were present. The Chief Rabbi delivered an address praising the achievements of the Union in the humanitarian, cultural and national spheres.

The anniversary celebration itself was held in the afternoon at the Palace Hotel. Speeches were delivered by the Minister of Education and Public Worship, Dr. Anton Koroschec, in the name of the Government, by the Lord Mayor of Belgrade, M. Marjanovic, in the name of the Municipality, and by the director of the staff at the Ministry of Public Worship, M. Janjic.

Mme. Helene Demajo, President of the Union of Jewish Women, and the Secretary, Mme. Almul, traced the activity of the Union during the five decades of its existence.

The Union of Jewish Women was founded in Belgrade in 1874, the first women's organization in the whole country. Its original purpose was to give assistance to women at childbirth and to widows, but its field of activity was gradually extended and branches were organized all over the country.

POLISH GOVERNMENT URGED TO FACILITATE RETURN OF POLISH JEWS FROM RUSSIA

Warsaw, Oct. 28.—Deputy M. Frostig, a member of the Club of Jewish Deputies, has intervened with the Minister of Foreign Affairs, M. Skrzynski, to ask for facilities for the Jews who are Polish citizens still resident in Russia to return to Poland. Large numbers of Polish Jews, he said, were evacuated to the interior of Russia during the War and have not had an opportunity of returning to their homes. Some time ago, he said, he had introduced an interpellation on the subject, and the Chairman of the Commission for Foreign Affairs, Deputy Fombski, had given assurances that the question would be settled shortly in a way favorable to the Jews. Deputy Frostig urged that all possible steps should be taken to enable Polish citizens now resident in Russia to return to Poland.

CONFERENCE OF RUSSIAN REFUGEES WILL BE HELD

Geneva, Nov. 14.—Representatives of several governments and of the League of Nations will participate in a conference which is to take place shortly concerning the colonization of refugees from Russia, among whom are many Jews. The conference will also consider the financial side of this problem.

KEREN HAYESOD COLLECTS £36,017 DURING OCTOBER

London, Nov. 14.—The receipts of the Keren Hayesod during the month of October amounted to £36,017, of which £21,310 came from America. Palestine contributed £78.

UKRAINE HAS NO UNLIMITED LAND RESERVES FOR JEWISH COLONIZATION, WARNS SECRETARY-GENERAL OF UKRAINIAN GOVERNMENT

Moscow, Nov. 14.—The Secretary-General of the Ukrainian Government has made a statement to the Press to-day on the subject of Jewish colonization in the Ukraine, pointing out that the land reserves in the possession of the Ukrainian Government are too small to be able to satisfy the great demand which is being made for land by Jewish applicants. We have no unlimited land reserves, he said, and the amount of land which we have at our disposal cannot provide for more than several thousand Jewish families during the next spring. These will be settled on the land in the Ukraine with as much dispatch as is possible. The number of persons to be settled in this manner during the spring is expected to be about 20,000 to 30,000. The Ministry of Agriculture of the Republic of the Crimea states that it is receiving numerous applications from Jews in the Ukraine and in other parts of the Federated Soviet Republics asking for land to be allocated to them in Northern Crimea for Jewish agricultural settlement and for facilities for establishing Jewish agricultural associations and Jewish agricultural colonies.

SENTENCED TO JAIL FOR ISSUING PORNOGRAPHIC PAPER

Warsaw, Nov. 14.—Mr. Zilbermintz, editor of a pornographic paper issued here under the name "Scheiget," was sentenced to seven months in jail. The court prohibits him from publishing anything for two years.

Rabbi M. J. Friedman, lately of Steelton, Pa., has taken up his duties at the Beth Israel synagogue, Roanoke, Va. Rabbi Friedman is a graduate of Temple University, Philadelphia, and Rebena Ischak Elchonan Seminary, New York.

Representatives of Jews, Catholics and Protestants will participate in the Jewish Tribune Forum, which will be held on Thursday, November 20, for the purpose of discussing the problem of how to check race hatred and religious prejudice in this country.

Dr. Charles S. Macfarland, General Secretary of the Federal Council of the Churches of Christ in America; the Hon. Alfred J. Taft, Dr. Mordecai M. Kaplan and David N. Mosessohn will be present at the meeting. Mr. Herman Bernstein, editor of the "Jewish Tribune," will preside.

NEW CENTERS AND SYNAGOGUES

A campaign to raise \$250,000 for a Jewish community center building in Albany has been started.

A site for the new community house in Glens Falls, N. Y., has been purchased. The building will be completed shortly.

A decision to erect a synagogue on Welfare Island for the 20 Jewish hospital patients there was announced by the New York Chapter of the Council of Jewish Women.

Mrs. Edward Josephy announced that the plan had the full consent and promise of cooperation of Bill S. Coker, Commissioner of Public Welfare, and \$10,000 will be required.

Mrs. Isabella Freedman offered \$10,000 as her donation to the fund in memory of her parents. Gifts of \$1,000 from Murry Guggenheim and \$500 from Mrs. Isaac Gimbel were announced.

mystery concerning it. The Court of Inquiry held immediately after his death, consisting of brother officers of high rank, found that his death was due to an accidentally self-inflicted wound. The State authorities, after careful investigation, reached the same conclusion; as did the jury in the Federal Court. Again, with characteristic suggestion of a falsehood, Ford declares that "the confession of Pothier implicating Rosenbluth is still unexplained."

"The official representative of the State of Washington analyzed the so-called confession and found that it was the result of shameful coercion and duress and was brought about by the application of the infamous third degree. Judge Cushman in the Federal Court, ruled that the confession to which the Government's star witness testified was worthless, and instructed the jury to disregard it. The Secret Service Agent who procured another of these confessions testified that he gave no credence to it. And the jury, by its verdict gave to all of these so-called confessions their quietus.

"That the prosecution of Captain Rosenbluth did not have a shred of evidence to support it, is established by the fact that the special counsel employed by the Government, after communication with the Department of Justice at Washington of his own motion and in the absence of Rosenbluth and his counsel, moved for a dismissal of the indictment; so that Rosenbluth and the fifty witnesses whom, at his instance, the Government subpoenaed and brought to Tacoma for his defense, were prevented, after crossing the continent, from giving their testimony. There never was a more complete admission of the utter absence of probable cause than that thus made by the prosecution.

"And yet Ford, the intellectual brother of the Ku Klux Klan, the inspirer of Hitler and Ludendorff, whose text-book is 'The International Jew,' which is distributed throughout the world by this irresponsible disseminator of libels, instead of making reparation, persists, as one would expect a man of his low mentality to do, in his crusade against him upon whom he has inflicted so terrible a wrong. There is not a decent man who would not rather stand in the shoes of Captain Rosenbluth than in those of Ford, even though he be the richest man in all the world. In the words of the Psalmist:

"The wicked plotteth against the righteous,
And gnasheth at him with his teeth.

The Lord doth laugh at him,
For he seeth that his day is coming."
