#### ANTI-JEWISH EXCESSES IN BUCHAREST. JASSY, KLAUSENBURG AND CZERNOWITZ

Witnesses Scenes-Instruct's King Ferdinand Troops to Restore Order—Guilt of Cusa and Other Professors Established—Barricades Erected in Bucharest Jewish Quarter.

(Jewish Telegraphic Agency)

Vienna, Dec. 18 .- Alarming news of anti-Jewish excesses were received here today from Roumania. At the Universities of Bucharest, Jassy, Klausenburg and Czernowitz excesses against Jewish stud-ents have been going on for several days. Four Jewish students were wounded at the University of Bucharest.

King Ferdinand is reported to have witnessed some of the excesses personally and issued instruc-tions to restore order. Nevertheless, excesses contions to restore order. Nevertheless, excesses continue, Jewish students are being driven out of the lecture halls at the universities. Deputy Busor introduced an interpellation in Parliament today and read a letter of Prof. Cantacucina, according to whom Prof. Cusa of the Jassy University was the initiator of the disturbance. The Minister of Education admitted the guilt of several professors.

It was stated that Prof. Cusa delivered a lec-

ture urging the Roumanian students to commit the excesses. Similar disturbances are reported from Temesvar, Oradeamara, Czernowitz and Klausen-burg. The Dean of the University of Jassy has "resigned because of the passivity of the authori-ties in not suppressing the disturbances.

Bucharest, Dec. 17.—Serious street fighting, in which many persons were wounded, occurred in the Jewish quarter of Bucharest yesterday, when about 700 students, after cutting the telephone wires at the university, attacking the Jewish students and breaking windows of Jewish shops, came downtown and invaded the Ghetto.

The inhabitants, warned of an approaching pogrom, barricaded the streets and offered resistance to the invading student army, a sharp struggle resulting

## ISAAC BEN AMRAM, HIGH PRIEST OF SAMARITANS, CALLS ON PALESTINE HIGH COMMISSIONER

Head of "Zion Proselytes" Proceeds to London to Write History of Ancient Sect. (Jewish Telegraphic Agency)

Jerusalem, Dec. 18.—Pictures of ancient Jewish history, through the periods of Assyrian, Persian, Roman, medieval and modern times came back to life vividly when Sir Herbert Samuel, British High Commissioner of Palestine, today received in audi-ence Isaac Ben Amram, the High Priest of the Samaritans

The Samaritans, an Israelitish sect which came into existence in the eighth century, B. C., following the separation of Israel from Judah, were comprised partly of Palestinian natives and partly of Assyrians colonized in Samaria by Shalmaneser, Assyrians colonized in Sannaria by Shannaneser, King of Assyria, in 722 B. C. Because the vicinity in which they settled was frequently attacked by lions, they accepted the religion of the country. Since then they were known in Jewish religious history as the "lion proselytes."

While retaining the principles of the Jewish religion, the "lion proselytes" recognized only the five books of Moses and refused to accept the teachings of the prophets and severed connections with further Jewish religious development.

Although living in the center of Palestine, considering Mount Gerizim in the vicinity of Nablus as their holy place, where they erected their Temples, they were in constant political and religious (Continued on Page 4)

# PALESTINE JEWISH CUNFERENCE FRO-TESTS AGAINST MANDATES COMMIS-SION REPORT Demands Abolition of Immigration Restrictions; Creates Aid Organization. (Jewish Telegraphic Agency)

Jerusalem, Dec. 18.—A protest against the atti-tude of the Permanent Mandates Commission of the League of Nations with regard to Jewish im-migration into Palestine was adopted today by the conference of representatives of the Jewish settlements and communities in session in Tel Aviv for the purpose of creating better facilities

for the arriving immigrants. The conference also adopted a resolution demanding immediate abolition of all restrictions on Jewish immigration into Palestine, An organization for extending aid to the immigrants is being created, according to a decision of the conference. A Central Bureau, with local committees in the various towns and colonies will be established. Another resolution adopted by the conference urges the Zionist Organization to assign a fund for the purpose of building cheap houses to ac-commodate the new arrivals.

## UNIFORM MINORITY LAW JEOPARDIZING SPECIFIC MINORITY CLAUSES DIS-CUSSED AT RECENT MEETING OF LEAGUE ASSEMBLY

Secretary of Anglo-Jewish Joint Foreign Committee Reports on Activities in Geneva-Inter-national Court of Justice Will Hear Appeal Against Hungarian Numerus Clausus.

(Jewish Telegraphic Agency)

London, Dec. 18 .- Specific clauses of the interrational treaties, resulting from the Versailles Peace Conference, for the purpose of protecting the national minorities in Eastern Europe were in danger of being abolished during the Fifth Assembly of the League of Nations in its last session at Geneva. This was made known with the publication today of the report of Mr. Lucien Wolf, Secretary of the Joint Foreign Committee, concerning his work during the Assembly as rep-resentative of the Jewish organization. It appears that in leading circles of European

statesmen a plan was discussed by which new international agreements concerning the national minorities were to be proposed for the purpose of introducing a uniform international minority law. Prof. Gilbert Murray took the view that the minorities question is a matter of internal law, it is not of international concern and states have no

right to interfere with each other.
Although the Fifth Assembly of the League of Nations was a memorable event, due to the par-ticipation of the British. French and Belgian Prime Ministers and the discussion of the problem of world peace, "the League's obligation towards the minority treaties, which is of such great importance to the Jewish communities of Central and Eastern Europe was discussed only as a secondary matter. The specific Jewish questions were not discussed before the Assembly itself, but were largely dealt with in private conversations and negotiations with the League's Secretariat and the delegations of the various governments

concerned", Mr. Wolf's report stated.

The report of the Joint Foreign Committee further deals with the representations made by Mr. Wolf concerning the compulsory Sunday Closing Law in Greece, the Numerus Clausus in Hungary, the nationality laws in Roumania and Poland. With regard to the numerus clausus in Hungray, the report states that notice has already been given that the matter will be appealed before the Permanent International Court of Justice at The Hague. With regard to the Roumanian Nationality Law, which threatens to depatriate large num-bers of Jews, particularly in Bukowina, the report states that the Roumanian Government has appointed a commission of inquiry, but this commission has not yet concluded its investigations. A similar situation exists with regard to the Nation-

Gompers' Shortcomings
The "Jewish Daily News", in an editorial of

Thus he became the severest opponent of immi-gration that America has ever had."

The "Sacramental-Wine" Case (By Our Chicago Correspondent, B. Smoliar)

Chicago, Dec. 17.-The season of sensational trials in which the Jews of Chicago and the rest of the United States, have been interested, directly or united States, nave been interested, directly of indirectly, is not yet over. Following closely on the heels of the cases of Leopold-Loeb, Bessie Gensselin and Leo Koretz, cases in which Jewish names figured prominently and frequently, comes a new case in the outcome of which not only the Jews of Chicago but of the entire country, will be intensely interested. I am referring to what be intensely interested. I am be intensely interested. I am is called here the "sacramental-wine" case.

Over seventy persons, among them some twenty or thirty Jews well known in local synagogu activities are indicted in this case. A number of high government and prohibition enforce-

ment officers are likewise involved.

At present this case is in a stage of investiga-tion, which is being conducted by the Federal gov-ernment, not by the state. However, there has been so much publicity in connection with it that when the trial of those indicted will begin, sometime this month maybe, it will attract no less at-tention than the several sadly-famous cases which occurred here recently.

I can say that neither the Leopold-Loeb case nor the Koretz case caused the Jews of Chicago so much embarrassment and discomfort as the present "sacramental-wine" case. In regard to the Leopold-Loeb and Koretz cases all the efforts of the newspapers to impress on the public mind the fact that the criminals were Jews failed to create an anti-Jewish sentiment. But in regard to the present case it is to be noted that even before the trial has begun and ere the public knows
the details of the scandal, the general impression is taking root that this is a specifically Jewish case, and this in spite of the fact that the majority of those indicted are non-jews. The knowledge that it is not of the spite of the sp edge that it is a case of the misuse of the privi-lege of "sacramental-wine" and that the Jews are the only ones to enjoy this privilege under the prohibition laws, is sufficient.

The average newspaper reader does not know that the "rabbis" and "congregations" mentioned in connection with this case are not real rabbis and congregations but ordinary criminals and nonexistent synagogues. He does not know that it is one big ring of swindlers and crooks, among whom there are a few Jews, who are organized for the purpose of carrying on an illicit liquor trade on a large scale and employing the "sacramental-wine "provision as a means of deceiving the government. He does not know, furthermore, that the most guilty ones in this case are a num-ber of the very prohibition agents who are supposed to see that the law be properly observed. He assumes that this is a Jewish swindle, perpetrated by rabbis and synagogues and based on a gross misuse of the "sacramental-wine" privilege. It must also be added that the manner in which

the press reports this case is certainly not too conducive toward a clarification of the true facts in the minds of the readers.

Sometime ago Mr. Julius Rosenwald and other prominent Jews urged that the "sacramental-wine" clause be erased from the prohibition statutes, but their move met with a great deal of opposition. li these Jews had succeeded in their purpose at that time we would not now be faced with the "sacramental-wine" case.

COUNTRY MEANS MESOPOTAMIA, SYRIA AND PALESTINE," ARAB PRINCE DECLARES

Anti-Zionist Propaganda Is Defense Argument. (Jewish Telegraphic Agency)

London, Dec. 18 .- The anti-Zionist propaganda London, Dec. 10.—1ne anti-Zionist propaganaa of certain Arab leaders was mentioned frequently in the British High Court today, when Lord Darling presided in a suit brought by Prince Habib Lotfallah, Minister of Foreign Affairs in ex-King Hussein's government and now diplomatic representative of Hedjas in Europe against Engineer Walker A. Harper of the Westminster Engineer Walker A. Harper of the Westminster Construction Company.

Prince Lotfallah invested £10,000 in shares of the Westminster Construction Company. The Company, which was engaged in reconstruction work in France, suffered a loss of 340,000 Francs. The Prince claims he bought the shares of the company on the understanding that it would start operations in the Neart East, which it failed to do. He therefore demanded the return of his in-

vestment.

Prince Lotfallah, who spoke French, explained that he had made the investment with the intention of improving the commercial and diplomatic relations between the Near East and England. He claims the Westminster Construction Company obtained the money from him on fraudulent representation.

Sir Leslie Scott, conservative member of Par-liament and pro-Zionist, who was counsel for the defense, in cross-examination of the complainant, said to Prince Lotfallah, "You claim that your "You claim that your was the creation of better relations bemotive tween England and the Near East, while in reality you wanted to drive the English out of Paiestine and Syria."

Prince Lotfallah in reply at first denied that he expressed political views against the English or that he was in any way hostile to England. Upon that he was in any way hostile to England. Upon further cross examination, however, the Prince admitted that he was "hostile to all who come to our country to dominate us." Asked for an explanation of what he understands by the words "come to our country", he stated that he referred to the English and the French. As to the meaning of "our country", he stated that he implied Syria, Palestine and Mesopotamia.

Sir Leslie Scott submitted evidence to the court that Prince Lottallah was in Washington in November 1922 demanding the territories of Mesopher 1922 demanding the territories of Mesopher 1922 demanding the territories of Mesons of the state of

The defense contended that the promised directorship in the Westminster Con-struction Company was withheld from the Prince because of his political expression against England.

PROBLEM OF NATIONAL MINORITIES IN LATVIA BECOMES ACUTE (Jewish Telegraphic Agency) Riga, Dec. 18.-The problem of the National Minorities in Latvia became more acute with the coming into power of the new government which was formed by the parties of the Right.

No mention is made, in the statement of the

new government to parliament, of the National Minorities in the Republic.

Deputy Professor Lasersohn, representing the Zeirei Zion and Rabbi Nurok, representing the Mizrachi, declared their opposition to the Government, Deputy Dubin, representing the Agudas Israel refrained from making any statement on the matter

The problem of the National Minorities in Latvia has recently become graver in view of the ordinance issued by the government that on new passports issued to citizens, the nationality of the bearer must be given. His own statement is not considered sufficient; it must be supported by two witnesses belonging to another nationality.

The situation in the Latvian parliament, consisting of one hundred members, is such that the Right and the Left parties are equally divided and the fifteen representatives of the National Minorithe hiteen representatives of the National Minorities, six of whom are Jewish, play the part of the fulcrum during the voting. Recently, Deputy Wirzbicki, representing the Polish National Minority in Latvia was charged with treason on ecount of his activities with regard to the rights of the Polish minority.

#### PALESTINE DEBT QUESTION SUBMITTED TO LEAGUE BY BRITAIN

Geneva, Dec. 18 .- The Secretary General of the League of Nations received a note today from the British Government, dated December 15, in connection with the sums imposed on Palestine, Transjordiania and Mesopotamia, as their payment of the public debts of the former Ottoman Empire.

The British Government, in the note, informs the League of Nations that Palestine, Transjordania and Mesopotamia are dissatisfied with the sums imposed on them and announces the intention of bringing an appeal against this allocation before an arbiter to be appointed by the League's council.
