#### ZIONIST ORGANIZATION STANDS FOR DR. WISE AS CHAIRMAN OF PALES-TINE APPEAL

Zionists Must Put an End to "Chillul Ha'shem," Louis Lipsky Declares in Appeal

What can be regarded as an official statement by the Zionist Organization is contained in an appeal by Louis Lipsky, published in the New Palestine of January 1.

"In spite of unusually grave difficulties, the United Palestine Appeal has forged its way into the heart of American Jewry, and become its dominant interest," the statement read. As our tried and loyal workers in a number of cities were preparing for public action, and conditions seemed auspicious for a successful effort, enabling us for the first time in our history to place \$5,000,000 in the service of Palestine, an indirect attack has been launched against the United Palestine Appeal through the hasty, ill-considered and irreg-ular action of the Agudath Harabonim, based on garbled versions of a sermon delivered by Dr. Wise in the Free Syangogue on Sunday, December 20th.

"Zionists know that our principles preclude the possibility of agreement with the views on the central figure of Christianity attributed to Dr. Wise which he has categorically denied. But this attack on Dr. Wise has been directed against him not as a minister of the Jewish religion, but as the Chairman of the United Palestine Appeal. A controversy has been aroused which threatens to become a 'Chillul Ha'shem'; and if Zionists will allow themselves to be drawn into the controversy not only will the United Palestine Appeal suffer grievous harm, but the principles upon which Zionism rests may be seriously impaired.

## UNEMPLOYMENT AMONG JEWISH WORK-ERS IN POLISH TEXTILE CENTERS CREATES SERIOUS SITUATION

#### Further Disturbances Feared (Jewish Telegraphic Agency)

Lodz, Dec. 31.-The unemployment of a great number of Jewish workers in the city of Lodz, the center of the textile industry in the Polish Republic, has created a situation which grows worse from day to day.

Difficulties have arisen the the last few days, owing to a disagreement between the leaders of the Kchillah and the leaders of the unemployed over the distribution of relief. The leaders of the unemployed refused to participate in the relief work of the Kehillah due to a disagreement over the method and extent of the relief. Further disturbances are feared.

Warsaw, Dec. 30.-Unemployment in Poland is assuming alarming proportions due to the economic crisis in the country.

Prime Minister Count Skrzynski toured the towns of Lodz, Sosnowiec, Bialystok, Kielce and other industrial centers where he received deputations of employers and workers in an attempt to remedy the situation.

An official report issued by the Polish Ministry of Labor declares that the number of unemployed of Labor declares that the number of unemployed in the Republic is 274403. During last week the number was increased by 12,552, of which 3,415 are workers in the textile industry in Lodz. Ninety-five per cent of all the textile workers in Warsaw are unemployed.

## ZIONISM WILL BE DISASTROUS FAILURE IF RABBIS VIEW POINT PREVAILS, NEW YORK WORLD SAYS

New York World of January 1st commented on the Wise controversy in the following editorial:

"Dr. Wise and the Fundamentalist Rabbis "With the doctrinal matters at issue between

Rabbi Wise and the Fundamentalist rabbis this newspaper is not concerned. There is, however, a public aspect which is important. Dr. Wise is the Chairman of a committee which is raising money to be spent on the development of Palestine. And it now appears that because he has said something which does not suit the Fundamentalist rabbis he must resign his office. The Union of Orthodox Rabbis seems to think that Zionism is the private property of those who can meet some sort of strict religious test.

'It that should prove to be the case, if it should turn out that Zionism is not merely a cultural and national movement of Eastern Jews into Palestine but an attempt to set up a theocracy and an established church in Palestine, then it would hardly be a movement which liberal people throughout the world would care to encourage. There is plenty of intolerance and sufficient heresy-hunting on this globe and more than enough in the Near East without establishing a new centre for it in Palestine. The attack on Dr. Wise in substance and in manner indicates a state of mind which is certainly not suited to the development of a new, free and progressive civilization in the Near East.

"Under the best circumstances, with the wisest leadership, Zionism will be an immensely difficult and doubtful experiment. In the state of mind exhibited by these Fundamentalist rabbis it would be a certain and disastrous failure."

#### ORTHODOX RABBIS REITERATE DEMAND FOR WISE'S RESIGNATION IN SECOND, MILDER RESOLUTION

Meeting of Orthodox Rabbis, Preachers and Mizrachi Leaders Declares If Wise Will Not Resign They Will Work for Palestine Funds Separately Outside of United Palestine Appeal; Term "Heretic and Beguiler" Omitted in Second Resolution

The demand that Dr. Stephen S. Wise resign from the chairmanship of the \$5,000,000 United Palestine Funds Appeal and the threat that in case his resignation is not accepted Orthodox Jews will find themselves compelled to carry on the work for the Keren Hayesod, National Fund, Hadassah and Mizrachi outside of the United Palestine Funds Appeal, was made in a resolution adopted at a conference of rabbis, preachers (Rabanim U'matifim) and Mizrachi workers held Wednesday afternoon at the Broadway Central

Hotel. The meeting, which was called by the Union of Orthodox Rabbis, the first body to take steps against Dr. Stephen S. Wise following his sermon, and the Mizrachi Zionisi group, lasted almost seven hours. The proceedings were conducted in a very tense atmosphere which at times recalled moments of Jewish martyrdom and at times, scenes of the dramatic events in Jewish history of the excommuncation of Baruch Spinoza and Uriel Acosta. Nearly 200 rabbis, preachers and Mizrachi workers were present.

The meeting, which was termed a special conference, met for the purpose of considering the controversy over Dr. Wise's sermon, although the two organizations which called the conference had already taken action on the matter separately. When the conference was called to order by Rabbi Eleazar Silver of Springfield, Pa., a member of the praesidium of the Union of Orthodox Rabbis, it was not clear whether the decision of the special conference would substitute the previous resolution of the Agudath Ha'rabanim or would merely complement it.

Term "Heretic and Beguiler" Omitted

The fact that the resolution adopted by the special conference omitted the reference to Dr. Wise as a "Mcissith U'madiach" (heretic and beguiler) as well as the previous declaration that it would be an "Issur Gamur" (religious transgression) to support the Palestine Appeal as long as Dr. Wise remains chairman, could be interpreted as a retraction of the previous stand of the Union of Orthodox Rabbis. However, no resolution to this

effect was proposed to the conference.

Rabbi Bloch referred to Maimonides "Yadd Ha'chazakah," Hilshoth Mamrib, Chapter 3, paragraphs 2 and 3, declaring that in cases of heresy when the persons involved are well known and purport to be the founders of new sects, witnesses and investigation are not required, in view of the fact that in such cases the judgment is rendered by the people.

Paragraph 2: "After it became known that he is an heretic

to the oral law, he is in the same status as all heretics, those who deny the divine authority of the Bible, the denouncers and converts who are not within the community of Israel. In such cases no witnesses, warning or judges are necessary." Paragraph 3:

"All this applies to a man who has denied in his thought and in matters which appear to him, in the oral law, and he followed his lightmindedness and the desires of his heart, denying the oral law first, as was done by Zadok and Baituth and those who followed them.

(Editor's note—The last sentence in paragraph 2, quoted by Rabbi Bloch, is omitted in some editions, such as the Vilna edition of 1900, printed under the Russian Czaristic censorship.)

After a short debate concerning the procedure of the meeting, it was agreed that the debate be limited to a number of speakers in view of the delicacy of the subject.

Rabbi Berlin Speaks Against Wise Rabbi Meyer Berlin, president of the American branch of the Mizrachi, the Orthodox faction in the Zionist Organization, was the first speaker.

"I am speaking not only for myself, but as president of the Mizrachi," Rabbi Berlin declared. " want to correct impressions which seem to prevail in certain circles. Never in the existence of the Mizrachi movement has there been more complete harmony between the Mizrachi and the Zionist Organization. I wish to emphasize this in order to prevent any misinterpretation of the attitude which the Mizrachi has adopted in the controversy over Dr. Wise's sermon.

"For the past two weeks Jesus has been a daily topic in all Jewish families. This fact alone tends to undermine the principles of our faith. Anyone who speaks in a soft, beguiling tone with regard to Christianity and its founder, harms the Jewish faith and the Jewish people. It is not important what the intention was. If one sets fire to a scrap of career and the few datasets and the sets for the sets fire to a scrap of career and the few datasets. of paper and the fire destroys a city, the destruction has been accomplished.

"Palestine must be built now. The work for Palestine must not suffer. The Jewish National Fund and the Keren Havesod must have our full support. But this will be impossible if Dr. Wise remains at the head of the United Palestine Funds Appeal. The entire work will then be destroyed. The campaign cannot be headed by the one who has set fire to the House of Israel in America, Rabbi Berlin declared.

Insists Wise Must Resign

"It must be made clear that the man who introduces Christianity into the Jewish world is not the Jewish leader. You cannot work for the campaign and be against your leader.
"I am the president of the Mizrachi.

"The man who has made Christianity an issue

Rabbi Berlin who was often interrupted by enthusiastic ovations, was followed by Rabbi Simon Bloch, a patriarchal figure on the platform.

## MISCONCEPTION OF JEWS MUST BE COMBATTED, RABBI WOLSEY TELLS JEWISH CHATAUQUA SOCIETY Louis Marshall, president of the American lew-

Pittsburgh, Pa., Dec. 31 .- "We Jews have maintained an altogether too supine and pacifistic attitude about non-Jewish misconceptions of us," de-clared Rabbi Louis Wolsey of Philadelphia before the thirty-ninth annual convention of the Jewish Chatauqua Society here, in his address which featured the "University Evening" of the assembly. Rabbi Wolsey stated that the Jewish Chatauqua has done more to dissipate false ideas about Juda-

ism than any other agency with the exception of the rabbinical seminaries. "By its university work," he said, "the Jewish Chatauqua is doing a service not alone to the Jew by deepening his Jewish con-sciousness, but also to the non-Jewish world which

needs to know what the Jew has to teach.
"In the face of the attempt to Protestantize our schools, the work of the Jewish Chatauqua becomes increasingly important. If we can make known to America what is the spirit of religious freedom we will come closer to the realization of that freedom."
As chancellor of the society, Rabbi Wolsey made a plea for its endowment. "Such an undertaking," he said, "would be a splendid investment in Jewish

Rabbi Felix Levy, of Chicago, in discussing the university work of the Chatauqua, contended that the erroneous ideas about the Jews which exist persistently in non-Jewish minds can be counter-acted only by a true teaching of Judaism. He sug-gested that Jews establish a university chair whose function it would be to present the spiritual contri-butions of the Jew, aside from their reference to

and connections with Christianity.

Doctor Harry Ettelson, of Memphis, Tenn., who presided, pleaded for a deepening of lewish consciousness. "We were meant to give the Bible to the world, but not away to the world," he declared.

## SIEMENS-SCHUCKERT, CONTRACTOR FOR NEW PALESTINE CITY, CHARGED WITH ANTI -SEMITIC ACTIVITIES

"You have asked my views concerning Dr. Wise's statement on the Jewish attitude toward Jesus. Not being a theologian, it seems idle to express an opinion on the subject which is highly controversial and leads easily to misunderstandings and misconceptions," Mr. Marshall declared. ings and misconceptions," Mr. Marshall declared,
"Nobody has a right to define the Jewish attitude,
because it diverges with the individual. The Gospels of Matthew, Mark and Luke depict Jesus to
have been a man, and his sayings show that he was
a Jew in thought, faith and profession. The Sermon on the Mount and many of the parables
demonstrate that his ethics were drived from the Hebrew scriptures and from the teachings of the rabbis. It was an entirely different Jesus around whom Paul built Christianity. The refusal of the Jews 'to accept him' either voluntarily or under compulsion resulted in an age-long tragedy and made of them a martyr people. Yet they have made of them a martyr people. Yet they have survived and Judaism continues to flourish. One need not, therefore, be surprised that to Jews who are loyal to their past 'the acceptance of Jesus' is not a harmless phrase referring solely to a recognition of his Jewish background. To them it signifies a departure from basic principles and the

surrender of cherished ideals.
"I am sure that Dr. Wise did not intend to express any opinion looking to apostasy. It is regrettable that he has been misunderstood and misinterpreted both by Jews and non-Jews. It merely proves how circumspect a preacher must be when those whom he addresses have varying points of view. They naturally apply to his words conflicting definitions. The unfailing consequence is a war of polemics, which is always deplorable."

#### WISE CONTROVERSY REECHOES IN JEW-ISH PRESS OF EUROPE

London, Dec. 31.-The controversy in the American Jewish community over the sermon of Dr. Stephen S. Wise reechoed widely in the Jewish

press of the European countries.

"On the other hand, it must be admitted that a very real danger exists in teaching of Christian doctrine from the Jewish pulpit," the paper states.

### RABBINICAL ASSEMBLY EXPRESSES SAT-ISFACTION WITH DR. WISE'S DIS-AVOWAL OF SERMON REPORTS

Gratified to Learn He Did Not Say "Jews Must Accept Teachings of Jesus"

The Rabbinical Assembly of the Jewish Theological Seminary, an organization of 200 rabbis, occupying palpits all over the country, in a statement issued Thursday, expressed satisfaction with the disavowal made by Dr. Stephen S. Wise, of newspaper reports of the sermon which he delivered before the Free Synagogue on December 20th. Dr. Wise made his disavowal in response to a resolution adopted by the Rabbinical Assembly inviting him to do so and specifically denied having said "Jews must accept the teachings of Jesus" and "the teachings of Jesus acc an unparalleled code of ethics."

The Committee which presented the resolution to Dr. Wise and which has now declared itself "happy that Dr. Wise has published his statement" consisted of Rabbi Jacob Kohn of the Congregation Aushei Chesed of New York; Rabbi Max Drob of Ansnet Luesed of New 10rs; Kanol Max Ludo of New the Washington Heights Congregation of New York; Rabbi Max Klein of the Adath Jeshurun, Philadelphia, who is also President of the Phila-delphia Board of Jewis Ministers; Rabbi Louis Finkelstein of the Kehlath Israel, New York; and Rabbi Norman Salit of the Shaare Tfilah Congrega-tion, Far Rockaway. Rabbi Max Drob is President of the Rabbinical Assembly.

The Rabbis' statement reads:

"The Rabbinical Assembly is happy that Dr. Wise-has published his statement which, we believe, should allay the controversy. Dr. Wise was glad to be given the opportunity of denying his authorship of the statements erroneously attributed to him an opportunity presented by the resolutions of the Rabbinical Assembly which were brought to his attention by the Committee."

The resolution of the Assembly was adopted at a special meeting of its Executive Council which took place last Monday and was as follows:

"WHEREAS, it has been alloged in the press that Dr. Stephen S. Wise, Chairman of the United Palesthe Apperl, made the following statements in a re-cent address, namely: 'Jews must accept the teach-ings of Jesus.' The teachings of Jesus constitute an unparalleled code of ethics.

"AND WHEREAS up to this time Dr. Wise has not made any public disavowal of these statements, "AND WHRERAS we nevertheless question their

authenticity "We invite Dr. Wise to deny his authorship of these statements."

#### GEORGE BLUMENTHAL RETIRES FROM BUSINESS TO ENGAGE IN PHIL-ANTHROPIC WORK

George Blumenthal, who has been seenior partner of the firm of Lazard Freres since 1904, retired from the organization at the beginning of the new year. It is understood that he will make his major interest the promotion of the welfare of the Metropolitan Museum of Art and Mount Sinai Hospital of whose governing boards he has been a member for many years. He is chairman of the Finance Committee of the Metropolitan Museum. Mr. Blumential has been active in Wall Street banking for forty-three years and has been with Lazard Freres since 1893.

He was one of five men who were managers of a syndicate which, in 1896, pledged \$50,000,000 with which to sell foreign exchange in order to avoid which to sell rotein exchange in Order to account further gold exports. The other members of the syndicate were the late J. Pierpont Morgan, Jacob H. Schiff of Kuhn, Loeb & Co., Walten of August Belmont & Co. and Mr. Thieret of L. von Hoffman & Co. The operations of the syndicate stopped the outflow of gold and resulted in the early resumption of gold importations. Mr. Blumenthal is the only living member of the group.

the partnership and the business flourishes, but one agy he discovers that his partner attempted to poison his wife or his children, the man will disrupt the partnership, although he is satisfied with the progress of the business. Joseph Barondess, who earned a reputation as peacemaker since the Philadelphia conference, came with the same mission to the conference of rabbis and preachers on behalf of a committee elected at a special conference called for the purpose of bring-ing about a reconciliation. He submitted the resolution adopted by this conference, urging reconcilia-

"I do not question your authority as rabbis and leaders of the Jewish people. It is not for me to give you counsel. Everybody agrees that the ad-dress of Dr. Stephen S. Wise was ill advised; everybody agrees that he has sinned. All are unanimous in expressing protest against such utterances. No one protests against your right to condemn such utterances. You have done your duty by demanding his resignation. If you had been silent you would have failed in your duty. I do not appeat to you to deviate one hair's breadth from your atti-tude. However," he appealed dramatically, "would you not give a sinning Jew the chance to repent?

Gedaliah Bublick, editor of the "Jewish Daily News," declared: "Not only the rabbis, but also laymen are interested in this subject. I speak to you as a layman and father of American born children. America is a religious country. Daily life in America is permeated with religion. If our children will not retain their Jewish religion, it does not mean that they will become free thinkers. The vaccum will be filled with Christianity.

Asserts Wise Leads to Christianity

"Dr. Wise, with his sermon, has torn down the barrier between the Christian Church and our children. A fact related to me, to the truth of which I can testify, will prove my contention. Jewish school teacher in Astoria, L. I., asked the superintendent not to have Christmas songs in a class where 30 per cent of the pupils are Jewish. The superintendent was about to grant the request of the Jewish teacher. On Monday, however, when the address of Dr. Wise was reported in the metropolitan press, the school teacher was reproached by the superintendent. What do you want? Here is what your rabbi says about

"If you want to judge the reaction to Dr. Wise's address, we must rely upon those who are well qualified to judge. They are the leaders of the Christian Church.

They ought to know. They are the leaders of a religion which has been doing missionary work for the last two thousand years. Mr. Bublick read two clippings from Boston papers, one in which Dr. S. Parkes Cadman was reported to have praised Rabbi Wise for his sermon, declaring that he was doing "excellent pioneer work" and the other relating that a Christian clergyman declared that the flower is an indication of the coming summer.

"When Dr. Wise declares the founder of Christianity to have been a radient Jewish teacher and Jewish children listen to what the rabbi says and

come to their parents and say, 'Here is a great rabbi who says that the founder of Christianity was a great Jew,' what in your judgment will be the future of these children?

"We must declare we are against Baptism. Baptism must be banished from the ranks of Zionism. I feel like the Jews in Spain when they were asked to bow before the Christian church. One must not enfold the banner of Zion in the banner of the Christian church.

"Several years ago when Dr. Wise proved himself a heretic to the policy of Dr. Weizmann, he seir a neretic to the policy of Dr. Weizmann, he was thrown out of the Zionist Organization. Now that he has proven himself a herctic to the very principles of Judaism, they want to keep him. We cannot yield. We are bound by our oath at Mount Sinai. If Dr. Wiss can yield, let him resign from his chairmanship. We Orthodox Jews are fighting for the souls of our children. I for one am ready to fight for these principles with the last drop of my blood," he exclaimed.

Many rabbis rose when Dr. Wises's name was mentioned and shouted, "Yimach Shemo V'zichro." Rabbi Jacob Levinson introduced the following

resolution: Resolution Reiterates Demand for Resignation

"Whereas addresses of Dr. Stephen S. Wise which find a particularly wide echo due to the fact of his chairmanship of the United Palestine Appeal Fund, concerning the teachings of the founder of Christianity undermine the very basis of Judaism and endanger the entire future of Judaism in America, and lead the younger generation on a way which leads to conversion and intermarriage.

"Whereas the address of Dr. Stephen S. Wise delivered recently at the Free Synagogue is being considered by the Christian World in America, considered by the Christian both the clergymen and the literary leaders, as a step nearer for Judaism towards Christianity, so that he was even thanked by representatives of

Christendom, and "Whereas missionaries who are eager to convert Jews will no doubt take advantage of this address and probably already are for their purposes using Dr. Wise's addresses as an acknowledged leader

Jews, and

"Whereas, in addition to the great moral danger to Judaism there is also danger that the reconstruction of Palestine will suffer due to the fact of Dr. Wise's remaining as chairman of the United Palestine Appeal Fund, because the great orthodox masses who are the main contributors to Palestine work will not contribute to the appeal despite its

importance and necessity. "Therefore be it resolved, by the conference of rabbis and preachers assembled at Broadway Cen-

tral Hotel on December 30 that

1. We urge with all our strength that the United Palestine Appeal Fund Committee accept the resignation of Dr. Wise immediately.

2. Be it further resolved that in the event that Dr. Wise remains president of the United Palestine Appeal Fund, it shall under no circumstances have our support, but the work for Palestine which is important and dear to all of us shall be further continued for the rehabilitation of Palestine, for the Keren Hayesod, for the National Fund, the

Mizrachi and for Hadassah outside of the United Palestine Appeal Fund."
Mr. E. Caplan and Mr. Jacob Fishman, manag-ing editor of the "Jewish Morning Journal," agreeng to the resolution asked for an amendment to the effect that the threat of separate work be eliminated. Mr. Fishman, who admitted that the resignation of Dr. Stephen S. Wise must be ac-

Says Orthodox Rabbis Are Pawns in Mizrachi

Political Plot Against Wise The charge that in connection with the Wise controversy the honest orthodox rabbis are being used unwittingly as tools in a political plot to enhance the prestige of the Mizrachi organization, is made by the "Day" of Dec. 31, which advises the Agudath Harabonim to withdraw their demand for Wise's resignation and to content them-selves instead with the demand that the Zionist Organization issue a statement expressing regret at Dr. Wise's sermon.

The paper thinks that "perhaps some of the most important leaders of the Agudath Harabonim now regret their hasty action no less than Dr. Wise regrets his sermon," and takes to task Rabbi Wise regrets his sermon, and cares to last and Meyer Berlin, president of the Mizrachi, whom it regards as "the leader of the present campaign to drive Dr. Wise out of the Palestine Appeal."

Rabbi Berlin stated at the meeting of the rabbis and Mizrachi leaders Wednesday that complete harmony has existed between him and the Zionist Organization in regard to the United Palestine Appeal and yet, the paper points out, Rabbi Ber-lin was fully aware at the time of Dr. Wise's appointment as chairman of the Palestine Appeal pointment as chainman of the Faissung Appear what Dr. Wise's opinions on Jesus and Christianity were. "How is it, then," the "Day" asks "that Rabbi Berin could agree in the first place to the appointment of Dr. Wise to the chairmanship of Whe Falestine Appeal." What if Dr. Wise as chair-wise the Falestine Appeal." What if Dr. Wise as chairman would facilitate the drive? Can an orthodox leader compromise his religion for money? not Rabbi Berlin's endorsement of Dr. Wise's chairmanship sanction the idea that a man who thinks highly of Christianity can be the leader of

the Palestine campaign?

"It is necessary," the "Day" continues "that those orthodox rabbis who really have the success of the Palestine Appeal at heart and aim at the strengthening of orthodoxy in America, should be told what is going on now, in order that they may understand the situation and take account of it. "In the midst of the orthodox rabbis there is being perpetrated a base political plot, and it must be disclosed before it is too late. The honest or-

thodox rabbis are being used for political purposes. They are being used as tools to strengthen the prestige of the Mizrachi organization which is

looking for an issue.

"Who started the campaign? Who started the whole row? Was it the rabbis? No. We have the evidence of very reliable persons who declared the evidence of very renable persons win declared openly at a meeting of prominent Jews that a 'certain Mizrachi leader,' not a rabbi, started the whole trouble, phoning the editorial offices and calling on the rabbis, demanding that Wise's sernom be turned into an issue. Eventually such a month be turned into an issue. Eventually such a flame was aroused that it now threatens to cause a split in orthodox Jewry, to break up the Zionist forces and to bring about a catastrophe which the

The "Day" also takes occasion to call the attention of the rabbis to the fact that if they persist in their present stand they will be guilty of aiding the Vatican in its anti-Zionist campaign in Palestine by offering it an argument regarding Jewish intolerance.

"To mix religion with politics, even though it is Zionist politics, is one of the most dangerous things for Jews," the paper observes in conclusion. "Such things are done by the Ku Klux Klan. But it is not a fit thing for our orthodox rabbis to do.

We believe the Agudath Harabonim would be justified in demanding of the Zionist Organization to issue a statement expressing regret at Dr. Wise's sermon, in order to show thereby that the Zionist Organization, which consists of Jews of all shades and opinions, positively cannot endorse Dr. Wise's opinions on Jesus. But the rabbis Wise's opinions on Jesus. should be content with that and not demand his resignation.

#### Second Resolution of Orthodox Rabbis Seen As Paving Way to Wise's Resignation

The action of the orthodox rabbis and Mizrachi leaders at their meeting Wednesday at the Broad-way Central Hotel in adopting a milder resolution way central roles in adopting a linder resolution against Dr. Wise is regarded by Jacob Fishman, of the "Jewish Morning Journal," as a paving of the way for the acceptance of Dr. Wise's resignation which, Mr. Fishman asserts, was prevented by the first resolution of the Agudath Harabonim.

Not only the organized Zionists, but Jews in general, says the writer, were amazed at the ex-treme behavior of the rabbis. "Many Jews won-dered: why were the rabbis so hasty with their verdict? Why did they not call Dr. Wise to a hearing and give him an opportunity to defend

himself?"
The Zionists, Mr. Fishman further stresses, were piaced in a terrible predicament. "Shall Dr. Wise be removed from his position as a heretic and religious beguiler? No. The Zionists could never agree to that. Dr. Wise, realizing his great misstake, tendered his resignation and the resignation could be accepted by the Zionists only on the ground that following his sermon, Dr. Wise was the country of the property of the property of the ground that following his sermon, Dr. Wise was not the right person to act in the name of all the elements in American Jewry, but that he was a heretic and religious beguiler—that was unthinkable. All that has been said about it is more prone to produce heat that light. To give the impression that Jews are anxious to discredit the lesus narrative, on the one hand, or to make of it a special plea for themselves, on the other hand, is hardly fair to any wing of Judaism."
