NTI-SEMITIC LEADERS PROTECTED FROM ARREST BY ORDER OF HUN-GARIAN MINISTER OF INTERIOR ANTI-SEMITIC Threatened Revolution; Two Jews Held

(Jewish Telegraphic Agency)

Budapest, Jan. 8.—A radical change in the un-masking of the anti-Semitic leaders involved in the 30 billion franc counterfeit conspiracy occurred yesterday when the order to arrest a number of leaders was countermanded.

Deputy Julius Goemboes, leader of the anti-Semitic group in the Hungarian parliament and Deputy Eckhardt, were not arrested as a result of the countermanding of the order of arrest. These instructions were issued as a result of the personal intervention of Minister of the Interior Rakovsky, because of the threats made by leaders of monarchistic and anti-Semitic organizations to start a revolution.

The pretext for these instructions was the immunity from arrest enjoyed by the deputies until re-moved by parliament. Deputy Ulain, who was ar-rested, and a number of other anti-Semitic depu-

ties, were included in this order.

Major Ladislaus Magasbasy, personal adjutant of Regent Horthy, was examined by the state attorney.

Two Jews are among the arrested. They are Eugen Halasz, administrator of the estate of Prince Ludwig Windisch-Graetz, and Polney. Their arrest is not on the basis of complicity in the plot, but for preventative purposes. The former is charged with having failed to notify the police of his employer's activities, although he had called the Prince's attention to the fact that his activities were in contradiction to the criminal code. Polney was charged with lending his trunk to his war comrade, Mankovits, although it was established that Polney did not know the purpose of Mankovits' trip to Holland.

#### **JEWISH** UNEMPLOYED IN WARSAW STORM KEHILLAH FOR HELP

(Jewish Telegraphic Agency)

Warsaw, Ian. 8.—The gates of the Jewish communal building in Poland's capital were stormed yesterday by thousands of Jewish unemployed workers in an attempt to secure relief from the Kehillah.

Members of the board of directors of the Kehillah received a delegation of the unemployed demonstrators, to whom they declared that they are not in a position to extend any relief, because the treasury of the Kehillah is empty. They advised them, however, to apply to the Warsaw City Council which is, under the regulation, compelled to care for both the Polish and Jewish unemployed.

By a recent decision the City Council raised the fare on the city transit lines 5 Groszy, as a special tax for the support of the unemployed.

The storming of the Kehillah gates did not cease until the police was called to disperse the workers Four mass meetings of the unemployed were called in the evening by the Bund, the Jewish labor party

Official figures published by the Employment Bureau show that 10,550 persons are unemployed in Warsaw, of whom 2,550 are professionals. The Employment Bureau does not have any record of the unemployed among the Jewish workers.

SECRET SOCIETY TO BOYCOTT JEWISH FIRMS FORMED IN SOUTH AFRICA

Movement is Childish, Government Representative Declares; Organization Similar to American Klan

(Jewish Telegraphic Agency)

Johannesburg, Jan. 8 .- A secret society of which rumors have been heard for some time and whose object is to boycott Jewish traders and professional men, has emerged and has taken the opportunity of the Jewish Orphanage Campaign, to advertise its existence and aims.

The organization is said to be called the "League of Gentiles" and to have secured as many as 10,000 members among the population of the country in the last twelve months although no publicity has been

given to the movement.

A representative of one of the local papers here has managed to obtain some information of the organization. Signature of the form of membership, he reports, entails an understanding not to deal with Jewish firms or business men and to cease dealing with any such firms or business men from the moment of joining the League. In the case of persons who are desirous of becoming members of the League but are tied to Jewish firms by reason of unpaid accounts, it is stated that the League has a system by which it will settle these accounts and the member can then join and pay the accounts to the League at his convenience.

The effect of the League's operations on the distribution of trade was explained to the press representative. "There are said to be something like 10,000 members," he was informed, "and they are mainly persons of the comfortable classes. Placing the average income at £300 per annum, all of which is spent one way or another, this would amount to £3,000,000 a year turnover lost to Jewish trade, or, rather secured for Gentile trade, for much of that sum in the past went to Jewish traders."

### HOUSE COMMITTEE BEGINS HEARING ON LIBERALIZATION OF IMMIGRATION LAW Louis Marshall Appears Before Committee (Jewish Daily Bulletin)

Washington, Jan. 8.-Louis Marshall and Congressman Perlman appeared before the House Immigration Committee yesterday to appeal for exemption from the quota of certain relatives, of declarants and citizens, namely, the wives, husbands, children and parents, which is proposed by Congressman Perlman's bill in the Touse and Senator Wads-worth's bill in the Senate. These bills were used as the basis of consideration by the committee.

Mr. Marshall, who appeared before the Committee on the invitation of Congressman Perlman, spoke for about an hour. Both he and Congressman Perlman stressed the great hardship caused by the separation of families, due to the impossibility under the present law of securing admission for the above mentioned relatives of declarants and of parents and husbands of citizens. At present only the wives of citizens and the unmarried children under eighteen are exempt from the quota.

While no open opposition was displayed, it could not be ascertained from the questions asked by the

#### WORLD CAPITAL DOMINATED BY ARYANS, STATISTICS PROVE

Anti-Semites' Charge of Jewish Financial Dominance Disproved (Jewish Telegraphic Agency Mail Service)

Berlin, Dec. 25 .- The fallacy of the charge of Jewish financial world domination was proven by statistics compiled by Dr. Hoffman Campe and published in the "Vossische Zeitung." "International capital is in Aryan hands and only

"International capital is in Aryan nature and only a small and diminishing proportion is in Jewish hands," Dr. Campe writes. "This applies not only in the case of industrial capital, which is almost entirely in the hands of non-Jews, but also in the case of bank capital, where the Jewish influence is much less than is popularly supposed. Among the six people with the largest incomes in America there is not a single Jew. Among the twelve men with the largest incomes in the United States, there is only one Jew, Otto Kahn, who has ninth place on the list. Among the twelve wealthiest men in the world there is not a single Jew.

"As for Germany, Dr. Rudolf Martin in his Millionaire's Year Book," stated that among the twelve richest people in Germany who had an in-come of over 15 million marks, there were only three Jews, two members of the Rothschild family and one member of the Speyer family. The richest Jew in Germany at that time was Baron Max von Goldschmidt Rothschild, who had 107 million marks and held fourth place in the list of the wealthiest people in Germany. Baroness Mathilde von Roth-schild with 76 million marks had seventh place, and Councillor Edouard Veit von Speyer with 76 million marks had eighth place.

"Since then conditions have changed very much. While the fortunes of the Krupps and of other Aryan industrial magnates have multiplied many Aryan moustrial magnates have multiplied many times over, the fortunes of the Rothschild family and of other Jewish families have been much reduced." Dr. Campe writes. "That the heirs of Stinnes have lost the fortune which had accumulated does not alter the fact that the man who exploited Germany's distress in the war and post-war period was an Aryan," the rriter concludes.

Through the sensational revelations of the Paris police the world has now learned that the patriotic 'saviors of Hungary' are in reality a band of terrible crimi-uels of the lowest class. Having lost their huge iortunes through the war and the revolution the gentle Hungarian nobles attempted to create millions by manufacturing and circulating false French francs." "Hungary, the country of the white terror, the country of bestial, tyrannical anti-Semitism, offers now the classical example of the kind of people the anti-Semites are and of the nature of the anti-Semitic disease.

"Perhaps the world will now see the present black, Jew-baiting Hungary in its true garb. Per-haps America will realize who are some of those that frequently find protection and friendship here."

The "Panama scandal," which was perpetrated by anti-Semites in France, is recalled by the "Jew-ish Morning Journal," which hopes that since that incident helped France to recover from her anti-Semitic intoxication a similar result will now come about in Hungary.

"The agitation against Jews must subside," we are told, "when it is seen to what low depths the men who make Jew hatred their stock-in-trade sink. It is to be hoped that the same result as came about in France lafter the Panama scandal will now take place in Hungary where the anti-Senites have been exposed as ordinary swindlers. Jews have done a great deal for Hungary and were treated well there before the war. The situation in that country cannot become normal until the attitude toward the Jews will change back to what it was about twelve years ago."

# Chief Rabbi of England Charges Liberal Judaism Repeats Experience of Early Christianity

(By Our London Correspondent)

London, Jan. 1 .- The charge that Liberal Judaism is repeating the experience of early Christianism is repeating the experience of early Christianity by advocating the abolition of the Abrahamic covenant, was made here by the Chief Rabbi, Dr. J. H. Hertz, in the first of a series of addresses in which he discussed the spiritual conflict between the Fundamentalists and the Modernists in Anglo-Jewry today.

"In England," the Chief Rabbi declared, "a small group has long been struggling to transplant Liberal Judaism to these shores. After many years of effort, they have erected a stately house of worship. So loud is their rejoicing thereat, that earnest men and women are perplexed by the claims of this movement. They are dazzled by its claims of this movement. They are dazzled by its ephemeral successes; and bewildered by the new shibboleths of its spokesmen. They turn their eyes to the Rabbinate for guidance. This guid-ance will be given them. I shall examine the attitude of Liberal Judaism to institutions and beliefs that are essential to Israel's existence, and show whither it is inevitably leading.

"Take a primal commandment like the Abrahamic Covenant. The martyrs in the Maccabean age died for it; also in the times of the Hadrianic persecution, in the dread days of the Inquisition, whenever or wherever tyrants undertook to up-root the Jewish Faith. Even an ex-communicated, semi-apostate like Benedict Spinoza declares: 'Such great importance do I attach to the sign of the Covenant, that I am persuaded that it is sufficient by itself to maintain the separate existence of the nation forever. But the protagonists of Liberal Judaism have everywhere worked for its total abolition. Abraham Geiger, the founder of the whole movement, denounced 'Meelah' as far back as 1845. Nearly all the spokesmen of the New Judaism today are in agreement with Geiger. They dispense with the Abrahamic rite in the case of infants, for an indefinite period of transition, as the principle founder of the London group carefully phrased it in 1919. For an indefinite period of transition! This distinction between proselytes and infants was at first also the rule in the Christian Church; but after 'Meelah' was once set aside in the case of proselytes it was not long retained even for infants. With open eyes, Lib-eral Judaism is repeating the experience of early Christianity.

"As for Sabbath and Holy Convocation, Fast and Festival," the Chief Rabbi continued, "these fare ill at the hands of these moderns. prominent religious guide advocated that Passover be struck off the Jewish Calendar, and proposed that instead, Christian and Jew should together celebrate Easter as Martyrs' Day; another argued that Tabernacles was a dying festival, a withered brasch that should be cut off from the Tree of Judaism; while still another has arranged in his synagogue that these two fundamentals be celebrated only on the Sunday of the week in which they occur. Many of these 'rabbis' declare that fasting on the Day of Atonement is a superstition; and they practise what they preach.

"Institutions, symbols and observances constitute merely the body of Judaism. The mind and soul of Judaism are the Sacred Scriptures, the Brotherhood of Israel, the Jewish Creed and Outside Land Land and the Judaism are the same of the habitant and the same of the same look. In this world mind exists only in the habitation of a body; and 'nude souls' are found only in the imagination of the mediaeval Mystics. religion, least of all Judaism, can continue without its historic, outward garb."

Dr. Bluestone will sail carly in March to take charge of the public health and medical work of Hadassah which carries on its activities in Palestine, irrespective of race or creed, although it is supported exclusively by American Jews.

He has been an extensive contributor to medical journals on hospital administration subjects. He will be in Palestine three years. During his stay in Palestine, Hadassah's health activities are to be enlarged.

sult in the offender being punished.

During the interview a member of the executive During the interview a member of the executive explained to the press representative that the membership of the League was over 10,000. There are members all over the country. Its full title is the "League of Gentiles." Protection and Benevolent Society." Many influential people are members of the League. It has sixten branches in the Transvaal alone. "We intend to create a strong Gentile organiza-

tion, powerful enough to influence the Government," a member stated. "Jewish organizations are powerful enough to influence the Government and we must

do the same."

The organization came out into the open as a rine organization came out into the open as a result of a campaign for funds for the local Jewish orphanage, a building formerly the residence of Sir Lionel Phillips, in which are housed Ukrainian war orphans, as well as local Jewish orphans. As a result of the appearance of various appeals to Jews alt of the appearance of various appeals to Jews to support the orphanage, the League inserted an advertisement in the newspapers calling for 20,000

Gentiles to join the League.

Inquiry was made as to the approximate number the proposed legislation would admit, but neither Mr. Marshall nor Congressman Perlman were in a position to submit such an estimate, although assurance was expressed that no unduly large num-ber is involved. Mr. Marshall, in a vigorous and impassioned appeal, brought out two main points, first, that it was a sound economic policy to unite relatives. America is built up on a family and home basis, he said. It is an indication of the desirability of an immigrant when industrious and conscientious enough to desire to bring over his close relatives, and, secondly, aside from this practical assurance, the proposed legislation should not be treated as a mere matter of cold figures but considered from the standpoint of humanity, in the spirit of President Coolidge's own expression of sympathy with this character of relief legislation. Congressman Dickstein of New York and Congressman Golder of Philadelphia, the new Jewish

member of the Committee, asked questions and made observations tending to assist in bringing out the points favoring the proposed measure. Although the real discussion on the part of the Committee will occur in the executive session after the conclusion of the hearings, there developed yesterday a brief interchange of remarks concerning the prin-cipal aspect in which Senator Wadsworth's bill differs from Congressman Perlman's. The former proposes only to exempt the relatives of those declarants who held that status prior to July 1, 1924.

Congressman Golder brought out that this would mean only those admitted into the United States prior to July 1, 1922, would be entitled to secure exemption for their relatives, as the law requires an alien to be a resident of America for two years prior to making his declaration of intention to be-come a citizen. Congressman Golder added that the number who would come in if the proposed restriction were eliminated could not possibly be so great as to affect the economic equilibrium or prove objectionable in any other way, whereas, such restriction would impose great hardships upon those who arrived after July 1, 1922.

Further hearings are expected next week, although no definite date has been set. Congressman Perlman indicated that Dr. Stephen S. Wise and other prominent Jewish leaders will be invited to appear before the Committee
