EDUCATORS DISAGREE ON NATION'S RELIGIOUS INSTRUCTION IN PUBLIC SCHOOLS

Righteousness By Formula Can Lead to No Results, Is Argument (Jewish Daily Bulletin)

Washington, Feb. 26.-The question of religious instruction in the public schools was considered yesterday by the Department of Superintendents of the National Education Association, which is holding its convention here. Noble of Sherwood, Indiana, state superintendent of public instruction, favored religious influence without advocating the formal introduction of religious instruction into the curriculum. "We must have an intelligence established on faith, built in prayer and nourished by good will," he declared. "The church and state should cooperate in this matter of religious education. The teacher should be identified with the church.

"This makes possible the most effective teaching, teaching by example. Religion is taught as well as caught. American children will receive their inheritance. The outlook for this joyful consummation is reassuring. We are training spiritual minutemen for the cause of religious education. Signal

heres for a mighty effort are burning—a spiritual re-naissance is imminent," he declared.

Ernest W. Butterfield, New Hampshire state commissioner of education, opposed any form of religious instruction, declaring:

"Any plan for sectarian instruction on school time is but a new form of the old experiment of stateenforced religion. As a nation we are attempting, (Continued on Page 4)

ROUMANIAN STUDENTS BEGIN STRIFFOR INTRODUCTION OF NUMERUS BEGIN STRIKE CLAUSUS

Cuza Assumes Leadership of Movement (Jewish Telegraphic Agency)

Bucharest, Feb. 25 .- The threatened strike of the Roumanian students began here yesterday at the Academy of Commerce. Students at other colleges are expected to follow.

Professor Alexander Cuza, the leader of the Roumanian anti-Semitic movement, arrived in Bucharest several days ago for the purpose of assuming personal leadership of the new student move-

ment. The strike was threatened by the anti-Semitic student organizations in case their demand for the introduction of a numerus clausus against Jewish students at the Roumanian Universities would not be fulfilled within ten days.

CATHOLIC PAPER COMPLAINS AGAINST NON-ADMISSION OF CONVERTS TO ZIONIST MOVEMENT

London, Feb. 25.—A protest against the consistent refusal of Zionist leaders to admit converts into the retusal of Zionist leaders to admit converts into the movement was voiced by the "Catholic Healdd" here. The "Heraldd" which is the organ of the Catholic Guild of Israel, a missionary organization, states that persons of Jewish race who have accepted Christianity and who assert that they have not ceased to be Jews racially are not admitted to the Zionist movement.

Zionist movement. "Whenever Christians of Jewish parentage apply for membership in the Zionist Organization, they are told that their being Christians disqualifies them. Every race has members of varying religious faiths," the paper states.

JEWISH FATHER BRINGS SUIT AGAINST SECRETARY KELLOGG FOR WARSAW CONSUL'S FAILURE TO VISE DAUGHTER'S PASSPORT

Delay in Granting Application Caused Loss of Preferential Status Because She Reached Majority

(Jewish Daily Bulletin)

Washington, Feb. 25.-The possibility of a court order being issued for the first time to compel the Secretary of State to instruct a consul to issue an immigration visa appears likely as a result of man-damaus proceedings brought by Lewis Friedman of this city against Secretary Kellogg to obtain a visa from the American consul in Warsaw for his daughter, Rose.

Friedman went to Poland to bring his daughter to America before she became twenty-one, while she had a preferential status for admission. He alleges that by reason of misinformation and fail-ure to render assistance on the part of the consulate his daughter attained her majority, thus losing her preferential status before her departure could be arranged.

In a preliminary opinion filed today by Justice Hoehling, he intimates that if the American Consul was guilty of the conduct charged, an order to compel the issuance of a visa would be justified. good reason exists why appropriate relief should not now be afforded the father, since the right to compel performance of a duty should not in equity and good conscience be held to be destroyed by the lapse of time within which in the first place the duty ought to have been performed," he said. He declined, however, to make a final decision at this time, stat-ing that first Friedman must offer proof of his request for assistance at the consular office in Warsaw and the failure of the consulate to render same and also suggested that the complaint be amended so as to include as defendants, Commissioner Hull and Secretary Davis, both of whom are also involved in decisions on immigration matters.

JEWISH EMIGRATION FROM POLAND TO SOUTH AMERICA ASSUMES LARGER PROPORTIONS

Warsaw, Feb. 25.-The emigration of Jews from the Eastern provinces of the Polish Republic to South American countries has increased during the last few months.

The emigration has assumed the character of a mass movement from the eastern provinces, which are suffering most both politically and economically.

Many steamship companies have opened special branches in these provinces for the accommodation of the Jewish emigrants.

The emigration of Polish Jews to Australia has begun. During the last year 114 Jewish emigrants left for Australia.

COOLIDGE ATTACKS RACE PREJUDICE IN WASHINGTON SPEECH

George Washington Was No "Small American," President Declares (Tewish Daily Bulletin)

Washington, Feb. 25.-President Coolidge again attacked race prejudice in his address on George Washington at the convention of the National Edu-

cation Association here.

"Envy, malice, uncharitableness, class jealousies, race prejudices and international calumnies are not realities, they do not abide, they are only the fictions of unenlightened comprehension. Those who preach them are not safe advisors and not sound leaders. Nothing but discord and disaster at home and abroad can result from following these policies,"
Rresident Coolidge declared.
"Washington was the antithesis of all this. His

writings and teaching breathe a higher, broader pur-pose, a more inspired leadership. No man clung more tenaciously to what he believed was right or was prepared to make greater sacrifices in its support. But he viewed the right as a universal principle to be applied not only to himself but to others, not only to his own state but to the nation, not only to his own countrymen, but to foreigners. There was nothing about him of the small American," the president declared.

AGAINST REFORM PROTEST RABBI'S INSTRUCTION IN NEW TESTAMENT

The Jews Are Ready-The Jews are ready-are the non-Jews? asks the

"Day" (Feb. 25), commenting on the Good Will Dinner last Tuesday in New York at which Chas. E. Hughes presided. Greeting the Good Will Dinner as a step in the

right direction, the paper stops to point out that the Jews are not responsible for the present digression in America from the spirit of traditional American democracy.

"The Jews are always ready for the spirit of unity and understanding. Jews are also ready in practice to be tolerant to others, in so far as it is humanly possible. Tolerance is imposed on us by the essence of our spirit, by our history and by the facts of life each day and each hour.

"We are ready—let but the other side be ready—

The "Day" thinks Mr. Hughes, and the other speakers at the Good Will Dinner, in denouncing intolerance and bigotry, should have mentioned by name Henry Ford, the Ku Klux Klan and the other individuals and organizations, all non-Jewish, that have been instrumental in spreading dissension and hatred in America.

"These corrupters of the noble American traditions. these underminers of true Americanism, should be made to hear openly what those who are interested in the further progress of inner American life think and feel about them. An open attack on the dark forces will more effectively paralyze their influence and their destructive activities," the "Day" concludes.

The Choice

"Are we ready," asks Florina Lasker, writing in the "Survey" of Feb. 15 on the question of the immigration laws, "to say to non-citizens—men who have contributed perhaps to the industrial and cultural life of this country even though they have not yet been drawn into its political structure-Take your choice. Go back to the countries from which you came, for we will not let your wives and children join you here; or remain alone in this country where you are now comfortably established, for it is better under the circumstances to forget the wives and children left behind.'

"We have spoken with hundreds of men who. faced with these two alternatives, have accepted the one or the other. Some there are who, satisfied that they must abandon all hope of ever bringing their wives and children to the United States, have elected to return to their native lands, even though this meant beginning life anew-often life without the possibility of eking out a decent existence. Some there are who, satisfied of the impossibility of having their families join them in this country, have accepted their fate, consoling themselves by forming new ties. . . .

Praises Justice Proskauer

Justice Proskauer's action in averting a strike in the dress industry by bringing the conflicting parties to an agreement, is lauded by the New York "World" of Feb. 25. Instead of confining himself strictly to the formal proceedings in his court, the paper points out, Justice Proskauer "saw a larger opportunity and higher duty ahead of him."

Possibility of New Government in Roumania With Non-Anti-Semitic Policy Arouses Discussion Among Jews

(By Our Bucharest Correspondent)

Bucharest, Feb. 2.-Is Roumania to have a new cabinet soon that will stop the anti-Semitic excesses and improve the situation of the Jews? This question has provoked considerable discussion in Jewish circles since reports began te go around recently in political spheres of a possible change of Government with General Averescu as Premier. The possibility of such a change and its probable effect on soming of such a change and its produce check of the position of the Jewish population was the sub-ject of an interview here given to the Jewish Tele-graphic Agency correspondent by Dr. Meyer Ebner, one of the outstanding Jewish leaders of Bukowina.

"If General Averescu forms a Government," Dr. Ebner said, "we can expect an improvement in the position of the Jewish population of Roumania. When General Averescu was head of the Govern-ment, there was no official anti-Semitism. The Averescu Government ratified the Peace Treaty and the Minorities Treaties and gave the Jews full citizenship. At that time, in 1920-21, there were no anti-Semitic excesses in Roumania. The student movement, too, was still in its infancy. The Government under General Averescu kept a strong hand on things, and the position of the Jews was tolerable.

"We anticipate the same policy from a new Gov-emment headed by General Averescu. But we are not fully certain that it will be so. For since General Averescu was last in power anti-Semitism has seized all classes and sections of the population, and even General Averescu's party contains today anti-Semites of note. Nevertheless, we expect, and we think we are justified in this, that General Averescu, who is no philo-Semite, but who is also no anti-Semite, will not depart from the path of

duty and justice.
"We Jews in Bukowina have confidence also in ex-Minister Dr. Dori Popovitch, who will probably take the leading position in an Averescu Government next to the Prime Minister himself. Dr. Popovitch is a son of Bukowina. We know him disposed towards the Jews. Only the future, however, can show whether we shall have cause to be as satisfied with a new Averescu Government as we were with the last Averescu Government.

Dr. Ehner also spoke in the course of the interview of the recently formed National Federation of Bukowinan Jews. Hitherto, he said, there have ben two big Jewish parties in Bukowina, the Zionis and the Jewish National People's Party, headed by Deputy Dr. Straucher. Owing, however, to cer-tain difficulties and disagreements there was a split in his party. One section remained with Straucher, and the other, the bigger section, united with the Zionist party, which had after its last conference decided to keep political work and purely Zionist work separate. The unification of the Zionist party

and this group has led to the establishment of the National Federation of all Jews in Bukowina. "The work of the National Federation," Di-Ebner concluded, "will be to bring about a revival in Jewish political life and to strengthen Jewish political significance in regard to the relations with the Government. Within the near future there will be big work to be done in the sphere of 'realpolitik, and the National Federation will have to take this work upon itself. It will stand on guard to protect the political, economic and cultural interests of the jewish masses. The National Federation will also prepare the way for a unification of all Jews in Greater Roumania, for the formation of a single Jewish political organization for the whole coun-

ESSMAN JOHNSON FAVORS AI ON OF RELATIVES PROVIDED QUOTA IS NOT INCREASED CONGRESSMAN MISSION OF

Philadelphia, Feb. 25.—The restrictive immigra-tion laws are on the statute books to stay, with no modification that will increase the number of aliens now admitted, Albert Johnson of Tacoma, Washington, chairman of the Congressional Committee on Immigration, declared in an address before the Patriotic Order Sons of America.

"I am sure that the people of the United States want restrictive immigration," said the Congressman, who is the author of the immigration laws.
"What slight modification may be necessary will
not be made at the expense of restrictive immi-

gration.

"A movement is being started to permit the wives and children of aliens already in this country to enter. It is humane to make this modification, but we must be careful. Such people will have to be admitted at the expense of a reduced quota for some other nation.'
