JEWISH DEPUTIES ASKED TO CAST VOTE FOR THE PILSUDSKI REGIME

Will Make Decision At Meeting on May 25; Bund, Jewish Labor Party, Supported Pilsudski's Coup, Is Report

(Jewish Telegraphic Agency)

Warsaw, May 21.—Negotiations with the Club of Jewish Deputies and the parliamentary representation of the Slavic national minorities concerning their attitude at the National Assembly were started by the Polish Left groups supporting Marshal Pilsudski.

The Club of Jewish Deputies will make clear its attitude following a general meeting of the Club, which will take place on May 25, leaders of the Club stated.

Leaders of the Polish Socialist Party (P.P.S.) also conferred with the representatives of the Jewish labor party, Bund, and the German Social Democratic Party concerning joint socialistic tactics.

The National Assembly will meet on May 29 for the purpose of electing a new president. Much comment has been aroused by the fact that the Right groups have put forward as their candidate Stanislaw Wojciechowski, the

former president who was compelled to resign by Pilsudski.

It has not been finally stated who will be the candidate of the Left groups.

So far anti-Semitic propaganda, which previously accompanied the party strife in Poland, has not been used in Warsaw in the polemic between the parties which followed Pilsudski's coup d'etat.

The correspondent of the Jewish Telegraphic Agency, however, learns that the elements in Posen which remained faithful to the previous Witos government are spreading incredible and ridiculous rumors, such as that Jewish boys in Warsaw have disarmed those Polish officers who remained faithful to the Witos government. These rumors have caused an uncertain situation in Posen where the Jewish population feels some anxiety. The governor of Posen, who refused until now to admit any change in the government, finally recognized the resignation of President Wojciechowski.

A cable despatch from Danzig to the Jewish Daily "Forward" states that the socialistic Jewish labor party, Bund, in Poland, supported Pilsudski's coup and that two Bund members were killed and several wounded in the street fighting.

LATVIAN JEWISH SOLDIERS WILL BE RELEASED FROM SERVICE ON SATURDAYS

Term of Service Extended Three Months

Riga, May 21.—Jewish soldiers in the Latvian army will be released from service on Saturdays, according to a resolution adopted by the Latvian parliament yesterday.

The resolution was adopted in the form of an amendment, introduced by the Jewish deputies, giving to the Jewish soldiers an opportunity, during the times of peace, to be relieved from duty on Saturdays. Those Jewish soldiers who observe Saturday will have to serve 21 months as their term in the army instead of 18 months.

REPORTS OF SUSPENSION OF LAND SETTLING WORK IN UKRAINE ARE DENIED

Charkoff, May 21.—A denial of press reports that the Ukrainian government has completely stopped the work of settling Jews on the land was made yesterday by Mr. Kantor, a member of the Central Committee for National Minorities of the Ukrainian government.

"It is true that the land settling work is proceeding slowly this season," Mr. Kantor declared, "but land has been allocated for the settling of 1800 families, the government and the central institutions are assisting the colonization. The only obstacle is the lack of funds."

MOSLEM DELEGATES WILL GO TO MECCA FOLLOWING FAILURE TO ELECT CALIPH

Cairo, May 21.—No agreement could be reached as to the election of a new caliph for the Moslem world at the Caliphate Congress which ended here after several days of fruitless discussion.

All the delegates were agreed on one point: the essential qualifications which the new Caliph must possess. These qualifications exclude any of the present Moslem rulers. The majority of the delegates who attended the congress will proceed to Mecca to attend the other caliphate congress which was called by Sultan Ibn Saud, pretender to the caliphate. This congress will take place in June.

AMERICAN SPORTSMANSHIP BROTHERHOOD TO HONOR THE HAKOAH SOCCER TEAM

Charter and Emblems to Be Presented for Fine Spirit of Sportsmanship and for Bringing America Closer to Europe

The first membership charter to a European Sports Club in the Sportsman Ship Brotherhood, an American organization founded as a "bridge of understanding between the nations of the world" will be granted to the Hakoah Sport Club of Vienna, according to a decision of the Board of Directors of the Brotherhood. This was made known yesterday in a letter from Mr. Paul Neumann, vice-chairman of the Foreign Contracts Committee of the Sportsman Ship Brotherhood and Sports Editor of the "New York Evening Post," addressed to Mr. Abraham Tevim, secretary of the Hakoah delegation to the United States.

"In view of the splendid spirit of sportsmanship shown by the Hakoah Football team on its tour, and in view also of the fine missionary work done in bringing the United States closer to continental Europe than all the diplomacy of the past eight years, I am authorized by Matthew Wolf, president, and the Board of Directors

of the Sportsman Ship Brotherhood to present to the Hakoah Club a charter of membership as the first European Chapter of the organization.

"At the same time I am authorized to present to the individual players of the Hakoah football team our 'sportsman ship' emblem, awarded only to men and boys who have proved themselves sportsmen in every sense of the term," Mr. Neumann's letter read.

The presentation will be made by Mr. Neumann at the testimonial dinner being tendered to the Hakoah team on June 1, before their departure from the United States.

The Sportsman Ship Brotherhood is a non-partisan, non-political, non-national and non-religious body of men organized to form a bridge of understanding between the nations of the world, according to the platform of the organization. It was created to foster the spirit of sportsmanship throughout the world. The organizers hold that the spirit of sportsman ship and athletic competition

JOHN D. ROCKEFELLER, JR. CONTRIBUTES \$100,000 TO THE UNITED JEWISH CAMPAIGN

A contribution of \$100,000 from John D. Rockefeller, Jr., to the United Jewish Campaign was received by Mr. Paul Baerwald, treasurer of the campaign, a statement from the headquarters of the campaign declared.

Mr. Rockefeller's letter accompanying the gift was addressed to Mr. Paul Baerwald, treasurer of the Joint Distribution Committee, and read:

"I have been following with interest the progress of the campaign of the Joint Distribution Committee for the relief of the Jewish people in Poland and Russia, and I noticed the generous response with which the appeal has met. On information which I have sought, the program for the distribution of this fund has been very carefully and wisely worked out.

"In a matter of this kind, there ought to be no barriers of race or creed. Therefore, although my participation in the movement has not been solicited, I hope you will allow me to enclose my check for \$100,000 toward the fund, which I do with best wishes for the successful consummation of the campaign."

Clarence H. Mackay, president of the Postal Telegraph & Cable Company, subscribed \$1,000, Bennie Leonard \$500 and Lou Tellegen \$500 to the United Jewish campaign, according to an announcement made by Acting Chairman David M. Bressler.

The total of the campaign up to Thursday night was \$5,787,000, Mr. Bressler stated.

A quarter million dollar increase over the original quota of \$6,000,000 was voted by the workers at the last rally.

The Amusement Industry Division, through its chairman, Joseph Leblang, announced that Col. Charles Stoneham had donated the Polo Grounds for the Theatrical and Sports Field Day for the benefit of the fund to be held on Sunday, June 27th.

DEFENDS J. D. C. ON TARBUTH SCHOOL QUESTION

(Communication to the Editor)

Sir: I am noted in press reports that the Jewish Education Conference called by the Zionist Organization and held on Sunday last at the Hotel Astor, drew up a resolution protesting against the Joint Distribution Committee's Cultural Committee for discriminating made against the Tarbut schools abroad.

This, I am sure, is due to a misunderstanding and lack of proper information. As one who has been actively engaged in relief work all the time, and particularly with the Cultural Committee since its inception, I deem it my duty to call attention to this error. It is a matter of record that all through the years of the J. D. C.'s Cultural activities abroad, the Tarbut schools were receiving their regular subsidies, along with all other educational institutions of whatever shade of opinion or faction. If these schools did not receive the entire sums necessary to maintain them with proper efficiency, one must remember that no institution did receive its full budgetary quota. The most that the J. D. C. could do was to aid them, by monthly subsidies, toward their regular budgetary outlays.

With the recent renewal of the Tarbut schools as in all other schools. The cultural Committee, and its Chairman, Dr. Cyrus Adler, particularly, displayed a broad-minded impartiality in its work all through the period of its existence. This is a fact known to all acquainted with the cultural activities.

Of course, when the J. D. C. discontinued its overseas work, the aid extended formerly to the Tarbut schools ceased, together with all other aid done to all other schools. Traditional schools and Yeshivas continued receiving support through the independent and devoted efforts of the Central Relief, and through its other source.

With the recent renewal of the J. D. C.'s activities, although there were no funds yet available in the treasury and regular budgets have not been worked out, the Tarbut schools did receive sums aggregating \$1,000,000 within the past three months, which was appropriated from time to time as Emergency subventions. Altogether a sum approximating \$100,000 has been allotted to the Tarbut schools since their foundation, and more will no doubt be extended for their support as the proceeds of the \$15,000,000 Drive come into the Treasury of the J. D. C.

The Temper of Polish Jewry Under the Stress of the Crisis

That the Jewish leaders in Poland realized, prior to the Pilsudski coup that events were shaping themselves for a dictatorship, in one form or another, appears from one of a number of articles in the Polish Jewish press which reflect the state of mind of Polish Jewry just before the recent coup d'etat.

Writing in the "Lodzer Tageblatt," Yiddish daily of Lodz, on April 23, Dr. J. Rosenblatt, Sejm Deputy, observed: "Everyone in Poland is so preoccupied with the economic troubles that the psychological process which the Polish people is passing through remains unnoticed. In many circles a discussion is going on whether Poland should go on under the present political forms, which have been determined by the Constitution, or pass over to other systems which have been adopted in some countries.

"The Polish press—and this is characteristic, a symptom of the time—is engaged," we are told, "with the question whether Poland should continue to develop along the present political lines or set up a dictatorship. There is prevalent in Poland today a disappointment with the republican form of government set up with so much pride only a few years ago."

The Polish Jews are urged against falling into a state of despair because of the critical conditions, in an article by Sejm Deputy Moïse Frostig, which appears in the "Najer Folkeblatt," another Yiddish paper of Lodz.

"The Jewish population and their leaders must not adopt a policy of bankrupts to whom it 'no longer matters' what will happen, having lost everything," Mr. Frostig writes. "We must be calm and seek to exert a quieting influence on our environment," he continues. "Perhaps we have committed mistakes in our political conduct during the past several years, but one success, perhaps the most important, we did achieve: thanks to our policy, not even the anti-Semitic parties today dare to blame the Jews, as they did in the past, for all evils and troubles in the country.

"Of course, we realize that our enemies still continue to regard the Jews, and the other national minorities, as merely material for political and economic exploitation and oppression. But we must not lose our heads. Let us not talk ourselves into the idea that we are falling into an abyss and that there is no salvation, no way of rescue. . . . We can accomplish nothing, we cannot improve our situation, through pessimism and despair."

SUGGESTS THREE METHODS IN COLLECTION OF UNPAID CHARITY DRIVE PLEDGES

**Jewish Relief Committee Action Basis
of Englewood Hospital Procedure**
(Jewish Daily Bulletin)

Englewood, N. J., May 21.—An interesting procedure with regard to the collection of charitable pledges was adopted by the Englewood Hospital, based on similar action taken by the American Jewish Relief Committee, the Hackensack Hospital and the Jamaica Hospital.

Following a legal opinion that hospital pledges are binding obligations and can be collected by due process of law, Clarence D. Kerr, chairman of the building committee of the Englewood Hospital, called a meeting of his committee to determine upon which of several methods shall be pursued in collecting overdue pledges necessary to meet bills for work completed on the hospital.

At the meeting the methods used by the hospital at Jamaica, L. I., the Hackensack Hospital and the American Jewish Relief Committee of New York City, were considered.

The president of the Jamaica Hospital outlined the procedure employed and the results attained in a letter read at the meeting.

"The results from our efforts were: First—A considerable number of payments as soon as the policy of the hospital was announced. Second—A large number of payments as soon as summonses were served. Third—A very decided favorable reaction on the part of the public toward the business-like handling of this matter.

"Naturally some of our trustees were fearful that such action would result unfavorably on the public. This has not been the result. On the contrary, comment has been entirely favorable. Sub-

that throws light on the Polish Jewish situation. The writer, N. Shwalbe, discussing the Polish-Jewish agreement, accuses both the Grabski and Skrzynski cabinets with a breach of faith in connection with the agreement. If Dr. Reich and his followers, who sought to improve the Polish Jewish relations through a policy of conciliation, failed, it was due, we are told, to the attitude of the Polish cabinets.

"The Jewish leaders had full confidence in the good faith of the Polish statesmen. That was their mistake: they did not suspect that responsible government leaders would deny obligations assumed and go back on their pledges.

"That the truth is on the side of the Jews—this will not be doubted by the world. The silence of Stanislaw Grabski since Dr. Reich's speech stating that the agreement consisted of 42 points, and not of 12 as claimed by Grabski, is the severest accusation against him and his methods.

"Will Skrzynski, who is so sensitive to opinion in foreign countries, likewise remain silent? Perhaps we will know when the present political crisis will have passed. . ."

DR. LEWIS BROWNE SAILS ON WORLD TOUR TO WRITE FOR JEWISH DAILY BULLETIN

Dr. Browne will describe the Jewish situation in the countries which he visits in news letters to the Bulletin.

Dr. Browne will visit England, France, Switzerland, Germany, Belgium, Holland, Poland, Lithuania, Turkey, Greece, Bulgaria, Yugoslavia, Hungary, Austria, Italy and Spain.

Dr. Lewis Browne ranks among the foremost of the younger historians and publicists writing in English today. Although his present widespread reputation came to him only with the publication in 1925 of "Stranger Than Fiction", his name has long been familiar to a small group through his frequent contributions to the "Freeman" the "Nation," the "New Republic" and other publications.

Dr. Browne, who was born in England, has lived in this country since his early youth. He received his education at Yale and prepared for the Jewish ministry at the Hebrew Union College of Cincinnati. His interest in social problems led him on three occasions to leave his congregations temporarily, and go off with migratory workers, or to labor in lumber camps and steel mills. Dr. Browne has drawn maps and illustrations for text-books and lectured in theological seminaries.

Dr. Browne will return to America in November and will then proceed to Asia.

JEWISH COMMUNAL ACTIVITIES

The contract for the construction of the synagogue for the Congregation Zichran Yehuda, New York, has been awarded. The present building on the site is to be demolished and a new building will be erected, construction of which is to start immediately.

The building will be designed in the Italian Renaissance style of architecture of brick, granite and terra cotta. The main floor is to have a lobby decorated with marble and ornamental plaster and ornamental stairs to balcony. The building will cost about \$50,000.

The dedication of the new synagogue in Orlando, Fla., was attended by a large audience. Plans for the establishment of a center in Berkeley, Cal., to include a meeting place and home center for Jewish students at the University of California were discussed at a meeting of the California Alliance of Jewish Women at the University N. W. C. A. It is planned to have a field secretary in charge at the center.

stantial people who made subscriptions, and paid them, are generally pleased that Jamaica Hospital had nerve enough to force payment by others who made subscriptions for advertising, perhaps, with no idea of ever paying. Several people who paid their subscriptions under pressure of court action, came back to us and complimented the board for its policy, and have become firm supporters of the hospital. Not a single instance of unfavorable comment has come to my attention.

"Of course, we did not proceed in the matter rough shod, but used every effort to collect subscriptions before suing. The finance committee endeavored to use the same good business judgment and exercise the same discretion, that a well managed business concern would use in collecting delinquent accounts."

Through civil action the American Jewish War Relief Committee collected \$1,500,000 by civil action in the courts.

The Hackensack Hospital followed a different method. It borrowed \$50,000 from the Hackensack Trust Co., and assigned \$100,000 in pledges as collateral. The Trust Co. proceeded and demanded payment as it would any other overdue promissory note. As a result in a brief time the Trust Co. collected most of the outstanding pledges, more than enough to pay the \$50,000 borrowed.

FIRE DESTROYS THIRTY HOUSES IN MIROPOL

Moscow, May 21.—Thirty houses were destroyed in a fire which broke out last night in Miropol, in the district of Zhitomir. Much damage was caused, machinery and workshops being destroyed.

JERUSALEM WIRELESS DELAYS ARE DISCUSSED
(Jewish Telegraphic Agency Mail Service)

London, May 4.—The question of delay of wireless messages from Jerusalem to London was raised in the House of Commons today, when Commander J. M. Kenworthy asked the Postmaster-General if he was aware of complaints of delays in wireless press messages sent via Egyptadio from London to Jerusalem, some of them taking 25 to 30 hours before delivery; what were the causes of the delays, and whether steps had been taken to improve the service.

Viscount Wolmer, the Assistant Postmaster-General, replied: "I am not aware of any recent complaint of excessive delay in press telegraphic messages between London and Jerusalem. If the member will furnish me with particulars of cases he has in mind I will have them investigated and inform him of the result."
