PROGRAM OF PALESTINE WORK ANNOUNCED BY PALESTINE ECONOMIC CORPORATION

To Participate to Extent of \$750,000 in Ruttenberg Electric Works;
Fund of \$100,000 for Long Term Loans Created

A program of work to be undertaken in Palestine, was announced yesterday by Bernard Flexner, President of the Palestine Economic Corporation.

The program places in the front rank, the necessity of assisting financially, in the completion of the Hydro-Electric station on the Jordan River, and the necessary transmission lines to connect the existing Diesel-engine power stations at Tel-Aviv, Haifa and Tiberias. The Palestine Economic Corporation has advised Pincas Ruttenberg, President of the Palestine Electric Corporation, the Company owning the concession, that it is prepared to participate in the completion of the above undertaking to the extent of \$150,000, approximately \$750,000, and is ready to enter into definite arrangements to this end.

The second item in the proposed program is assisting in the building of a certain number of small, standard-sized homes for workers in and around Tel-Aviv, by the side of the ancient city of Jaffa. There has been a serious shortage of housing facilities for workers, and the Palestine Economic Corporation will undertake certain steps to assist in remedying the situation in part, by advancing credits for the building of simple homes, to be constructed in accordance with standards approved by the Palestine Government, these homes to be sold to workers on easy terms, payable over a period of from twelve to fifteen years.

The Palestine Economic Corporation has set apart \$200,000 for this purpose.

EMILE BERLINER, INVENTOR OF TELEPHONE TRANSMITTER. CELEBRATES 75TH BIRTHDAY

Washington, May 22.—Emile Berliner, noted Jewish inventor of the telephone transmitter, the gramophone and the talking machine disc record celebrated his 75th birthday on Thursday.

Mr. Berliner is now engaged in a series of experiments for the invention of "acoustic tiles," said to be destined to revolutionize interior architecture. By means of them the hearing facilities in public gathering places will be vastly improved, it is stated.

During the present year, which is the golden jubilee of the telephone, Mr. Berliner's indispensable contribution to this instrument of modern civilization was recalled. Without his invention, it is said, the telephone would never have been practical.

Another item in the program will be to provide a certain amount of money, \$100,000 to begin with, to be loaned to agricultural and other groups in Palestine for a longer period than is now possible, through the Central Bank of Cooperative Institutions, Ltd., which has its head office in Jerusalem. The funds of the Bank have been limited in the main to loans not exceeding one year in duration, and it is believed important to furnish a certain amount of money to be loaned for longer periods.

The above amount is provided for the first twelve months' activities, and in the opinion of the Executive Committee, sufficient to indicate the feasibility and method of making these loans.

The Committee considered with favor, an item brought to its attention by Mr. S. A. Van Vriesland upon his recent visit to this country, by buying up certain obligations of Jewish farmers to the Keren Hayesod. This will be limited, to begin with, to a small amount to be loaned to those farmers who, after careful investigation, are found to be self-supporting and in a position to begin to pay interest on and amortize their loan. This will make available to the Palestine Foundation Fund (Keren Hayesod) addi-

London, May 22.—Samuel Samuel, Member of the British Parliament, was chosen to preside at the International Parliamentary Commercial Conference which will open in London next week.

More than 200 delegates from many countries are expected to participate in the conference.

ANTI-JEWISH BOYCOTT IS STARTED IN BULGARIA; CONSISTORY COMPLAINS Government Promises to Take Steps Against Movement

(Jewish Telegraphic Agency)

Sofia, May 22.—An official complaint against anti-Semitic agitation and boycott propaganda throughout Bulgaria directed against the Jewish population, was submitted to the Bulgarian government by the Jewish Central Consistory, a Jewish communal organization recognized by the Bulgarian government.

The complaint is directed against the anti-Semitic organization, Rodna Zashchita, which is responsible for the boycott propaganda and which has issued anti-Semitic pamphlets and posters. It is believed that Russian emigres resident in Bulgaria are behind the movement.

The Bulgarian government has promised to take the necessary steps, it was stated.

The Central Jewish Consistory of Bulgaria was the only Jewish communal organization in the world which officially joined the Iyar organization month proclaimed by the World Zionist Organization for the purpose of increasing the membership of the organization. The Consistory issued instructions to all its subsidiary organizations for special lectures on Zionist topics to be held during this month and that special emphasis be laid on Jewish history and Hebrew literature in the schools during the organization month.

23 JEWS TRIED IN LATVIA FOR DEFENSE ACTION AGAINST ANTI-SEMITES

(Jewish Telegraphic Agency)

Riga, May 22.—The trial of twenty-three Jewish residents of the village Warklian is attracting wide attention throughout the Republic of Latvia.

At the trial which started four days ago, the defendants were charged with attacking and beating Latvian students. The prosecuting attorney presented the case in such a manner as to give the impression that this reflected a national conflict between Jews and Latvians, putting forward the accusation that the Jews attack the students because of a "Jewish hatred."

The Latvian Jewish community is greatly interested in the outcome of the trial. One hundred and twenty-seven witnesses were called, including the local clergymen.

The defense is conducted by Professor Lazarsohn, Jewish member of the Latvian parliament, and the German attorney Garnitzki.

The reading of the act of indictment took several hours.

The defense denied the charges made against them. Pastor Racibor-

DENY OTHER JEWS PLAN TO RESIGN FROM WEST- CHESTER-BILTMORE CLUB

Jolson Confirms His Resignation in
"Jewish Daily Bulletin" Interview

Reports that other Jewish members of the Westchester-Biltmore Country Club planned to follow the example of Al Jolson, by resigning, were denied. "The resignation of Mr. Jolson was a personal matter," the representative of Mr. Bowman, president of the club, stated. "He offered it and it was accepted. That is all there is to be said. We have not received any additional resignations, nor do we look for any."

Al Jolson, before his departure for Atlantic City, confirmed his resignation from the club, in an interview with the representative of the "Jewish Daily Bulletin."

Mr. Jolson declared that he regretted that he did not know all the time that the club had a policy directed exclusively against Jews. "I was never made to feel that way," he said.

"I am a Jew and I will always remain a Jew. I was never ashamed of my Judaism. I prided myself on my Judaism at the club, just as I am proud of it at home. If the club does not consider it fit to have Jews as members, I should not be fit for membership either," Mr. Jolson declared he told Roy Jackson, manager of the club.

Asked where the club has made "exceptions" also of other prominent Jews and whether there are other Jewish members in the club, Mr. Jolson stated that he has no information concerning the matter.

76,000 CONTRIBUTORS TO THE UNITED PALESTINE APPEAL IN NEW YORK

Benjamin Winter, Chairman, States
\$1,411,000 Raised from Masses;
Charges Wealthy Jews Have
Failed in Duty to Palestine

A new record in Jewish philanthropy for New York was established in the Greater New York Campaign of the United Palestine Appeal, according to a report issued by Benjamin Winter, Chairman, which reveals that over 76,000 individuals contributed the \$1,411,000 that has been raised thus far in the campaign. The 76,000 contributors to the United Palestine Appeal is almost twice the number of donors to any previous Jewish fund-raising effort in the city. Mr. Winter stated, and represents an increase of about one-third in the number of contributing the Jewish Homeland.

"The average contribution from the New York subscribers to the United Palestine Appeal this year is about \$20," Mr. Winter said, "which is striking evidence of the fact that the great masses of the Jews of New York alone are bearing the responsibility of rebuilding the Jewish Homeland."

"It is sad but true that many of our wealthy Jews who have demonstrated their readiness to give of their means for the purely charitable needs of their people have as yet not appreciated the great historic and moral value of the reconstructive work that Jews are now accomplishing in Palestine. I know well the sentiments and aspirations that actuate the great masses of Jews in Poland and other countries of Eastern Europe and there is no doubt that what they desire is not merely economic relief, but a place of honor and dignity in the world. Such a place of honor and dignity, in which the Jews of the whole world may take a legitimate pride, is now being established in Palestine."

"It is fortunate that the great masses of the Jews of New York who have not yet served the thread of moral kinship with their people on the other side, appreciate these aspirations and contribute of their means to the extent that they can in order to help in their realization. I have not given up the hope that the wealth of our community will also, before long, come to understand this truth. When that happens, the present speedy rate of the upbuilding of Jewish life in Palestine will become even more speedy and Palestine will offer a secure home for hundreds of thousands of Jews who are at present, to all intents and purposes, homeless," Mr. Winter's statement declared.

JOUVENEL WILL GRANT A GENERAL AMNESTY IN SYRIA

Jerusalem, May 22.—A general amnesty will be granted in Syria, according to an announcement of Henri de Jouvanel, high commissioner of Syria, despatches received here state.

The amnesty will be granted on condition that the insurgents cease hostilities within 20 days.

Al Jolson Lauded

The resignation of Al Jolson, the famous Broadway comedian, from the Westchester-Biltmore Country Club, because of anti-Jewish discrimination in that organization, is lauded in the Jewish press.

"Al Jolson deserves no little credit for having had the courage to appear in his 'own color' in defending the Jewish name, which he regards as no less precious than his reputation as an artist," declares Jacob Fishman, in the "Jewish Morning Journal" (May 21).

"It is gratifying to see that a Jew who paints his face black for dollars and cents has preserved the purity of his Jewish heart and acted as a proud Jew," Mr. Fishman observes.

The "Day" writes in a similar tone. "The Jewish pride and self-respect in Al Jolson prompted him," it says, "to do the right thing when he resigned from the club on being told that Jews were not welcome there, although an 'exception' was made in his case."

"No Jew," the paper further remarks, "can feel himself at ease in a society which bars its doors to Jews, and certainly no proud Jew will permit fraternization with him by those who insult the entire Jewish people."

A Suggestion to the Jewish "Would Be" College Men

The tendency of the Jewish "would-be" college men to ignore the less well known colleges of America and go only to the greater universities, such as Harvard, which of recent years have been suspected of anti-Jewish discrimination, is deplored by the "American Israelite."

"It may not be amiss to say a few words to the 'would be' college men," the paper writes in its issue of May 20. "They might be asked: 'What is your object in wanting to go to college, is it for an education, or only for having the label of a college man or for making desirable social contacts?' If going to college is not primarily for the purpose of getting an education, it is hardly worth four years of sacrifice. If, however, the object is to obtain an education, it is not at all necessary to go to one of the greater universities, such as Harvard or Yale, where there may be some question as to discrimination."

"There are a number of other universities where just as thorough an education can be obtained, such as the Universities of Michigan, Chicago, Wisconsin, Illinois, Cincinnati, and a score or more of great institutions of learning, even if less well known. The really earnest students can get as much and as solid an education at any one of these as at Harvard or Yale and probably meet with a great deal more of cordiality from their fellow-students."

U. J. C. PLANS TO EXCEED \$5,000,000 QUOTA BY QUARTER MILLION AT FINAL RALLY

New York Chairman Sends Letter of Appreciation to Rockefeller for Gift

"Over the top by a quarter of a million by Monday night," was the message which was sent by Acting-Chairman David M. Bressler to the 1500 workers in the United Jewish Campaign of Greater New York, urging them to double their efforts to bring the drive to a successful conclusion at the final rally tonight at the Hotel Biltmore.

With the addition of \$100,000 from John D. Rockefeller, Jr., and \$14,000 already reported from collections in various synagogues during the Shevuth memorial services on Thursday, Mr. Bressler announced that the total had reached \$5,901,000, leaving \$99,000 still to be raised to reach New York's goal of \$6,000,000.

Mr. Bressler made public his reply to the letter from John D. Rockefeller, Jr., enclosing his contribution of \$100,000.

"It affords me unusual pleasure to acknowledge, on behalf of the officers of the United Jewish Campaign, your magnificent contribution of \$100,000 to the \$6,000,000 fund we are endeavoring to raise in New York City as part of a national overseas chest of \$25,000,000 for the alleviation of the distress of millions of our co-religionists in Europe, and for reconstruction, medical, cultural, child care, agricultural settlement, refugees and relief in foreign lands.

"We appreciate your gift the more deeply in that it is an entirely voluntary contribution by you, and because as you say, it was not solicited by us. Equally great is our satisfaction that your contribution has been made after an investigation of the plan of distribution of our funds by the Joint Distribution Committee which you have found to be very carefully and wisely worked out.

"But even beyond that, we are profoundly moved by the breadth of spirit which your contribution displays. It is good to have this very concrete evidence that at a time when large masses of human beings are suffering, no barriers of race and creed are strong enough to prevent all humanity from rushing to their rescue," Mr. Bressler's letter read.

AMERICAN EXPEDITION REPORTS UNIQUE FINDINGS IN PALESTINE EXCAVATIONS

Records of Ancient "City of Books" are Unearthed

(Jewish Daily Bulletin)

Philadelphia, May 22.—Continued excavations by the expedition of the American School of Oriental Research in the area of Kirjath-sepher, have unearthed relics dating back to the early bronze age, 2,000 years before the Christian era and have afforded archaeologists a new insight into the times of the ancient Hebrews.

In a letter received here by Professor James A. Montgomery, president of the American School of Oriental Research, Professor M. G. Kyle, head of the expedition, reported that they have dug far into the area of the buried communities.

"I am sure you will be anxious to hear of our success," Prof. Kyle writes. "I will say at the outset that it has been far beyond our general expectations at the beginning, and that after only two weeks' actual digging.

"We have the most desirable field, i.e., best preserved and most typical of old Canaanite and Israelite cities, and history now in our possession runs certainly from the Early Bronze Age, 2,000 or earlier, B.C., down to 300 B.C.

"It thus covers every Canaanite period, from the twelfth Egyptian Dynasty and the whole of Israelite history from the Conquest to the Exile.

"We have at the gateway clearly five periods of building and rebuilding—one Early Bronze, two Middle and Late Bronze, and two Israelite. The city was burned at least three times, once about 1,700 by some unknown to us (at the invasion of the Hyksos into Egypt?), once by Othniel at the Conquest, and at last by Nebuchadnezzar about 600 B.C.

"There was a magnificent wall of Canaanite work, now topped by Israelite work, from 35 to 40 feet in height, about 30 feet of its revetment built against the precipitous side of the mountain, and the parapet, whose heights we cannot yet gauge, as it is all thrown down to the foundation.

"The great quantity of sling bullets attest terrific fighting around the walls and at the Great Temple (?). This latter is a mystery yet. It is quite unique, seems to have been a series of shrines with Matseboth, each shrine enclosed in a room and all united into one temple. But we are not yet sure about this temple. We must wait for further light.

"There is a unique plumbing system, not only for drainage at the gate, which is simple enough, but for a water tank in the great tower at the east gate. The tank is concrete or heavy plaster and a stone pipe, three-inch bore, leads to it. We are tracing this back with the hope that it will lead us to the secret source of water within the walls."

Eleven Graduated From Hebrew Union College

Cincinnati, O., May 22.—A meeting of the executive board of the Union of American Hebrew Congregations will be held here on May 30th and 31st. Appropriations for the work of the Union and all its departments will be made at the meeting where the report of the budget committee will be considered.

Consideration will also be given to the proposed constitution for the Synagogue Council of America of which the Union is a constituent member.

Eleven rabbis will be graduated from the Hebrew Union College in Cincinnati, on May 29th. The baccalaureate sermon will be preached by Rabbi Gerson B. Levi, of Chicago.

Announcement will be made of the results of the efforts of the Sisterhoods' Committee on Hebrew Union College Scholarships to raise scholarships for the maintenance of students at the college during the current year.

NEARLY HALF OF NEWARK'S COMBINED CAMPAIGN QUOTA RAISED AT OPENING DINNER

Newark, N. J., May 22.—With \$285,000 in pledges, this city's joint drive for \$600,000 in behalf of the United Jewish Campaign, the United Palestine Appeal and the local Conference of Jewish Charities, was formally opened at a dinner in the Y. M. H. A.-Y. W. H. A. Building, Thursday night. The actual canvassing for subscriptions among local Jewry will start Monday and will continue until June 2.

The largest donors at the dinner were Louis Bamberger and Felix Fuld, prominent merchants and philanthropists, each of whom pledged \$30,000 or jointly 10 per cent of the entire amount sought.

The principal speakers at the dinner were Dr. Stephen S. Wise, chairman of the United Palestine Appeal, and Dr. Henry Moskowitz, prominent civic and social worker of New York. Both urged unanimous support on the part of local Jewry in the drive. Dr. Moskowitz related personal experiences while on an observation trip through eastern and central Europe last summer. Other speakers were Mr. Fuld, who is the State Chairman of the United Jewish Campaign; A. J. Dimond, chairman of the Initial Gifts Committee of the joint drive, and president of the Conference of Jewish Charities; and Morris Scheck, chairman of the United Jewish Appeal, as the local joint campaign is known.

Women workers in the local drive met at the Progressive Club Friday noon and heard addresses by Mrs. Rebekah Kohut and Irma Lindheim, both of New York.

Among the charitable bequests of the late Simon Simon of Alexandria, Louisiana, who died in December, was one of \$30 to the Jewish Agricultural Society.

DOCUMENTS SHOW KLAN IN CANADA ORGANIZED BY AMERICAN LEADERS (Jewish Daily Bulletin)

Toronto, Can., May 22.—Definite proof that the Knights of the Ku Klux Klan in Canada were organized by leaders in the Ku Klux Klan in the United States is contained in the text of an agreement filed in the Toronto Supreme Court. The agreement, which names the organizers and throws light on the character of the organization, read:

"This Instrument of Agreement made and entered into Dec. 1st, 1924, by and between R. L. Cowan, of Toronto, Ontario, J. H. Hawkins of Newport, Va., and C. Lewis Fowler of New York City.

"Witnesseth that all three parties named above agree to and hereby enter into covenant to launch and to operate the Knights of Ku Klux Klan of Canada and that they agree to launch the work on the first of Jan., 1925.

"That the three parties named above agree that they shall be the first Imperial Officers of the Organization and they shall name the other officers as occasion shall demand and they shall be as the three originating officers, the Provincial Kloneillum or Official Governing body of the Order. They shall be the controlling body and shall occupy the following offices in the body: R. L. Cowan, Imperial Wizard (President), J. H. Hawkins, Imperial Klaliff (Vice President) and Chief of the Staff, and C. Lewis Fowler, Imperial Kligrapp (Secretary) and they shall be equal in all matters pertaining to the work, but the laws of the Organization shall set forth specifically the official obligations and work of each. They agree that they shall be as one in the launching of the movement.

"That the three parties hereto agree to be equally responsible in launching the movement financially and that they each shall take care of his prorata part of the expenses incidently in setting up the organization and that they shall share equally in the income after the organization is set up, determining the salaries to be paid both themselves and to all other imperial officers.

"That C. Lewis Fowler is instructed and authorized to proceed to Canada the first of January and to take such steps, make such moves as shall be necessary in setting up the Organization. In said capacity he shall for all three and his acts are to be official in law until he is joined by all three parties in the work. He is to be paid as to his expenses and is to be allowed a reasonable sum each week for his services in representing the other two parties in the initial work. He agrees to inform both the absent parties in detail about all developments.

"To keep an accurate account of all expenses and expenditures and also all income if any until the three shall meet to perfect the organization. He is authorized to use any income in helping to defray expenses until the three shall meet for the permanent organization and to keep an accurate account of same.

"That this instrument is executed in triplicate and is binding from December

The available cash resources of the Palestine Economic Corporation at this time, consist of certain cash acquired by the Corporation as the result of the merger, a limited number of subscriptions to capital stock at the time of the merger, and a part of the tentative allocation made several months ago by the American Jewish Joint Distribution Committee, of \$1,500,000 out of the then quota of \$15,000,000 of the United Jewish Campaign.

The Palestine Economic Corporation was organized in February, 1923, by a merger of Palestine Cooperative Company, (a subsidiary of the Palestine Development Council), and the Palestine activities of the Reconstruction Committee of the Joint Distribution Committee, the new Corporation having acquired the assets of the other two agencies.

SOVIET REMOVES BAN IT IMPOSED ON YIDDISH POET FOR PRO-HEBREW STAND

(Jewish Telegraphic Agency Mail Service)

Moscow, Apr. 25.—The ban imposed two years ago on David Hofstein, the Yiddish poet, because of his championship of the Hebrew language, was removed today by a unanimous vote at a special meeting of the Yiddish writers in Moscow, called to consider what action to take in view of Hofstein's repudiation of his former views in the letter addressed by him to the Yiddish Communist organ, the "Emess," on his return from Palestine.

During the past two years Hofstein has been under a boycott here. His writings were not published and he could take no part in any social movement. It was this which practically forced him to leave Russia and visit Palestine.

At the meeting, Hofstein repeated the statements he had made in his letter to the "Emess," declaring that he had been mistaken in his views regarding Hebrew, as well as regarding the question of Palestine, and asked that he should be allowed to take part in the building up of a new life for the Jewish toiling masses of Russia under the Jewish colonization scheme.

After a heated debate, a resolution was adopted by the meeting in which it was said that "taking into consideration" Hofstein's letter published in the "Emess" on his return from Palestine and also his statements at this meeting, that he sees his mistake in having signed the memorandum on Hebrew, and that he considers it his duty henceforth to work together with Soviet society which is directed by the Communist Party, this meeting places it on record with great satisfaction that these statements open the road to renewed collaboration with Hofstein, and annuls the previous resolution adopted by the Jewish writers and cultural workers concerning Hofstein."
