## SCHECHITA PROHIBITION PLANNED IN NORWAY

French Grand Rabbi Protests; Jews  
Will Leave Country If Measure  
Passes, It Is Stated

(Jewish Daily Bulletin)

Oslo, Norway, June 10.—The Parliament is expected soon to adopt a law prohibiting the Schechita, the Jewish method of slaughtering animals. Agitation toward this end is being conducted by various farmer organizations. Recently representatives of the Parliament demanded admission for personal inspection in the Jewish slaughterhouses.

Orthodox Jews are protesting and declare they will leave Norway if the prohibition measure passes.

Norway's severe climate demands the eating of meat. It is impossible to import fresh kosher meat during the summer.

Paris, June 10.—Commenting on the despatches that Norway is planning to prohibit kosher meat, Dr. Israel Levi, Grand Rabbi of France, declared the proposed measure was arousing great indignation among Jews in France, who have sent letters of protest to the Orthodox Government.

"The pretext given is that slaughter by jugulation is cruel," he said, "but any slaughter is cruel, and it is to be feared that other and less worthy motives are involved. The number of orthodox Jews in Norway is very small, and it would be regrettable if they should be subjected to official persecution," he stated.

## SCHWARTZARD COUNSEL PROTESTS SANITY PROBE

Zionists of Eastern Galicia Threatened  
in Anonymous Letters

Paris, June 10.—A protest against the examination of Sholom Schwartzbard's mental condition was made by his attorney, Henri Torres. Schwartzbard declared that he acted with full knowledge and that he has assumed full responsibility, his attorney stated.

When interviewed by the correspondent of the Jewish Telegraphic Agency, M. Torres declared that he alone will conduct the defense of Schwartzbard. "My defense will be more in the nature of a prosecution," he said. "I will accuse the world-wide

## DISTINGUISHED BRITISH VISITOR OBSERVES SOCIAL ANTI-SEMITISM IN UNITED STATES

Scores Jews Who Desert Fold Because of Ostracism; "Earn Contempt of Kin  
Without Gaining Admiration of Others," he says; Palestine  
National Loan is Possibility. Declares Alexander Lyle-Samuel

Interesting observations concerning Jewish life in England and the United States, and the prospects of the development of Palestine, were expressed by Mr. Alexander Lyle-Samuel, representative of the Panama Corporation and former member of Parliament for the Liberal Party, when interviewed yesterday at the Hotel Ambassador by a representative of the "Jewish Daily Bulletin."

The interviewer called upon Mr. Lyle-Samuel in the belief that he was a member of the famous Jewish family of Samuel. He was delighted to learn however, that although Mr. Alexander Lyle-Samuel is not of Jewish origin, he is intensely interested in and well-posted on Jewish affairs.

Mr. Alexander Lyle-Samuel readily expressed his views on the question of the development of Palestine, on anti-Semitism in the United States as it finds expression in social discrimination in comparison with the lack of such discrimination in the high social circles of England, on the unfounded charges of anti-Semitic agitators, and on the disloyalty towards Judaism displayed by certain Jewish families in the United States.

"I have been greatly surprised at the strong anti-Semitic sentiment which I have observed in the high social circles in the United States. I have observed that many members of these circles will avoid social intercourse with Jews. I was made to understand by some of my friends that if I wanted social intercourse with Jews I would have to forego meeting them together with my non-Christian friends. In attending social affairs I have found the company made up of either only Jews or only non-Jews. I personally have many Jewish friends in the United States and count myself fortunate and privileged in this.

"This social discrimination which I observed in this country is absent in England, where social intercourse with Jews is taken as a matter of course. No one would question the religion of a guest at a social gathering. Religious prejudice is very low in England. A Jew, Rufus Isaacs, has become the first Jewish Marquis in England—a title which is next to a Duke, or nearest to royal blood. He will soon receive the Order of the Garter, which is the highest order in our country. These honors have been conferred upon Reading without consideration of his religion. The only question was whether his achievements merited such distinctions. If they did, no anti-Jewish prejudice could have any weight. We

Britishers can no longer be stirred by racial or religious prejudice.

"I have found that in the United States the scions of a few prominent Jewish families have attempted to escape social ostracism by adopting the Christian faith. As far as I could observe, they have earned by this step only the contempt of their own community, without gaining the admiration of the community they have sought access to.

"This world, while it should be looking forward derives its strength mainly from the traditions of the past. There is nothing of greater value to the future progress of this world than the traditions of the past, no matter what these traditions may be. It is particularly true of the traditions of the Jewish people, with their manifold contributions to civilization and culture. If the Jews, whose service to the world equals that of any other nation—in science, literature, etc., were to be extinguished, it would be a serious loss to mankind. I am surprised the Jew does not realize that he is heir to one of the oldest traditions and races of the world which justifies his being proud of his forefathers' history and culture.

"Viewed from this angle I was amazed to observe that a number of socially prominent Jews in the United States, out of social ambition, have even embraced Catholicism. I have always considered Catholicism as the last re-

**AUSTRIAN HAKENKREUZLER  
ACTIVITIES HAVE CEASED,  
VIENNESE EDITOR DECLARES**  
N. M. Rocker, "Wiener Morgenpost"  
Editor, Here

The Hakenkreuzler, the anti-Semitic organization which threatened the safety of the delegates to the Zionist Congress in Vienna last year and was responsible for many anti-Jewish riots, is practically dead, declared N. M. Rocker, editor of the "Wiener Morgenpost," the first Yiddish daily in Austria, on his arrival in the United States yesterday.

The Austrian Hakenkreuzler received their support mainly from Germany and Hungary. Now when the Hungarian anti-Semites have suffered defeat because of the discovery of the counterfeiting plot, the Austrian anti-Semites have lost their source of support and their activities have stopped. Mr. Rocker declared.

In general the political situation of the Jewish community in Austria is very favorable, he stated. Mr. Rocker will visit his uncle, Mr. S. Rocker, editor of the Cleveland "Jewish World."

**LEOPOLD JESSNER, FAMOUS  
GERMAN JEWISH PRODUCER,  
WILL COME TO THE U. S.**

Berlin, June 10.—Leopold Jessner, director of the Staatstheatre and most famous producer in Germany, has accepted the invitation of the Theatre Guild in New York to come to the United States next fall.

Mr. Jessner is a devoted Jew and is affiliated with the Zionist movement.

A farewell luncheon will be given today at the Hotel Pennsylvania, in honor of Judge Harry M. Fisher of Chicago, who is sailing for Palestine to survey the Jewish colonization program being carried out to develop the country as the Jewish homeland. Leaders in the Zionist movement will be present. Dr. Stephen S. Wise will be the chairman. Judge Fisher has been one of the leaders in the United Palestine Appeal campaigns in Chicago and the Middle West and the luncheon is being given in recognition of his services during the past year.

**ZIONIST EXECUTIVE DEMANDS  
TO LEAGUE ARE INADEQUATE,  
REVISIONIST LEADER STATES**

Vladimir Jabotinsky Analyzes Weizmann's Letter; Document Contains Important Admissions, He Says

The reaction of the Zionist Revisionists, the oppositional group within the Zionist movement, to the steps now taken by the Zionist Executive in its presentations to the Permanent Mandates Commission of the League, was expressed in a statement issued yesterday by Vladimir Jabotinsky, leader of the League of Zionist Revisionists, who is now in the United States.

"The Memorandum of the Zionist Executive to the Mandates Commission and Dr. Weizmann's accompanying letter can be analyzed from three points of view: 1) as to whether they give a true picture of the situation in Palestine; 2) whether they contain the necessary demands; 3) what could be done in case the demands, such as they are, are not granted," Mr. Jabotinsky declared.

"As to the picture of the Palestine situation, we cannot judge whether it does full justice to reality until we have seen the complete text of the Memorandum. But even the portions already published in America contain some interesting admissions. For instance: "Land values show a constant tendency to rise. . . . It follows that the more land the Jews acquire and the more improvements they carry out, the higher is the level to which they are in effect raising prices against themselves. . . . The result (is) that numbers of immigrants who have come to Palestine with the intention of starting a new life on the soil have up to the present been unable to do so." This admission disposes of the usual cant that the cause of the slump in our rural colonization is only in the slackness of the Jewish financial response.

"Other interesting admissions: though the Executive made an application for State land in the South a year ago, 'this application has not, up to the present, had any definite result.' In general, the Zionist Organization is hampered in 'taking the initiative' of such applications, because 'its information as to the actual limits of the State lands, and the degree to which they are available, is necessarily (?) less complete than that which is in the possession of the government' which means that even an elementary courtesy as to give the Jewish Agency statistical data has either been refused—or never asked for. And as to the unfortunate Frontier Force, Dr. Weizmann cannot even hold out a definite hope that Jews will be sufficiently represented on it; he only feels sure that the Mandatory Power will appreciate the legitimate desire of the Jewish population to take a corresponding share in the defense of Palestine." We already know, from another cable in the "Jewish Daily Bulletin," that all the share allowed to the Jews in the Frontier Force is 28

**The Achievement of the Philadelphia Federation**

The significance of the Philadelphia Federation of Jewish Charities in the social, philanthropic and civic life of that city, is discussed by the Philadelphia "Inquirer," on the occasion of the celebration of the Federation's twenty-fifth anniversary.

"The Federation," the paper declares, "embraces practically all of the Jewish charities, it has a membership of 20,000, and it raises something like \$1,500,000 annually. Thus, relatively speaking, it has taken its place in the forefront of all such movements in this country.

"It is gratifying to know that this large sum of money is spent for the relief of suffering regardless of creed, color or other conditions. It is a significant fact, for instance, that the patients at the Jewish Hospital are nearly 65 per cent non-Jews.

"It is amazing," the "Inquirer" concludes, "to see how much welfare work can be accomplished by cooperation and systematic giving, and in doing this so freely and generously the Jewish Federation is entitled to the thanks and the hearty good will of the people of Philadelphia."

**The Report of the U. S. Department of Commerce on Palestine**

The recent report of the United States Department of Commerce regarding conditions in Palestine, is commented on by the Paducah (Ky) "News-Democrat," which observes:

"The reconstruction by this scattered people, of their ancestral home must be an extraordinary thing to watch, judging from the Commerce Department's account. Not, indeed, that the department makes any attempt at a picturesque handling of the subject. It's simply a dry commercial report, but in order to give a proper idea of the country's business possibilities, the department's investigators do find it necessary to make some reference to the settlers' accomplishments in the last few years. That they have done so much is all the more remarkable in that they got away to an unfavorable start."

The Staunton (Va.) "News," writing on the same subject, says:

"Probably few persons in this country noted facts and figures made public recently by the Department of Commerce dealing with developments in the Holy Land. Yet if they could be read with proper understanding of the background they would be found to be a stirring section in one of the most romantic stories that followed the peace of 1919, the attempt to create a great Jewish community in Palestine."

fige of the doubter. If I were to lose all faith, I would swallow the Catholic text book. Rather than be an atheist, I would believe the unbelievable and prostrate my judgment before the incredible.

"I must say that I have found that those Jews who rank highest in the Jewry of America have not followed this example, and have remained faithful to their fold.

"I know of the agitation Henry Ford has put forward in this country. I have high regard for what Henry Ford is, but I am not confused about him when he changes from the mechanical genius to the childish political prophet and the medieval cherisher of ancient grudges. It is fortunate for him that his cars are more up-to-date than his ideas on religion.

"In business I happen to be closely affiliated with various enterprises which specialize in all kinds of essential metals. The accusation levelled by Ford against Jews, that they monopolize a number of essential metals is absurd. The Jews undoubtedly play a prominent part in the international market of certain metals. I merely want to mention the Guggenheims and the English Rothschilds in regard to zinc and copper, the British Joels with regard to gold and diamonds and the Samuels in the silver industry, but I have found the Jewish influence in no way detrimental, either to the producer or the consumer. Quite the contrary. The Jew has a particular inclination for going into the market of such products of unfixed value, while the non-Jew is inclined to deal with commodities of fixed value. This speaks for the enterprising spirit with which the Jew is imbued.

"There is in this regard a similarity between the Jew and the Englishman. We are both willing to go to distant corners of the world, and risk without being gamblers.

"I believe deeply in the future of the Jewish race. I was always interested in their attempts to rebuild Palestine as the Jewish national homeland. As a member of Parliament I supported the Balfour Declaration, and I have done my bit toward obtaining parliamentary support of the policy embodied in the Declaration. Sir Alfred Mond, who is one of the ten outstanding men in our country, is directly interested in the rebuilding of Palestine.

"The British Parliament would readily give its moral and financial support to the Zionist ideal, but the difficulty arises out of the fact that the Jewish community in Britain is divided on the subject. If a British Parliament were convinced that the Jews are united in this matter, their support would be stronger.

"I was interested to learn of the attempts with regard to a Palestine national loan. The Jewish people have won the admiration of the entire world for their enterprising spirit and their admirable method of taking care of

their own and it may be assumed that Jewish financial houses would issue it. Nevertheless, I believe that if the loan offered were economically sound, British financiers would not hesitate to participate on its merits. Money knows no racial prejudices.

"The outlook of the world has changed radically in the last hundred years. It is literally a new world within this century. The rapid means of transportation has made this a communicative world and cancelled distances and reached beyond space. Peoples who are now compelled to reach each other must be compelled to understand each other by realizing that all the fruits of the earth are in the same soil and have the same economic roots. The modern methods of cabling, of transportation, the miraculous means by which even photographs made in London can on the same day appear in American newspapers—all this has made all parts of the world neighbors. Now we must learn to be neighborly. For example, in rural life as it existed a hundred years ago in England, which until the introduction of steam had not changed for centuries, communities could reach each other only after days of travel. Each, therefore, remained a world in itself. Now, they move in minutes and share in national and world thoughts. Hours make an interminable journey. Transmutation and transference have resulted.

"In such an atmosphere a spirit of intolerance is indeed an anachronism, and must disappear. The Jew can play a particularly important role in the process of international consolidation and world peace because, being scattered over every part of the world, yet joined as one great family, the Jews can help bring about a better understanding among the nations of the world and carry everywhere their enriching gifts," he concluded.

Alexander Lyle-Samuel was a Liberal member of Parliament from Eye Division of Suffolk in 1918. He is the son of the late Rev. George Samuel of Christ Church, Aston, Birmingham. He was born in 1883 and was educated at King Edward's School, Birmingham, and Cambridge. He is a member of the Honorary Society of the Middle Temple. He has travelled extensively in America, residing in the United States from 1913 to 1915 when he returned to England to serve in the War, where he was a Lieutenant until 1917, then being invalided out.

## JEWISH PROFESSOR WILL BE MAIN SPEAKER AT MEMORIAL SERVICES FOR GARIBALDI

The Italian Patriotic Association, Alma Roma, presented Professor Pavia with a gold medal in recognition of his patriotic services.

## KLAN PARADE AT SESQUI IS TO DEMONSTRATE ITS POWER, ORGANIZER STATES

Philadelphia, June 10.—Paul M. Winter, Ku Klux Klan organizer for Philadelphia county, announced today that "Senators, Governors, and other civic and patriotic leaders from all over the country" will speak at the national klonvokation here September 9, 10 and 11.

Details of the klonvokation are being planned at a secret headquarters in this city. Winter, in explaining why the address of the headquarters is kept secret, said Klan officials "don't want every person who has an enemy calling on them to right wrongs or mingle in their difficulties."

An interesting disclosure in connection with the parade the Klan will stage September 11 through the city and the Sesqui-Centennial grounds, is the fact that many foreign-born Americans, of the Protestant faith, are expected to be in the line of march as members of a branch of the Klan known as the American Crusaders.

There is a good deal of speculation in this city as to how many persons the Klan will be able to muster for the parade, and it is no secret that the officials of the Klan are making every effort to get as great a turnout as possible, to refute rumors of waning strength.

From Sesqui-Centennial officials it was learned the Klan will be compelled to unmask during the parade.

"The Klan, like the Shriners or any other civic or patriotic group will receive the same courtesies during their convention that we accord to all," said A. L. Sutton, a Sesqui official.

According to Winter, the "Senators and Governors" who will speak at the Klan sessions will also march in the parade.

"During the march," said Winter, "not a man, woman or child in the ranks will be allowed to speak. The marchers will look straight ahead, and it is my confident expectation that the country will be surprised and enlightened at the real meaning of our organization."

Among the speakers will be Hiram Wesley Evans, Imperial Wizard of the Klan. Americanism is to be the theme of the three-day session, according to Winter. A new Wizard also will be elected.

## CZORTKOW REBBE WILL SETTLE IN PALESTINE: COLONY BEING PLANNED

Vienna, June 10.—Rabbi Israel Freidman, the Czortkow rebbe (Chassidic rabbi) will settle in Palestine in a colony which is being founded by his adherents, it was learned here today.

The adherents of the rabbi plan to acquire a strip of land amounting to 1,000 dunams in the Valley of Jezreel. The colony will be named Beth David in memory of Rabbi Friedman's father, the famous Chassidic rabbi.

(twenty-eight) men out of 750 (seven hundred and fifty).

"This shows that Dr. Weizmann has totally failed in his recent negotiations with Lord Plumer on this subject. And, evidently, not only on this. Presumably, the President of the Zionist Organization did also inquire—at least we hope he did—what the High Commissioner intends to do about that one year old application for land in the South—and now he has to complain to the League that there has been no definite reply.

"How, after all that, Dr. Weizmann and his lieutenants can tell us that the political situation in Palestine 'has never been so favorable' is a mystery.

"As to the demands formulated in Dr. Weizmann's letter, they are hopelessly inadequate. Apart from the request for land in the South (he does not say how much) Dr. Weizmann asks for a few odds and ends of the Beitran area which the Arabs may prove unwilling to use. The main problem, the utilization of all the waste lands of Palestine, especially of those privately owned by absentee landlords (the wasted area of Palestine is official 17 million dunams, of which only one-seventh belong to the State)—the question of an Agrarian Reform is not mentioned at all. Nor does Dr. Weizmann's letter mention the plight of our industry which, owing to absence of adequately protective tariffs, has recently led to closing down of important factories. The resolution of the Vaad Ha-Leumi that, in view of the totally non-Jewish character of the Frontier Force, a Jewish military unit should be created is simply ignored in the President's letter. Two more things for which he definitely asks are: an increase of the school grant from 8% to 12% of the official educational budget (a matter of some ten or fifteen thousand pounds) and the right to put boughs along the Walling Wall on Yom Kippur.

"These, apparently, should be all the remedies needed to combat the land speculation, the retention of industries, the impossibility of a large immigration (admitted by Dr. Weizmann himself in his Tel-Aviv speech) and the lack of security of a country whose order is guaranteed by one thousand British soldiers and an Arab Frontier Force and a Police of about hundred Arabs and only two hundred Jews.

"The President's letter is a singular exhibition of a total lack of any constructive program.

"What can be done if even these scanty claims are not granted? Nothing. The present Executive has cut out every last even imaginable way of obtaining for our people. The only court of appeal is public opinion, but you cannot stir public opinion by a request for a tiny area, for 15,000 pounds of school grant, for boughs along the Walling Wall. Public opinion can only be stirred by demands containing real facilities for a

### HOLDS CONVENTION

Fraternity Works for Inter-racial Amity, Alfred M. Cohen States (Jewish Daily Bulletin)

Kansas City, Mo., June 7.—Plans to advance the work of the Independent Order B'nai B'rith in District No. 2 and throughout the United States during the coming year by increasing its membership and participating in a national drive instituted by the Constitution Grand Lodge for two million dollars for the extension of activities not provided in the regular budget were approved by the convention of District Grand Lodge No. 2, which held its annual convention here.

A campaign for \$1,500,000 to be raised by Districts Number 2 and Number 6 for a new site and buildings for the Orphan Home at Cleveland was also endorsed. District 2 includes eight western and mid-western states.

Judge A. B. Fry, of St. Louis, president of the District, reviewed the activities of the organization for the last year, following an address of welcome on behalf of Kansas City by Hon. Albert I. Beach, city manager.

Judge Fry submitted to the delegates suggestions from the membership for the welfare of the Order. Among these were the suggestions that B'nai B'rith Lodges take a greater interest as Lodges, in communal affairs, particularly in Jewish communal affairs, and that a plan for formal noon day meetings be adopted, in order that numerous Jewish leaders whose widespread communal activities make attendance at evening meetings difficult, may be enabled to participate in I. O. B. B. work.

Alfred M. Cohen, national head of the B'nai B'rith, was guest of honor at the convention banquet. Mr. Cohen and Dr. Boris D. Bogen were the principal speakers. In his address Mr. Cohen told how the I. O. B. B. was helping to bring about inter-racial and inter-religious amity.

"By cooperating with the Federation of Christian churches, we are trying to reach the sponsors' cost of misunderstanding," he said. "In some cases a lay has been set aside for joint meetings of Catholics, Jews and Protestants in a synagogue, one of our organizations goes in a body to a Methodist church for services, and in regard to the Methodist congregation work on synagogues. By radio talks, speeches and lectures, we are gradually coming about a better understanding.

An increase of fifteen hundred new members during the last year was reported to the convention.

less immigration, of which the Agrarian Reform is the main one.

Dr. Weizmann has recently emphasized in his Palestine messages that the government is at fault but the failure is due exclusively to the Jewish people which has not given enough money. The Renter Agency has published this statement throughout all over Europe, so that now everybody 'knows' that the Jews have only themselves to accuse for any failures in Palestine."

criminal, anti-Semitic movement. I shall defend Schwartzbard who is my brother Jew and who was my brother-in-arms with all my strength and faith.

"I cannot prophesy what will be the verdict of the jury, but I have great confidence in French justice and the conscience of the French people," he declared.

The trial preliminaries will take four to five months, it was stated.

Warsaw, June 10.—Anonymous threats were received by the Zionist Organization of Eastern Galicia in connection with the Petlura assassination, despatches received here state. Anonymous letters directed to the Zionist Organization demanded that the Jewish press in Poland stop publishing articles against Petlura and his pogroms.
