

ROUMANIAN JEWS WILL DECIDE NATIONAL PARTY QUESTION BY PLEBISCITE

**Union of Rumanian Jews Opposes
Formation of Separate Party**
 (Jewish Telegraphic Agency)

Bucharest, June 25.—The question whether Jews in Roumania are to form a separate national political party which would urge Jewish voters to exercise their franchise in favor of Jewish candidates, members of the party, will be submitted to a plebiscite. The plebiscite will be conducted by the Union of Roumanian Jews.

This statement was made by Horia Karp, noted Roumanian journalist, and a leading member of the Union of Roumanian Jews in an interview with the newspaper "Politika."

"I have no faith in the successful work of a Jewish national party in Roumania. The Union of Roumanian Jews will submit this question to a plebiscite of Roumanian Jews for their decision. If the voters decide on the formation of a Jewish national party, we will submit to this decision," Mr. Karp declared.

PUNISHMENT OF CAPTAIN FOR HANDSHAKE WITH JEW CAUSES LATTER'S SUICIDE

Bucharest, June 25.—Jancu Fishman, a Jewish soldier in the Roumanian army stationed in Bucharest, committed suicide yesterday. The reason for his suicide, it was declared, was that he was sentenced to four days disciplinary confinement. However, in a letter left by Fishman, he declares that the reason for his suicide was that he was subjected to persecutions because he was a Jew.

In his letter Fishman relates that the colonel of his regiment sentenced a captain in the regiment to several days disciplinary confinement because he "conducted himself unworthily by shaking hands with a Jew," referring to Fishman.

MINNESOTA SUPREME COURT WILL DECIDE ON READING OF BIBLE IN PUBLIC SCHOOLS

Duluth, Minn., June 25.—The Minnesota State Supreme Court will soon be called upon to decide whether the reading of extracts from the Bible in public schools is contrary to the constitutional rights of certain individuals in Minnesota.

Briefs have been filed in the high court for the case of Max Kaplan, against the independent school district of Virginia, where extracts from the Bible have been read to the pupils.

The school board of that district a year ago authorized the purchase of the King James version of the Bible with permission for the school super-

FIERY CROSSES BURNED IN PHILADELPHIA AS PROTEST AGAINST BAR FROM SESQUI

**Maryland Grand Dragon of K.K.K.
Resigning, Condemns Order**
 (Jewish Daily Bulletin)

Philadelphia, Pa., June 25.—Fiery crosses were burned Wednesday night on the outskirts of the city by Klansmen in protest against Mayor Kendrick's order cancelling the proposed Klan celebration at the Sesqui-Centennial Exposition. The demonstration took place not far from the place where a wayside Catholic shrine was burned a few nights ago.

Mayor Kendrick cancelled the permit issued to the Klan for a three-day celebration with the announcement that such a demonstration would be "dangerous" and contrary to the spirit of the Sesqui-Centennial. The Mayor stated he had not been informed the Klan had been given a permit.

"The Mayor's statement regarding his knowledge of the intended event is untrue," said Paul M. Winter, Kleagle of the Ku Klux Klan in this city. "I will publish, within the next few days, photostatic copies of correspondence between us and signed by him which indicates he did approve of the Klan plans at one time."

Mr. Winter has appealed to the national officers of the organization in Washington for advice, as a consequence of Mayor Kendrick's action, it was stated.

PALESTINE ECONOMIC CRISIS DISAPPEARING, SEPHARDIC CHIEF RABBI, MEIR, STATES

**Welcomed in Roumania on Way to
Carlsbad**

(Jewish Telegraphic Agency)

Bucharest, June 25.—The opinion that the economic crisis in Palestine is disappearing and that the political situation there is good was expressed by Rabbi Jacob Meir, Sephardic Chief Rabbi of Palestine, who disembarked at Constanza on his way to Carlsbad.

A delegation of Jews and non-Jews, headed by Rabbi Schechter and Priest Gregorescu, welcomed the Palestinian Chief Rabbi. A banquet in his honor was arranged by the Jewish community of Constanza.

When interviewed by the correspondent of the Jewish Telegraphic Agency, the Chief Rabbi stated that the political situation in Palestine is good, that the administration of Lord Plumer has not disappointed Palestine Jewry and that the economic crisis is disappearing. Asked concerning the existing relations between the Sephardic and Ashkenazic Jewish communities, the rabbi stated that these relations were excellent.

JEWISH LABOR DELEGATES CLASH IN OFFERING VIEWS TO MIGRATION CONGRESS

**Bund Delegate Scores Western Labor
Organizations**

(Jewish Telegraphic Agency)

London, June 25.—The plight of the Jewish working masses in Eastern Europe, unable to find employment in their native countries and prevented from finding new homes by the existing bar on immigration in overseas countries, was presented to the World Migration Congress in session here.

In making these presentations a clash between the views of the Jewish Socialist Labor Party, Bund, and the Poale Zion, the Zionist Socialist party occurred.

In arguing his amendment which asks the world Migration Congress to urge the principle of free migration upon the respective governments, Mr. Victor Alter, a delegate representing the Jewish labor party, Bund, in Poland, declared:

"I am speaking in the name of the majority of Jewish workers in the Republic of Poland, one of the chief countries of emigration. We are unable to understand the opposition of organized labor to immigration because of its desire to safeguard its own position. Why should we be left in our state of misery, because you desire to be prosperous? Where is your workers' solidarity if those who are in the most tragic position are to be sacrificed. If migration presents no solution to the problem, then it is the duty of international labor to remove the causes which compel the workers to emigrate. The

JUDAISM AND EVOLUTION DO NOT CLASH, CONFERENCE OF AMERICAN RABBIS TOLD

(Jewish Daily Bulletin)

Asheville, N. C., June 25.—That Judaism does not clash with evolution and science was the assertion made by Prof. Harry A. Wolfson in his address on "Judaism in Relation to Philosophy and Science" before the convention of the Central Conference of American Rabbis here. Dr. Wolfson occupies the Littauer Chair of Jewish Literature and Philosophy at Harvard University.

Judaism from its very beginning was based upon two principles, Prof. Wolfson declared. First, the Bible as the inspired work of God; second, the freedom of interpretation of the text of the Bible in accordance with the changes in scientific and ethical views. The Bible in its legal part was never taken by Judaism literally, he stated.

From the earliest time, Judaism adapts the legislation of the Bible to the altered conditions of the time, and similarly in its religious views, Judaism interpreted the Bible in accordance with the scientific ideas of the times, Prof. Wolfson stated.

This free interpretation of the Bible started long before the Christian era and has continued uninterrupted through the ages. One of the problems that confronted Judaism at the very earliest time was its nature and relation to the universe and the origin of the universe, and with the scientific ideas contributed through the teachings of the Greek philosophers and scientists. This problem is similar to that with which modern man is confronted, he declared.

The Conference considered the problem of religious education and heard the report of Rabbi David Phillips.

This report, like that of the Committee on Church and State, which was presented by Rabbi Edward N. Calisch, of Richmond, Va., stressed the need of religious education outside of the schoolhouse, without, however,

Zionist Revisionists Tender Him

Vladimir Jabotinsky, leader of the League of Zionist Revisionists, will sail for Europe on July 3, following a five months stay in the United States where he was active on behalf of the League.

Before sailing, Mr. Jabotinsky will be the guest of honor of a dinner tendered to him by the League of Zionist Revisionists of America, on July 1, at Libby's Hotel, New York. A special program has been arranged. Joseph Cherniavsky, the well known cellist and his Orient band is included in the musical part of the program.

DAVID TRIETSCH ARRIVES

David Trietsch, well-known authority on Palestine and on Jewish colonization, arrived Friday on the Mauretania. Mr. Trietsch has written several books treating with various aspects of Palestinian colonization. He is the author of the "Palestine Handbook" which appeared in a number of languages, "Jewish Immigration and Colonization" and the "Economic Atlas of Palestine."

The Temple on the Heights, of Cleveland, Ohio, which was dedicated in March, will celebrate the sesqui-centennial of the Declaration of Independence with flag raising exercises on Sunday, July 4.

Rabbi Abraham Nowak, the rabbi of the congregation, together with H. H. Canfield, he manager of the Township of Cleveland Heights, will raise the flag for the first time over the Temple on the Heights.

in any way joining the public school with the religious institutions.

"The American principle of the separation of church and state," said Rabbi Phillips, "is too basic and sacred for us to countenance any attempt to violate it. The essential problem, therefore, is to find time during the week for additional hours for religious instruction and at the same time not to weaken this underlying principle of American freedom."

Rabbi Louis L. Mann of Sinai Congregation, Chicago, Chairman of the Religious Education Committee for the Conference, pointed out that the function of his committee is to keep the members of the Conference informed as to the latest method in pedagogy and showed how far and in what way it could be utilized in Jewish religious schools, first, in the teaching of Jewish history; second, in forms and ceremonies; third, in presenting Biblical material.

Rabbi Barnett R. Brickner, of Cleveland, Dr. E. G. Aaron, of Cincinnati, and Rabbi Joseph L. Baron, of Davenport, Iowa, assisted in the presentation of the work of the committee.

Dr. Mann also arranged an exhibit of the best text books dealing with the project method in education.

Suggests Revision of Revisionism

The opinion that if Zionist Revisionism would revise certain features of its own program, its fundamental principle would become acceptable to many Zionists, is expressed by the "Jewish Daily News," which writes on The Sound Elcment in Revisionism, in its issue of June 22.

Tracing the causes which led to the rise of the Revisionist movement, the "Jewish Daily News" observes: "If Revisionism would not talk about a Jewish Legion, which is an absurdity, and about taking away land from the present owners, a propaganda which is very harmful to us—then the Revisionist party would have a chance of becoming a big oppositionist, perhaps even the leading, party in Zionism. But even now, when Revisionism has shackled its own feet with the demands for a Legion and land expropriation, it nevertheless has a power of attraction because of its sound kernel—the demand for a firmer policy in regard to England. There are some who believe that Weizmann's firm tone in his recent letter to the Mandates Commission of the League was a result chiefly of the fact that the Revisionists made the issue regarding Weizmann's weak policy more burning than it had been before."

Baltimore "Sun" on the Klan

The board of directors of the Sesqui-Centennial celebration has acted wisely in revoking the permit granted the Ku Klux Klan to hold a parade in the grounds and use the auditorium for meetings, declares the Baltimore "Sun" of June 24, remarking:

"It hardly seemed credible that at a celebration held to commemorate the anniversary of the Declaration of Independence honor would be done an order which bases its creed on denial of the fundamental principles contained in this promulgation and whose activities are so repugnant to the aims of the government its signers sought to establish."

Referring in another editorial to the announcement, made, according to the paper, "not furtively, but openly and loudly," that the Grand Dragon of the Ku Klux Klan of Maryland has resigned his office, owing to disagreement with the national officers of the Klan, the Baltimore "Sun" observes:

"It is quite obvious that up to the present the Klan has not prospered in the Free State. The number of Maryland Nordics willing to fork over ten dollars has been small. The Klan has languished except in the outlying bucolic districts. Even the antics of the hundred per cent Nordics in the pulpits have not served to steam up the movement."

TWENTY-NINTH ANNUAL ZIONIST CONVENTION OPENS IN BUFFALO TODAY

600 Delegates Expected; Louis Lipsky, in Report, Terms Last Year Triumphant in History of Zionism in America; Reviews Period of Controversial Issues in American Jewry; Jewish Agency Must Remain Goal of Zionist External Action, Lipsky Declares, Urging Intensification of Zionist Sentiment

Buffalo, June 25.—The twenty-ninth annual convention of the Zionist Organization of America, the largest body of Zionists affiliated with the World Zionist movement, aiming to establish in Palestine the Jewish National Home, will be opened in the presence of 800 delegates on Sunday at the Hotel Statler.

The convention will be opened at 1 P. M. with greetings by state and city officials and members of the Buffalo reception committee. The address of Mr. Louis Lipsky, chairman of the Zionist Organization, the annual report of the Zionist Organization, submitted by Meyer W. Weisgal, Secretary, and addresses by Miss Henrietta Szold on the Hadassah; on American Association for Jewish Culture and Education, by Professor Nathan D. Isaacs; on the Histadruth Ivrit, by Abraham Goldberg and on the United Palestine Appeal by Emanuel Neumann will occupy the first session of the convention.

Representatives of Zionist districts and Jewish communal workers from all parts of the country are expected to assemble here to participate in the deliberations and discussions of the convention, which follows a year of intensive activity in the Zionist movement, following the successful conclusion of the United Palestine Appeal, in which the largest sum ever obtained for Zionist funds in the United States, was raised.

The number of members affiliated with the Zionist Organization of America is now 71,226, representing an increase of 6,962 over last year, according to a report which will be submitted to the convention. Of this membership, 37,185 are enrolled in the Zionist Organization, 29,492 in Hadassah, the Women's Zionist Organization, and 4,549 in the Order Sons of Zion, fraternal body affiliated with the Zionist Organization.

Lipsky Terms Year "Most Triumphant in History of American Zionism"

The "most triumphant year in the history of Zionism in this country," is the way in which the annual report of the Zionist Organization of America, made public by Louis Lipsky, Chairman, on the eve of the twenty-ninth annual convention in Buffalo, sums up the preceding twelve months of Zionist activity, which are also characterized as among the "most difficult" in the annals of the movement.

The report contains frequent reference to the last year's controversy between Zionists and non-Zionists on the subject of the Russian colonization plan in connection with the inauguration of the United Jewish Campaign and the United Palestine Appeal.

"It may be openly said," declares Mr. Lipsky, "that at no other period was the organized movement in America faced with so crucial a situation, by reference not only to Palestine and to the Dias-

pore at large, but in the light of local circumstances. As a test of the strength of Zionism nothing more searching could have been deliberately devised. The issue has been one which makes the twenty-ninth annual convention a celebration as well as a preparation for larger tasks."

The difficulties which the Organization met as enumerated in the report, were the economic collapse of Eastern and Central European Jewry, cutting down the flow of private capital from immigrants going to Palestine with their own money, and likewise making a shortage of public funds expected for the various Zionist colonization agencies, which the success of the United Palestine Appeal overcame, the report states. In America the Organization was faced with the Russian colonization plan launched in connection with the relief campaign, which through the publicity accorded it, became "an assault on the one colonization ideal which for two generations has been the subject of Zionist endeavor—the rebuilding of the Jewish Homeland," the report states.

Emphasizing that the Zionists "greeted with satisfaction" the revival of relief activities for the Jews of Eastern Europe, the report points out that the "advertized dimensions" of the proposed Russian colonization plan, threatened to divert America, the mainstay of Palestine, from the upbuilding of Palestine and it was against this that Zionists rallied.

Emphasizes Two Achievements

"Two achievements have resulted from the action of the Zionists," the report continues. "The colonization element in the relief program has ceased, for the time being at least, to be the main subject of propaganda in the relief campaign. This change of attitude has been thoroughly welcomed by the Zionist public and has even made possible in certain sections of the country, a union of forces in joint campaigns. The other achievement was equally significant. The threat—conscious or unconscious—to subordinate Palestine to any other public project, and to thrust the Jewish Homeland into the background of public attention, roused the Zionists of America to vigorous action. The Baltimore Conference was called and the send-off was given to the United Palestine Appeal—the most successful action for Palestine in the history of American Zionism.

"The double victory for Palestine has had a wholesome effect on the general situation. It is definitely established that the masses of American Jewry will not be side-tracked from the enterprise of rebuilding the Jewish Homeland. It is further established that the sentiment for Palestine, measured both in money and in moral support, is still on the increase. And, finally, it has been made clear that the influence of the Zionist movement extends far beyond

the limits of its membership," Mr. Lipsky states.

Discussing the Jewish Agency, the report charges the non-Zionist group with delay in its failure to cooperate in the extension of the Agency. "It can not be denied," the report states, "that the development of the Jewish Agency has received an unfortunate set-back. Since the declaration made by the non-Zionist group at the Conference of February, 1924, the Zionists have waited for the practical consummation of the partnership. It is still the view of the Zionists of America that the non-Zionist group in this country has not shown the readiness which might have been expected and that whatever offers of cooperation have come have been out of all proportion to the means of the non-Zionists and to the privilege of partnership which the Zionists were prepared to extend.

The Jewish Agency

"The Zionists have been justified, in their opinion, in the belief that though the Jewish Agency must still remain as the goal of Zionist external action, the safety of Jewish Palestine calls, as before, for the extension of the Zionist Organization as such, and for the intensification of Zionist sentiment."

The foundation of the Jewish Cultural Association under the auspices of the Zionist Organization during the past year, a departure in American Zionism, is referred to in the report with the hope that by the time of the thirtieth Zionist convention, the Association "will have made a distinct place for itself in the Jewish life of this country, stimulating that spiritual activity which is the natural foundation of Zionism, and playing the part of a cultural director in American Judaism."

The report refers to the results of the visits of Chaim Nachman Bialik, Dr. Schmarya Levin, Nahum Sokolow, the large number of American Jews who visited Palestine, which is beginning to provide every Zionist district with one or more members who can speak of Palestinian conditions at first hand. The report also mentions the leading role that American Zionists now play in the affairs of the World Zionist Organization, three of the most important posts at the last Zionist Congress in Vienna being held by Americans.

CARL E. PRITZ TREASURER OF HEBREW UNION COLLEGE

Mr. Carl E. Pritz, of Cincinnati, was elected treasurer of the Hebrew Union College. This office came into being under the new rules and regulations of the College as an incorporate body, and Mr. Pritz is the first treasurer elected under the new regulations.

Mr. Pritz has been a member of the Executive Board of the Union of American Hebrew Congregations for many years and has been active in the work of the Union.

The largest graduating class in the history of the City College received degrees at the eightieth commencement yesterday. Degrees were awarded to 826 students, 706 of whom are Jews.

With an average of 94.97, Aaron L. Shalowitz of Baltimore took scholastic honors in the class of 20 seniors at the Georgetown University School of Law.

that he "would not countenance unclean methods in Maryland," Frank H. Beall resigned Wednesday night as grand dragon of the Ku Klux Klan in Maryland. He announced that he had severed all connection with the organization. It is expected to lead to a split among klansmen in Maryland.

"All I care to say now is that the national officers wanted to propagandize the State along lines that were objectionable to me and I refused to permit it because of my past experiences," Mr. Beall said.

This propaganda is said to involve the collection of \$10 a year from a member, the national officers to get \$5 of it. This is believed to be only one feature of the program Mr. Beall found objectionable to him and a large group of his friends in the Order.

"I will not go down the line with anything that is not clean," Mr. Beall asserted. He added that he expected to make a full statement in a few days.

Mr. Beall joined the Klan in 1918, having been the ninety-ninth man in Maryland to go into the Order. His friends indicated some time ago that he was out of sympathy with the national officers, but his resignation was a surprise to them.

intendent to choose certain selections from it to be read by the teachers of the various schools. This action was taken by the board following resolutions adopted by the Ministerial association of Virginia, in which they called upon the board to authorize the reading of extracts from the Bible without note or comment.

Kaplan sought an injunction against the school board in the St. Louis county district court but Judge Edward Freeman, in February, 1925, held that no constitutional right of the plaintiff was violated and denied the petition for the injunction. He later denied a new trial to Kaplan from which order an appeal was taken to the supreme court.

Polish government, for instance, is the largest employer in the state, but this government is boycotting the Jewish worker," he declared.

Referring to the situation in Palestine, the representative of the Bund, which is opposed to Zionism, declared that Palestine immigration does not cover the immigration problem of the Jewish workers. Immigration should be unrestricted into Palestine as well as other countries, he stated.

B. Locker, representing the Poale Zion, contradicted the assertion of Mr. Alter with regard to Palestine, pointing out that during the year 1925, only 10,000 Jews entered the United States of America, while 34,000 Jewish workers entered Palestine during the same period. He stated that over 250,000 in Eastern Europe are without any alternative besides emigration. He criticised the labor parties of Geneva and Australia who were unwilling to cooperate with the Congress.

Mr. Ben Zvi, representing the Palestine Labor Federation, in outlining the work of his organization, took the stand for the open door policy for immigration. He stressed as particularly important that Palestine be open for Jewish immigration.

The Zionist World Organization is represented at the Congress by Messrs. Israel Cohen and Dennis Cohen.
