

## ITALIAN KING PROMISES TUNIS JEWS INTERVENTION AGAINST FASCIST AGITATION

**Leader of Tunis Jews Tells King  
About Anti-Semitic Propaganda**  
(Jewish Telegraphic Agency)

Rome, June 30.—The King of Italy today received Salvatore Carlo, president of the Jewish community of Tunis, who called on the King in connection with the anti-Jewish agitation conducted by the Fascist press of Tunis.

Signor Carlo complained to the King that the Tunis Fascists are publishing violent attacks against the Jews, charging them with being Freemasons and anti-Fascists. Assuring the King that these accusations are false and that the Tunis Jews are loyal to the government, Signor Carlo asked the King to stop the anti-Jewish propaganda.

At the conclusion of the interview, the King promised to take measures to stop the agitation of the Fascist press of Tunis.

## KLAN WILL NOT PARADE AT SESQUI, PENNSYLVANIA KLAN OFFICIAL STATES

Philadelphia, June 30.—If Mayor Kendrick stands firmly upon his edict prohibiting the Ku Klux Klan demonstration in connection with the Sesqui-Centennial next September, the Klansmen will not attempt to parade, it was announced at a Klan meeting here.

"We must remember that Mayor Kendrick is the highest executive in the city," Charles B. Lewis, head of the hooded order in Easterr. Pennsylvania, told the Klansmen, "and he was elected by you. You are bound by your oath as Klansmen to respect law and authority. If the Mayor decides that native-born American citizens cannot march through the streets of the city of Philadelphia, we shall obey the law—but I think he will change his mind."

The Mayor, however, has said that his decision is final.

## ANTI-SEMITIC DISTURBANCES CONTINUE; JASSY STUDENTS NOT READMITTED TO COLLEGE

Bucharest, June 30.—The anti-Semitic students who were recently expelled from the Jassy University for anti-Jewish excesses will not be readmitted, according to a decision made by the Board of Professors of the Jassy University.

This decision was made as a result of the efforts that are being put forth by anti-Semitic elements to reinstate the students who had participated in the anti-Jewish disturbances.

## WAILING WALL QUESTION IS SOLVED BY LEAGUE, LONDON "MORNING POST" REPORTS

**Dr. Rappard's Suggestion to Palestine  
Delegation Accepted, Report Says**  
(Jewish Telegraphic Agency)

London, June 30.—The solution of the problem created by the recent removal on the request of the Arabs, who own the ground around the Wailing Wall in Jerusalem, of the benches used by the Jews at the Wailing Wall, has been found, the Geneva correspondent of the "Morning Post" claims, in a despatch to that paper.

The correspondent of the "Morning Post" declares that William Rappard, Swiss member of the League's Mandates Commission, suggested to the Vaad Leumi delegation, which complained to the League regarding the Wailing Wall incident, that the worshippers at the Wailing Wall adopt the method employed by the Alpine herdsmen who carry portable stools strapped to their waists.

The Arabs, the "Morning Post" writes, object to the permanent benches because they fear the Jews would erect roofs over the seats as protection against rain, and would eventually claim ownership of the enclosed ground. They have, however, no objection to non-permanent seats.

The "Morning Post" correspondent asserts that the Vaad Leumi delegation, after some hesitation, accepted the suggestion made by Dr. Rappard.

## QUESTION OF STRANDED JEWISH FAMILIES IN BAGDAD IS BROACHED IN COMMONS

London, June 30.—One hundred and forty Jewish families from Kurdistan and Mesopotamia are at present stranded in Bagdad, unable to proceed to Palestine, for which they had started out, owing to the fact that permits to enter Palestine have not been issued to them.

Lieutenant-Commander Kenworthy questioned the Colonial Secretary in the House of Commons today, as to the reason for the failure of the Palestine Government to issue permits to the stranded Jewish families in Bagdad. All of the stranded families sold their entire property before leaving their homes, and they are in possession of sufficient means. The delay however, is very costly, as it drains their resources.

## BILL TO CONFISCATE JEWISH PROPERTY REINTRODUCED

Berlin, June 30.—The anti-Semitic Voelkische fraction in the German Reichstag introduced today for the second reading their bill, which was recently rejected by the Reichstag, calling for the confiscation of the property of all the East-European Jews resident in Germany.

## SECOND EXAMINATION OF SHOLOM SCHWARTZBARD TAKES PLACE IN PARIS

**English Teacher, Who Witnessed the  
Assassination, Gives Testimony**  
(Jewish Telegraphic Agency)

Paris, June 30.—Two witnesses were questioned today during the second examination of Sholom Schwartzbard, which took place before Magistrate Peyre.

The first witness, an English teacher, Reginald Smith, aged 66, who was the first to hold Schwartzbard after Petlura was shot, described the scene of the assassination. He declared that when arrested, Schwartzbard exclaimed, pointing at Petlura: "This is the real assassin!" Smith said that he was convinced by the expression and behavior of Schwartzbard at the scene of the assassination, that it was a political crime.

Mr. Smith further stated that he himself sympathizes with Schwartzbard, adding that he regretted that he himself had not killed Kaiser Wilhelm and that he would have killed Edith Cavell's murderer if he had found him.

The second witness, a Ukrainian named Illarion Kossenko, who is editor of Petlura's paper "Trezub" (Trident), published in Paris, said he was convinced Schwartzbard is an agent of the Bolsheviks. The witness contended that Petlura was not guilty of the pogroms in the Ukraine. Admitting that the pogroms took place under Petlura's regime, Kossenko said they were perpetrated by the armies of the Bolsheviks and Denikin.

In the course of Kossenko's examination he was confronted with Schwartzbard. In reply to questions, Schwartzbard declared that he never belonged to any political party, and asserted that Petlura's paper "Trezub" published pogrom articles. In attempt

## INVESTIGATION REGARDING MURDER OF PETLURA'S FORMER AIDE COMPLETED

Warsaw, June 30.—The investigation regarding the murder of Oskilko, former aide to Petlura and pogrom leader in the Ukraine, has been completed, it is announced.

Recent reports indicated that Oskilko was killed by a personal enemy, a Ukrainian. A number of searches have been carried out by the police but so far no arrests have been made. It is stated, however, that sensational arrests will take place shortly.

The wreaths that had been placed on Oskilko's grave were found removed today by Oskilko's widow who visited the cemetery. It is not known who was responsible for this. The police has been informed and investigation regarding the matter has been instituted.

### PROPOSES \$5,000,000 FUND BY RABINICAL ASSEMBLY FOR SPREAD OF JUDAISM

(Jewish Daily Bulletin)

Long Branch, N. J., June 30.—A proposal that the Rabbinical Assembly of the Jewish Theological Seminary of America raise a fund of \$5,000,000 for the purpose of conducting a campaign to strengthen traditional Judaism in America, was made at the Convention of that body which opened its sessions here yesterday, by Rabbi Max Drob, in the course of his presidential address.

Explaining the position of the Rabbinical Assembly, which, he said, is not Reform nor hide-bound in Orthodoxy," Rabbi Drob declared:

"Our Assembly must become militant. Believing as we do that our type of Judaism is the only one which has any hope of perpetuating itself in America, we must bend every effort to convert every American Jew to our point of view. We need periodicals, which shall be the organ for our views, and require propagandists to plead our cause. The time has also come for us to systematize and make possible the proper observance of Judaism. We are the logical body to undertake this gigantic task of bringing order out of the chaos which now prevails in Sabbath observance, kashruth, Jewish education, and in charitable and social endeavor. To accomplish this great task a large fund will be required to make possible the growth of the primary and the United Synagogue. Therefore urge that this convention make plans for a five million dollar campaign for traditional Judaism. With such a fund at our disposal we will be able to take our rightful place in American Jewish life."

Elia Glassman of New Mexico, was among 148 boys and girls chosen from various parts of the country to compete for the American Youth Award in connection with the Semi-Centennial, who assembled at the Semi-Centennial ground Tuesday and then proceeded to Washington to be introduced to President Coolidge.

### CELLER CHARGES "NATIONAL ORIGIN" QUOTAS FAVOR DESCENDANTS OF TORIES

The charge that the Immigration act of 1924 conferred special privileges upon the descendants of American Tories, who opposed the American Revolution and the efforts of Washington, Jefferson, Madison and Hamilton, was made by Congressman Emanuel Celler yesterday in a statement.

"Commencing Jan. 1, 1927, the total number of immigrants allowable in this country is to be 150,000," Mr. Celler said. "This number is to be apportioned among the various countries according to the national origin theory."

Explaining this theory Mr. Celler said that if throughout our history the English people and their descendants gave a certain amount of population, and the Germans and their descendants gave a portion, then the quotas from England and Germany would include such part of the population as the English stock and the German stock bear to our entire population.

Mr. Celler declared that the English were predominant among the 2,600,000 or 2,800,000 persons present in this country when the Revolution began, and added that approximately one-third of these were Tories. He said that the new act was written in anger and fear, and after-war hysteria.

"The English, because more numerous in 1776, are to have 83 per cent. of the quota after 1927," he continued. "I have no quarrel with England; it is a great and noble country. I do quarrel with the silly national origin theory which gives to England 83 per cent. of the 150,000 immigrants—gives it to the descendants of the English Tories."

### ELECTION OF ROUMANIAN RABBI TO SENATE RATIFIED

Bucharest, June 30.—The election of Rabbi Niemirower as member of the Roumanian Senate was ratified today by the Cabinet.

Rabbi Niemirower was elected recently by the Jews of Bukowina as the Jewish representative in the Senate, in accordance with an arrangement made recently with the Roumanian Government.

Workers in the United Jewish Appeal in Gary, Ind., now are engaged in raising the \$20,000 added to their quota of \$30,000, the first quota having been subscribed. The total funds collected to date amount to more than \$25,000.

### Comments on James N. Rosenberg's Report

The statement made by James N. Rosenberg, Vice-President of the J. D. C., upon his return the other day from Russia where he inspected the Jewish settlements, that the Orthodox Jews in Russia are evincing a desire to settle on the land, is commented on by the "Jewish Morning Journal" of June 30. Says the paper:

"When the middle class, or the former middle class, follows a certain direction, it is natural that the Orthodox element should go the same way. As stated in yesterday's report, Judaism is not altogether barred from the existing Jewish colonies, where a religious life is developing, although the conditions are not favorable. And other Orthodox Jews, even Rabbis, manifest an interest in plans for establishing Orthodox Jewish colonies. The fact that the government grants land and other forms of assistance cannot but have its effect, although the obstacles, of which the greatest is the shortage of money, cannot be disregarded. The sum total of the whole thing is that good work is being done insofar as it is possible under the circumstances but not on a large enough scale to cause uneasiness to the opponents or to satisfy the enthusiastic supporters of the plan."

### Approves Open Sunday at Sesqui

The decision of the Board of Directors of the Sesqui-Centennial Exposition to open the exposition on Sundays, which has provoked a religious controversy in Philadelphia, is lauded by the New York "World."

Referring to the material considerations in the case, the paper says that even waving this aside—

"the locking of the gates on Sunday would exclude many thousands of persons whose allowance of leisure will not permit them to visit the Sesqui on working days. The Metropolitan Art Museum and other museums are open on Sunday for that very purpose. It is difficult at this day to understand the feeling that regards the educational use of the Sabbath as a profanation, and would therefore curtail the use of a national patriotic exposition."

### On the Proposed Jewish Center in Jerusalem

The plan for the erection by the American Jews of a Center in Jerusalem, is commented on by the Orlando (Fla.) "Star," which observes:

"Assurances have been received that Jews of all types of faith will use it, and such divisions of Judaism as obtain in America will not be duplicated in the Holy Land. A most commanding site is under consideration. To make

## LOUIS LIPSKY IS ELECTED PRESIDENT OF ZIONIST ORGANIZATION AT FINAL SESSION OF BUFFALO CONVENTION

Office Restored to Honor Leader for Devotion and Service; \$7,500,000 Quota for United Palestine Appeal in 1927 Endorsed; Dr. Stephen Wise and Judge Mack Chosen Honorary Heads of Appeal; Judge William B. Lewis, Chairman; Convention Adopts Resolution on Jewish Agency and Russian Colonization Plan; Expresses Adherence to Congress Decision; Criticizes Representation of Russian Colonization Plan as Rival of Palestine

Buffalo, N. Y., June 30.—The Presidency of the Zionist Organization of America, an office which has not been formally filled since the Cleveland convention when the split with the Brandeis-Mack group occurred, was restored and the title of President was given to Louis Lipsky.

This was the climax of the twenty-ninth annual convention of the Zionist Organization of America, which ended its sessions at the Hotel Statler here yesterday.

The twenty-ninth annual convention, which was termed the convention of self-assertion of the democratic elements in the Zionist movement, took this action following a day of important discussion and adoption of resolutions outlining the future course of the policy of the organization and plans concerning the extension of its activities in the immediate future.

### Honor Mr. Lipsky

The nomination, announced by Louis Levinthal of Philadelphia, chairman of the nominations committee, was enthusiastically received by the delegates who rose and applauded President Lipsky for nearly ten minutes. In the midst of the enthusiastic approval given to the nomination, Emanuel Neumann, who took over the chair, introduced a motion asking the Executive Committee of the Zionist Organization to consider a fitting manner in which to honor the election of Mr. Lipsky to the Presidency, which coincides with his attaining the age of 50. Mr. Neumann's resolution was seconded by Joseph Barondess, Rabbi Abba Hillel Silver and Dr. Schmarya Levin who, in glowing terms, paid tribute to the service which Mr. Lipsky renders to the Zionist movement.

With the simplicity and modesty characteristic of him, Mr. Lipsky, in his reply, declared that he sees no difference between the title of Chairman and President.

"I do not think that one is entitled to speak of sacrifices made by this or that individual for the Zionist cause. The Zionist movement is so rich in spiritual values and satisfaction that no matter how much one gives to it or how much one does for it, he is doubly rewarded," Mr. Lipsky declared. "We have in the Zionist Organization a democratic movement marked by mutual understanding and mutual respect," he stated.

A budget of \$223,000 for the forthcoming year was also adopted by the convention.

### Approve \$7,500,000 for Next U.P.A.

The recommendation of the committee on Palestine funds, headed by Mrs. Archibald Silverman of Providence, to the effect that the quota of the forthcoming United Palestine Appeal be not less than seven and a half million dollars was endorsed. The following officers were recommended for the United Palestine Appeal.

Dr. Stephen S. Wise, Honorary Chairman; Judge Julian W. Mack, Rabbi B. L. Levinthal, Honorary Vice-chairman; Judge William B. Lewis, Chairman; Emanuel Neumann, Chairman Executive Committee; Hermann Conheim, Treasurer; Vice-Chairmen, Louis Lipsky, Zionist Organization of America; Morris Rothenberg, Keren Hayesod; Bernard A. Rosenblatt, Jewish National Fund; Dr. David J. Kaliski, Hebrew University Fund.

A place was reserved for the president of Hadassah.

### Discuss \$300,000,000 Loan for Palestine

The idea of a Jewish National Loan to the amount of \$300,000,000, which would be raised and invested within the next ten years with a view to enabling the creation of a Jewish majority in Palestine within that period, was brought before the convention by David Remes, representative of the Palestine Labor Federation.

The suggestion made by Dr. Max Heller of New Orleans, that this matter be referred to the Executive Committee, urging it to give the question of a loan its earnest consideration, was set aside when Judge Bernard A. Rosenblatt and Dr. Schmarya Levin stated that this matter is holding the attention of the members of the Zionist Executive and that it is now being studied by a special commission headed by Dr. Arthur Ruppin.

Two matters of great interest to

American Jews were also debated and determined upon during the last day of the convention; one, concerning the Jewish Agency, on which negotiations with the non-Zionist group under the leadership of Mr. Louis Marshall, are pending, and the other dealing with the Russian Colonization plan, as a part of the work of the Joint Distribution Committee.

### The Jewish Agency and the Russian Colonization Plan

In the debate on the Jewish Agency resolution, the difference of opinion was as to whether this resolution was to contain a reference to the Russian Colonization plan, which, it was maintained, constitutes an important element in the pending negotiations concerning the Jewish Agency. Ab. Goldberg urged the adoption of the resolution.

Maurice Samuel, Israel Goldberg and Ezra Shapira of Cleveland spoke in favor of an amendment inserting such a clause in the resolution. Louis Lipsky met with the approval of the delegates when he declared that it was the right of the administration to insist that contrary to parliamentary procedure the vote be taken first on the report and then on the amendment. The resolution was then put to vote and adopted by an overwhelming majority. The resolution on the Jewish Agency read:

### Executive Empowered to Continue Efforts for Extension of Jewish Agency

"Resolved, that we, the Zionists of the United States in convention assembled, give our full support to a resolution of the Zionist Congress held last year in Vienna, authorizing Dr. Weizmann as President of the World Zionist Organization, to take the necessary steps for the creation of the Jewish Agency in accordance with the terms of the Mandate.

"We deplore the inactivity and delays that have marked the negotiations in this country in spite of our earnest and persistent requests for action. We note the assurances made by organizations and persons not affiliated with the Zionist Organization that when the time for action came, such action would be forthcoming. We urge again upon these groups that such time for action has now arrived.

"Accordingly, we authorize and instruct the National Executive Committee to co-operate with Dr. Weizmann for the purpose of arriving at an understanding with such non-affiliated organizations and persons who have committed themselves to participation in such Agency and to take such other

steps as may make possible the early extension of such Agency."

A heated debate developed at the closing session on the "resolution on Crimea," which was brought back from the committee after revision following a recommendation taken at the morning session to recast the resolution. Rabbi Hammer and Mrs. Meyers of Boston, urged the rejection of this resolution.

Rabbi Abba Hillel Silver introduced a substitute resolution to give expression to the opinion of the Zionist delegates but in a milder form. Hon. Elihu D. Stone and Robert Silverman of Boston, Isaac Carmel and Jacob Fishman urged the adoption of the resolution as presented by the Committee. The speakers urging the adoption of the resolution argued that the Crimea project has become the rallying point for all anti-Zionists, and that the propaganda which is emanating from this project is calculated and is being employed to set up the Jewish settlements in Russia, which are a part of a larger relief program, as a rival to Palestine.

### Mr. Lipsky Explains Position on Russian Colonization

Explaining to those who urged the rejection of the resolution, Mr. Lipsky declared: "It would be folly for the Zionists gathered here in convention to pass by occurrences of the past twelve months without condemning certain things which are really obstacles to the development of the unity of American Jewry. We have gone through a year of effort to raise funds for Palestine under the most critical circumstances and in the midst of this work there has come forward a propaganda which is calculated to distract the attention of American Jews from Palestine. It is a mistake to think from this resolution, or what I said in my opening address, that the colonization project in the Crimea or the Ukraine or wherever it may be is what the Zionists object to.

"What we object to is something in the propaganda. This propaganda for the project of colonization is being conducted in such way as to destroy the unity of American Jewry. It is being used for the purpose of a counterfoil of the Palestine project," Mr. Lipsky stated.

The resolution which was finally adopted by a majority of 102 to 42 read as follows:

"This convention endorses the views extended by the Chairman of the Zionist Organization of America in his annual address to the Convention with regard to the attempt which has been made, in public utterance and in organized propaganda, to give to the Agricultural relief measures for the Jews of Russia a significance tending to counteract the efforts of Zionists extending over a whole generation, to mobilize the public sentiment of Jewry in favor of a Jewish Homeland in Palestine."

The convention was closed Tuesday after midnight by Rabbi Abba Hillel

## WRITER COMPLAINS "BABYLON IS FALLING ALL OVER AGAIN"

The complaint that "Babylon is falling all over again," was made by Dr. William T. Ellis of Swarthmore, Pa., who returned Tuesday from the Near East, where he had spent the last ten months writing a book on Bible lands.

"What is today happening in ancient Babylon is of concern to every historically minded person. The remains of the ancient city, so carefully and expensively excavated throughout a long course of years by German archaeologists, are entirely neglected and unguarded, and the priceless and irreplaceable bas-reliefs along the Sacred Way are being broken and pilfered by the Arabs. In a few years more there will be nothing to show of the unearthened remains of the grandeur of the city of Nebuchadnezzar," Dr. Ellis stated.

"The Iraq Government has a department of antiquities, which apparently confines itself to seizing for display in the Bagdad museum the choicest of the finds of American and British archaeologists, at such new sites as Ur of the Chaldees and Kish. It totally neglects the preservation of one of the greatest archaeological treasures in all the world, the uncovered ruins of mighty Babylon, once ruler of the whole world."

today by bands of anti-Semitic students in the course of the anti-Jewish excesses which have been renewed here in the last few days.

Today's disturbances began after examinations in the biology and medical departments of the Bucharest University were over, when the students in these faculties made attacks against their Jewish colleagues.

## MARYLAND GRAND DRAGON CHARGES K.K.K. CORRUPTION

(Jewish Daily Bulletin)

Baltimore, Md., June 30.—Frank H. Beall, who resigned last week from his office as Grand Dragon of Ku Klux Klan in Maryland, owing to disagreements with the national officers, charged yesterday that some representatives of the National Propaganda Department have been "shamefully crooked" and "shockingly immoral" in the conduct of their operations in this State and that national officers had proposed a repetition of objectionable propaganda methods.

Under the national scheme, he explained, King Kleagles, assisted by staffs of Kleagles, go into the various States and solicit new members wherever they desire. Their practice, Mr. Beall said, has been to go over the heads of local Grand Dragons.

Mr. Beall asserted he had promised Maryland Klansmen that he would not countenance the methods of these agents and that he had resigned in order to keep that pledge.

He denied that he had been forced out of the office, and declared he had advanced \$25 to agents of the Klan and that this money had not been returned.

ing to deny Schwartzbard's assertions, Kossenko charged that Schwartzbard could not read Ukrainian. "I lived in Ukraina up to the age of 19, and understand Ukrainian very well," Schwartzbard answered.

A striking scene took place when Schwartzbard, as he was leaving the room, exclaimed in Yiddish to the Jewish reporters: "Jewish blood cannot be shed without punishment!"

After the examination, Schwartzbard was allowed to see his wife.
