## LILLY MONTAGU PREACHES YOM KIPPUR SERMON IN LONDON SYNAGOGUE

### Event Is Declared to Signify Equality of Sexes

(Jewish Telegraphic Agency)

London, Sept. 20.—The Hon. Lilly Montag, a sister of Lord Swaythling, is the first English woman to preach in an English synagogue on Yom Kippur.

Miss Montag, who was one of the initiators of the recent International Conference of Liberal Jews, delivered her sermon in the Liberal Jewish Synagogue here. Her subject was "Man's Answer to God's Call."

Officials of the Liberal Synagogue, commenting to the press on this event, stated that although Jewish law forbids women from officiating at religious services, the Liberal Synagogue has abolished this ban, believing in the full equality of the sexes. The Liberal Synagogue also does not insist upon fasting on Yom Kippur, they stated.

## CANADIAN NATIONAL RAILWAYS SETTLE JEWS IN BRITISH COLUMBIA

Harbin, China, Sept. 20.—The settling of Jewish refugees in Western Canada has been started by the Canadian National Railways.

The first group of Jewish farmers to be settled by the railways, left for Canada to settle on large tracts in British Columbia, which is now being colonized by the railways. The group consists of sixteen Jews who have had farming experience. They come from Siberia and other parts of the Far East. It was declared here that if the first group is successful a larger group of Jewish farmers will emigrate to Canada. Each farmer is required to invest four hundred dollars.

## HAIFA TO HAVE FIRST ELECTRIC STREET CARS

Jerusalem, Sept. 20.—The first electric street car system will be installed in Haifa, it was learned here today.

The cars will run from Haifa to Mount Carmel, on the summit of which is the Jewish residential district, Hadar Ha-Carmel.

The concession to inaugurate this system was given by the city to Engineer Pinchas Rutenberg, the originator of the Palestine electrification and irrigation plan.

## PROFESSOR BRAUNSTEIN, JEWISH SCIENTIST, DIES

Moscow, Sept. 20.—Professor Braunstein, prominent oculist, scientist and social worker in the Ukraine, died yesterday in Charkoff. He was 62 years old.

## PROMINENT NON-JEWS ATTEND YOM KIPPUR SERVICES IN WARSAW

### Freethinkers' Demonstration Dispersed by Police

(Jewish Telegraphic Agency)

Warsaw, Sept. 20.—The American Consul General here was among the many non-Jewish guests who attended the Yom Kippur services at the Great Synagogue on Tomackie, where Cantor Gerson Sirota officiated.

The Great Synagogue and all other houses of worship throughout the capital and provincial towns were overcrowded.

The most solemn day of the Jewish year did not pass without incidents here. On Kol Nidre night the police surrounded a meeting of workmen at the Workmen's Home, under the auspices of the Left Poale Zion. The police dispersed the meeting and arrested eight participants.

On Saturday at noon, a group of Jewish freethinkers arranged a workmen's meeting at the Circus. The police surrounded the building and dispersed the meeting. Following this, the participants formed small demonstrative groups in the Jewish quarter, eating and smoking publicly, to the annoyance of the Orthodox element.

## COMMUNISTS CELEBRATE SYNAGOGUE CONFISCATION

### Red Flag Raised Over Kiev Temple, Largest in Ukraine

Moscow, Sept. 20.—Brodsky's Synagogue of Kiev, the largest synagogue in the Ukraine, was officially turned into an artisans' club yesterday when the Kiev Soviet handed the keys of the synagogue to the management of the artisans' club.

To celebrate this event, groups of Jewish artisans and workmen demonstrated before the Soviet building, expressing their gratitude for the action of the Communist authorities. The red flag was raised over the synagogue building, indicating that it has become a building housing a Communist institution. A special committee was appointed to take over the property belonging to the synagogue.

The Kehillah has lodged a protest against its being turned into a purely religious community.

## SCHROEDER SENTENCED TO DEATH IN MAGDEBURG COURT

Berlin, Sept. 20.—Schroeder, the confessed slayer of Helling, the bookkeeper of the Magdeburg Jewish merchant Randolph Haas, was sentenced to death in the trial held in the Magdeburg court, when the jury returned a verdict of guilty.

## LEAGUE COUNCIL DECIDES NOT TO CONSIDER HUNGARIAN NUMERUS CLAUSUS QUESTION

### Count Klebberg Makes Another Statement to J.T.A. Director

(Jewish Telegraphic Agency)

Geneva, Sept. 20.—The failure of the Hungarian government to fulfill its promise to abolish the numerus clausus will not come up for discussion at the present session of the Council of the League of Nations, it was learned here.

It was stated that the Council has decided not to deal with this matter at the present meeting.

Lucien Wolf, representative of the Joint Foreign Committee of the Board of Jewish Deputies and the Anglo-Jewish Association, as well as the Alliance Israélite Universelle, submitted another memorandum to the Council on the question of the numerus clausus in Hungary.

Vienna, Sept. 20.—The "Pester Lloyd" publishes a report of another interview given by Count Klebberg, Hungarian Minister of Education, to Jacob Landau, managing director of the Jewish Telegraphic Agency, on the question of the numerus clausus.

"The abolition of the numerus clausus does not lie within my authority, but the task of the cabinet as a whole," the Minister stated. When asked by Mr. Landau concerning the attitude of the League of Nations toward the matter, the Count replied that any foreign intervention in this matter would be harmful. "I do not know how Hungarian public opinion would react, if foreign pressure would compel Hungary to abolish the numerus clausus. I do not believe that the Hungarian representative would make any statements on the matter at Geneva at this time," he said.

## RABBIS REFUSE JEWISH ATHLETES PERMISSION TO EAT ON YOM KIPPUR

Budapest, Sept. 20.—Jewish athletes cannot claim exemption from fasting on Yom Kippur to maintain their physical strength before athletic events, according to a decision of the Budapest rabbis.

### ORTHODOX RABBI ISSUES "CHEREM" AGAINST MODERN HEBREW SCHOOL IN TELZ

(Jewish Telegraphic Agency)

Kovno, Sept. 20.—The fight between the Orthodox Jewish elements and the modernists in Lithuania came to a climax in Telz, for many years the seat of orthodoxy and Talmudic learning in Lithuania.

Recently, the Zionist group in the town opened a Hebrew school of the type maintained by the Tarbuth, where instruction is given in the Hebrew language and where a secular attitude is maintained toward all subjects. Hitherto, the town had no secular schools, except the Orthodox school, Bonch. Following the opening of the school, Rabbi Bloch, issued a "cherem," ex-communicating all parents who send their children to the Tarbuth school. As a result of the "cherem," a number of parents withdrew their children from the school.

### 200,000 PARTICIPATE IN VIENNA ANTI-JEWISH DEMONSTRATION

Vienna, Sept. 20.—Two hundred thousand persons joined a demonstration organized by anti-Semitic leaders here, in memory of Karl Lueger, one of the pioneers of the anti-Semitic movement in Europe.

The demonstration took place on the occasion of the unveiling yesterday of a bronze statue to Lueger, who was notorious for his anti-Semitic propaganda during his mayoralty of Vienna from 1892 to 1910.

### DR. BOGEN, I.O.B.B. EXECUTIVE SEC'Y, ON WAY TO FLORIDA

Cincinnati, Sept. 20.—Dr. Boris D. Bogen, Executive Secretary of the Independent Order B'nai B'rith, left today for Florida, a statement issued by Alfred M. Cohen, president of the Order, announced.

Dr. Bogen will visit the area devastated by the hurricane for the purpose of extending relief to the stricken population, among whom are a considerable number of Jews.

**MORE WITNESSES HEARD****IN SCHWARTZBARZ CASE****Preparations Made for Opening of Trial**

(Jewish Telegraphic Agency)

Paris, Sept. 20.—Another step in the development of the case of Sholom Schwartzbard, who killed Semion Petlura, was taken by the investigating authorities when a number of witnesses called by the accusation were heard. The witnesses included M. Bezpalko, Labor Minister in Petlura's cabinet, M. Schulgin, foreign minister in the same cabinet, and Messrs. Dvolchenko and Tchumitzky, personal friends of Petlura, and a Frenchman, M. Boudri. All of them defended Petlura.

Henry Sliosberg, well known Russian Jewish lawyer, was also called. He declared that Petlura did not personally assist in the pogroms, but he was responsible for not taking preventative measures.

At the hearing Schwartzbard insisted on Petlura's culpability. When told that Petlura was a friend of France, he declared that it was Petlura who called the Germans to the Ukraine during the war.

Petlura's brother has associated himself with the group which is conducting the case against Schwartzbard.

Moscow, Sept. 20.—Bernard Lekash, who is in the Ukraine on behalf of the Schwartzbard Defense Committee of Paris, visited Cherson, Odessa, Kiev Zhitomir, Rostoff, Proskuroff and a number of small towns in the Ukraine, investigating the records of the pogrom period.

M. Lekash has interviewed hundreds of pogrom victims and collected much material concerning Petlura's part in the pogroms and those who financed him. M. Lekash has directed particular inquiry into the attitude of the French commanding staff which was stationed in the Ukraine at the time of the pogrom period. He will also visit the Jewish colonies in the Ukraine.

### POLISH MINISTER CLAIMS MINORITIES ARE SATISFIED

London, Sept. 20.—The assertion that the national minorities in the Republic of Poland are well satisfied with the present regime was made by M. Zaleski, Polish Minister of Foreign Affairs, who represented this country at the League Assembly in Geneva, in an interview with the representative of the "London Observer."

It is a long time since any complaint of the national minorities in Poland has been made to the League against the government. During the recent Congress of the National Minorities in Geneva, the Jewish representatives declared that they were well satisfied with the Polish rule, he stated.

The Friedlaender Classes which give elementary and advanced instruction in the Hebrew language and other Jewish subjects for adults, will re-open on October 6th, 1926, at 34 Stuyvesant Street, New York. These classes form the extension department of the Teachers' Institute of the Jewish Theological Seminary of America and have been named after the late Professor Israel Friedlaender, who was killed while on a mission in Ukraine.

### Head of Jewish Section of Communist Party Reviews Jewish Colonization

A review of the results of the first two years of Jewish land settlement in Russia is presented by A. Merezhin, head of the Yevsektzia, Jewish section of the Communist party and of the Gezerd, Society for Jewish land settlement in Russia, in an article appearing in the "Freiheit," (Sept. 19), Jewish Communist daily of New York. Mr. Merezhin takes occasion to draw a comparison between the reconstruction work in Palestine and the Jewish colonization work in Russia, claiming that the efforts in Palestine have been a failure while those in Russia were highly successful.

Enumerating the practical achievements, area of land allotted for Jewish colonization, etc., Mr. Merezhin dwells on the effect produced in other countries by the work of the Communist agencies in Russia which are promoting the Jewish colonization.

"The second year has also been a year of increased influence on the outside world," he declares. "During the two years since the existence of the Comzet, (Soviet government agency for Jewish colonization) we did not send any delegations or delegates abroad, despite the fact that the Zionists are constantly sending delegates everywhere: Weizmann, Sokolov, Bialik, Poale Zion, Histadruth, etc. On the other hand, however, the Jewish land settlement work has become a force of attraction for all practical organizations and practical social workers.

"We had during the second year delegations and delegates from the Joint Distribution Committee, Ica, Icor, Alliance Israelite and the Ort. There were representatives from workingmen's organizations, bourgeois societies from America, France, Germany, etc. We gave them all every possible opportunity to travel about free and undisturbed wherever and whenever they desired, and we have heard nothing but approvals, affirmative reports and opinions, even from the Zionist Brainin, who came here direct from Palestine."

## CONGREGATIONS JOIN IN "JOIN-A-SYNAGOGUE" DRIVE; FIRST OF ITS KIND

Far Rockaway, L. I., Sept. 20.—What was said to be the first movement of its kind in American Jewry was begun last week when trustees of reform, orthodox and conservative congregations here united in an effort to launch a campaign to increase Jewish affiliations here. At the meeting the Boards of Trustees of Temple Israel, Far Rockaway; Temple Beth El Cedarhurst, and Congregation Shaaray Tefila, Far Rockaway, unanimously approved a campaign to stimulate the Jews of the Rockaways to become affiliated with some Jewish religious organization.

Leo J. Goldberger was chosen permanent Chairman of the "Join-A-Synagogue" campaign. Mr. Goldberger said that more than 1,500 Jewish families in the section from Hewlett to Far Rockaway are not affiliated with any synagogue.

Alvin Austin Silberman, Chairman of the Committee on Public Information for the drive, announced that efforts are under way to interest children in writing essays for the children's contest on the subject of "Why My Parents Should Join a Synagogue," and that literature outlining the contest was distributed at the synagogues during the holiday services.

A general Executive Committee to direct the campaign was elected.

## HEAD OF EMIGDIREKT ON WAY TO UNITED STATES

Bremen, Sept. 20.—Dr. Myron Krainin, Russian Jewish social worker and president of the Emigdirekt, the United Jewish Emigration Committee of Berlin, sailed on the steamer Columbus for New York.

The purpose of Dr. Krainin's journey is to confer with leaders of the Hebrew Immigrant Aid Society of America concerning the needs of Jewish emigrants.

Dr. Krainin was formerly president of the Petrograd society "Mefitzei Haskala," a society existing before the war for the purpose of spreading culture among Russian Jews. During the war Dr. Krainin was president of the Yecopo, the Jewish relief committee of Russia, which collected and expended during the war eighteen million dollars. Dr. Krainin at one time donated the sum of \$100,000 for the "Mefitzei Haskala."

### Citizens Yesterday—Aliens Today

(By Our Czernowitz Correspondent)

Czernowitz, Bukowina, Sept. 4.—A remarkable scene is being enacted in Bukowina: every day crowds of Jews who but yesterday were citizens queue up before the aliens' registration centres in order to be registered as aliens in the country where some of them have lived 30 and 40 years. This is a result of the new citizenship law promulgated by the previous "Liberal" government of Bratianu and now being enforced in all its severity by the Averescu government.

It will be recalled that when the protests against the Bratianu government, which, in direct violation of the articles of the Treaty of St. Germain, refused to consider applications for naturalization from Bukowina Jews and deprived many Roumanian Jews of their citizenship, reached the League of Nations, the Roumanian government thereupon tried to allay the anxiety expressed by the public here and abroad by assuring that it intended in the matter of naturalization to proceed strictly in accordance with the law. In fact, new commissions were set up to re-examine the claims of those who had been deprived of their citizenship rights. But instead of facilitating the conditions for naturalization the commissioners made these still more difficult and began to deprive more Jews of their citizenship. People who had been living in the country for a generation or two were declared to be "aliens." Nothing was of avail. Thousands of former Austrian citizens born in Bukowina and living there all their lives are regarded by the Government as "aliens" and are subject to all the legal restrictions in force against undesirable aliens.

Needless to say, the lot of these newly created aliens is much worse than that of the foreigners proper who, whether only on a visit or permanently settled, belong to a certain State which protects them against injustice, whereas the Bukowina "aliens" have no State to fall back on and are refugees in their own country. There have been cases of the alien-police demanding that the aliens of overnight whose parents were born in the country and whose sons served in the Roumanian army should send in applications for permission to remain in the country for a certain period of years. Thus tens of thousands of Jews have been outlawed. They are not allowed to move about freely in Roumania, nor have they any possibility of leaving the country and going elsewhere because no other Government will recognize them.

There were optimists who thought that this iniquitous citizenship law would be revised with the advent of the Averescu Government, but the new Minister for the Interior, M. Goga, who is notorious for his anti-Semitism, is doing his utmost to have the law applied in all its severity.

## RECORD SYNAGOGUE ATTENDANCE EVERY- WHERE ON YOM KIPPUR

Synagogue attendance reached the highest mark in New York City and in all Jewish communities throughout the country when Yom Kippur was observed on Saturday.

The observance of Yom Kippur caused the closing down of many wholesale and retail establishments.

Tribute to the memory of Oscar Straus was paid by Rabbi Samuel Schulman, of Temple Beth El, in his sermon, "The Jew and America." In his eulogy of the late philanthropist, who was a member of his congregation, Rabbi Schulman said:

"What the Jew can give to America, when he is both true to his Judaism as a religion and to America as the expression of his nationality, has been admirably exemplified in the distinguished, noble life of Oscar Solomon Straus."

Lack of religion in everyday life was blamed for the lawlessness and decadence of modern life by several rabbis in their Yom Kippur sermons.

## MANDATED TERRITORIES QUESTION TO BE REOPENED

(Jewish Telegraphic Agency)

Geneva, Sept. 20.—The dispute between the Council of the League of Nations and the Permanent Mandates Commission concerning the mandated territories is expected to be reopened again today.

The question is expected to be raised at the sixth session of the League Assembly. Fridtjof Nansen, representative of Sweden, and other delegates intend to reopen the question and take up the cudgels for the Mandates Commission against Sir Ausen Chamberlain, for Great Britain, and Briand for France for the right of the Permanent Mandates Commission to examine the administration of the mandatory powers in the mandated territories.

## MOSLEM SUPREME COUNCIL BEGINS ARAB COLONIZATION

Jerusalem, Sept. 20.—Colonization work for Arabs in Palestine was undertaken by the Moslem Supreme Council, a religious body.

It was announced that the Council will establish an Arab colony at Rubin, near Jaffa, on a strip of land of 32,500 dunams. The land is Wakf land, religious property bequeathed to the Moslem religious authorities. The Council plans to establish the first Arab agricultural school there.

## ARAB IS APPOINTED TO PALESTINE EDUCATION DEPT.

(Jewish Telegraphic Agency)

Jerusalem, Sept. 20.—Mr. Sakakini, an Arab leader, was appointed rapporteur in the governmental Department of Education, it was learned here today.

Sakakini was formerly secretary of the Palestine Arab Executive.

**MEXICAN BANDITS HANGED FOR ROSENTHAL MURDER**

(Jewish Daily Bulletin)

Mexico City, Sept. 20.—Detailed reports of the kidnapping and slaying of Jacob Rosenthal, retired New York merchant, show that Rosenthal was slain within three miles of Cuernavaca during the encounter between the kidnapers and the troops. Two knife wounds were found in his body and a bullet hole in his forehead.

Thirteen bandits have already been killed as a result of the slaying of Rosenthal.

Seven suspected outlaws were killed by Federal soldiers in a clash near Huitzilac, where Rosenthal was kidnapped last Sunday. Three suspects were killed the night before in the same district. Three prisoners were brought to this city after being captured near the scene of the outrage. They were picked out by Joseph Ruff, Rosenthal's son-in-law, from a line-up of fifty prisoners and identified by him as members of the gang that robbed his party on Sunday and kidnapped Rosenthal. It is stated that the three prisoners will be executed.

The kidnapers slain for the death of Jacob Rosenthal, of New York, include former General Bonifacio Hindjosa, of the Zapata forces, former Mayor of the village of Huitzilac, and Miguel Garcia, warden of the jail in the same village.

As a warning against banditry, the dead prisoners have been strung to trees along the road to Cuernavaca near the spot where Rosenthal was kidnapped and murdered.

Charge d'Affaires H. F. Arthur Schoenfeld transmitted to the Mexican Foreign Office a note from the State Department at Washington, calling for the apprehension and punishment of the assassins of Rosenthal.

Mr. Schoenfeld also received peremptory instructions from Secretary Kellogg to forward full details of the assassination at once. It is understood President Coolidge called for this information.

Washington, Sept. 20.—The State Department believes "commendable efforts" are being made by the Mexican government to apprehend and punish the slayers of Jacob Rosenthal. In the pursuit of the bandit gang, 500 Mexican troops under General Dominguez now are being employed, the State Department was advised today in a message from H. F. Arthur Schoenfeld, charge d'affaires in Mexico City.

The body of Jacob Rosenthal will be returned to his residence in Woodmere, L. I., for burial.

Following an investigation into the attack on Harry Wolbert, crippled house painter of Somers Point, N. J., whose home was burned while he was spirited away to a swamp, the Atlantic City prosecutor's office asserted on Saturday belief that the outrage had been due to Klan influence and that six arrests probably would be made Monday.

It was also announced the office was in the possession of twenty names of prominent Klan men who were alleged to be implicated in the affair. Those seized will be charged with arson and attempted murder. Wolbert is still critically ill in Atlantic City Hospital from exposure and the beating he received.

**ONE-FIFTH OF TOTAL QUOTA FOR ALL COUNTRIES USED UP**

Washington, D. C., Sept. 20.—About one-fifth of the total annual quota, for all countries has already been used up. The Irish Free State showed the largest number in proportion to its quota, 5,368 visas having been issued to that country up to August 31st out of a total yearly quota of 28,567. Heavy immigration from northern Europe has marked these first two months.

According to an announcement made by the State Department, visas have been issued as follows during July and August, the first two months of the present fiscal year: Poland was granted 1,155 visas, balance 7,272; for the remainder of the year 4,827; Russia was granted 448, balance 1,800; Roumania was granted 54, remainder 290; Czechoslovakia was granted 543, remainder 2,530; Latvia was granted 71, remainder 97; Palestine was granted 77, remainder 29; Hungary was granted 65, remainder 408; Austria was granted 153, remainder 632; Germany was granted 9,762, remainder 41,465; Great Britain and Northern Ireland were granted 5,909, remainder 28,098.

refugees in Bukovina and Bessarabia are in still worse a position.

The United Evacuation Committee in Paris, it is true, decided that the problem of the Ukrainian refugees in Roumania and those in the Transylvanian cities should be liquidated and the emigration committee of Czernowitz was to have convoked an inter-party conference and to have created the liquidation committee, but so far nothing has been done. In the meantime the position of the Ukrainian refugees is becoming worse from day to day. The plan to settle these refugees in the Argentine and Brazil came to nothing. Many of the refugees want to return to Russia but the frontiers between the two countries are closed and to travel to Russia via any other country is too costly.

The intolerable economic position of the refugees is rendered worse by the campaign against them carried on by Cuza and his followers, who demand that all refugees should be at once deported on the ground of the economic difficulties in the country and the alleged lack of loyalty to Roumania among the refugees.

The Ku Klux Klan has established a business organization, with several suites of rooms elegantly furnished and a corps of well dressed men and women for its personnel in Washington, D. C. In addition to the regular program of the organization an insurance business is being developed.
