Report of Special Representative on Scene of Disaster Miami, Sept. 23.—The Jewish population of Miami and the surrounding

area laid in ruins by the hurricane is not in need of bread relief. They require constructive help in the form of loans with which to rebuild their ruined houses and their trade. This was made clear today at a conference of local lewish leaders, called for the purpose of organizing a central Jewish relief committee. Both the Orthodox and Reform elements participated in the conference which took place at the Gralyn Hotel. A joint executive was elected, with David Cromer as chairman; D. Apte and H. Magid, vicechairmen: A. Aronovitz, secretary and Isadore Cohen, treasurer. Rabbi Murray Alsted, Orthodox, and Dr. Jacob Kaplan, Reform, were appointed counsellors. Joint Distribution Committee in Europe, when interviewed on his arrival stated that had it not been for the United Jewish Campaign, the Jews of Poland, Russia, Eastern and Central Europe would have suffered a catastrophe from which they could not have recovered in this generation. The \$25,000,000 campaign, said Dr. Kahn, came in the nick of time to prevent loss of all the millions raised by American Jewry during and since the

Dr. Kahn, who is paying his first visit to America in three years, stated that all of the twenty-five million dollars now being raised, and more, will be needed to meet the acute conditions of suffering there which will continue for many years, and American Jewry must prepare to extend assistance to their coreligionists abroad for several vears to come, until European economic conditions are permanently stabilized. "The situation today." Dr. Kahn

said, "is most acute in Poland where, however, political and economic condi-tions have somewhat improved in the past few weeks. The work of the Ioint Distribution Committee today is quite different from that during and immediately after the war. Our work today is almost entirely reconstructive, that is, helping people to help them-selves through the loan organizations we are forming, through stimulating the resumption of industry and in other ways helping the Jews to restore their economic footing. At the same time, however, we are still feeding 18,000 school children, 15,000 orphans, and 20,000 unemployed workers in Europe.

'In Poland, we are furthermore confronted at the same time with a severe epidemic of scarlatine, to combat which the Joint Distribution Committee has appropriated a special fund. It is admitted that through the funds raised in the \$25,000,000 campaign now being carried on in America hundreds of suicides have been averted, and a large number of individuals have been enabled through our help once more to earn a livelihood. It will take years to overcome the present crisis and to adjust the Jewish population to new economic conditions, and it will take two or three years to relieve even the acute distress prevailing throughout Central and Eastern Europe. But, this is not all. Some way must be found to make permanent the work of

### NUMERUS CLAUSUS ABOLISHED BY POLISH REFUGEES BUILD NEW **GOVERNMENT ON PROTEST OF JEWS**

Minister, Under Fire, Annuls Secret Circular of Previous Government: Abolition Comes Too Late; Jews Continue Protest

Warsaw, Sept. 22.-The protest of the Jewish population against the policy of the present Ministry of Education in continuing the practice of the Numerus Clausus against Jewish stu-dents in Polish universities and colleges, will be given expression to in a resolution expressing lack of confidence in the Education Minister Soikowski.

The Club of Jewish Deputies, at its meeting yesterday, decided to introduce this resolution at the Thursday session of the Sejm. It is unlikely that the resolution of the Club will find support among the other parliamentary groups.

Warsaw, Sept. 23.-The Jewish Telegraphic Agency was officially informed today that the numerus clausus limiting the number of Jewish stu-dents in the Polish universities and colleges was abolished by a special circular issued by Minister of Education Soikowski. Although the numerus clausus in

Poland was not enacted as a law. was practiced in many colleges on the basis of a secret circular issued by Minister of Education Glombinski of the former Grabski cabinet.

The continued application of the numerus clausus under the Bartel government caused great dissatisfaction among Jewish leaders and at the last meeting of the Club of Jewish Deputics, it was decided to introduce a resolution at today's session of the Sejm expressing the lack of confidence of the Jewish club in the Minister of Education.

### WAR INDEMNITY CLAIMED BY SYRIANS FROM FRENCH

Jerusalem, Sept. 23.-The French administration of Syria will have to pay the amount of several hundred million francs for damages to the property of Syrian citizens, as a result of the war in Syria. The Lebanese government has received at least five thousand claims for indemnity from private citizens.

## JEWISH COMMUNITY IN HEART OF MEXICO

Jews in Mexico Are Safe, Dr. Margoshes States

The several thousand refugees who have come to Mexico during the last few years are building a new Jewish community, according to Dr. S. Mar-goshes, editor of "The Day," who just returned from a visit to Mexico where he investigated Jewish conditions.

"I spent three weeks in Mexico investigating the Jewish situation, speaking with all types of Jews and meeting the representatives of all Jewish institutions and parties. I have come away with a feeling that a new Jewish community is being built up in Mexico," Dr. Margoshes stated in an interview with the representative of the Jewish Daily Bulletin. "The building process is not going to be a rapid one, as the economic structure of the country precludes a large scale immigration, but there is no doubt that on the Jewish foundation laid in Mexico in the last three years a new Jewish structure is going up. The seven to eight thousand Lewish refugees who have found their way into Mexico are slowly, if laboriously, adjusting themselves to the new environment and are sending for their relatives in Eastern Europe.

"Despite the present economic de-pression, few Jews leave Mexico and the number of relatives, who are not refugees, entering the country is on the increase. I found a very health City. FEWER IMMIGRANTS CAME TO UNITED STATES IN JULY (Jewish Daily Bulletin) Washington, D. C., Sept. 22.-During July, the first month of the current

immigration fiscal year, a total of 38,379 aliens entered the United States but only 22,283 of these were classified as immigrants, the balance being tourists or other temporary visitors, according to an announcement by Commissioner of Immigration Hull. During the same month 25,022 aliens

left the United States, 17,970 being returning visitors or aliens going to some foreign country for a short stay. the other 7.052, classified as emigrants. leaving to make homes abroad again, According to Commissioner Hull the admissions in July were below monthly average for last year and the departures exceeded the average of that period.

petitioners. He complained that the method of the Permanent Mandates Commission in dealing with the Syrian situation has prolonged the Syrian war by three months. During the discussion it became evident that a considerable amount of resentment exists among the representatives of the smaller states against the criticism of the Permanent Mandates Commission by Sir Austin Chamber-lain and Aristide Briand.

Miami, Sept. 23.—A story of heroic courage inspired by religious devotion, amidst the scenes of desolation and destruction, was related to the representative of the Jewish Telegraphic Agency by Louis Slutsky, the sexton of the Beth David Synagogue, who rescued the Holy Scrolls from the synagogue, when it became endangered by the rising storm and hurricane.

"At the beginning we paid little at-tention to the storm," Slutsky said, "but later, when we saw roofs flying in the street and when the flood began, it became clear to me that something must be done to save the Torahs at the syna-

"It was already dangerous to venture into the street because of flying pieces from the buildings and the flood. thought that a repetition of Noah's de-

luge was coming, when everything would be washed off the earth.
"Let's go to the synagogue and see about the Torahs, I said to my ten year old son. 'If we die, then, at least it will be with a clear conscience that everything was done to save the Toarhs.' My son agreed and we left our house for the synagogue. Every second of our way was a terrible ex-perience, but we reached the synagogue safely because 'Shluchei mitzwa Einon Nizukin' (a messenger on a good errand will not be harmed).

"Arriving at the synagogue, we found the building damaged and water flooding it. The water was over the Oren Kodesh (the Ark) when we reached the Torahs. Not thinking of our lives, we saved them and took them up to the women's section in the gallery. We were prepared to carry them higher if the flood reached the gallery. But the water did not reach the gallery. remained in the synagogue until the storm had quieted down," Mr. Slutsky concluded.

West Palm Beach, Florida, Sept. 24. -Six Jews perished and over one hundred were injured in the Florida disaster, according to the results of an investigation conducted by Rabbi I. S. Ravech of Daytona Beach, Florida, on behalf of the Jewish Relief Committee of Miami.

Some Jewish residents in the afflicted area are still missing. The property damage of Jewish families in this region amounts to \$20,000,000, according

to Rabbi Ravech's estimate.

The amount of \$100,000 is necessary for the relief of the afflicted Jewish families, according to the rabbi, who issued an appeal. "American Jewry

several hundred homeless and penniless Jewish families in the region. Emergency committees have been organized in the various towns. All available synagogues have been converted into Red Cross stations. There are sixty Jewish families in Fort Lauderdale. None of the mem-

bers of these families perished or suffered injuries. The amount or prop-erty damages suffered by them amounts to a quarter of a million dollars.

In Hollywood no Jews were killed. Ten families remained homeless. Their property losses amount to three quarters of a million dollars. The city authorities are doing wonderfully well in the relief work there.

Miami, Fla., Sept. 24.—Steps to col-lect exact data on the losses of the Jewish population in the devastated region were taken by the Jewish Relief Committee of Miami when it despatched several survey commissions which are to visit the entire stricken district. Whether or not the Jewish Relief Committee of Miami is to issue a nationwide appeal to American Jews or only a statewide appeal to Florida Jews was debated at yesterday's meet-ing of the Committee. The belief was expressed that the stricken Jews are not in such great distress as to necessitate a nationwide appeal. The question will be taken up again following the arrival of Dr. Boris D. arrival in the United States, began to bring out short stories, novels and translations of Russian classical writers. His earliest stories and articles appeared in the New York "Evening Post." He was a pioneer in introducing to the English-speaking world the works of such masters as Tolstoy, Chekhov, Gorky and Andreyev. He is the author of "In the Gates of Israel," "Contrile Hearts," "With Master "Contrite Hearts," "With Master Minds," "Celebrities of Our Times," "The Road to Peace," and has contributed numerous articles and stories to leading American magazines and newspapers.

He toured Europe many times as special correspondent of the metropolitan newspapers.

In 1912, after the abrogation by the United States of its treaty with Russia of 1832, because of the continued refusal of that country to observe its provisions in so far as American Jews were concerned, Mr. Bernstein, who sought entrance into Russia as a special correspondent of the New York "Sun," was debarred on the charge that by his writings he had sought to do injury to the autocracy.

During all his journalistic work, Mr. Bernstein maintained a deep interest in Jewish affairs, and was one of the earliest, after the Russo-Jewish exodus, to interpret that element of the "new immigration" to the American public.

In 1913, he was elected Secretary of the American Jewish Committee, a position which he held until the following year when he founded the well known Jewish daily, "The Day," of which he was editor for two years, when he acquired the "American Hebrew, which he was the publisher and editor for three years, after which he re-sumed his journalistic work. In 1921, he published "The History of a Lie," in which he exposed the notorious "pro-tocols of the Wise Men of Zion," as a clumsy forgery. Since June, 1923, Mr. Bernstein has been the editor of "The Jewish

#### RABBI LOUIS GROSSMAN OF CINCINNATI DIES

(Jewish Daily Bulletin)

Cincinnati, Sept. 24.-The body of Dr. Louis Grossman, rabbi of the Plum Street Temple Congregation in this city for thirty years and rabbi emeritus when he died, will arrive from Detroit today, accompanied by Dr. Grossman's brothers, Dr. Rudolph Grossman of New York and C. Grossman of Chicago and will lie in state in the temple. The funeral services will be conducted by Rabbi James G. Heller, rabbi of the temple; his father, Rabbi Max Heller of New Orleans, a classmate of the deceased in college and university; Dr. Julian Morgenstern, President of the Hebrew Union College, and Dr. Leo M. Franklin.

Dr. Grossman has been principal of the Teachers' Institute of the Hebrew Union College from 1909 to 1921.

Rabbi Grossman, who was sixty-three years of age, was a former President of the Jewish Religious Educational Association and of Hebrew Union College, Cincinnati. He founded a number of Hebrew educational and religious organizations, including the Western Association of Jewish Min-isters, of which he was honorary president.

Rabbi Grossman was a noted lecturer and the author of a score of books. Among his last literary works was the "Science of Comparative Religions," a treatise on modern and ancient theology, and the Biography of Isaac M. Wise, Jewish educator.

Dr. Grossman was born in Vienna,

Austria, Feb. 24, 1863, the son of Rabbi Ignatz and Nettie Rosenbaum Gross-man. Rudolph G. Grossman is a brother.

Coming to the United States as a youth he entered the University of Cincinnati and in 1884 received his Bachelor of Arts degree there. In the same years he also completed his rabbinical training at Hebrew Union College, which gave him a D.D. five years later and a Doctorate of Hebrew Law in

For the first fourteen years of his career he was rabbi of Temple Beth El in Detroit, from 1884 to 1898. Then followed twenty-four years as rabbi of the Congregation B'nai Jeshurun in Cincinnati. Recently he had been at-tuched to the Plum Street Temple in that city. His other affiliations were many, as educator, editor and leader. He served several terms as President of the Central Conference of American Rabbis, and he was Professor of Ethics, Theology and Pedagogy at Hebrew Union College from 1898 to 1922.

abject misery, but it has strengthened all the means of reconstruction and has given new hope to Eastern European Jewry. "We have made splendid progress in

Russia. I have been in that country twice within the last twelve months and visited almost all of the colonies the Joint Distribution Committee has established, viewing them in all stages of development. I could hardly believe my eves when on my second visit, twelve months after the first, I saw neat villages with hard-working Jewish peasants, Jewish children playing and the atmosphere of a well-conducted and fairly prosperous peasant village, where twelve months earlier I had seen only dug-outs, barracks and a few adult Jews tilling the soil. It seemed a miracle. "The agricultural work stimulated by

the Joint Distribution Committee has aroused the admiration of everybody, and will live in history as one of the most admirable constructive works the Jews have ever performed. The settlement on the land has taught the Jews and the non-Jews of Russia that the Russian Jews are able to work in all lines of human endeavor and to adjust themselves to the most extraordinary changes in their economic life. there still remain many thousands of Jews in the towns and villages of Russia whose life is one of starkest tragedy and for whom relief measures must be continually strengthened."

#### PLAN JEWISH HOSPITAL FOR MENTAL DISEASES

Title to a building has been taken by the Jewish Mental Health Society for a hospital for Jewish mental cases which will be the first of this character organized by and for Jews, according to an announcement by Dr. Israel Strauss, president of the Board of Directors.

Dr. Strauss in presenting the plans of the new hospital stated: "The lack of provision for the care of Jewish mental patients is due to ignorance of the causes and nature and right treatment of mental disorders. Jews discovering a case of mental disease in their family, unable to pay the high fees of a commercial sanitaria, have no other recourse but the commitment of the patient to a state hospital. An Orthodox family is reluctant to place a member in a non-Jewish environment

"During the calendar year 1925 at two of the three hospitals to which New York City patients are committed, 365 Jews forming 19 per cent of the total, were admitted. An average of more than 100 Jewish mental cases pass through the psychopathic wards at Bellevue hospital every month.

"Due to this condition a group of physicians realizing this need, associated themselves with a group of laymen under whose auspices the Jewish mental hospital is being projected. The hospital, we hope, will have adequate provisions for the prevention, the discovery, the care and cure of mental disorders in the Jewish population of

New York City.
