TEACHERS ORDINANCE Jewish Teachers May Teach Where Roumanians Are Employed (Jewish Telegraphic Agency)

Bucharest, Oct. 6.-Relief for Jewish teachers in Roumania was in sight yesterday when new regulations concerning teachers were issued by the Ministry of Education.

The Ministry issued a circular annulling the former circular promulgated Angelescu, according to which Jewish teachers were barred from the Roumanian schools.

The new circular permits the employment of Jewish teachers in those schools where Roumanian teachers are also employed.

NABLUS ARABS STRIKE AS PROTEST AGAINST CATTLE PLAGUE OUARANTINE (Jewish Telegraphic Agency)

Jerusalem, Oct. 6 .- A one day protest strike was proclaimed by the Arab inhabitants of Nablus against the government's quarantine in connection with the cattle plague now prevalent in the country.

The protest was directed against the strict enforcement of the regulations promulgated by the government in connection with the plague. The strikers declared that their action was due to the fact that the cost of living in the town has been increased since the regulations were issued by the government. Many shops and factories have been closed.

PALESTINE WILL HEAR ADDRESS ON PROHIBITION (Tewish Telegraphic Agency)

CHICAGO SEMINARY **ENROLLS 400 STUDENTS**

HAAS DEMANDS HALF MILLION MARKS INDEMNITY (Jewish Telegraphic Agency)

Berlin, Oct. 6 .- Indemnity amounting to half a million marks was asked from the state of Prussia by Rudolf Haas, German Jewish merchant who was falsely accused of murder in an anti-Semitic conspiracy.

Mr. Haas presented his claim on the ground that the false accusation directed against him cased him damage and that many of his business relations have been broken off during the agitation.

AMERICAN FEDERATION OF LABOR TO CONDEMN ALIEN RECISTRATION BILL

Manufacturers' Association for Bill

(Jewish Daily Bulletin) Detroit, Mich., Oct. 6.—A resolution condemning the proposed Alien Regis-tration Bill was presented at the con-

vention of the American Federation of Labor here today by J. M. O'Hanlon, delegate of the New York State Federation of Labor.

The resolution points out that the proposed legislation for the registration of foreign born workers would permit photographic and finger printing and make it impossible for the foreign born to participate in the struggle of American Labor for a higher standard of living.

Cyrus S. Ching, Chairman of the Immigration Committee of the National Association of Manufacturers, in his report to the annual convention of the Association in session at the Waldorf Hotel, expressed the committee's doubt of the new immigration quota based upon "the national origin test," which is to become effective in 1927. Constant intermarriage, he said, made it dubious whether we have the date upon which to predicate even approximately racial origin. Mr. Ching recommended that the registration of

aliens should be made compulsory by Commissioner General of Immigration Harry E. Hull who addressed the convention declared that the present restrictive policy of the Government on immigration should be upheld. He recommended the adoption of some means of registering the 2,000,000 to 3,000,000 aliens now in this country who are considering themselves citizens and will only learn for the first time that they are not should they leave this country and attempt to recutting down the admission of aliens had done away with the day of cheap labor. EXPLAINS SITUATION IN COUNTRY TO J.T.A. DIRECTOR (Jewish Telegraphic Agency Mail Service)

Budapest, Sept. 22.—Hungary has now reached the stage of stabilization in spite of the severe economic crisis caused by the war, the two revolutions

and the inflation period, according to Dr. Joseph Vass, Vice-Premier and Minister of Welfare, in an interview he granted Jacob Landau, managing director of the Jewish Telegraphic Agency. The difficulties with which Hungary has to contend now are easily recognizable. The large customs-union constituted by the Austro-Hungarian Em-

pire with its fifty million inhabitants,

has been split into five different parts.

Hungary has lost her outlet to the sea,

is compelled to import raw materials,

and the old opportunities to dispose of

her products in the country have gone.

Hungary must now look for foreign markets and compete with Czecho-Slovakia, Germany and other States. spite of that Hungary has succeeded in stabilizing her currency and is gradually rising again economically. The Jews have taken a considerable part in this work. They have restored the connections with the financial powers abroad which were broken off by the war and as before the war they are again taking an active part in the industry and trade of the country, Dr. Vass stated. The anti-Semitic movement in Hungary, Dr. Vass declared, results from The overwhelming and three causes.

leading part played by the Jews in trade, finance and industry have contributed to the development of an anti-Semitic movement. Secondly, not all the Hungarian Jews tried to prevent the streaming into Hungary of thousands of new Jewish immigrants before and during the war. It is true that a number of Jews saw the danger and took preventative measures. but the non-lews who had grown accustomed to the native Jews could not feel the same toward the thousands of new Jewish immigrants and refugees. This contributed a great deal to the growth of the anti-Semitic movement. Thirdly, there was the excessive participation of the Jews in the Radical movements. It is true that Jews were to be found in all the parties, but in no other party were they as strong and holding such leading positions as in the Radical Parties. While the Jews constitute only five to six per cent of our population, fifty per cent of the leading personages in the Radical Parties were Jews. Obviously then, there was an excess of Jewish participation in the Radical movement, he said.

CHICAGO U. J. C. CONFERENCE AFFORDS WAY FOR ESTABLISHING HARMONY IN AMERICAN JEWRY ON RELIEF AND PALESTINE

Non-Partisan Observer Reviews Situation in Both Groups; Uncertainty Created by Recent Controversy Must Be Speedily Cleared Up, He Says; Way for Harmony and Peace Open

The approaching national conference of the United Jewish Campaign and the Joint Distribution Committee is viewed with great interest in wide circles of American Jewry. Interest centers not only in the forthcoming reports concerning the work accomplished by the Joint Distribution Committee in the various European countries and in Russia during the pass years of the conference of the pass of the conference but also in the effects which the proceedings of this conference may have on the political and social constellation of the American Jewish Committee of the

The controversy which reached its peak in the summer months between the leaders of the Zionist Organization of America and the United Jewish Campaign, as well as the forthcoming arrival of Dr. Chain; Weizmann, president of the World Zionist Organization, to complete the negotiations for the extension of the Jewish Agency to include American non-Zionists, add interest to the proceedings. Rumor has it that a request for the postponement of the Chicago conference until after the arrival of Dr. Weizmann, when the situation will have been clarified, was presented but not acted upon.

A feeling of uncertainty prevails in various circles of Jewish leadership as to the forthcoming course of the two leading groups of American Jewry which seem to have been estranged in recent months. The fate of the long expected and much talked of Jewish Agency depends upon a reconciliation which would lead to harmonious action in both fields of American Jewish endeavor, that of general relief work in Europe and reconstruction work in Palestine. Much uncertainty prevails in both groups and the situation is viewed with anxiety and fear for the future harmony within American Jewry. Some are wondering whether the Chicago conference will not hear the echoes of the strife at the Philadelphia conference and the unharmonious sounds of the summer months' controversy.

Y JUDGE FRIEDLANDER DIES FOLLOWING YEAR'S ILLNESS

Funeral services for Samson Friedlander, president-justice of the Municipal Courts, who died late Monday night, were held yesterday at his home, 230 West Ninety-fourth Street. He had been ill about a year. He has been a Municipal Court justice since 1917 and president-justice since January, 1924.

Despite his illness, Justice Friedlander was active on the bench until last June. Justice Friedlander was born in Manasquan, N. J., the son of Jacob H. and Dora Friedlander, Following his

Manasquan, N. J., the son of Jacob H. and Dora Friedlander. Fellowing his graduation from high school he became a reporter on a Manasquan newspaper and remained there until he entered the law school of New York University. On receiving his degree he opened law offices at 271 Broadway.

In 1915 he was elected alderman and two years later was elected a Justice of the Municipal Court. When Justice Aaron J. Levy, then president-justice, was elevated to the Supreme Court Bench Justice Friedlander was elected to fill the vacancy.

Justice Friedlander was the recipient grew years ago of a bronze tablet, prescated by captains and lieutenants of the Fire Department in appreciation of his services in obtaining salary increases for them.

ISRAEL ZEVIN, WELL KNOWN JEWISH WRITER, DIES AT 54 Israel J. Zevin, noted American

Jewish writer, better known to the Yiddish reading public as Tashrak, the pen name he used, died yesterday at his home in Boro Park, Brooklyn, following a brief illness. Mr. Zevin was 54 years old.

He was born in 1872, in Zarbi, Russia, and at a very early age became known as a keen minded scholar and Hebrew student. In 1889 Mr. Zevin arrived in the

United States where, during the first few years, he earned his living by peddling. Later, however, he took to writing and became a regular con-tributor to the "Jewish Daily News." He soon made a name for himself as a writer of humorous stories and novels wherein the life of American Jewry, at that time in its first moulding, was cleverly depicted. English versions of some of his stories also appeared in the metropolitan papers. Just before his death Mr. Zevin was engaged in a translation of the Midrash into Yiddish.

NATIONAL CONFERENCE IN NEW YORK ON OCTOBER 24

A national conference of the American Ort will be held at the Hotel Penn-

sylvania on October 24.

Reports of the work of the Ort in Europe will be submitted to the conference. This report includes the work of the Cooperative Tool Supply Company, one of the branches of the Ort. which supplies tools to artisans, farmers and industrial workers.

The company, which is less than two years old, has helped thousands of Jewish families by extending them long term credits for tools and implements needed to obtain a livelihood. According to all present indications the business of this Company will reach the million dollar mark by the end of the fiscal year, a statement of the Ort declared. The Company has been able to obtain very favorable prices from tool and supply manufacturers on long term credits, and only recently in Leningrad supplied one of the Russian Cooperative agencies with sufficient tools to aid 1,200 families. Thus far the activities of the Cooperative Tool Supply Company have been carried on without the loss of a single dollar. The Company reports that very often the loans made to Jewish agriculturists and artisans are paid back long before the period of the time extended, which in some cases is over fourteen months. The Company was initially capitalized at \$20,000 and has made rapid progress with this sum and a turn-over. It is planned now to substantially increase the capital of the Tool Supply Agency and thus enlarge its scope of activities.

than one-fourth of that for 1907, the peak year of immigration," said the Commissioner. "During the past two fiscal years ended June 30, 1925 and 1926, respectively, 294,314 and 304,488 immigrants were admitted to the United States. In the fiscal year 1907 immigration reached a total of 1,225-

The Commissioner discussed the problem of dealing with the citizenship of women. "Prior to Sept. 22, ship of women. "Prior to Sept. 22, 1922, on which date the Cable Act was passed," said the Commissioner, "the marriage of an alien woman to a citizen of the United States made her a citizen and conversely the marriage of an American citizen woman to a foreigner forfeited her citizenship. Since that date an American woman who married a foreigner (except in certain cases where the husband is ineligible to become a citizen) does not lose her citizenship, nor does the American husband confer citizenship on his foreign wife. As a result of this situation we have had some very hard cases before the department on appeal. We had to regard as aliens under the law women who are as much citizens as you or I and who have wanted to return from foreign residences where they have been living with their husbands. I think that in a case like that a general discretion should be conferred upon the department to authorize the readmission of expatriated native and naturalized citizens."
