ARABS REPEAT COMPLAINTS IN MEMORANDUM TO PERMA- NENT MANDATES COMMISSION

Decrease in Jewish Immigration Cited
As Proof of Their Contentment

(Jewish Telegraphic Agency)

Jerusalem, Mar. 19.—The temporary decrease in the volume of Jewish immigration into Palestine is one of the arguments made by the anti-Zionist Palestine Arab Executive in its memorandum which will be submitted to the forthcoming session of the Permanent Mandates Commission.

The correspondent of the Jewish Telegraphic Agency here learns that the memorandum of the Palestine Arab Executive expresses the continued opposition of this body to the Zionist policy in Palestine. The decrease in Jewish immigration confirms the contention of the Palestine Arab Executive that the government's policy in Palestine was wrong, it argues.

The memorandum further complains that the recommendations made by the Permanent Mandates Commission with regard to the situation in Palestine were not carried out by the Palestine government; that the number of British officials in the country has been increased; that legislative institutions have not been established.

The Executive also takes up the recent dispute between Arab villagers and the Palestine Jewish Colonization Association with regard to the land in Caesarea. The Palestine Arab Executive complains that in this dispute the Palestine government acted contrary to the instructions of the British Colonial office.

URGE REELECTION OF JUDGE MACK TO HARVARD BOARD

Boston, Mar. 19.—A movement on the part of the Harvard Alumni Association to place Judge Julian W. Mack on the Board of Overseers of Harvard University was launched by William P. Evans, a Boston lawyer and Harvard graduate who filed with Winthrop H. Wade, secretary of the Board, a petition signed by 200 graduates.

Among the signers of the petition are three judges of the Superior Court of Massachusetts, also Professor Richard C. Cabot of Harvard, Elihu Root, Jr., and Walter Prichard Eaton.

Judge Mack was a member of the Board three years ago.

JUDGE RAYMOND TO ANNOUNCE DECISION TODAY ON ADMISSIBILITY OF "INDEPENDENT'S" ANTI-SEMITIC PROPAGANDA IN FORD-SAPIRO TRIAL

Cameron, Ford's Editor, Testifies That Auto King Is Lenient to Soviet; Senator Reed Confused As to Who's Who Among Those He Accuses; Is Corrected By Sapiro Counsel When He Mentions Non-Jews As Jews

(Jewish Daily Bulletin)

Detroit, March 19.—W. J. Cameron, editor of the "Dearborn Independent," took the stand Friday as the first witness in the \$1,000,000 libel suit of Aaron Sapiro against Henry Ford, being tried here.

Cameron's testimony was brief and called forth so many objections from Senator James A. Reed, chief of defense counsel, that Judge Fred M. Raymond halted the trial and called for a conference behind closed doors. The break came when William H. Gallagher, Sapiro's chief counsel, asked Cameron certain questions about articles printed in the "Dearborn Independent" prior to those which attacked Sapiro. Senator Reed was on his feet immediately objecting to the question as irrelevant.

Gallagher protested that he asked about these earlier articles in an effort to determine just what the term "International Jew" had come to mean to

the "Independent's" readers, and that this information was necessary to properly determine the nature of the libels against Sapiro. Judge Raymond at this point called the counsel for both sides into his private chamber to settle the point of procedure. His decision on the matter is expected when court opens again on Monday.

Questioned as to Ford's views as compared with those of the "Dearborn Independent," Cameron said: "Mr. Ford is strong against war and all that pertains to it and the paper stands for preparedness. Mr. Ford looks on the Russian Soviet Government more leniently than we do."

"Do you mean he favors the Soviet Government?" Gallagher questioned. "He's just more lenient towards it than the 'Independent.'" Ford's counsel continually objected to any questions asked Cameron pertaining to Ford's views on the Jewish race, the international "Ring of Jews," or any other racial questions. Frequently the counsel for both sides engaged in arguments concerning the procedure, and these held up the trial considerably.

At one time Gallagher asked: "Have you discussed at any time with Mr. Ford his attitude towards the money power?" This question was instantly opposed by Senator Reed. Senator (Continued on Page 4)

AUSTRIAN JEWS URGED TO VOTE FOR JEWISH TICKET IN NATIONAL ELECTION

"For Judaism and Austria" is Campaign Slogan

Vienna, Mar. 19.—The Jewish population in Austria has been asked to cast its vote for a Jewish ticket in the forthcoming parliamentary elections which will be held on April 24.

"For Judaism and Austria." This is the campaign slogan of the Jewish election committee, which has issued an appeal to Austrian Jewish voters. The committee, which consists of representatives of the Zionists and nationalists, supports the Jewish ticket. The appeal urges a united Jewish front to counteract the influence of the anti-Semitic parties, the Christlich Soziale and the Austrian Social Democrats, who are antagonistic to the Jews.

ANTI-SEMITIC GROUP LOSES GRIP IN GERMAN PARLIAMENT

Berlin, Mar. 19.—The political influence of the anti-Semitic Voelkische group in the German parliament is fading rapidly with the secession of the National Socialists. Due to the decrease in their numerical strength, the Voelkische group will have to be disbanded. It has already lost its right to representations in the various parliamentary committees and the Committee on Committees.

RABBI SIMON HONORED BY GERMAN RED CROSS

Washington, Mar. 19.—Rabbi Abram Simon, former president of the Central Conference of America Rabbis, has been decorated with the Order of Honor of the German Red Cross. The decoration was conferred by the German Ambassador, Baron Ago Maltzan. Rabbi Simon served nine months as a captain in the Red Cross.

A similar honor was recently conferred upon Emile Berliner, noted Jewish inventor of this city.

"CITY OF JERUSALEM," AIRSHIP TO BE BRITISH-INDIA LINK. IS INDUCTED INTO SERVICE

(Jewish Telegraphic Agency)

Jerusalem, Mar. 19.—The airship "City of Jerusalem," which is to link Great Britain with India via Palestine, was christened yesterday by Lord Plumer, High Commissioner of Palestine, at impressive ceremonies held at the Kalandia airdrome. The High Commissioner, accompanied by Col. Symes and officials of the air service, made an experimental flight following the exercises.

In opening the ceremonies, Col. Burchall, assistant manager general of the British Imperial Airways, stated that Palestine is a wonderfully developed country and he expects Palestinians to make use of the latest methods of transportation. It was impossible, for technical reasons, to establish the air station in Jerusalem, but they decided to name this liner in the air service the "City of Jerusalem."

The High Commissioner, replying to the address of Col. Burchall, thanked him on behalf of the people of Palestine for naming the airship the "City of Jerusalem." Palestine is an important link between Great Britain and the East. The Imperial Airways do not merely join the localities technically but do much more, the High Commissioner declared.

DR. EMANUEL LIBMAN SAILS FOR PALESTINE

Dr. Emanuel Libman, New York heart specialist, sailed for Palestine on Saturday as representative of the American Jewish Physicians Committee, to conduct a series of lectures in the Medical Department of the Hebrew University at Jerusalem. A clinic will be conducted in the Rothschild Hospital of the Hadassah Medical Organization.

Dr. Libman is treasurer of the American Jewish Physicians Committee and a member of the Board of Governors of the Hebrew University.

TEXT OF JOHNSON BILL TO FURTHER RESTRICT IMMIGRATION PUBLISHED

Washington, D. C., Mar. 19.—The bill calling for a further restriction of immigration which Chairman Johnson of the House Immigration Committee introduced on the eve of adjournment of Congress, and which he stated will be re-introduced by him at the next session, provides for the repeal of the National Origins provisions of the present Immigration law. At present these provisions have only been postponed for one year. The full text of Representative Johnson's bill is as follows:

"That immigration quotas, as determined under subdivision (a) of section 11 of the Immigration Act of 1924, shall be reduced 10 per centum per annum from and after July 1, 1928, until June 30, 1933, after which date the annual quota of any nationality shall be 1 per centum of the number of foreign-born individuals of such nationality resident in continental United States as determined by the United States census of 1890. Provided, that from July 1, 1928, until June 30, 1933, the minimum quota of any nationality shall be 100, and after June 30, 1933, the minimum quota of any nationality shall be fifty: Provided further, that during the fiscal years 1929 and 1930 quota numbers equal to one-half of the reductions herein authorized for such fiscal years shall be set aside for and made available to the unmarried children under twenty-one years of age and the wives of aliens lawfully admitted to the United States, married prior to July 1, 1924: Provided further, that after July 1, 1928, the maximum quota for any country entitled to quotas shall be 25,000.

"Section 2. The national origins provisions of the Immigration Act of 1924, being subdivisions (b), (c), (d), and (e) of section 11 of the Immigration Act of 1924, are hereby repealed.

"Section 3. The Secretary of State and the Secretary of Labor shall jointly make regulations carrying this Act into effect."

JACOB LANDAU SAILS FOR PALESTINE ON AQUITANIA

Jacob Landau, managing director of the Jewish Telegraphic Agency and the "Jewish Daily Bulletin," sailed Friday night on the Aquitania for Europe and Palestine.

While in Palestine Mr. Landau will take steps to extend the service to the American and Jewish press from Palestine and the Near Eastern countries, through the Palestine Telegraphic Agency. During his trip Mr. Landau will also make a study of Jewish conditions in Roumania, Yugoslavia and other Balkan countries.

DIGEST OF PUBLIC OPINION ON JEWISH MATTERS

Charges Press of Germany Is Largely Anti-Semitic

The charge that, so far from being controlled by Jews, as alleged by the anti-Semites, the press of Germany is largely under anti-Semitic influences, was made by Georg Bernhard, editor of the "Vossische Zeitung," in a lecture delivered on Feb. 21 in Breslau and quoted by the "Juedische Zeitung" of that city, wherein we read:

"Dr. Bernhard declared that the charge that the press is being 'Judaized' can easily be disproved. Jews are to be found as journalists only in Berlin and other large cities and even here only in few of the newspapers (Mosses, Ullstein, 'Frankfurter Zeitung', to some extent Scherl). The point where public opinion in Germany is chiefly influenced is the province and the province is dependent on the great news agencies, where Jews are almost completely barred. No matter how important the metropolitan press may be the voter stands under the overwhelming influence of sources which at best are not directly anti-Semitic.

"In Berlin and in Frankfurt am Main," Dr. Bernhard continued, "there are of a total of 350 journalists, 108 Jews, many of whom are converts. In Germany, however, there are some 4,000 journalists, the majority of whom are anti-Semites."

On the Anti-Semitic Propaganda of Mrs. Stetson's Christian Scientists

The anti-Jewish and anti-Catholic propaganda conducted through radio by Mrs. Stetson, who is the leader of a seceding wing of the Christian Science movement, is the subject of comment in the "American Israelite" of March 17. The paper observes in part:

"Mrs. Stetson's absurd attitude drew forth a long reply from an 'unnamed Jewish leader,' which is much to be admired because of its candor and temperate statements. Naturally it is a waste of time to point out the entire nonsense of such statements as those by Mrs. Stetson and her accomplice and their utter futility for anything except to continue and help spread the pernicious doctrines which many of the Christian churches are just now preaching against the Jews, the Roman Catholics and a few other sects under the ban of these one-hundred-per-cent-Americans, not to say Christians. The so-called Christian Scientists as represented by Mrs. Stetson must not be confused with the original Church of Christ, Scientist. The latter are people of the highest intelligence and entertain the broadest views toward other beliefs and nationalities."

COL. KISCH DEFENDS ZIONIST EXECUTIVE IN JERUSALEM; REPLIES TO CRITICISM

Defends Zionist Officials; Have Not Received Salaries for Past Three Months

Jerusalem, Feb. 22.—The prolonged period of economic depression through which Palestine is passing, has not unnaturally produced a wave of criticism directed against the Zionist Executive and the activities which it has conducted within the limits of the available resources to remedy the situation and to foster the upbuilding of the country, Colonel Kisch, the head of the Palestine Zionist Executive, states in a letter which he has issued to the Palestinian press.

"Time and the explanations to be given at the next Congress," he proceeds, "will prove to what extent these criticisms are justified. On the other hand, I find it necessary to reply at once to the unjust and ill-founded charges which have been raised in many quarters against the officials of the Zionist Organization. These charges, which have been repeated in the Jewish press both in Palestine and in the Diaspora, may be summarized as suggesting that the Zionist Executive, and its dependent institutions (Keren Hayesod, Keren Kayemeth, etc.) are greatly overstaffed with idle officials who live in luxury and make no sacrifice for the common interest during the present distress.

"Our staff in Jerusalem comprises 90 officials, of whom 5 receive £E41 to £E30, 4 £E36 to £E40, 16 £E26 to £E35, 18 £E19 to £E25, 28 £E12 to £E18 and 19 £E8 to £E11.

"This scale of remuneration was fixed by a neutral commission which was set up in April 1922, and whose recommendations in the matter of salaries were at once accepted by the Executive. The scale is moreover to be examined by a new neutral commission appointed by the Executive in accordance with the decision of the last Actions Committee.

"In regard to the suggestion that the staff of the Executive is excessive, for the benefit of those living in the Diaspora who are not well acquainted with the scope of the duties of the Executive, I would mention that this staff has to handle the work of the following departments, Labor Department, Immigration Department, Education Department, Finance Department, Auditing Department, Political Department, Vaad Habriuth and General Secretariat.

"The Executive is responsible for the control of the disbursement of a Congress budget of £500,000 and anyone acquainted with business methods will appreciate the volume of bookkeeping and account which is involved, in order to avoid wastage and possible loss in connection with the expenditure of so vast a sum. Apart from the actual work connected with current expenditure, the Executive deals with a vast amount of work independent of any monetary payments, as for example, correspondence and negotiations with the Government on a great variety of issues, preparation of reports for League

of Nations; replying to inquiries from would-be immigrants or to questions connected with trade and industry; Labor questions, etc. Finally it should be mentioned that between one and two hundred persons come to visit the office of the Executive daily for personal information, and have to be received and dealt with by members of the staff.

"I do not hesitate to say, and I can speak with some knowledge of the subject that the staff which we employ is by no means excessive for the work which it has to do, and, which but for the exceptional devotion and zeal of the staff, would not be effectively dealt with without a considerable increase in personnel. I should add that many members of the staff remain extra hours in the office after closing time, while others regularly take office work to their homes to do at night. No overtime salaries or allowances are paid.

"There remains the question of the contribution of the staff to the common welfare, both generally and with reference to the present crisis.

"I would first mention that not only does the whole staff pay Maasor to the Keren Hayesod, but that whenever there is a collection of any national purpose, as for example, inscribing a name in the Golden Book of the Jewish National Fund, the first address to be visited by the collectors is that of the officials, and such appeals invariably meet with a generous response. On the occasion of the recent collection by the Moazath Poalei Jerusalem for the unemployed, unmarried officials of the Palestine Zionist Executive all gave 12 days' salary to the workers' relief funds, and married officials gave nine days' salary. Finally, it is with regret that I have to record that the officials have received no salaries for the last three months, and have loyally accepted this suspension of what has become due to them. It is a deplorable thing that the Executive has been obliged thus to hold up the salaries earned by the officials by continuous and steady work under conditions of great pressure, and were it not for the devotion of the officials and for their desire to share the distress of their comrades in the field of labor, such suspension of salaries would have produced demoralization, which has happily been entirely absent.

"Instead of attacking and criticizing the officials, Jewish labor in Palestine and supporters of Zionists funds everywhere should appreciate both the work they are doing and the sacrifice they have made. It seems to me that the Jewish public ought to have helped the Executive to create a Civil Service of expert officials devoted to the national aspirations and honored by the public for their labors. It would also be more appropriate and desirable for the critics to adopt the custom prevailing in enlightened countries, namely: not to attack officials directly, but to direct criticism—if there be any—to the elected executive who are responsible to the highest national bodies," Col Kisch concluded.

SIR WYNNDHAM DEEDES, DISTINGUISHED VISITOR, IS FETED BY ZIONISTS

Britisher Urges Non-Jews to Support Palestine Work Which Is Unique Undertaking in World's History

A luncheon for Sir Wyndham Deedes, former civil secretary of the Palestine government who has come to the United States to aid in the United Palestine Appeal, was given last Thursday at the Commodore Hotel prior to Sir Wyndham's departure for the west.

Emanuel Neumann, executive chairman of the United Palestine Appeal, presided. Dr. Chaim Weizmann, Dr. Stephen S. Wise and Morris Rothenberg, chairman of the Board of Directors of the Keren Hayesod, welcomed the distinguished guest.

In describing the devotion of Sir Wyndham for the Zionist movement and his helpfulness during his stay in Palestine, Dr. Weizmann stated: "We Jews have no titles to confer. We have only one expression which may be properly applied to Sir Wyndham. He is one of the 'Chassidei Umot Ha'olam' (Righteous men of the nations) and as such he will long be remembered."

Sir Wyndham Deedes, in a lengthy address, outlined his attitude toward the Zionist movement and his belief in the ultimate success of the rebuilding of Palestine as the Jewish national home. He urged the non-Jewish world to set aside its prejudices with regard to Jews and help in the rebuilding of Palestine as it will give the Jewish people an opportunity to live a wholly Jewish life, which will be an example for the entire world.

Sir Wyndham stated that the Jews in Palestine will have the opportunity of showing the world the real meaning of the national idea.

"I regard Zionism as a national, religious movement," he stated. "I often fail to understand why some view Zionism as a purely national movement which is totally secular and is opposed to religion. So far as Jewish life goes, the national idea and religion are so closely interwoven that they are inseparable. We should not overlook the fact that in Judaism the religion was a natural development of the life of the nation and was not superimposed upon an already existing national culture as was the case with the Christian nations.

"An opportunity for the Jewish people to live a wholly Jewish life will be a tremendous thing for the world to observe and emulate," he declared.

COL. LEHMAN TO DIRECT SMITH'S 1928 CAMPAIGN

Colonel Herbert H. Lehman will succeed Lieut. Gov. Edwin Corning as chairman of the Democratic State Committee. He will also become the temporary head of the movement to nominate Governor Smith for President, it was stated.

JUDGE WILL RULE TODAY ON ADMISSIBILITY OF 'INDEPENDENT' ARTICLES

Reed finished his address to the jury before noon. In it he alleged that American farmers lost millions of dollars through the Sapiro plan of cooperative marketing, while Sapiro collected \$1,000,000 in fees. Reed told the jury he would introduce evidence concerning a secret meeting in Chicago in October 1925 which was attended by former Governor Frank O. Lowden of Illinois, Eugene Meyer, Jr., former head of the War Finance Corporation and Robert H. Bingham of Louisville.

This meeting, Reed held, "was called to consummate the plans of Mr. Sapiro in the formation of the cooperative wheat association in all the wheat states of the country, and then the federation of these associations into national exchanges, and then an international exchange."

"This, however, was not the program of the American Farm Bureau Federation. Later these plans became public, and the federation refused to join in them."

Gallagher interrupted to ask what that had to do with the libel case.

The Senator declared: "If counsel will let me have the floor long enough to say one word—it appears in the pleadings that 'The Independent' has charged Sapiro was trying to form an international association and this evidence bore on the charge."

"But if the court please," Gallagher insisted, "we do not claim any libel in having the intention to advertise to the farmers of the world to combine for their interests. Our libel charge is that they charge we are one of a gang of international Jews who are organizing the farmers for the benefit of the international Jews."

Under fire of the objections on the part of Sapiro's counsel, Senator Reed showed complete confusion as to who is who in the alleged "international ring."

"If Frank O. Lowden is a part of this conspiracy, is one of the gang of international Jews—if they can prove that—all well and good," Gallagher declared.

"Oh, well," Senator Reed said, "Eugene Meyer was a Jew and Sapiro was a Jew and Sam Guard was a Jew."

"Sam Guard is not a Jew," replied Sapiro. "Never was a Jew."

"Then I am in error, but Herbert Steen?"

"Herbert Steen never was a Jew and is not today."

The argument continued until Judge Raymond declared he could not rule then on admissibility of evidence to come later and allowed the Senator to continue.

"I want to show," the Senator went on, "that these people planned to control the wheat of the United States and to control wheat internationally. That is the very charge that has been made, and that, I think, Mr. Gallagher said we could not prove."

"Prominent Jews advanced loans to carry out Sapiro's plan, he continued. Bernard M. Baruch advanced \$3,000 for

ISRAEL MATZ SEES FUTURE FOR PALESTINE INDUSTRIES

"The encouragement of industries will solve the unemployment situation in Palestine and assure a sound development," declared Israel Matz, well known New York business man and philanthropist, who returned from Palestine last week.

"The 6,000 unemployed Jewish workers could find steady employment if the orange industry were more widely encouraged. Palestine exports annually two million cases of oranges. If ten times as many could be exported, a market for this product would still be found because Palestine oranges are in demand."

"Funds put in Palestine orange growing are a good investment from a business viewpoint. A company with a capital of a half million dollars has already been formed in Palestine for the purpose of extending orange growing."

Mr. Matz also stated that in his opinion it would be easy to develop the sugar industry, the granite industry and grapefruit growing.

A Jewish theatre to cost about one million dollars is to be built on Eastern Parkway, Brooklyn. The project was announced yesterday with the purchase by Hoodack, Gold & Schreier, of the property at the corner of Eastern Parkway and St. Johns Place. Plans already prepared by Harrison Wiseman, who designed the Jewish Art Theatre in Manhattan call for a structure to seat 1,800 persons. The site valued at \$155,000, was sold by the Stockman Realty Corp., and a twenty-one year lease was simultaneously given to William Roland, who will operate the property.

The Carnegie Corporation of New York, in making public a list of 29 fine arts students recommended for scholarships for 1927-1928, has named as alternate Daniel Goldstein of New York, graduate of Columbia University 1925, graduate student 1926-27, to continue graduate study at Columbia.

Meyer Schapiro of New York, graduate of Columbia 1924, graduate student in Europe 1926-27, was named for reappointment to continue study at Columbia. The appointments are to be made on March 22, following a meeting of the trustees.

the project; Julius Rosenwald, \$15,000; Bingham, \$2,000 and Sapiro put in \$5,000." "We will show you," Reed told the jury, "that thousands of farmers suffered losses totalling millions and millions of dollars as a result of Sapiro's plan. We will show you that Sapiro had in his mind a dream of an Empire."

"We will show you that it was Henry Ford's duty to publish these articles and that they were published in good faith and then we will ask you to find that Aaron Sapiro did not exploit the American farmer."

It is expected that Cameron will resume his testimony today.

JEW CANNOT ADOPT CATHO- LIC CHILD, COURT RULES

Julius Tannen, the actor, because he is a Jew, will not be allowed the custody of Martin ("Red") Ritter, the eleven-year-old youngster whom the Tannen family wished to adopt, according to a decision handed down in Children's Court on Friday. Mr. Tannen will bear all the financial responsibilities when Martin, who is a Roman Catholic, is placed in a Catholic family.

The law states that in adopting a child "commitment must be made when practical to an institution or a family or a person of the same religious faith or persuasion as that of the child." Judge Boyle said that there was no alternative.

The case was decided behind closed doors in Judge Boyle's ante-room. Judge Boyle afterward explained the law and praised Mr. Tannen's attitude which he termed wholly altruistic.

Martin is to be entrusted to the care of Mrs. Mae Hundrickson, of Laurelton, identified for many years with the work of the Children's Court. She is to find a home for him.
