

CLASH AT FORD-SAPIRO TRIAL AS JEWISH ISSUE PERSISTS; CAMERON QUIZZED

Letter of "Dearborn Independent" to Writer, Instructing Him to Get "Something Tangible" Regarding "Jewish Boys", Read by Gallagher, to Prove Jewish Issue; Cameron, "Independent" Editor, on Witness Stand, Fails to Name Members of Alleged "Band of Jews," or the "Band's" Headquarters; Jury Excused as Counsel Contend Issue

(Jewish Daily Bulletin)

Detroit, Mar. 21.—A letter from the "Dearborn Independent" to one of its writers instructing him to get facts regarding "the Jewish boys" who are "putting the works on the farmers," was read to the jury today by William Henry Gallagher, Sapiro's counsel in the \$1,000,000 libel suit against Henry Ford. This letter was adduced as evidence to show that Ford's organ, the "Independent," started out with a campaign against the alleged "Jewish gang" or "conspiracy" of which Sapiro was later named as a member. Thus the "Jewish issue," which the Ford counsel sought so assiduously to keep out, came up again and caused a clash which resulted at one point in the excusing of the jury while counsel argued the matter.

William J. Cameron, editor of the "Dearborn Independent," was recalled to the witness stand. He insisted that Ford was unaware of the anti-Jewish articles published in his paper. When asked to name some members of the alleged "Jewish gang," Cameron said he did not remember, nor did he know where the headquarters of the "gang" were located.

The letter read by Gallagher was written by R. H. Rowland, of the "Independents'" editorial department, to Harry H. Dunn of Berkeley, Cal., whose articles appeared under the pen name of "Robert Morgan." The letter, in part, follows:

"Don't snicker when I tell you that the Jewish boys are putting the works on the farmers. It began when Barney Baruch first became interested in Kansas after Wilson left the White House. Since then there has been a great deal of Jewish interest in the plight of the farmers, especially as to mortgaging their souls and bodies through the Government agencies, plus the various co-operative movements.

"We have been desirous of getting something tangible, and here seems to be the opportunity to clean up the West Coast situation. I don't imagine you will have much difficulty in rounding the facts up on this, although all of it will take considerable time. If you can get it we'll protect you, of course, and it will be as fully remunerative if not more so than the Abrams material.

"Let me know from time to time how the work is progressing, and if there is any trip you must take to gather the facts, go ahead, and send in

the expense account to us. I believe that you have an opportunity to do considerable 'chronicling' of the neglected truth' in this case."

Mr. Gallagher contended that the articles, which named a number of distinguished Jews, became a libel of Sapiro and each of the men named individually.

Charges and denials that Ford maliciously inspired articles in his "Dearborn Independent" alleged to libel the plaintiff preceded the resumption of testimony.

"We will show," declared Gallagher, "that Mr. Ford maliciously conspired in these libels in the 'Dearborn Independent', and we will show further that the 'Independent' is only the mouthpiece of Henry Ford.

"And we demand that he be penalized in proportion to his wealth; that he be

LEADERS EULOGIZE LATE DR. NATHAN AT FUNERAL SERVICES IN BERLIN

Berlin, Mar. 21.—Representatives of German Jewry as well as of East European Jewish communities, were present at the funeral of Dr. Paul Nathan which took place here yesterday.

James Simon, president of the Hilfsverein der Deutschen Juden, Edward Bernstein, Dr. Bernard Kahn, Judge Teitel and a representative of the Prussian government eulogized the late leader.

Edward Bernstein termed the late Dr. Nathan "the champion of democracy and the fighter against Ludendorffism."

"Anti-Semitism in Germany is stronger today than ever before. The loss of Dr. Paul Nathan is therefore especially deplorable," Mr. Bernstein said. He strongly attacked Ludendorff who, he said, is openly conducting and inciting propaganda for anti-Jewish pogroms.

Dr. Bernard Kahn, who spoke on behalf of the American Jewish Joint Distribution Committee, stated that Dr. Nathan was the initiator of the great American relief work.

Former government member Gothein exalted Dr. Nathan as a great German

SITUATION OF JEWS IN ROUMANIA WORSE, LUCIEN WOLF REPORTS

Anti-Semitic Propaganda Campaign, Threatening Safety of Jews in Roumania, Matter of International Concern, He Says; South African Government Urged to Bring Matter Before League

(Jewish Telegraphic Agency)

London, Mar. 21.—The situation of the Jewish population of Roumania is if anything worse than last month, declared Lucien Wolf, secretary of the Joint Foreign Committee at the monthly meeting of the Board of Jewish Deputies here on Sunday.

"The Jewish population is panic stricken and apprehensive. The anti-Semitic agitation is more inflammable than hitherto. The attitude of the anti-Semitic press and several organs which are in close touch with the Roumanian government is shameful. One man paper incites its readers to kill all Jews at sight." Such incitement is against international law. The responsibility rests entirely with the Roumanian government; the Roumanian government will be responsible for the results," Mr. Wolf declared in his report.

"The agitation now being carried on in Roumania is perhaps intended to intimidate the Roumanian Jews in order to prevent them from appealing abroad, but this is not a matter of concern to Roumania alone. It is a ques-

tion which concerns the protection of national minorities and is an international obligation. These attempts to intimidate the Jews are but another reason to take strong steps.

"Meanwhile, the Joint Foreign Committee continues its courteous relations with the Roumanian government, awaiting a reply to its protest. The Joint Foreign Committee is also in touch with our American and European co-religionists with whom we are working in this matter," Mr. Wolf said.

Asked whether it would be advisable to organize a protest meeting in London against the Roumanian government, Mr. Wolf stated that the Joint Foreign Committee is unable to organize such a meeting but "there would be no harm if such meetings against the treatment the Roumanian government accords the Jews would be held."

Tribute to the late Dr. Paul Nathan was paid at the session by D'Avigdor Goldsmid. "His death is a loss for the

ARABS WHO DESTROYED JEWISH AFFORESTATION WORK ARE TO BE TRIED

(Jewish Telegraphic Agency)

Jerusalem, Mar. 21.—Vadi Bustani, the Arab attorney who instigated the attack on the Jewish afforestation work in the neighborhood of Caesarea, will be tried in the Palestine court.

Bustani and ten other Bedouins, his accomplices in the uprooting of 4,000 Eucalyptus trees planted by the Palestine Jewish Colonization Association, were arrested. Under the provisions of the Palestine government Forest Ordinance, the maximum penalty is three years imprisonment.

ANTI-SEMITES RENEW RITUAL MURDER CHARGE

Berlin, Mar. 21.—Ritual murder agitation is being conducted by the "Illustrierter Beobachter," a publication of the anti-Semitic group headed by Adolf Hitler.

The newspaper publishes articles in which the Jews are accused of performing ritual murder and pictures purporting to show Jews drawing blood from a Christian boy accompanying the articles.

The "C. V. Zeitung," the organ of the Central Verein Deutschen Buerger des Juedischen Glaubens, demands today that the Berlin police intervene and confiscate the issue.

The Luisenstrasse and the Neue Wilhelm Strasse in Berlin, as far down as Unter den Linden are to be improved and laid out as a Boulevard to be named after the late Hugo Preuss, the author of the Constitution of the German Republic, who died in October, 1925. This decision has just been made by the Highways Commission of the Berlin City Council on a vote of nine for and seven abstaining. It is expected that the plenary session of the City Council will agree to the proposal.

POLES IN CLEVELAND GREET DEPUTY ISAAC GRUENBAUM

Cleveland, O., Mar. 21.—A delegation representing the Polish population of Cleveland greeted Deputy Isaac Gruenbaum at a meeting of the Federation of Jewish Organizations held Sunday at Euclid Avenue Temple. The delegation was introduced by Rabbi Barnett R. Brickner.

Judge Joseph Sawicki, former head of the Polish National Committee of America and Mr. Cleveland, president of the American Equality League, spoke on behalf of the delegation and expressed the hope that Deputy Gruenbaum's visit will create a spirit of mutual cooperation and better understanding not only between Jews and Poles in America but also in Poland.

Deputy Gruenbaum replied in Hebrew and Polish. He referred to the forthcoming conference in Warsaw of Polish minorities outside of Poland at which Judge Sawicki will head the American Polish delegation and said this conference had great historical significance since the Polish Diaspora has the task of explaining that if Poles outside of Poland are to have an opportunity for free national development, the Jewish minority as well as the other minorities within Poland must have their civil and national rights respected.

Mr. Gruenbaum stated that this was the first time a Polish delegation had greeted a Jewish representative in the Polish Parliament.

ICA, HIAS MEETING TO ADOPT PLAN FOR IMMIGRATION WORK

Berlin, Mar. 21.—A conference of representatives of the Jewish Colonization Association, the United Emigration Committee and the Hebrew Sheltering and Immigrant Aid Society of America will take place in Paris on April 5.

The meeting was called following the ratification by the Hias at its annual meeting in New York of the recently concluded agreement of the three organizations.

The purpose of the Paris meeting will be to work out a program of action and elect a committee of 20 which is to be in charge of the work. The committee will consist of 10 representatives of the Hias and Emigdi-rect and 10 of the Ica.

whole of Jewry. He was one of the most distinguished Jews of our time," Mr. Goldsmid declared.

Johannesburg, S. Africa, Mar. 21.—A resolution protesting against the anti-Semitic excesses in Roumania and the passive attitude of the Roumanian government was adopted by the Jewish Board of Deputies here.

The resolution, which was transmitted to Premier Herzog, urges the South African government to make representations to the League of Nations in this matter.

JERUSALEM JEWS UNITE FOR MUNICIPAL ELECTIONS

Jerusalem, Mar. 21.—A bloc of all Jewish parties in the Jerusalem municipal elections was formed here. The bloc includes the Agudath Israel. The candidates of the Jewish bloc are Ben Zwi, Chaim Salomon, Elishar and Shamaa.

Jerusalem, Feb. 20.—Twelve hundred and fifty Moslems, 1,025 Jewish and 800 Christian voters have been registered up to date in Jerusalem for the forthcoming municipal elections. It is believed that the register of Christian voters is now completed.

In Tiberias 452 voters have been registered, including 275 Jews, 137 Moslems and 40 Christians. Some of the Jewish residents of the city whose names are not included in the registers have brought a complaint before the Electoral Committee contending that they are entitled to vote.

MORTALITY INCREASE AMONG VIENNA JEWISH POPULATION

Vienna, Mar. 21.—An alarming increase in the mortality among the Jewish population here has been observed.

During the last three months, the number of deaths among the Jewish population was twice as great as the number of births. In the past week 78 deaths and 22 births were recorded.

The cause for this situation is, it is stated, the spring epidemics and the general economic hardships suffered by the Jewish population.

LODZ TEXTILE STRIKE ENDS; 8,000 JEWS WERE INVOLVED

Lodz, Mar. 21.—The strike in the textile industry, which involved 8,000 Jewish workers, ended today. The strikers decided to return to work immediately, both sides having agreed to accept the award concerning an increase of wages made by an arbitration committee.

BERLIN HAKENKREUZLER ASSAULT JEWS IN CAFE

Berlin, Mar. 21.—Anti-Jewish riots took place here last night at the Romanisches Cafe.

The riots were perpetrated by a band of Hakenkreuzler who attacked Jewish patrons in the cafe. Dr. Adolf Cohn, Polish Jewish physician, was wounded. The attackers escaped.

Of the three prize winners at the Annual Oratorical Contest of the Metropolitan League of Y.M.H.A.'s, held at the Bronx Y.M.H.A., two were on Achad Ha'am. Miss Sarah Goodman, of the Bronx Y.M.H.A., won the first prize with a brilliant oration on "The Palestine Achad Ha'am." Robert Marcus, of the Borough Park Y.M.H.A., won the third prize for his talk on the same subject. Six organizations competed. Moses Herman, of the 22nd Street Y.M.H.A., who spoke on "The Meaning of the Constitution Today," won the second prize. Malvina Fertig, president of the Bronx Y.M.H.A., was crowned the judges were Leo B. Kagan, attorney; Samuel L. field secretary of the Jewish Welfare Board; and Louis Diamant.

DIGEST OF PUBLIC OPINION ON JEWISH MATTERS

NEW YORK "TIMES" URGES FORD TO TAKE A CHANCE

Henry Ford should discard the legal technicalities placed about him as a protective barrier by his counsel and take the opportunity of telling in court all he knows about the "Jewish conspiracy," alleged by him, if he is an honest man, urges the New York "Times" of Sunday in an editorial headed "Mr. Ford's Opportunity."

"Henry Ford's appearance on the witness stand in the Detroit suit for libel against him," the "Times" writes, "is expected to be marked by every form of legal technicality. He will be protected by the Judge from questions not strictly in accord with the rules of evidence. This is his lawful right. So it is to employ skilled lawyers who will guard him against any cross-examination which might be held to be irregular. But the case has assumed such proportions and importance that a man of Mr. Ford's position and great wealth ought not to be willing to take advantage of the intricacies of court procedure. It is perfectly possible for him to cut through all the red tape of the trial and insist upon making his attitude clear in the whole controversy."

"For years through 'The Dearborn Independent' he has been pursuing a certain line of policy. His sincerity in so doing need not be questioned. It may be that he has acted upon insufficient information or distorted evidence, but his persistence in causing to be published what he has printed about the 'great Jewish conspiracy' indicates that he honestly believes the statements which have been made public under the warrant of his authority. This being so, he now has a wonderful opportunity to take the whole country into his confidence, to set forth the reasons for the course which he has pursued, and to justify, if he can, the assertions which he has caused to be printed. It would seem that a man of his strong convictions would jump at the chance to set the whole matter straight, so far as he is able to do it."

"He has at his disposal an instrument of publicity absolutely unequalled. Through 'The Dearborn Independent,' published at a loss and with a limited circulation, he could reach but a comparatively few Americans; but if he were to take the stand in Detroit and tell all that he knows about the subjects in dispute, every word of his testimony would be printed on the first page of every newspaper in the United States. What an opportunity to reach what an audience! To a man with a cause deeply at heart the invitation would appear to be simply irresistible. If Mr. Ford is convinced, as he must be if he is an honest man, that the matter printed in 'The Dearborn Independent' truthfully states an abhorrent and appalling menace to the people of the United States, it is hard to see how he can refrain from painting the danger in such colors before the eyes of this entire country,

and in fact of the whole world, that the facts will be established beyond challenge, since it is plain that he has complete faith that they can be so established."

"It may be said that for Mr. Ford to undertake anything of this kind would imperil his chances in the suit for libel now being pressed against him. But any such consideration is beneath his notice. Even if the plaintiff made out his case and were able to win the claim of damages to the extent of \$1,000,000, this is a sum which Henry Ford could put out of his reckoning with contempt. It would mean nothing to him except a few scratches of a pen on a check. Moreover, it is an amount of money, trifling in comparison with his vast holdings of property, which he might eagerly sacrifice in order to take advantage of his unparalleled opportunity to get the explanation of his anti-Jewish attitude before every citizen of the United States."

"Besides opportunity, it is an obligation that knocks at the door of Henry Ford," the "Times" further emphasizes. "He has allowed his name to be made sponsor for cruel accusations. His charge that prominent Jews have conspired to bring about a hateful domination of American finance, and a still more hateful oppression of American laboring men and farmers, is not a matter of grave concern to those whom he has immediately attacked. They know how impossible of proof are the allegations, and they also know how to defend themselves. But this tide of race calumny has swept on, in the columns of the 'Dearborn Independent,' until it has brought pain and suffering to millions of American citizens. They have felt themselves equally hurt and helpless under such sweeping and anonymous attacks. Now the day has come when Mr. Ford, as an honorable and sincere man, might well feel that he is bound either to justify himself or else manfully to retract the charges which have been made in his name. It is an unexampled opportunity now within his grasp. Will he seize it? It is, more than that, a solemn duty laid upon such a world figure as he has become. Will he rise to it?"

GUGGENHEIM FELLOWSHIP AWARDS ARE ANNOUNCED

The award of Fellowships totalling \$143,000 for the assistance of young American scholars and artists during the year 1927-28 is announced today by the Trustees of the John Simon Guggenheim Memorial Foundation. This Foundation was established in 1925 by former United States Senator and Mrs. Simon Guggenheim as a memorial to a son who died on April 26, 1922. The Foundation has a capital fund of \$3,500,000.

Fellowship grants for 1927-28 have been made to sixty-three persons.

The stipend is usually \$2,500 for a period of twelve months. The Fellowships are open to men and women, being citizens of, or permanent residents in the United States, of every race and creed.

These appointments to Fellowships include: Nathaniel Peffer, Writer; Lecturer, New School for Social Research, New York City was appointed to a study of the effects of individualism and nationalism on the Far East. Dr. Ephraim Avigdor Speiser, University of Pennsylvania, Philadelphia, Pa., for the continuation of certain philological and historical investigations of the Mitanni-Hurri group of peoples, in northern Mesopotamia.

JEWS CONGRATULATE PILSUDSKI ON BIRTHDAY

Warsaw, Mar. 21.—Col. Mieses, a Jewish chaplain in the Polish army, was received yesterday by Josef Pilsudski, with representatives of other faiths who called on him to extend greetings on the occasion of his birthday.

On this occasion religious services were held yesterday in the synagogue on Tomackie where civil and military leaders were present.

BREVITIES

Michael Obolensky, a Russian prince, was sentenced to serve ten days in the workhouse when he was arraigned before Magistrate Tolleris in Essex Market Court charged with disorderly conduct. He was arrested Thursday while addressing a crowd of 200 at Thirteenth Street and Avenue A, New York, when he declared "all the Jews should be killed." Magistrate Tolleris said he did not impose a longer sentence because of the plea of the Prince's wife, the former Katherine Trask, with whose parents the defendant said he is now living at East Orange, N. J.

Rabbi Barnett R. Brickner, of the Euclid Avenue Temple, Cleveland, O., has accepted the invitation of the Cleveland Joint Board of the Amalgamated Clothing Workers of America, and the employers, to serve as impartial arbitrator.

Rabbi Brickner was formerly the head of the United Jewish Social Agencies of Cincinnati, and the Federation of Jewish Philanthropies in Toronto, Can., and has from time to time acted as arbitrator in industrial disputes in the United States and Canada.

Louis Bamberger and Felix Fuld, prominent merchants and philanthropists, are included among a group of five representative citizens of Newark, N. J., who have purchased a 1,735-acre camp site at Warren County, N. J., overlooking the Delaware Water Gap, for the Boy Scout organization.

made to pay a sum which would seem as large to him as \$100 would to me."

The foregoing declaration developed over a motion by counsel for Ford to exclude files and correspondence of the paper prior to the date in which the series of articles appeared that assailed Sapiro, so he alleges, as the agent of an international conspiracy of Jewish financiers seeking to enslave the American farmer through the forming of co-operative selling organizations.

When Mr. Cameron was recalled to the stand he was asked by Gallagher to identify various articles in the "Independent."

Q. Haven't you in your mind the name of a single banker who was a member of such a band? A. No, but I have a picture in my mind.

Q. Did you know that at the time these articles were published not a single dollar had been borrowed from any Jewish banker by any association Mr. Sapiro was connected with? A. No, I did not.

Q. Was there any banker you had knowledge of who had loaned money to any association Mr. Sapiro was connected with?

Cameron started to explain and was interrupted. Finally, he answered negatively.

He said he had an impression that Sapiro's associations in several instances employed advertising agencies which had Jewish members.

Q. Did you know only two associations organized by Mr. Sapiro employed a Jewish selling organization? A. No, I didn't know that.

He made the same denial with regard to the employment of Jewish managing and office staffs.

Cameron Does Not Know Where Alleged "Band" Is Located

Q. Did you have any understanding as to where the headquarters of this band of Jews was? A. It wasn't a question where but who.

The subject of the letter to Dunn was next brought up. Mr. Gallagher asked:

Did you have a part in writing that letter? A. Well, it was all a part of a plan.

Q. Your idea at that time was a set of Jewish articles and not necessarily a set of Sapiro articles?

This question precipitated a violent argument, and the jury was excused while lawyers fought over the matter, which involved the manner in which the alleged libels came to be published.

Detroit, Mar. 20.—The second week of the trial beginning Monday with William J. Cameron, editor of the "Independent," resuming the witness chair, finds the so-called "Jewish issue" yet outside the record in definite form.

Concerning this phase, Judge Marx, one of Sapiro's counsel, said:

"The counsel for the plaintiff will change tactics thus far employed in the examination of William J. Cameron and will abandon for the present attempts to secure a statement from

Cameron regarding Ford's attitude toward Jews and how cognizant Ford was of the character of the articles."

There are twenty-one of these counts, embracing 141 separate instances of purported libel. Marx discussed two instances outlined by United States Senator James E. Reed of Missouri, chief of Ford counsel, in the Senator's opening statement. He added:

"One of the weaknesses of the defense was indicated in Senator Reed's statement regarding Sapiro's supposed connection with the Oregon Hop Growers' Association. The statement was made that Sapiro was connected with this organization to his own profit. The fact is that Sapiro never heard the character of the articles.

"Another similar misstatement by the defense concerned Sapiro having been 'the burr of the golden fleece of Oregon'; that is, that he represented Oregon wool growers. The fact is that when that organization was first arranged the incorporation papers were drawn up by a young attorney named Goldsmith. The fee was \$65. Goldsmith had no connection with Sapiro. It is true he once was in Sapiro's law offices, but he had severed all connections with it and had moved to Portland when the incorporation papers of the wool growers were drawn. Goldsmith later became attorney for the wool growers at \$25 a week. Sapiro never at any time was connected with that organization, directly or indirectly."

In commenting on Longley's statement regarding Mr. Ford's lack of knowledge concerning the Sapiro articles, Marx went on:

"Such lack of knowledge only serves to make the libel greater. It is an indication that Ford, although sponsoring the 'Independent,' didn't investigate what his publication was doing, if indeed, such was the case."

After the first four witnesses are heard, the reading of 250 depositions will be begun. The depositions were taken by Ford attorneys, and will be supported by more than 250 witnesses. Then will come a rebuttal by Sapiro, who has upward of 150 witnesses to support his libel claims.

Counsel for both sides today reaffirmed their stand that there can be no compromise, no settlement except in court.

According to rumors Bernard M. Baruch, Eugene Meyer, Jr., Otto H. Kahn, and Julius Rosenberg may be called as witnesses by Sapiro.

Jews Not on Trial in Detroit, Says Dr. Samuel Schulman

The Jewish race is not on trial in Detroit, Rabbi Samuel Schulman, of Temple Beth-El, New York, said in his sermon Saturday morning. Aaron Sapiro is seeking vindication for himself, not for his race, Rabbi Schulman declared.

If Sapiro was correctly quoted, he made a great mistake in saying he sought vindication for his people, Rabbi Schulman stated.

"He should not identify himself with his people in this matter," the speaker said. "He should seek, and I hope and

am convinced he will obtain, vindication for himself.

"Israel does not seek vindication in Detroit. Without fear and with faith, without defiance and with dignity, the Jew should face anti-Semitism. Wherever he can, he should ignore it with contempt. Wherever he must he should fight for his rights. Always he should remember that he belongs to a community, described as the servant of God, the people in whose hearts is 'My law'."

"The Jew is not on trial in Detroit," the rabbi said. "It would be absurd to think that whatever the jury or the lawyers on either side, or even the judge might say, could determine the reputation of the Jew. That reputation is made. The record has been made. It is a record of 4,000 years. As Webster said of his beloved Massachusetts: 'There she stands.'"

Rabbi Stephen S. Wise, in referring in his Sunday morning sermon at the Free Synagogue to the Ford-Sapiro trial in Detroit, said:

"I offer the homage of my reverence, to a man ready to face the richest and, in some senses, the most powerful man on earth, and say, 'You may libel me, but you shall not lie about my people.'"
