POLISH MINISTRY SEEKS OPINIONS ON PROPOSED CHANGE IN SUNDAY LAW Jewish Organizations' Representatives

Advocate Change; Christians Oppose It (Jewish Telegraphic Agency)

Warsaw, Apr. 7.—Steps to ascertain the opinion of Polish Jewry as to the workings of the compulsory Sunday Rest Law were taken by the Polish Ministry of the Interior.

The Ministry called a conference of Jewish social and communal workers to obtain their opinion with regard to to obtain their opinion with regard to the advisability of changing the law. Deputies Wislicki, Trockenheim and Hartglass, speaking in behalf of the Jewish Merchants' Association, ex-pressed the opinion that the law be amended to the effect that a five-hour period of business be allowed to Jewish merchants on Sunday. Mr. Lew of the Poale Zion and Mr. Alter of the Bund demanded that the working class be given the opportunity of free choice between Saturday and Sunday rest. One delegate, Okrant, an extreme Left, expressed satisfaction with the status quo. Delegate Ratner, speaking in behalf of the artisans, demanded that the artisans have the freedom of working the entire day Sunday.

The conference will last some time, it was stated, as many organizations were called to express their opinions. All representatives of Polish Christian organizations spoke against changing the

VIENNA POLICE CONFISCATE HAKENKREUZLER ORGAN FOR RITUAL MURDER AGITATION (Jewish Telegraphic Agency)

Vienna, Apr. 7.-The police of Vienna has finally taken notice of the dangerous propaganda carried on by the "Volkskampf", the organ of the Hakenkreuzler, in connection with the approaching Passover week.

Yesterday's issue of the newspaper was confiscated by the police in view of its continuation of the ritual murder agitation and also on the basis of an article which was insulting to the Jewish community.

EASTERN EUROPE PRE FARES FOR PASSOVER Jews in Soviet Russia to Celebrate As in Old Days: Swindler's Band, Forging American Checks, Detected

(Jewish Telegraphic Agency)

Riga, Apr. 7.—Passover will be celebrated this year in Russia, the Ukraine and White Russia as in the "old days," reports received here from Soviet Russia indicate.

The Jewish communities throughout the territory which comprised the former Russian Empire are busy with preparations for the celebration of the holiday. Even in the Soviet cooperative stores, special sales of matzos, Passover wines and spirits are being held. A feature of the Passover season is the placing on the market of a red covered Haggadah.

For the first time since the outbreak of the war, Russian Jews will have Palestine oranges on their tables this Passover due to a recent shipment which has arrived.

The Jewish Communist press is, as usual, publishing articles attacking the holiday, but there is no general anti-religious campaign. It is interesting rengious campaign. It is interesting that the majority of the settlers in the new Jewish colonies have demanded that they be supplied with matzos.

Warsaw, Apr. 7.—The approaching week of Passover is felt in every town in the Republic of Poland where there is a Jewish community. Life in many homes has brightened due to the receipt of substantial amounts of Passover money from American relatives, according to the custom of providing their needy brethren with Passover JEW APPOINTED SOVIET

FARMERS' GROUPS RUINED BY FORD'S ANTI-JEWISH CAMPAIGN, SAPIRO SAYS

Maine Potato Growers' Failed After "Dearborn Independent" Began Attacks

(Jewish Daily Bulletin)

Detroit, Apr. 7.-Further testimony by Aaron Sapiro, plaintiff in the \$1,000,000 libel suit against Henry Ford. that he, Sapiro, suffered materially as a direct result of the anti-Jewish articles in the "Dearborn Independent," presented by him today. Undergoing the ninth day of cross-

examination at the hands of Senator Reed, Ford's counsel, Sapiro moreover attributed the collapse of the Maine Potato Growers' Exchange to the articles printed in Ford's paper.

It was the third loss of income Sapiro had attributed directly to the "Independent's" articles.

Senator Reed traced the organization of the Maine Potato Growers and Sapiro's receipt of fees and had passed on to the Minnesota potato growers when he turned back and took up the Maine Cooperative.

"Oh, by the way, that concern lived only about eighteen months or so and then it went into the hands of a re-ceiver, didn't it?" he asked. "Oh, no; I am sure it lived longer than that," Sapiro replied. "I think it

lived through 1923 and through 1924. until after the appearance of the first 'Dearborn Independent' article against me. Then it collapsed."

"Do you say that is the reason it collapsed?"

HADASSAH CONCLUDES NEW AGREEMENT WITH ZIONIST ORGANIZATION Pact to End Jerusalem Controversy

(Jewish Telegraphic Agency)

Jerusalem, Apr. 7.—The controversy between the Hadassah, the American Women's Zionist Organization conducting medical work in Palestine, and the Zionist Executive in Jerusalem, came to an end yesterday when an agreement between the Hadassah and the Executive was signed.

According to the new agreement, the Hadassah will be more independent of the Zionist Executive. The Hadassah budget is to be approved by the Zionist Congress.

Additional details of the new agreement were announced by the headquarters in New York City.

By its terms the Hadassah Medical Organization in Palestine will hereafter be administered by a committee seven, consisting of the director of the Hadassah Medical Organization chairman; two members elected by the American Governing Board; two members elected by the Palestine Zionist Executive and two members at large to be elected by the five members, all of whom, with the exception of the director, shall be laymen, not members of the medical profession and not memiers of the Hadassah medical organization staff. Formerly the executive of the com-mittee consisted of one representative

each from the Palestine Zionist Executive, Vaad Haleumi, the National Council of Palestine Jews, Kuppath Cholim, Sick Sanitive Association, acting as an advisory to the director. Dr. E. M. Bluestone, is the present

director of the Hadassan Medical Organization. The members of the Hadassah Commission are Henrietta Szold, honorary president of Hadassah, Nor-vin R. Lindheim, of the Executive of the United Palestine Appeal, and Mrs. Edward Jacobs, vice-president of the Hadassah.

The difficulties between the Hadassah and the Zionist Executive in Jerusalem, pertaining to the work of the Kuppath Cholim, the labor sick benefit fund, were widely discussed in Palestine recently. The situation had developed into an irritating quarrel between Col Frederick H. Kisch and Dr. E. M. Bluestone, head of the medical work of Hadassah in Palestine, which culminated in the fact that the Zionist Executive was not invited to the laying of the cornerstone for the Straus Health Center. This caused wide comment in the Palestine press and it was due to the intervention of Miss Henri-etta Szold and Nathan Straus that the difficulties were smoothed out.

Some time ago a commission of the Hadassah, headed by Miss Szold and Norvin R. Lindheim, left for Palestine to smooth out the difficulties.

of the anti-Jewish articles published in his paper, the "Dearborn Independent", and the confession that "Ford's Own Page" in that paper was not written by the auto manufacturer but by its editor Cameron, are termed by the Bridgeport (Conn.) "Post" "fraud" indicative of the nature Ford's charges against the Jews. "Post," in its issue of March 26, writes: "The motor magnate never knew what sayings had been put into his

mouth until he read them in the maga-"This was amusing, but not startling, for readers of the magazine must have

suspected it from the beginning. Whether or not Sapiro and his cooperative organizations were libeled by the 'Dearborn Independent', it is quite apparent that most of the fulminations of that magazine were the product of ignorant prejudice rather than real independence, just as the magazine's boasted honesty was a fraud in the case of its most advertised page."

A similar view is held by the Chi-cago (Ill.) "Journal of Commerce", which observes on March 24: One of the things we cannot believe

is that any important editorial policy of his 'Dearborn Independent' is not in substantial harmony with Ford's views. In that paper's series of attacks on Jews, for instance, which continued for weeks, Mr. Ford himself could not convince us that they were not made at his suggestion. He may not have seen a single article before it appeared, but a newspaper 'angel' always gets what he wants in it, and nothing else if his writers can help it." The Wilmington (N.C.) "Star" of

Mar. 27, employing a satirical vein, ex-

presses itself thus: "So Mr. Cameron writes Mr. Ford's page in the 'Dearborn Independent'. Mr. Cameron admits it, Mr. Ford does not deny it, so it must be true. Not surprising. Not strange. Lincoln and Barnum were both right. Lincoln said that it was impossible to fool all the people all the time, and Barnum re-joined that the people like to be humbugged. If Cameron had written that page under his own name, it would have meant no more than the views of any periodical of the same class as the 'Dearborn Independent'. With Ford's name over it, the people swallowed it whole. They liked it, therefore score one for Barnum. Then along came one for Barnum. Only malice or stupidity can accuse the Jews of being enemies of the State, seeking in that way to justify anti-Semitic terrorism. All sensible and just people, however, know that we Jews have never had irredentist aims, neither in the West nor in the East, and that we feel ourselves closely bound up with the Roumanian State. "But we welcome the ratification of

the Bessarabian Treaty not only as Roumanian citizens, but also as Jews. The ratification of the Treaty and the unification of Bessarabia for ever with the Roumanian State which it implies, indicates an orientation on the part of our country towards the West. To the Jews of Bessarabia, the unification of Bessarabia with Roumania means their liberation from the Cuzist yoke and a barrier against Bolshevik anarchy. The overwhelming majority of Jews stand on the ground of the bourgeois order and for the respecting of all bourgeois rights and liberties. We see in the fights and inserties. We see in the future a prosperous and happy time coming for all the inhabitants of Roumania, and it is not in servility nor in hypocrisy, but in the recognition of the logical course of events, that I as a Jewish Deputy, stand here and con-gratulate the Roumanian Government on the ratification of the Bessarabian Treaty.
