BRANDEIS' READINESS TO RETURN TO PARTICIPATION IN ZIONIST AFFAIRS CREATES EXCITEMENT AT ATLANTIC CITY CONVENTION

Opposition Group Headed by Emanuel Neumann; No Objection Raised to Brandeis' Return. But His Proposed Leadership Through Proxy Declared Insufficient; Lipsky, in Presidential Message, Takes Exception to Placing Zionist Movement Under "Tutelage"; Emphasizes Need of Roorganization in New York, London, Jerusalem; Demands Task of Fixing Zionist Budget Be Removed from Zionist Congress to Executive; Lipsky Elected Convention Chairman; Impression Created by Felix M. Warburg's Message Urging Unity in Zionist Ranks; 756 Delegates Present at Opening Session

UNION OF ROUMANIAN JEWS URGES JEWISH POPULATION TO VOTE FOR LIBERAL PARTY Government Issues Manifesto Guaranteeing Freedom of Elections (Jewish Telegraphic Agency)

Bucharest, June 27.-Freedom of elections is guaranteed in a manifesto issued by the government. The manifesto declares that all attempts to create disorders will be suppressed.

The King recommended to the Cabinet that it adopt a conciliatory attitude toward all citizens. Local authorities have issued orders preventing any insult to religious or national feel-

ings during the campaign. The election block of the Union of Roumanian Jews and the Liberal Party has been finally concluded. The joint list includes Dr. William Filderman as candidate for parliament, and Horia Carps, well known journalist, for the

Senate. The Zionists in Bessarabia have concluded an agreement with the peasants party for mutual support in the elections. In the district of Kishineff, the Zionists have nominated Meyer Ebner and the attorney, M. Landau.

> Interest in the problems facing the Zionist movement was in evidence among the delegates to a much greater extent than that observed in previous years, due to the fact that the opening session and the week-end days prior to the formal opening, passed under the spell of echoes of the Cleveland Zionist convention which ushered in a new period in the history of American Zionism, since the split with the Brandeis group occurred. Although no official pronouncement was made to that effect, reports circulated | by leaders of a recently formed oppo-sitional group, gave the impression to the delegates that a return of Louis D. Branders, Associate Justice of the United States Supreme Court, was an immediate possibility, provided that certain conditions are met. These re-ports gave rise to heated discussion which found expression in lobby conversations and in caucuses called by groups of delegates, who were ad-herents either of the administration or of the oppositional group. The oppoor the oppositional group. The opposition group was said to be headed by Emanuel Neumann, Executive Chairman of the United Palestine Appeal, and member of the Administrative Committee of the Zionist Organization of America.

It was stated that a month ago Mr. Neumann submitted his resignation from the Administrative Committee due to differences which had arisen between him and the Committee. Others who were identified with the opposition were Israel Goldberg, Publicity Director of the United Palestine Appeal and Morris Zeldin, New York director of the United Palestine Appeal. It appeared that discussions caused by the opposition would lead to a marked division in the ranks of the Zionist membership.

RABBIS CONVENTION URGES INTENSIFICATION OF WAR AGAINST SOCIAL INJUSTICE Development of Reform Movement in

Palestine Is Planned (Jewish Daily Bulletin)

Cape May, N. J., June 27 .- Man's inhumanity to man as embodied in such social injustices as strikes, class oppression, racial discrimination, will be more vigorously opposed henceforth by the Jewish Reform Rabbinate. Resolutions to this effect were adopted yesterday by the Central Conference of American Rabbis in session here. Action was recommended and based upon the report of the social justice commission

The commission is composed of the leading rabbis, the chairman being Rabbi Ephraim Frisch.

"We feel that the time has come for our conference to face the serious and pressing problem of its obligation in the field of social justice," read the com-mission's report. "It is our consistion that the conference has contented itself with too limited program of activities in this direction and, furthermore that these activities have been of too general and theoretical a character. It is high time that we envisaged more comprehensively our large and solenn obligations in this field of labor in the light of the ever-growing industriali-zation of modern life, of the spread of imperialism, of the rise of the tides of race and color and of the undiminished dangers from miltarism. His Majesty, the King, that the country should be governed in a spirit of conciliation towards all those who inhabit it and who have linked with it their destiny, the Union of Roumanian Jews is fully confident of the realization of the King's wishes by the Na-tional Liberal Party called to power in order to give a solution to the difficult problem of consolidation. "Having in view that other democratic parties and political groups have

joined the Liberal Party in the fulfill-

ment of this task, and considering that the Union of Roumanian Jews is pursuing the solution of the problems of the cults and schools inasmuch as it is not contrary to the work of consolidation and safety being carried on in the country in which our ancestors. fathers and sons have sanctified the soil with their blood in three wars; considering also that our request has found an echo with all the governments and that various Royal Messages promise a solution; considering also that the National Liberal Party disapprove of an agitation destined to foster discord between citizens of the same country and that they have promised to solve the problem which interests us within the provisions of the existing laws and in full accord with the higher interests of the state, the Union of Roumanian Iews invite the Jewish population to vote the Liberal Party list in the forthcoming elections." According to cable despatches recently received by the Jewish Tele-graphic Agency, the Union of Roumanian Jews concluded the agreement

with the Liberal Party for cooperation between the two parties in the forthcoming parliamentary elections, whereby the Liberal Party undertakes to advocate through its representatives in the Roumanian parliament, the promulgation of laws concerning the organization of Kehillahs throughout Roumania, to support the demand of the Jewish leaders that Jewish schools be granted public rights, that the government make allotments to subsidize the Kehillahs and the schools and that the party will combat the anti-Semitic movement.

Under the agreement, the Union of Roumanian Jews will be given five seats in the Chamber and two in the Senate.

ANTI-EVOLUTION AND RELIGIOUS LEGISLATION PRESENTED IN CALIFORNIA (Jewish Daily Bulletin)

Sacramento, Cal., June 27.-At the recent session of the California State Legislature a so-called Release Bill in-troduced by Senator Cobb of Fresno was defeated as the result of the activities of a Committee of Clergymen and Laymen of which Rabbi Louis I. Newman of Temple Emanu-El, San Francisco, was a member.

The Cobb Release Bill would have excused children for two hours a week during school time for reliigous instruction. At a stormy public hearing before the Senate Education Committee, the measure was tabled by a vote of 6 to 5. It was not drawn out of Committee to the floor of the Senate as was done with a similar bill in the California Assembly in 1925. In addition to Rabbi Newman, Mr. Richard Gutstadt of the B'nai Brith; Rev. Berkeley Blake, Minister of the First Unitarian Church, Sacramento, and Rev. W. F. Martin of the Seventh Day Adventists, argued against the Bill. A widespread propaganda in its favor had been organized, but for the third time in succession the Release Bill was defeated. Best wishes." Similar was the effect of the messages of Dr. Chaim Weizmann and Judge Otto Rosalsky. "If peace in Icwry in general is so essential a factor in the fulfillment of our highest aims, how much more essential is it in our own ranks? We require all our energies for the accomplishment of the stupendous task before us. For this reason we hope that the remarkable demonstration of confidence and loyalty that marked the recent celebration of your president's (Louis Lipsky's) 50th birthday, and of his completion of twenty-five years' devoted service to our cause, will be renewed on the occasion of your convention. With him as your leader you have gained your present commanding position in our movement and under his continued guidance you will assuredly be able to render still more valuable contributions to the return of Fretz Israel,' Dr. Weizmann's message read.

Message from Dr. Weizmann In his message, Dr. Weizmann, reviewing the present condition in Palestine and in Zionism, referred to mistakes that have been made. true, we have made mistakes. The Fourth Aliyah had overestimated the addition to the population which the country is capable of absorbing at the present stage of its development. The influx of people into Palestine must bear a certain relation to the influx of national and private capital, and this relation has been ignored. But this fact must not be allowed to obscure the clear recognition, that we may proudly derive from our positive achievements, that Palestine is capable of accommodating a vast Jewish settlement, if only the Jewish people would provide the requisite funds. Let us but learn the lessons of past ex-perience, let us but amend our mistakes and multiply our efforts, and we need not have any doubt whatsoever that Eretz Israel will fulfill all our hopes."

The interest of the delegates in the reorganization question and the possible return to Justice Brandeis to Zionist leadership was intensified when action along these lines was taken by the leaders of the Hadassah convention which was in session here for several days. Interest centered around the text of a letter which was not made public but had been addressed by Justice Brandeis to Mr. Jacob deHaas, formerly Execu-tive Secretary of the Zionist Organization of America, prior to the Cleve-land convention. In this letter Justice Brandeis expressed his readiness to lend his moral and financial aid to the American Zionist Organization, as well as to take an active part in the affairs of the Organization, at such time as would not interfere with his judicial duties. This participation was to be the Zionist delegates will demand a forthcoming only if certain conditions radical change in the policy of the Zi-

were met. The nature of these conditions were not specified by the sponsors of the movement, but it was learned that it would involve a general change of personnel in the administration of the Zionist Organization and would also call for an interregnum period. Ac-Zionist convention would not elect an administration for the forthcoming year but rather a commission of ten or fifteen to be composed of men who are to be approved by Justice Brandeis, to bring about the reorganization of the organization and to institute such policies as would remedy the situation in Palestine.

Hadassah Organization, while not in favor of ousting the Lipsky administration in toto, was in favor of the proposal of a provisional commission with the participation of Justice Brandeis. Nevertheless, the Hadassah convention took no direct action on this question. The matter was disposed of by a resolution which gives the Hadassah delegates free hand in voting on the subject at the general Zionist convention.

The proposal was heatedly discussed in the administration camp. At a meeting of the Committee held Sunday morning the subject was thoroughly discussed. It was learned that although no objections were raised against the reentry of Justice Brandeis to active leadership in the Zionist movement, doubt was expressed whether Justice Brandeis would find it possible to resume active leadership. It was also argued that a leadership by proxy would not meet the needs of the hour.

Mr. Lipsky's Address

The convention was formally opened at 3 P.M. at the Chelsea Hotel. Following greetings of the representative of the local Zionist Committee, and by Mr. Persky, City Counsellor of Atlantic City, in behalf of the Mayor, Mr. Lipsky delivered the President's message.

In his message the President of the Zionist Organization of America took vigorous exception to the efforts of those who would place the Zionist movement under what he termed to be "tutelage." He emphasized the need of reorganization of Zionist forces, both in the United States, in London and in Jerusalem, and presented a plan which would, in his opinion, offer a solution. He objected however, to what he termed the "dry efficiency system" which represents nothing bu a "replica of philanthropy" on Palestine soil. He protested against the defeatists who would call for an interregnum regime which would indicate admission of failure. "Just as the Jewish people cannot be declared in a state of bankruptcy, so cannot the Zionist movement," he exclaimed.

In outlining the policy of the American delegation to the Fifteenth Zionist Congress Mr. Lipsky announced that

onist Executive, with regard to its Palestine work. He declared the budget to be no longer suited to the present state of affairs. "We have confidence in Dr. Weizmann's leadership. It is however clear that a change of method is necessary and with his guidance we will succeed in bringing about this change," he stated. He also advocated that all colonization activity in Palestine be discontinued until the Experts' Commission of the Jewish Agency submits its report, the interim to be employed for consolidating what has been acquired. The Zionist Executive is to be constitutionally prevented from incurring obligations beyond the assured actual income, instead of undertaking obligations which are calculated upon expected receipts a few years hence.

Lipsky Urges Reorganization

With regard to the affairs of the Zionist Organization of America, Mr. Lipsky also urged a thorough reorganization which would include the election of a new personnel. He offered a plan whereby the Zionist Organization of America would be restored to its dominant position instead of the anomalous relations which existed between the Organization, the parent body, and the various fund-raising agencies which were created by it. He recommended that the organization abstain from undertaking to grant subventions to the various cultural activities unless sufficient funds are available. He explained the matter of the deficit incurred by the organization by the fact that the administration, acting upon recommendations of the annual conventions, supported a number of activities which are of the utmost importance to the Zionist movement.

Mr. Lipsky was given a long ovation at the beginning and conclusion of his message.

The praesidium of the convention was constituted when the convention adopted the recommendations offered by Joseph Barondess on behalf of the Executive Committee. Mr. Barondess nominated Louis Lipsky as the Chairman of the convention, Miss Hen-rietta Szold, Morris Rothenberg, Judge William M. Lewis of Philadelphia, Max Schulman of Chicago and Elihu D. Stone of Boston as vice-chairmen; Maurice Samuel, B. Rabelsky and Dr. S. Bernstein as secretaries. No other nominations were made and the convention passed upon this list by acclamation.

The first indication of an opposition in the convention came to the surface when Mrs. Robert Szold, representing the Hadassah, objected to the proposal that the Chairman of the convention appoint a Committee of Committees.

look upon its social justice work as having a proper claim on its atten-tion. To minimize the urgency and extent of this work means to fail to comprehend the challenge of the new era in which we live.'

The committee appointed to investigate the feasibility of the Central Conference of American Rabbis creating a committee on the development of a reform movement in Palestine is to make a study of the ways and means for the furtherance of such a movement. The Chairman of this committee is Edward N. Calisch.
The Commission on Jewish Education of which Dr. David Philipson is chair-

man, declared that the interest in Jewish education is continually increasing in this country and that "the greatest of our problems is how to keep burning the flags of religious interest and enthusiasm in our moderate American environment. The pitfall of divorcing Jewish culture and education from the religious contents must be avoided." Evolution is compatible with Jewish

religion because "evolution is the name for an aspect of God's present activity, it is the description of his creative ability," said Dr. Israel H. Mattuck of London, England, addressing the Cen-tral Conference of American Rabbis here yesterday at the services held in the First Presbyterian Church. Dr. Mattuck delivered the sermon lecture, his topic being "The Conception of God in its Relation to some Aspects of Modern Thought and Life."

Dr. Max X. Currick, of Erie, Pa., in his conference sermon declared that many non-Jews often praise the three pillars of Jewish strength and solidarity; our wholesome family life, our pure religion and our pious attitude towards our departed.
