ART COMMISSION DENIES PREJUDICE IN REFUSING SALOMON STATUE SITE

Ouestion Responed as Research Yields Results; Burden of Proof Placed on Promoters of Project

The question of whether or not the New York City Art Commission took a justified course of action in its refusal to permit the Federation of Pol-ish Jews in the United States to erect in Madison Square Park a monument to Havm Salomon, the Polish Jew who helped finance the American Revolution, continues to occupy the attention of the metropolitan press.

The Federation of Polish Jews has started a campaign for a fund of \$75,000 to erect the monument, but permission to do so was declined by the New York City Art Commission in September, 1925. The issue cen-tered around the contention of the Art Commission that there is not sufficient historical proof of the role which Haym Salomon played in the financing of the American Revolution. Neither the Art Commission nor the Federa-tion of Polish Jews made a public statement to that effect until now, in view of the fact that since the burden of proof was placed on the Federation of Polish Jews, the sponsors of the (Continued on Page 3)

JERUSALEM POPULATION SEES SMOKE ASCENDING FROM DEAD SEA REGION Geologist Says Phenomenon Is Result of Earthquake: Similar to Bible Story (Jewish Telegraphic Agency)

Jerusalem, July 22.-A volcano, extinguished a long time ago, located on Zerka near the shore of the Dead Sea, 25 miles from Jerusalem, started to issue screens of smoke last night. From elevated places in Jerusalem the volcano smoke could easily be seen. A large number of inhabitants of the Holy City watched the volcano smoke all night.

London, July 22.-The Jerusalem report concerning the Zerka volcano smoke 25 miles from Jerusalem called forth wide comment here. The volcano is situated on the Transfordanian shore of the Dead Sea.

A noted British geologist told the correspondent of the Jewish Tele-graphic Agency here that what the Jerusalem population observed last night was not the smoke of a volcano but the smoke of gases ascending from the depths through cracks formed by the earthquake which are burning their way to the surface.

It appears, the geologist stated, to be a similar phenomenon to what is described in the Bible story as seen by Abraham from Hebron, during the destruction of Sodom and Gemorrah, the cities located on the site now covered by the Dead Sea. There are several places in the vicinity of the Dead Sea shores where gases are known to ascend through cracks, he stated.

An appeal to the Jewish and non-Jewish public to send in donations for hand, information received from reliable sources indicates a serious disturbance in Palestine affairs-the demolition of private and public buildings, the destruction of a number of Arab villages and, worst of all, serious injuries to hundreds of persons and the loss of many lives.

"Such a catastrophe in any established country could probably be dealt with by the unaffected residue of the population. The Palestine Government is doing everything possible to deal with the emergency. But Palestine is in an exceptional state, for there is not a sufficiency of local recuperative strength to alleviate the situation without outside help. Such appeals for help have come from the Acting High Commis-sioner and from various communities in Palestine.

"In view of the many inquiries that have been received, asking for guidance in the remittance of funds, the Zionist Organization of America is prepared to receive contributions to the Palestine Earthquake Relief Fund, and to transmit such contributions to the appropriate committees that have been formed in Palestine for the extension of relief regardless of race or creed.

Morning Journal" observes: "Nothing will be accomplished if the

allegation is made that the members of the New York Art Commission were influenced in their decision by an anti-Jewish prejudice. Although prejudice is indeed bad, it is almost impossible to be entirely free from it. Prejudice must be taken into account when a decision is sought. The proper way is not to formulate charges against people whose opinion is not free from such sentiments, but to prove that they are wrong. "Erroneous opinions which have been

accepted and have become deeply rooted are being taken into account in practical life. It would be a doubtful honor for us if the monument were erected in a public place in New York and caused discussion, doubts, and perhaps even insults. The Jews would derive less satisfaction from that than they do now on account of the unfavorable opinion of the members of the Art Commission or of historians. "Is there no legal proof of the "claim" of Haym Salomon's heirs that

the American Revolution or its leaders remained indebted to Salomon for a great sum of money? All that we know is that the claim was never recognized by a court or by Congress. There are other justified claims which are not recognized, and it is the task of the claimants to prove that their claims are iustified. This is, in our opinion, the task which rests upon the Jews of America or, to be more precise, upon those Jews who have undertaken to erect the monument.

'A new thorough legal investigation, as is the procedure in a real trial, must now be made. We have among us prominent lawyers who are interested in Jewish history and in the prestige of the Jewish name. It is their duty to make out a case if possible. The press of the country will eagerly publish the results. The proofs available must be collected and an effort must be made to find new substantiated evidence. But this requires labor and time. It has now others and for ourselves. Let there be no one who could doubt that Havm Salomon deserves the recognition which the Jews are willing to confer upon his memory."

ords is being carried on. The question was publicly raised last Monday, when the Executive Com-

mittee of the Jewish Council of Greater New York, an organization affiliated with the American Jewish Congress, issued to the press the text of a resolution it adopted, which criticized the Art Commission, charging prejudice.

This charge was answered yesterday by Robert W. DeForest, who is chair-man of the Municipal Art Commis-"Prejudice did not enter into the re-jection of the plan," he stated. "The Art Commission gave very careful

consideration to the proposed statue to Haym Salomon. Their final disapproval related chiefly to the site proposed and the disapproval was without prejudice to resubmission for another site. "The careful consideration given this matter by the Art Commission is

illustrated by the report of its committee which was adopted and which forms part of the Art Commission's files. The claim is still unproved, according to Mr. DeForest, but the matter is not necessarily closed. The statues

in Madison Square Park, according to the committee's findings, are of men whose names are widely known, while the claims of Mr. Salomon are regarded as obscure.

Examination of the minutes of the meeting of the Municipal Art Commis-

sion held on Sept. 15, 1925, discloses that before the meeting, at which the project was turned down, the Commission had cooperated with the Federation of Polish Jews and had suggested changes in the design for the memorial It was only after the campaign for a \$75,000 fund was well under way, a

competition for the design concluded and a contract signed with Anton Schaaf, the winning sculptor, that the commission began to have doubts that Salomon really was entitled to immortality through a monument in Madizon Square. This question had not been passed on previously. The matter will rest until those who believe Salomon did great service to the Colonies can produce documentary proof of his work. This is virtually impossible, because of loss of the records in the invasion of Washington

by the British in 1814.

The minutes of the Art Commission show the original design was disapproved June 9, 1925 and that June 24 a new design was submitted by the Federation of Polish Jews. This was satisfactory enough to justify erection of a replica, full size, of the statue on a site facing 23rd Street in Madison Square Park on July 30, the members of the Art Commission visited the replica and the same day met to consider the matter. It was at this meeting that for the first time the question of the worth of Salomon

A decision was made to consult authorities on history. Victor H. Paltsits, head of the Manuscript Division of the New York Public Library, an authority on the sources of American history, was asked for an opinion. Being away at the time. Dr. Paltsits sugng away at the time, Dr. 1 arisits suggested that the commission get in touch with Worthington Ford of the Massachusetts Historical Society, who had studied the subject. Dr. Ford re-ported Aug. 29 that in his opinion claims made in behalf of Salamon were without prcof. ". . . . the various supporters of the

Salomon story," he wrote, "have produced no evidence in its favor . . . no one who has studied the finances of the Revolution has recorded or

knew of such evidence . . . the story itself is incredible. What documents have been brought forward are of no value, and in default of proper documents the tradition is too exacting to be acceptable, and I see no reason for connecting Haym Salomon's name with the Nation's history, and only as an estimable merchant has he claims to any recognition."

A committee, whose names are not revealed in the minutes, handled the

matter for the Art Commission, which decided the claim of Salomon's proponents still was unproved. The application for a monument was denied without prejudice to its renewal for another site upon clear proof that Haym Salomon is entitled to this de-

erce of recognition in New York.

Historians are agreed that little appears in the records or in early histories regarding Salomon. This is attributed to the fact that the Federalist Party was anxious to have credit given to Robert Morris and Alexander Hamilton. According to Madison C. Peters, who has written a brief history

of Salomon, both Morris and President Madison mentioned Salomon frequently in their letters. For a time, ac-cording to these sources, Salomon paid the salaries of several Virginia members of Congress. His place in history was indorsed by the Committee on Revolutionary Claims in the Senate in 1865, accord-

ing to Mr. Peters. He is said to have lent, without security and without interest, sums totaling as much \$600,000 to the new nation. Of this not a cent ever was paid. S. Stanwood Menken of the National Security League is a lineal great-grandson of the financier. He has been one of the contributors to the monument fund.

Fund-Raising Has Administration Cost of Four Per Cent

The Federation for the Support of Jewish Philanthropic Societies issued a statistical summary of the work done by its ninety-one constituent agencies during the twelve month period ending June 30. The summary, made public by Dr.

Solomon Lowenstein, executive director of the Federation, shows that the six medical care agencies, which received \$1,171,395 this year from the parent body, took care of 27,987 hospital patients and that the dispensa-The six ries recorded 111,069 visits. hospitals in the Federation include Montefiore Hospital for Chronic Diseases, which gave more free service than any other non-municipal hospital in the city during the twelve-month period; Mount Sinai Hospital, which led the field in free service among the private general hospitals of the entire city; Hospital for Joint Diseases, the largest orthopedic hospital in the country; Lebanon, Jewish Maternity and Beth Israel Hospitals.

The report further shows that 2,765 orphans were housed daily by the Home for Hebrew Infants, the Hebrew Orphan Asylum ,the Hebrew Sheltering Guardian Society and allied agencies some of which employ the boarding-out plan through private homes. Children numbering 1,382 who were discharged within recent years from the orphanages were placed in homes and supervised.

Through the Federation's fresh air camps, 7,013 mothers and children were given vacations. The Institute for Improved Instruction of Deaf Mutes and the Crippled Children's East Side Free School cared for 356 deaf and dumb and crippled children.

The Jewish Board of Guardians, which handles all delinquency cases, sheltered, fed, clothed and educated for honorable self-support 318 delinquents and did preventive work with 3,014 individuals of whom 512 were given jobs and made self-supporting. This agency includes the Hawthorne School for boys; Cedar Knolls; the Shelter; Committee on Field Activities; Lakeview Home; Jewish Big Brothers and Jewish Big Sisters.

The Home for Aged and Infirm Hebrews sheltered and cared for 337 old men and women; the Young Women's Hebrew Association and Young Men's Hebrew Association provided 235 young men and women with comfortable living quarters at reasonable rates; the Bureau of Jewish Educa-tion and six Talmud Torahs or Hebrew free schools gave all year round courses in Jewish education to 7,676 boys and girls.

Through the Hebrew Technical Institute and Hebrew Training School for Girls, 1,015 boys and girls were being taught useful trades.

Gossett, that American Jewish leaders consider steps to create a Federation of Federations which would be the Lewish fund-raising agency in the United States, thus eliminating the various campaigns and drives, is supported editorially by the "Jewish Tribune".

Mr. Gossett points out that, if, as Mr. Warburg suggested, American Jewry is to work out a ten-year program of work in these countries, 'there should be an end to the many national campaigns involving tremendous expendi-tures for money-raising and for the maintenance of machines and publicity apparatus.' He proposes that each local federation add to its budget a proportion of the amount needed for the overseas program and conduct a single annual campaign to raise the necessary sum. GERMAN MINISTER REBUKED FOR CHARGING JEWISH OFFI-CIAL WITH DISLOYALTY

Berlin, July 22.—A "Jewish issue" occupied the attention of the leaders of the German Republic during the sessions of the Reichsrat.

At one of the sessions of the Reichsrat last week Herr Keudell, Minister of the Interior, attacked Dr. Hermann Badt, well-known German Jewish leader, who holds the position of Ministerial Director and is by reason of his office a member of the Reichsrat. He charged that the proceedings of the Reichsrat are of grave importance to Reichsrat are of grave importance to servey is imperative. Badt, he charged, would violate the secrecy of the proceedings.

At yesterday's meeting of the Reichsrat, Herr Braun, Prime Minister of the Prussian Government, took vigorous exception to these charges. The Prime Minister guaranteed the most complete loyalty of Dr. Badt.

brew Association, Young Men's Hebrew Association of the Bronx, the Educational Alliance, Federation Settlement and Emanuel Sisterhood, registered 28,321 persons in recreational and cultural activities.

The Jewish Social Service Association, formerly known as the United Hebrew Charities, gave financial relief and performed social service for 222 families during the twelve-month period. This agency, which receives the largest single budgetary allotment from the Federation, securing \$667.309 this year, has for its object the development of normal family life, and the work involves not only the alleviation of present distresses but the attacking of fundamental causes of budgetary and other evidences of maladiustment.

The report of the ninety-one constituent societies of the Federation also includes a supplementary statement by the Federation, which shows that the Federation's raising of funds is conducted at an administrative cost of four per cent.
