Government Appoints Commission To

Overnment Appoints Commission To Deal With Students Question (Jewish Telegraphic Agency)

Bucharest, August 4.—Dr. William Filderman, Deputy, and Senators Horia Karp and Dr. Jacoby have registered in parliament as a separate group, under the name of the Union of Roumanien Jews.

The cabinet has appointed a subcominission to deal with the students' question in the country. This commission is composed of Minister of Education: Anghelescu, Minister of Justice Popescu and Minister of the Interior Tatarescu.

The "Monitorui," official organ of the government, states that at the cabinet sitting of May 28, naturalization was granted to Rabbi Chaim Schor. Schor had demanded the right to be the senator representing the Jewish faith instead of Rabbi Niemirower. It is now disclosed, the paper states, that Rabbi Schor was not a Roumanian citizen and was therefore ineligible for this post.

#### DEMAND THAT ARABIC BE ONLY OFFICIAL LANGUAGE

(Jewish Telegraphic Agency)

Jerusalem, August 4.—The demand that the Arabic language should be the only official language in Palestine will be pressed at the Palestinian Arab Congress which will open here in a few days.

Representatives of the two families, Husseini and Nashishibi, which had hitherto been hostile to each other, will participate in the congress. A new executive will be formed with an equal number of representatives from the two families.

A united policy with regard to the government has been decided upon by the two families. They are willing to recognize the British mandate, but they persist in their stand against a large Jewish immigration into the country.

#### ABRAMSON NAMED HEAD OF LAND SURVEY COMMISSION (Jewish Telegraphic Agency)

Jerusalem, August 4.—A. Abramson, former governor of the Haifa District, has been appointed chairman of the Land Survey Commission. Mr. Cowell of Nyassaland will succeed Mr. Abramson to the governorship of the Haifa district.

## HFAS LEADERS PROTEST UNFAIR INTELLIGENCE TESTS FOR IMMIGRANTS Surgeon General Cummings Promises

To Investigate (Jewish Daily Bulletin)

Washington, August 4—A special delegation of the Hebrew Immigrant Aid and Sheltering Society of America (Hias) consisting of John L. Bernstein, B. Vladeck and Isidore Hirschfield, called on Surgeon General Cumnings yesterday in order to confer with him on the so-called intelligence tests to which Polish Jewish emigrants have to submit when applying for visas.

The delegation drew the attention of Dr. Cummings to the fact that while the American officials in Poland may have sincere intentions with regard to the questions they ask the emigrants, the questions are of such a nature that they create the impression on the emigrant that he is being ridiculed. The applicants for visas then become confused and embarrassed and their replies cannot be considered an indication of whether or not they are mentally proficient.

Dr. Cummings evinced great interest in the statements of the delegation. He asked the committee to submit a memorandum and said upon consideration of the memorandum by the American medical supervisors abroad and by himself, he would communicate his decision.

The action of the Hias in this matter was based on complaints which veached them from many Jews in Poland that they are being unfairly treated by the American Consulate in Warsaw. It was pointed out in these protests that the officials delib-(Continued on page 4)

## CONVERTED JEW AROUSES INDIGNATION BY ANTI-SEMITIC LECTURE IN BERLIN (Florible Technology Control

"Berliner Tageblatt" Severely Criticizes Lubarsch's Behavior

(Jewish Telegraphic Agency)
Berlin, August 4.—Much indignation
was aroused by the anti-Semitic remarks which Professor Lubarsch, director of the Pathological Institute

here, made during a lecture.

Professor Lubarsch, who is a converted Jew, made those remarks while demonstrating certain organs of Ivan Kutisker who died in prison on July 12 and whose body was turned over to the Institute for study. Professor Lubarsch referred to the fact that Kutisker had been an East European Jew and made insulting remarks with regard to East European Jews in general, to the merriment of the students,

The "Berliner Tageblatt" criticises the professor, declaring that Lubarsch himself is descended from Jews and therefore probably indulges in tirades against the Jaws, thinking thus to conceal his origin. The paper further draws attention to the fact that Kutisker did not die a convicted man but was awaiting the result of his appeal.

Ivan Barueh Kutisker, who was sentenced to five years imprisonment on charges of credit fraud in transactions with the Prussian State Bank, died the day before the judgment on his appeal was to have been given. The charges against Kutisker, a Latvian Jew, were, like those against the Barmat brothers, part of the anti-Semitic campaign conducted by the German Nationalists who sought in this way to compromise the Prussian Government and bring about the return to power of the anti-Semitic party who would then proceed to the expulsion of all foreign Jews.

When the Barmat investigation was concluded recently, it was stated that the charges had been invented by the German Nationalists for the purpose of anti-Jewish propaganda.

#### STR JAMES PARR PRAISES ZIONIST WORK IN PALESTINE (J. T. A. Mail Service)

London, July 22 .- Sir James Parr. High Commissioner for New Zealand, who recently returned from Palestine, expressed his admiration for the Zionist works in Palestine in a letter to the Zionist Organization.

"I am interested in the work of the Zionist Organization in Palestine, and it was a welcome opportunity to see what was being one." Sir James Parr wrote. "I think the organization is doing good work. I was particularly interested in the thorongly scientific manner in which farm instruction and organization is being carried on, and further observed with pleasure, the keen interest of the young Hebrew men, from all parts of Europe, to become farmers. The operations of this training farm seem to be quite comparable with the work done in similar institutions in New Zealand and Australia.

"I was especially struck with the Training School for Jewish Girls which you have at Nahalal. It was a most interesting sight to observe 60 Jewish girls brought, at about the age of 17, from Russia and other European countries to Palestine and there being instructed in domestic science and in farm work, so that they might become useful helpmates to the Jewish young men of the Settlement, who will be their future husbands.

"I believe that the Zionist settlers in Palestine may yet prove to be the true interpreters in many things between the East and the West .- to be, so to speak, the liaison or bond be-

BE INCLUDED IN ACTIVITIES OF EMIGRATION SOCIETY

(J. T. A. Mail Service)

Warsaw, July 20 .- Questions touching upon the policy to be pursued with regard to Jewish emigration to the Argentine were heatedly discussed at the meeting of the Cntral Committee of the Emigration Society in Warsaw.

Mr. Woll, delegate from Vilna, opposed the new plan of training the emigrants in artisanship. There are thousands of qualified artisans among the Jews who desire to emigrate and there is no need to produce new artisans he declared. The money which is spent for training them could better be used to supply poor prospective emigrants with the funds to enable them to proceed abroad.

Th speaker also urged the Emigdirekt to influence the Ica to accept into its colonies not only qualified agricultural workers but also Jews from small towns who are familiar with gardening and agriculture on a

small scale.

Mr. Rudnitzki joined Mr. claiming that the training of emigrants as artisans was not the business of the emigration society and should be left to those organizations which specialize in this work or to the Hechalutz. Mrs. Stein dwelt on the difficulty

of the emigration problem. The situation, according to her, was such that experiments are necessary. It emigrants into agricultural workers and the Jewish emigration stream ought to be directed to places where land can be obtained for them. S. Biber declared the joining of the

Emigdirekt with the Ica merely in the sphere of emigration, excluding colonization, was a great defect. The future of emigration, especially to South America, is of an agrarian nature. "We do not know how many Jews will be able to find employment in industry. For the time being we know that there is a crisis in industry. while the agrarian possibilities in the South American countries seem to be unlimited and they will most likely develop more and more in the future. Therefore, colonization is an integral part of the entire emigration problem." he said.

#### DR. BUCHLER PLEADS NOT GUILTY TO PERJURY CHARGE Rabbi Samuel Buchler, ex-Deputy

Attorney General, pleaded not guilty yesterday to the Federal indictment charging perjury which was returned against him Tuesday. Dr. Buchler was held for trial under \$1,000 bail by Federal Judge Harry B. Anderson.

The defendant's counsel, former Congressman Nathan D. asked for immediate trial. Judge Anderson said Dr. Buchler could have his "day in court" as soon as two other cases were disposed of.

Mr. Perlman declared that his client was absolutely innocent and that the indictment had been the cause of great embarrassment. In his statement issued to the Jewish Daily Bulletin, Mr. Perlman declared:

"The substance of the charge is that Dr. Buchler falsely testified before the Federal Grand Jury that one Klemas had no connection with him in the matter of the campaign for funds of the Transvivanian Jewish Hospital

Commission of America. "Our investigation satisfies us that Dr. Buchler truthfully testified before the Grand Jury on all matters. He voluntarily appeared before the Grand Jury and gave full, concise and truthful testimony. We, as attorneys for Dr. Buchler, this morning requested an immediate trial so that he may be fully exonerated. "How many minutes and seconds are there in an hour? What does one do when it rains? What is the difference between a man and a woman?" The Consulate refused her a visa because she did not answer

these questions precisely.

asked the following questions: "What is the difference between summer and winter? What is the difference between silver and iron?" first she replied: During the summer it is warm and in winter it is cold. Her answer to the second question was that silver and iron are two different metals. The consul refused her application for a visa. Two of Mrs. Friedman's children had already departed for America and she and her sixteen year old son were to follow. The son obtained a visa but Mrs. Friedman must remain in Poland all alone."

Other questions asked the emigrants included the following: "How many feathers has a goose? How long is a string? How many feet have ten horses? How many feet has an American cat?" Can you make a stove out of butter?" The emigrants, many of them elderly people, believe when they hear these qustions that they are being ridiculed and they lose their composure. If their answers are not given quickly, they are often refused visas, the report says.
