## JEWISH AGENCY VALUELESS UNLESS FUNDS INCREASE, DR. WEIZMANN DECLARES (Jewish Telegraphic Agency)

Basle, Sept. 8.—Dr. Chaim Weizmann, president of the World Zionist Organization, was extensively interrogated concerning his plans for the organization of the Jewish Agency at the meeting of the political committee.

Replying to the questions, Dr. Weizmann stated that the American branch of the Jewish Agency will include not only the Marshall group but other groups as well. As to the financial aid expected by Zionists from the Jewish Agency, Dr. Weizmann stated that so far only the Marshall group has been approached. What is known so far of the plan which might be adopted by the Agency is Dr. Frankel's bank project, he stated. Should the extension of the Agency prove in a reasonable time to have no effect on the increase of the financial means necessary for Palestine, the Agency plan will be useless, he added.

## CHARGE THAT ARABS MISUSE EARTHQUAKE RELIEF FUNDS (Jewish Telegraphic Agency)

Jerusalem, Sept. 8.—The Head Office of the Palestine Jewish Colonization Association has transmitted to Col. Symes, the Chief Secretary to the Palestine Government, a sum of £E.500 donated by James de Rothschild to the Earthquake Fund.

Substantial loans from the Earthquake Relief Fund were granted to Government officials in Transjordan for the purpose of repairing the damage caused to their houses, states the correspondent in Amman of the Arab paper, "Al Carmel."

The correspondent charges that much of the money is being misused by the recipients. "Some of them" he declares, "bought land with the money, others went on a holiday and a number kept the money."

## MAVROMATIS CASE AGAIN AT INTERNATIONAL COURT (Jewish Telegraphic Agency)

The Hague, Sept. 8.—The International Court of Justice opened today its second hearing on the Palestine electrification concession granted by the Turkish government to the Greek engineer, Mavromatis.

The dispute was taken up by the intervention of the Greek government, which submitted its claim against the British government as the mandatory power for Palestine.

## DEADLOCK OVER CHOICE OF NEW EXECUTIVE CONTINUES AT ZIONIST CONGRESS

Control Office for Zionist Funds to be Created; Parties Wrangle Over Executive Policy; Orthodox and Labor Delegates Again Clash

(Jewish Telegraphic Agency)

Basle, Sept. 8.—The deadlock created at the Fifteenth Zionist Congress by the insistence of the American delegation on an efficiency executive in Jerusalem continued today with only one more day of scheduled sessions.

In preparing the agenda for the Congress, the general procedure had been departed from and the first Saturday evening session set aside for the election of the Executive, in order to provide ample time for the discussion and to prevent the recurrence of the events of the Fourteenth Congress. This provision was of no avail because of the divergent views prevailing among the delegates and the

insistence of the various factions.

The American proposal of a Jerusalem triumvirate, supported by Dr. Weizmann, was voted down a second time at a meeting of the Committee on Committees where the formation of the Executive is the chief subject of discussion. This vote showed that Weizmann's proposal cannot secure a majority in the Congress if it is brought for discussion at the general session. Weizmann has requested the committee to submit its own list.

Important progress was reported by the finance committee. From reports issued it appears that the committee has obtained the consent of Dr. Weizmann for the creation of a permanent, independent control office which would be authorized to review the activities of all Zionist financial institutions. Engineer Shockin was proposed as head of this office.

No headway was made by the committee on education where the views of the Orthodox and labor groups are clashing, both as to the amount to be allotted for the educational system and as to the principles underlying the system. The General Zionists hold the balance of power.

The representatives of the Mizrahi Orthodox organization in the committee have submitted a demand that the schools affiliated with the Mizrahi be given wide autonomy in the Palestine Hebrew educational system. The Mizrahi is represented on this committee by Rabbi Wolf Gold of San Francisco, Rabbi M. Magnes of New York and delegate Stawisky. A rabbinical committee was formed to outline the views of Orthodox Judaism on the educational problem in Palestine. This platform will be submitted by the Mizrahi delegates to the Congress.

## DR. RUPPIN TO STUDY JEWISH SETTLEMENTS IN RUSSIA (Jewish Telegraphic Agency)

Basle, Sept. 8.—Dr. Arthur Ruppin, Zionist colonization expert and formerly a member of the Zionist Executive in Jerusalem, will proceed to Russia following the close of the Congress, it was learned here.

The specific purpose of Dr. Ruppin's journey will be to make a comprehensive study of the Jewish colonies in the Ukraine and the Crimea.

## GOGA JOINS CUZA IN NEW ANTI-SEMITIC CAMPAIGN (Jewish Telegraphic Agency)

Bucharest, Sept. 8.—A renewed campaign to spread anti-Semitic propaganda in Roumania will be undertaken shortly, according to press reports published today.

The campaign is to be initiated after the return from abroad of Octavian Goga, Roumanian poet and minister of the interior in the Averescu government.

It was stated that Goga has concluded an agreement with Alexander Cuza to establish a united anti-Semitic National Christian Party, of which Goga will be president and Cuza honorary president.

The party plans to publish a new Roumanian daily by the name of "Idea Nationale" to propagate its program. The party will also endeavor to win the sympathy of the students by establishing a student city, dormitories and student homes.

## DISPUTE OF HADASSAH IS AMICABLY SETTLED (Jewish Telegraphic Agency)

Jerusalem, Sept. 8.—The dispute between the Hadassah administration and the medical staff of its institutions in Jerusalem was settled amicably.

The settlement was brought about by granting wider privileges to the physicians of the staff. It is probable that Dr. Garry, Chief Surgeon of the Hadassah Hospital, will withdraw his resignation which he tendered as a protest against what he termed autocratic rule.

Russian Chulizim Now Held in Prison  
To End Persecution

Russia, Sept. 3.—A limited immigration  
of unskilled workers to Palestine  
will be the policy of the Zionist move-  
ment for the next two years, accord-  
ing to recommendations submitted to the  
Fifteenth Zionist Congress by the  
immigration committee. The committee  
recommended a budget for immigra-  
tion activities amounting to only  
\$25,000. The revised immigration  
budget for 1928 amounted to \$255,000  
and the expenditure for that year to  
\$255,000.

The adoption of this reduced bud-  
get, which includes the items neces-  
sary for procuring the pioneers for  
the country, signifies the intention of  
Zionist leadership to partly close and  
partly curtail the staff in the Pale-  
stine immigration offices at various  
points in Eastern and Central Europe.  
The Committee recommended that in  
the allotments out of the immigra-  
tion budget, preference be given the  
Chulizim in Soviet Russia, particu-  
larly those who are held in prison for  
their Zionist activities and who may  
be released on condition that they  
proceed to Palestine. The committee  
has reports that a number of these  
Chulizim have committed suicide in  
the Russian prisons being in despair  
because of their inability to proceed  
to Palestine lacking the necessary  
funds.

CANADA'S FIRST JEWISH  
PAPER CELEBRATES ITS  
TWENTIETH ANNIVERSARY

(Jewish Telegraphic Agency)

Montreal, Sept. 3.—Twenty years  
of Jewish journalism in Canada find  
a fitting commemoration in the  
anniversary number issued by the Cana-  
dian Jewish Daily Eagle (Der Kana-  
der Adler), published in Montreal.

Hebrew, Yiddish and English writer  
contribute to this issue, which contains  
some one hundred articles from var-  
ious and noted pens; and greetings  
from men in diverse sections of life.

The issue contains one hundred and  
fifty pages, including English, Yiddish  
and Hebrew sections.

"Der Kanader Adler," considered  
the leading Jewish daily in Canada,  
has had an interesting career. In  
1917, after the Kishineff pogrom, the  
paper came into Canada as Jewish immi-  
grants created the need of a Jewish  
paper to help organize Jewish commu-  
nal life in the country. Three years  
later the first attempt was made by  
issuing a weekly sheet, appearing  
every Friday. The popularity of this  
sheet manifested clearly the need of  
a local paper and the fact that the  
United States put a tax on papers  
coming into Canada so that an Ameri-  
can paper would cost two cents as  
compared to the cost of one cent for  
a local paper brought in from the  
U. S. On August 20, 1920, the first  
issue of Der Kanader Adler was  
published. After many vicissitudes Der  
Kanader Adler was firmly established  
and its future assured. As E. Wolf-  
sky, the founder and present editor  
explained it to the representative of  
the Jewish Daily Bulletin: "We started  
Der Kanader Adler as a weekly in  
1917. When things went bad, we pub-  
lished the paper as a bi-weekly. And  
when our creditors were ready to close  
us, we issued the paper as a daily." Among  
the first editors of the paper  
was Nathan Ben-Zion.

The anniversary issue is printed in  
magazine form and contains among  
its interesting matter a reproduction

# JEWISH PRESS UNANIMOUS IN CONDEMNING MAX D. STEUER'S ASSERTION

Charges Had Political Background, Paper Claims; Others, in Editorial Comments, Call His Statement Irresponsible

The Yiddish press is unanimous in its criticism of the accusation and later modification of his charge by Max D. Steuer with regard to Jewish relief funds sent to Europe prior to 1925.

The "Jewish Morning Journal" writing editorially terms Mr. Steuer's assertions "A good lawyer's bad case," declaring: "The ever dissatisfied and always revolting Deputy Isaac Gruenbaum of Warsaw has had a talk with our well known Max D. Steuer in Zurich. Gruenbaum pumped into Steuer the old and 100 times repeated assertion concerning the losses suffered by American relief work through the changing rates of exchange of the Polish currency.

"At home Mr. Steuer is too busy with his professional and other duties to be informed concerning everything which was done and which is being done in the large and wideflung relief work. However, in the mild climate of Switzerland where a rest could be easily taken from the 'fight for minority rights' on a battlefield where the enemy was absent, the old story was told the American jurist as something new. The American jurist coming home gave out the story as good currency. It is therefore natural that Mr. Steuer should have to apologize for the bad case which Gruenbaum gave him," the paper writes.

"The Day" in an editorial entitled "Irresponsibility" refers to its previous editorial where Mr. Steuer's

The policy of Der Kanader Adler is pro-labor. In Montreal it was instrumental in establishing the Va'ad Ha'ir, a committee to coordinate Jewish religious activities. The paper is a staunch advocate of Zionism and in the twenty years of its existence has established a reputation as one of the leading Jewish dailies in this country.

The Canadian Eagle also publishes an English weekly, the "Canadian Jewish Chronicle."

As a fitting conclusion to the celebration of its anniversary, the Canadian Eagle is sponsoring a concert, the proceeds of which will be given to local Jewish schools, on next Sunday afternoon, at the Princess theatre, under the supervision of Dmitri Dobkin. In the evening a banquet will be held for the staff and representatives of local schools, newspapers, institutions and organizations. A. J. Freeman, President of the Zionist Organization of Canada, will preside at the banquet.

statement was termed "dangerous sensationalism." "Mr. Marshall is absolutely right in his attitude," the paper writes. "Mr. Steuer makes himself only ridiculous and to a high degree irresponsible when he attempts to place anybody under suspicion for that unfortunate time. On the other hand, Mr. Steuer proves that he knows very little concerning Jewish affairs and Jewish relief work in particular. Being anxious to get out of the great mistake he made, he tells a story that certain Polish Jewish representatives in Zurich have talked with him concerning a plan to colonize Polish needy Jews on the land. That plan may perhaps be all right and we have nothing in principle against it, but it has no connection with the question.

"What remains to be hoped is that Mr. Steuer's irresponsibility will not cause any harm to Jewish relief work in any form."

The "Jewish Daily News" similarly treats Mr. Steuer's charge as an "irresponsible sensation." Mr. Steuer, the paper says, "is a great criminal lawyer. He is learned and knows how to differentiate between facts and talk. He knows the principle of evidence. He knows that evidence from third hand cannot be accepted and even at first hand an able lawyer must look for the motive of the witness. Now, Mr. Steuer the lawyer did not take all this into consideration. He had heard something and made a sensation of it. He forgot that Gruenbaum was here not long ago and had he really had a case he could have made it public when he was here.

"Mr. Naumberg is a man who often writes short stories which may be good and which are sometimes not so good, but his authority as a social worker and champion of truth is not yet established. Mr. Steuer should have been the last man to take hotel lobby and cafe talk and offer it as facts.

"However, there was, as Shakespeare said, a method in his madness. There was a reason for Mr. Steuer to make this sensation. Steuer was a delegate to the conference on Jewish Rights held in Zurich. All the great Jewish organizations, rightly or wrongly, refused to participate in it. The conference was greatly excited over this and it was necessary to hit back.

"Mr. Steuer," the paper goes on, "has simply excluded himself from the role of a Jewish communal leader. Such accusations are not made by a

PALESTINE MAKES SLOW BUT STEADY PROGRESS. RABBI ABBA SILVER, BACK, SAYS Comments on Present Conditions in Palestine and Russia

Rabbi Abba Hillel Silver of the Temple, Cleveland, returned yesterday from a trip abroad during which he visited Palestine and Russia.

When interviewed by the representative of the Jewish Daily Bulletin, Rabbi Silver summarized his impressions of the two countries.

"I re-visited Palestine after eight years. The changes which I noted were simply amazing," Rabbi Silver said. "From a small, backward Oriental province, Palestine had been transformed into a progressive country wherein modern standards of life and thought are fast gaining ascendancy. It is all a remarkable tribute to Jewish enterprise and enthusiasm.

"New towns and settlements have been built. Great land areas have been redeemed and placed under cultivation. The whole of the Emek is one beautiful plain dotted with Jewish colonies, where pioneers, amidst struggle and hardship, are rebuilding their own lives, and fashioning the home of Israel.

"Some of the cities of Palestine have suffered and are suffering from a temporary economic depression, brought about by the collapse of the 'boom' of two years ago. Palestine cannot be built along American 'boom' lines. The future of Palestine lies in the slow and steady development of its agricultural life. Urban development will follow as a matter of course," he said.

"The Zionist organization ought to devote itself almost entirely to this task. It should not with its limited means attempt to do those things which by right ought to be done by the mandatory power. The Zionists are spending too much money on health work and education, and have therefore very little for colonization and credit. Health and education are government obligations, and should be met out of the moneys paid by Jewish taxpayers.

"I visited Russia. Jewish life there is sadly disorganized but not destroyed. The Jewish religion is not proscribed, and religious practices are not prohibited. But religious education of the youth in schools is prohibited. The faithful are making desperate efforts to save the next generation for Judaism.

## JEWISH WOMEN IN EUROPE WOULD AID JEWISH AGENCY

Interest among Jewish women in Europe in the plan of a Non-Partisan Jewish Agency for the upbuilding of Palestine is wide according to Mrs. Rebekah Kohut, prominent leader among American Jewish women, who returned from a trip to Europe. The plan of allying Jewish women's organizations in Europe and America to further a cultural program in Palestine is being taken up, she said.

On the whole Mrs. Kohut found conditions in Europe better than when she visited there a year ago. The people are more hopeful, she said.

The Jewish Students' House on the Campus of the University of Pennsylvania will be re-opened for the new scholastic year next Thursday, according to an announcement made by Mrs. Robert S. Ginn, Chairman of the House Committee. The Students' House is conducted under the auspices of the Philadelphia Branch of the United Synagogue of America.

Bernard Horwich, prominent Zionist and Communal leader of Chicago, was appointed by Mayor William Hale Thompson a member of the Police-men's Pension and Retirement Board.

Rabbi Daniel L. Davis, formerly of Hammond, Ind. was installed as rabbi of congregation Sha'alai Shamayim, Lancaster, Pa.

## CAMERON SILENT ON FORD'S "INTERNATIONAL JEWS" CIRCULATION IN GERMANY

When asked by a representative of the New York Times to verify or deny a statement by the Hammer Verlag Publishing Company of Berlin, Germany, that it has orders from the Dearborn Publishing Company to continue the distribution of Henry Ford's book, "The International Jew," as reported in a Jewish Telegraphic Agency despatch from Berlin, William J. Cameron, editor-in-chief and publisher of the Dearborn Independent today said:

"It is very interesting, but I have nothing to say."

The statement of the Berlin publishing house said that Ford has not as yet withdrawn the book from circulation.

"Russia is slowly and painfully recovering from the economic debacle which was brought about by the military communism of the earlier years, by the Civil War and the blockade. The New Economic Policy which marked the practical defeat of communism, prepared the way for Russia's economic recovery. But the Government has not yet adjusted itself to the full ramifications of this Policy. It has been constrained to permit private trade, but it is endeavoring in every way to throttle it.

"A struggle is brewing within the ranks of the Communist Party. There are those who fear the growing power of the small bourgeois, and the richer peasants. They therefore urge continued revolution at home, and intensified revolutionary propaganda abroad, to end Russia's isolation. The more 'conservative' members of the Party are more concerned at the moment with Russia's rehabilitation than with world revolution. They would be glad to come to terms with capitalistic Europe and America.

"Russia is becoming militaristic. At the moment it is swept by a war fever induced by the fear of another international combine to overthrow the present government. The youth of Russia is trained to think in terms of the next defensive war," Rabbi Silver said.

Construction of the new \$150,000 addition to the Community center building in Albany was begun. Milton S. Levinson is chairman of the building committee. The building is expected to be finished by January 1.

## DR. CYRUS ADLER VISITS MILITARY TRAINING CAMP

Dr. Cyrus Adler, chairman of the Army and Navy Committee of the Jewish Welfare Board, recently, upon the invitation of Major General Douglas MacArthur and Major General J. H. McRae, of the United States Army, visited Fort Monmouth, N. J., one of the Citizens' Military Training Camps.

Commenting on his visit, Dr. Adler stated: "I went through the men's quarters, was present at the mess, visited the library and recreation rooms, and saw some squads at drill. The Camp made an excellent impression on me; it certainly seemed a healthful and instructive way for young Americans to be spending a month in the summer."

The Jewish Welfare Board conducts religious and social activities for Jewish young men at the Citizens' Military Training Camps. Fifty Jewish young men are at Fort Monmouth. Rabbi Emil Friedman is the representative of the Jewish Welfare Board there.

## WANT JONAH J. GOLDSTEIN FOR SUPREME COURT BENCH

Friends of Jonah J. Goldstein have opened a campaign to obtain for him the nomination to the Supreme Court to succeed Justice Mitchell L. Erlanger, who will retire Dec. 31, barred from another term by the age limit.

Leaders in Jewish communal activities have been given to understand that Tammany intends to pick a Jew for the post.
