

JEWS OF CONSTANTINOPLE RELIEVED AS COURT FINDS ANTI-JEWISH CHARGE FALSE All Charges Declared Baseless— Jews are Released

(Jewish Telegraphic Agency)

Constantinople, Sept. 23.—The Jewish community of Constantinople welcomed with relief the verdict of the tribunal acquitting the nine Jews arrested on the charge of having participated in the funeral of the Jewish girl Elsa Niego, which was charged to have been an anti-Turkish demonstration. The prisoners were released immediately.

The soldier Avramos who was sentenced to 35 days imprisonment will be released tomorrow as his term expires counting the days he was held pending the trial.

The verdict of the court which declared all accusations against the prisoners and the Jewish community of Constantinople baseless was met by great applause in the courtroom and among the large crowds which waited outside the courthouse for the verdict.

PALESTINE GOVERNMENT TO ENTERTAIN NEW PROPOSAL FOR LEGISLATIVE ASSEMBLY

Jerusalem, Sept. 23.—Lord Plumer, the High Commissioner, brought back from London a definite proposal for the constitution of a legislative assembly in Palestine, according to "Al Siassa" of Cairo, which states it obtained the information from its London correspondent. It is understood, however, that the government will not make any move in the matter until a proposal has been submitted by the authorized representatives of the Palestine Arabs. The paper states that a meeting of leading Arabs in the country will be convened to draw up the proposals which should be submitted to the Government.

TO OPEN HEADQUARTERS OF JEWISH RIGHTS COUNCIL

Geneva, Sept. 23.—Steps toward the establishment of headquarters for the Council on Jewish Rights, the creation of which was decided upon at the conference on Jewish Rights held last month in Zurich, were taken on the arrival here of Bernard G. Richards, Executive Secretary of the American Jewish Congress. Mr. Richards will sail for New York on October 7.

ANTI-ALIEN RAIDS TO BE EXTENDED TO ENTIRE COUNTRY, HUNGARIAN MINISTER ORDERS

**Hungarian Legation in Washington Denies Raids Are Directed Against
Jews; Fifty Percent of Those Expelled Are Jews**

Budapest, Sept. 23.—The anti-alien raids which affect a large number of Jews in Hungary continue, resulting mainly in deportations.

The situation called forth panic among considerable sections of the population. Interest in the matter is growing. Even members of the government party have stated they will intervene with the government.

The Minister of the Interior announced today that the present raids which are being carried on in the region of Szabolcs will be extended to the entire country, but they will not have a discrimina-

tory character against any group or religion.

On the other hand the newspapers report today that the local rabbis and superintendents of schools were asked by the authorities to submit lists of all pupils who have not birth certificates showing they are natives of Hungary.

In response to the query of the Jewish Daily Bulletin the Royal Hungarian Legation at Washington stated that it has entered into telegraphic communication with the Hungarian government concerning the en masse expulsions of Jews.

The Government advised the Legation, the Jewish Daily Bulletin is informed, that "in all 391 undesirable aliens who had not complied with the laws regulating the stay of aliens in Hungary have been made to leave the country. About fifty percent of these were Jews from Eastern Europe. It appears that persons trying to evade the regulations above referred to abound especially among these people," the statement of the Hungarian Legation declared.

PUBLISHER SENTENCED FOR YIDDISH LABOR SONG BOOK

Warsaw, Sept. 23.—A Gitlin, Jewish publisher in this city, was sentenced to two months unconditional imprisonment for issuing a collection of Yiddish labor songs.

The collection called "Der Arbeiter Deklamator" was published in 1923. In 1926 the book was confiscated by the Warsaw authorities, the reason being the inclusion of "the Oath," the hymn of the Jewish labor party, Bund, and labor songs by Abraham Raisin and S. Ansky.

The case was tried yesterday by the Warsaw district court. The state attorney demanded a sentence of three years. The confiscation of the book was confirmed by the court.

The publisher will appeal to the higher court.

SELIGMAN, FRENCH-JEWISH ART COLLECTOR, DIES AT 73

Paris, Sept. 23.—Simon Seligman, noted art dealer, died here Wednesday night.

Mr. Seligman, who was born in Frankfurt a/Main seventy-three years ago, was of a family which emigrated before the Prussian advance in 1866. With his brother, Jacques, he founded in 1878 the business in French art objects of the eighteenth century and the Middle Ages. He retired from business twenty years ago and gave his attention to collecting thirteenth century champeane enamels, becoming the possessor of the greatest private collection of these in the world.

Mr. Seligman was a large contributor to various philanthropies.

YIDDISH WRITERS REACH AGREEMENT ON REPRESENTATION IN WORLD BODY

Warsaw, Sept. 23.—An understanding between the Association of Jewish Writers and Journalists in Poland and the J. L. Peretz Verein, Jewish writers club of New York was reached concerning the representation of Yiddish writers in the international P.E.N. club.

Following the decision of the recent P.E.N. conference held in Brussels to admit Yiddish writers organizations into the international writers association provided they create a Jewish P. E. N. club, the two associations of Warsaw and New York determined to establish the club in Vilna. The club will have branches in New York and Warsaw.

The representative of the American Jewish P. E. N. club will be J. Opatoshu, well known novelist.

DR. RUPPIN IN WARSAW ON WAY TO CRIMEA COLONIES

DR. C. ADLER OF HEBREW UNIVERSITY MAKES SUCCESS- FUL SCIENTIFIC RESEARCH

(Jewish Telegraphic Agency)

Jerusalem, Sept. 23.—Dr. C. Adler, of the Hebrew University, has succeeded in tracing the origin of the Popotaci and Jericho-rose diseases by carrying out research work on certain protozoa, an announcement of the Hebrew University declares.

He devoted his attention specially to the sand-fly (Phlebotomus). It is stated that Dr. Adler's researches have extended further than the researches conducted by the League of Nations mission for tropical diseases and the British mission in India.

The foundation of the Physics-Mathematics Institute of the Hebrew University has been completed and the excavation work for the National Library building is preceding satisfactorily, a report of the building progress stated.

The work of repairing the earthquake damage is going forward rapidly. The workshops which were badly damaged have been pulled down entirely. New buildings will be erected near the animals' shed.

It is expected that the work of repair and the installation of the fixtures and apparatus will be completed before the rainy season. This is due to the prompt financial help which was sent to the Hebrew University authorities after the earthquake. The academic course will begin in the fall without any delay.

FORD RETRACTION RIGHTED GREAT WRONG, STRAUS' ROSH HASHANAH MESSAGE SAYS

Henry Ford's recantation was viewed as one of the outstanding events of the year in the Rosh Hashanah message of Nathan Straus, who issued a challenge to Ford last year to either prove or retract his charges.

"On the occasion of Rosh Hashanah I extend my greetings to the Jewish people and express the hope that the New Year may witness the improvement of the condition of our people everywhere, that discriminations and persecutions directed against them in certain lands may cease, that their rights be equalized everywhere with those of the rest of the population, and that better understanding among themselves and their neighbors may prevail," Mr. Straus declared in his message.

"I also hope that the Jewish people will bend all their energies on the rebuilding of Palestine during the coming year, so that the Holy Land may again become a great spiritual center for peace and prosperity—the Jewish Homeland for the good of Israel and the whole world.

"The year just closed has witnessed one of the gravest wrongs righted. I refer to the retraction made by Henry Ford regarding the slanders against the Jewish people that appeared in the 'Dearborn Independent'. Henry Ford's change of heart and his frank admission of error will help to destroy the vicious propaganda that the bigoted enemies of the Jewish people are conducting in various countries.

"I wish also, on this occasion, to thank heartily all those who expressed such sympathetic anxiety during my recent serious illness," he concluded.

DR. CH. WEIZMANN WILL SAIL FOR PALESTINE OCTOBER 30

London, Sept. 23.—Dr. Chaim Weizmann, president of the World Zionist Organization, will sail for Palestine on October 30, it was learned here today.

Particular importance was attached to Dr. Weizmann's journey to Palestine this time in view of the creation of the Jerusalem triumvirate and the adoption of a new economic policy by the Zionist Congress.

J.D.C. ALLOTS 1,500 ZLOTYS FOR POLISH FLOOD VICTIMS

Warsaw, Sept. 23.—The amount of 1,500 Zlotys was allotted by the headquarters of the American Jewish Joint Distribution Committee in Poland for the victims of the flood in Eastern Galicia.

The amount was transmitted by the J.D.C. to the Polish Ministry of the Interior.

BIBLE READING IN PUBLIC SCHOOLS IS SUSTAINED BY MINNESOTA SUPREME COURT

Washington, D. C. Sept. 23.—Reading of the Bible in the schoolroom without comment and without compulsory attendance is lawful, according to a recent decision of the Supreme Court of Minnesota, the Bureau of Education has announced.

That it is lawful and no constitutional provision is infringed by the reading of the Bible in the schoolroom, without note or comment, permitting pupils to retire who do not care to listen to the reading, is the substance of a recent decision by the Supreme Court of Minnesota, the Bureau of Education announcement reads.

The Minnesota Supreme Court ruled: "The purpose of the defendant school board in having the Bible read in the public schools was to implant in the mind of the pupil higher moral and ethical standards and a knowledge of the Bible and was not for the purpose of teaching the doctrines of any religious sect."

JABLONNER REBBE, LEADER OF CHASSIDIC COLONY, HERE

Rabbi Ezekiel Taub, known as the Jablonner Rebbe, Chassidic leader and founder of the Chassidic colony, Nachlach Jacob in Palestine, arrived in New York on the steamer Mauretania.

The establishment of the Nachlach Jacob colony was the culmination of an intensive Palestine movement among the Chassidim in Poland. The rabbi received wide applause when the first group of Chassidic settlers arrived in Palestine two years ago under his leadership.

The colony has recently suffered greatly because of lack of funds and its progress has been hampered. Rabbi Taub stated to the representative of the Jewish Daily Bulletin that he had come to the United States to attempt to raise a fund among his followers for placing the colony on a sound economic basis. Sixty families compose the colony.

ALLIANCE GIVES BANQUET TO AMERICAN LEGIONNAIRES

Paris, Sept. 23.—A large reception and banquet in honor of the American legionnaires attending the American Legion convention will be given Sunday evening under the auspices of the Alliance Israélite Universelle.

JACOB FISHMAN, RETURNED FROM EUROPE, COMMENTS ON RECENT DEVELOPMENTS

Schwartzbard Will Not Be Acquitted, He Predicts

The opinion that Sholem Schwartzbard will not be acquitted but will not receive a heavy sentence was expressed by Jacob Fishman, managing editor of the Jewish Morning Journal, who arrived on the steamer Mauretania following a several months stay in Europe where he attended the Conference on Jewish Rights and the Zionist Congress in Basle.

"The Ukrainians in France are better organized than the Jewish circles interested in Schwartzbard's defense. The Ukrainians have recently obtained powerful political support in France. They also receive indirect support from Polish diplomatic circles," Mr. Fishman stated. The propaganda of the Figaro, owned by the French perfume magnate, Coty, against Schwartzbard was partly counteracted by the publication of a collection of documents concerning the Petlura pogroms. This book was issued by the Schwartzbard Defense Committee.

Concerning the Zionist Congress, Mr. Fishman expressed his satisfaction with the results. The influence of the American delegation at the Congress was no doubt great, but the Americans would have been in a much better position if many of the delegation's members would have had the endurance to remain until the conclusion of the session. Many of the Americans left the Congress before the vote on the important resolutions was taken, Mr. Fishman said.

Commenting on the Zurich Conference on Jewish Rights, Mr. Fishman stated that the success of the proposed Council is entirely dependent upon the work of the American Jewish Congress during the next year. "If the American Jewish Congress will receive greater support and will pursue a stable policy, the Geneva Council on Jewish Rights will be firmly established," he said.

A considerable improvement is observable in the economic position of the Jews in Germany, Mr. Fishman said. "As I am informed, there are in Germany many Jewish business men who enjoy prosperity which does not appear less when judged by American standards," he said.

The United Palestine Appeal campaign will be launched in several Southern cities during the High Holidays. Appeals will be made in Bainbridge, Ga. where Mr. H. Nussbaum is chairman of the drive. In Valdosta, Ga. A. Pearlman is chairman. J. Herzfeld will direct the drive in Westport, Ga.

RABBI RUDOLPH GROSSMAN, OF RODEPH SHOLOM, DIES

Rabbi Rudolph Grossman, rabbi for thirty years of Temple Rodeph Sholom, died of heart disease Thursday at his home in New York City. Funeral services will be held Sunday morning at West End Synagogue, and Dr. Stephen S. Wise, will officiate at the funeral.

Dr. Grossman was sixty years old. He was born in Vienna. He was the son of Rabbi Ignatz Grossman and Nettie Rosenbaum Grossman, and was brought to this country in his childhood. In 1889 he was graduated at the head of his class from the Hebrew Union College in Cincinnati, Ohio, and in the same year received the degree of Bachelor of Laws from McMillen University in the same city.

After his graduation Dr. Grossman came to New York as associate rabbi of Temple Beth-El. He remained at Temple Beth-El for eight years, and went to Temple Rodeph Sholom in response to a unanimous call. Hebrew Union College conferred the degree of Doctor of Divinity upon him in 1892.

In March, 1922, Dr. Grossman's silver jubilee as rabbi of Temple Rodeph Sholom was celebrated. A dinner of the congregation at the Commodore Hotel was given in the course of the three-day celebration.

His wife, who was Martha Keller, of this city, survives Dr. Grossman with three daughters.

Dr. Grossman was president of the Jewish Religious School Union of New York and of the Board of Jewish Ministers and a member of the Commission on Jewish Religious Literature. He had served as vice-president and later as president of the Association of Reform Rabbis of New York.

Dr. Grossman was Past Grand Chaplain of the Order of Free Masons in New York State, and had been active in several fraternal organizations, particularly the Masons.

FOUR JEWISH CANDIDATES FOR SUPREME COURT BENCH

A judicial convention will be convened for the nomination of a Democratic nominee to succeed Justice Mitchell L. Erlanger who will retire on December 31st it was announced. Among the candidates for the nomination the following have been mentioned: Irwin Untermeyer, Jonah J. Goldstein, Henry L. Sherman, Abraham Benedict.

ZIONIST GROUP, AT MEETING, PLANS "BACK TO HERZL" MOVEMENT; TO ISSUE CALL

De Haas Speaks On Herzlian and Achad Ha'am Concepts

What might appear as the beginning of a "Back to Herzl" movement among American Zionists was made at a gathering held Thursday night at the Hotel Martinique.

About 25 New York Zionists were present at the meeting presided over by Robert Szold. The meeting was called to order by B. Cassel who, with B. Eisenstadt, sent out the invitations to the meeting. Almost all of those present participated in a wide discussion on the present state of affairs in the Zionist movement and in Palestine.

The tenor of the remarks concerned itself with the crisis in Palestine and in the Zionist movement, giving expression to a feeling of dissatisfaction. Among those who participated in the discussion were Jacob de Haas, Mr. Szold, Mr. Cassel, Mr. Eisenstadt, M. Danzis, B. Epstein Dalidansky and others.

In introductory remarks prior to the discussion, Mr. de Haas developed his views as to the causes of the present crisis in the Zionist movement. He stated that the apparent deadlock and setbacks of the movement are due to the fundamental deviation from the original Herzlian conception of Zionism. He asserted that the present Zionist leadership headed by Dr. Weizmann is thoroughly imbued with the Achad Ha'am conception of Zionism as aiming not at the creation of a Jewish state in Palestine but at the establishment of a "spiritual center." This conception, which is only a continuation of the old Chovevei Zion theory was the main motive power of the movement under the present leadership and is not intrinsically capable of bringing Zionism to an economic and full political success.

The Balfour Declaration, particularly since its later interpretation through the Churchill White Paper, did not change the aspect. The present Zionist leadership, which got into control of the movement by an accident due to the world war conditions, compromised, not with the Herzlian conception, but with the Achad Ha'am conception, Mr. de Haas stated.

S. Z. Zetzer and another speaker voiced their doubts as to the advisability of starting another oppositional group within the Zionist movement.

The meeting took no definite action but a temporary committee was appointed, charged with the task of calling a large meeting at which time the program is to be presented and a call issued for the creation of a "back to Herzl" movement.

HADASSAH CONCLUDING CAMPAIGN FOR \$120,000

Intensive efforts will be put forth in the final days of the Hadassah summer campaign for \$120,000, which closes on Sept. 30, according to reports from the 271 chapters in the country, a statement from the Hadassah headquarters declares.

After complete reports are received, the winner of the contest for the largest subscriptions raised will receive a Chrysler automobile, an offer of Mrs. Charles Werbelowsky, of Brooklyn. The essential condition of the contest is that Hadassah raise the full \$120,000. This amount represents three monthly commitments to Palestine for the Hadassah Medical Organization, which conducts medical and health welfare work in Palestine.

The chapters heading the list of contributions so far are: New York, \$4,215; Chicago, \$4,000; Brooklyn, \$3,628; Detroit, \$3,010; Boston, \$2,505; Far Rockaway, \$2,200; Louisville, Ky., \$1,425; Worcester, Mass., \$1,125; St. Paul, Minn., \$1,000.

The first Administrative Committee meeting of the American Jewish Congress since the return of the delegates to the Zurich Conference was held at the headquarters of the Congress Wednesday night.

Dr. Wise and some of his associate delegates reported on the Conference and the meeting occupied itself chiefly with the program for the Executive Committee meeting of the American Jewish Congress to be held Sunday afternoon, October 2nd, at the Astor Hotel.

That meeting addresses will be made by the American Delegates, including Dr. Wise, Max D. Steuer, Judge Gustave Hartman, Dr. Joseph Tenenbaum and others and there will be a full discussion of the newly created Council on the Rights of Jewish Minorities which grew out of the Zurich Conference.

The Executive Secretary of the American Jewish Congress, Bernard G. Richards, together with Marvin Lowenthal, the European representative of the Congress, Dr. Leo Motzkin of Paris and Dr. Emel Margolis of Prague are now engaged in creating the purpose headquarters of the Council, it was announced at the meeting.

The Chicago Daily News Radio Station WMAQ, is installing a microphone in the synagogue of the Congregation Anshe Emes, Chicago, for the purpose of broadcasting the principal portions of the services of the High Holy Days. This is the first time in Chicago that the Orthodox services of the High Holy Days are being broadcast directly from the Synagogue.

A new large Orthodox synagogue in the United States is planned for Philadelphia.

Plans were formulated at a meeting held in the Academy of Music. More than 5,000 persons attended.

On a motion made by Joseph Gross, the new congregation was tentatively organized under the name, B'nai Joseph. Louis Schaeffer was elected president and Max Roomin, secretary, of the new organization.

HAGUE COURT REGISTRY DESCRIBES PROCEEDINGS IN MAVROMMATIS CASE (Jewish Telegraphic Agency)

The Hague, Sept. 10.—The proceedings of the Permanent Court of International Justice in its hearing of the case on the Jerusalem electrification concession was described in a statement issued today by the Registry of the Court.

The Permanent Court of International Justice met this morning, Saturday, September 10th, to hear the further statements of the representatives of the British and Greek Governments in regard to the question of jurisdiction raised in the case of the readaptation of the Mavrommatis Jerusalem Concessions, the statement declared.

In opening the sitting, the President called on Mr. Purchase, Counsel for the Greek Government to speak. Mr. Purchase in his speech submitted a number of observations bearing upon points of English law with a view to refuting the arguments of the British representative in regard to the same points.

When Mr. Purchase had concluded his remarks, Sir Douglas Hogg, Counsel for the British Government rose to reply. In the first place, Sir Douglas Hogg said that he regretted that the representative of the Greek Government had on the previous day led the discussion into a domain which did not exclusively relate to the question of jurisdiction, with which question the Court was solely concerned at the present session. In his subsequent remarks, Sir Douglas Hogg endeavored to bring the discussion back to the question of jurisdiction. He then sought to refute certain arguments set out by his opponent relating chiefly to alleged breaches of the obligations of the British Government towards M. Mavrommatis.

In conclusion, the representative of the British Government summarizing his argument, emphasized the following points: There might be a breach of contract, but in no case was there a breach of an international obligation. Consequently, the Courts of Palestine alone had jurisdiction; Even admitting, for the sake of argument, that it was a question of the breach of an international obligation, that breach would not be one committed in the exercise of the powers of public control provided for in Article II of the Mandate, and that was the only case in which the Court was given jurisdiction.

As the representatives of the Greek Government did not wish to make any rejoinder, the hearing was declared closed.

PALESTINE FREES FARM IMPLEMENTS FROM DUTY (Jewish Telegraphic Agency)

Jerusalem, Sept. 23. — Exemption from payment of duty for agricultural implements was granted in a new ordinance promulgated to-day. The ordinance exempts from duty agricultural machinery, implements, tools and spare parts, including milking machines, incubators and such tractors as are not used in non-agricultural work. Manufactured goods ordinarily paid duty of 11 per cent.

MANDELSTAMM'S WIDOW DIES IN PHILADELPHIA

Mrs. Fanny Mandelstamm, widow of the late Professor Leo Mandelstamm, Russian Jewish scholar, died in Philadelphia at the age of 78.

Mrs. Mandelstamm arrived in the United States 38 years ago following the death of her husband.

Rabbi Abraham A. Neuman, Associate Professor of History at Dropsie College, and for nine years rabbi of Congregation B'nai Mishurun, will be installed as rabbi of Mikveh Israel Congregation, Philadelphia on Sunday.

Dr. David Solis Pool, of the Spanish-Portuguese Congregation Shearith Israel of New York, will deliver the installation sermon.

The installation prayer will be offered by Rabbi Mortimer J. Cohen, Rabbi of Beth Shalom Congregation and Vice President of the Philadelphia Board of Jewish Ministers, of which Doctor Neuman was recently elected President.

The address of welcome will be delivered by D. Hays Solis-Cohen, President of Mikveh Israel Congregation. Greetings from the B'nai Mishurun Congregation will be brought by United States Congressman Benjamin M. Goldstein, Chairman of the Board of Directors of that Congregation. Dr. Cyrus Adler, President of the Jewish Theological Seminary of America, will deliver an address.
