TRIAL DATE IS POSTPONED IN CELEBRATED CLEVELAND JEWISH CENTER CASE If Arbitration Attempts Fail, Trial Will Open Nov. 28

(Jewish Daily Bulletin)

Cleveland, Nov. 15.—The opening of the trial in the suit brought by an Orthodox committee of the Congregation Ansche Emeth Beth Tephilah, which built the Cleveland Jewish Center, against Rabbi Solomon Goldman, rabbi of the Center, and the Board of Directors, for deviating from the constitution of the congregation providing that it must adhere to the Orthodox ritual as long as ten members insist on it, was postnoned today.

The case was scheduled to be heard today in the Court of Common Pleas. The trial will take place, it was stated,

on November 28.
Several days before the scheduled date of the opening of the trial, attempts were made by a neutral New York Committee to settle the matter out of court. The first attempt led to no result. Before the opening of the trial, however, the committee succeeded in persuading both parties to re-open the question of arbitration.

ORDINANCE WILL REGULATE CHILD LABOR IN PALESTINE

London, Nov. 15. — Lord Plumer, High Commissioner of Palestine, was authorized to enact an ordinance regulating women's and children's labor in the country, according to a statement made in the House of Commons yesterday by Major Ormsby Gore, Understate Secretary for the Colonies, in reply to a question from Susan Lawrence.

Replying to Commander Kenworthy, Sir Ormsby Gore stated that the High Commissioner had not asked the government for a grant to relieve the victims of the earthquake since the funds required had been raised privately.

London, Nov. 15.—Rabbi Eleazar P. Phillips of the Garnethill Synagogue, Glasgow, was the man who guided Oscar Slater to his freedom after a period of 18 years spent in the Peterhead Prison. Rabbi Phillips met Slater at the prison gate and took him to Glasgow where it is expected the Jewish community will provide for the needs of the released man.

Ramsay MacDonald and many members of parliament voiced the demand that a public injury be instituted to establish Slater's innocence.

Slater was convicted in 1909 of the murder in Glasgow of an aged woman, Mrs. Marion Gilchrist, and sentenced to be executed. The sentence was commuted to life imprisonment two days before the day set for the execution because of agitation based on doubt as to his guilt.

A few days ago Mary Dannermen, who was a fitteen-year-old errand girl and one of the chief wintesses against Slater, signed an affidavit saying she had not meant to identify Slater positively as a man she saw running away from the seene of the crime, but had been influenced by the Prosecutor. EXPERTS WHO WERE INVITED BY CECIL DE MILLE EXPLAIN PART IN 'KING OF KINGS' FILM (Jewish Telegraphic Agency)

Los Angeles, Nov. 15.—Rabbi Ernest R. Trattner, of the City Temple, this city, issued a statement explaining his part as Jewish expert in the production of the film, "King of Kings," by Cecil de Mille.

Rabbi Trattner stated that he had agreed to give De Mille as much information and technical help as would correctly represent the Jewish point of view a its historical setting but resigned after month's work.

"At that time I did not fully realize bow distorted the picture would be but I was wise enough not to be misled," the Rabbi declared in his statement. "I acted for my own interests and protection when I said good-bye. The King of Kings' was never sanctioned by me or any other Rabbi or any Jew prominent in public life.

"I make this statement not only in the spirit of defense but also to guard against any instinuations that may be made in Europe to the effect that American rabbis have given it either encouragement or apnroval.

"In the interests of international and religious goodwill the picture must not be shown in Europe. It has already done an incafculable amount of harm here in the United States. What will be the outcome if it is shown in countries of bloody anti-Semitism like Hungary or Roumania?"

AMNESTY GRANTED TO FIVE JEWISH STUDENTS IN LATVIA

(Jewish Telegraphic Agency)

Riga, Nov. 15. — Amnesty was granted to five Jewish students held in jail for having defended themselves against the attack of anti-Semitic students in Warkilan. On the occasion of the celebration of Latvian independence, 100 prisoners were released, including the five Jewish students.

The Jewish students were arrested a year ago. At that time fourteen were arrested, 9 were acquitted.

BLAMES CONGREGATIONS FOR INTELLECTUAL DECLINE

Gewish Daily Esuletin Baltimore, Md., Nov. 15.— Declining intellectuality among the clergy is due to congregations, Rabbi Edward L. Israel said in a sermon at Har Sinai Temple. In connection with his views he discussed two recent novels, "Elmer Gantry," by Sinciair Lewis, and "Death Comes to the Archbishop," by Willa Cather.

Congregations admire the intellectual clergyman, but they do not want to listen to him, Dr. Israel said.

"The intellectual minister," he continued, "is usually kicked upstairs into a theological school while the encouragement of the public approbation goes to the sensationalist who delights huge congregations with sermons on such subjects as "Would You Like Your Mother to Go in Bathing without Stockings?"

ROCKEFELLER IS LAUDED FOR JERUSALEM MUSEUM

The establishment in Jerusalem of a archaeological museum by John D. Ro. kefeller, who provided the amount of \$2,000,000 for this purpose, is lauded by the Jewish and non-Jewish press.

"We as Jews are doubly proud of this ioundation," declares the "Jewish Morning Journal" editorially, "Outside of its great value for humanity in general and outside of the demonstration of the noble manner in which the Rockefeller family makes use of its wealth, every unbuilding activity in Palestine is an encouragement for our task in the country. A great part of the antiquities which are being mearthed in Palestine have to do with our past. Wealthy Jews might have given more than they now do for the archaedlogical excavations in our ancient fatherland. It is to be hoped that the example given by a Christian will induce them to do likewise."

The "Day" observes: "A fund of \$2-00,000 for the vital needs of present-day Palestine might perhaps have been morvaltable. However, a culture is not nourished with bread alone and not all of the cornerstones of a country should be exchanged for rations. Bread is necessiry but scientific research is also imperative. In addition, if the world at large should come to our aid in the rebuilding of Palestine, it can happen only in the manner in which Rockefeller has now done it, namely: by creating in the country such cultural institutions whose value is apparent for all the peoples of the world.

"The need of the day, the bread of the day and the specifically Jewish work—that is our Jewish task that is our Jewish task which we must meet. For this we will receive the recognition of the Jewish future. However, Rockeeller already deserves the recognition of Jews for creating the archaeological museum in Jerusalem. It is a structure for the world, an achievement for generations,"

LABOR DEPARTMENT OFFERS NEW PLAN FOR | under a waiver of the contract labor II. S. IMMIGRATION POLICY

Restriction to Continue but on Different Basis in Proposed Codification of Immigration Laws; Wives and Minor Children, Husbands of American Admitted; Residence of Illegal Entrants Women to be Before 1924 to be Legalized

(Jawish Daily Bulletia)

Washington, Nov. 15 .- Secretary of Labor Davis will recommend to Congress an entirely new quota basis for limiting immigration to the United States, different from either the present 1890 Census basis or the proposed National Origins plan, according to a statement issued by the Secretary yesterday, in which he also announced additional important proposed recommendations. Secretary Davis is still at work on the proposed new plan, which will be embodied as one of the features of a consolidated code of immigration laws, not yet completed by the Department of Labor.

Relief to separated families by alleviation of the present quota restrictions regarding the wives and minor children of aliens admitted prior to July 1, 1924, who were then married and legalization of the residence of aliens who entered unlawfully prior to said date provided they can meet the physical, literacy and other general requirements of the immigration laws, except the quota restrictions, were among the important proposed recommendations indicated by the Secretary. It is significant, however, that the Secretary fails to declare for an absolute exemption from the quota of the separated relatives, merely stating that "Congress should consider the necessity for special relief" of such aliens without specifying the precise character of the relief. The Secretary also links his proposed legalization recommendation with his old plan of enrollment of aliens under the direction of the Naturalization Service.

Among the recommendations made by Secretary Davis are the following: Secretary Davis' Recommendations

"That alien husbands of American citizens, who are now accorded only a preference in the issuance of immigration visas, shall be classed as exempt from quota requirements, which status is now accorded to the alien wives of American citizens.

That the unmarried alien children of United States citizens between the ages of 18 and 21 be accorded the status of non-quota immigrants, as in the case of children under 18 years of age, instead of being granted only a preference in the issuance of immigration visas, as at present. In other words, that all un-married children of Ameri-

can citizens who are minors be accorded a non-quota status.

"That the provision under which alien students are regarded as nonquota immigrants under Section 4 (e) of the Act of 1924, be transferred to Section 3 of that Act, thereby giving in territory belonging thereto who them the status of non-immigrants, have lost their United States citizenwhich is the status of all other classes of aliens who are admitted for a temporary stay only. It is also recommended that provision be made for admitting students under bond where deemed necessary, no such provision being included in the present status.

Aliens' Families

"He calls attention to the fact that during the past few years there have been large numbers of quota aliens admitted who are members of families of aliens previously residing in the United States, and also that in the meantime many of those who could petition for their families have become citizens and have thereby secured nonquota status and are admissible for that reason.

"He also pointed out that as this only affects families of aliens who arrived prior to the present quota act that it will only be a very short time before every alien who would bring his family under special consideration could become an American citizen and thereby secure a nonquota status. He does not believe, however, that a desire other than an honest one to become a citizen should impel an alien to become naturalized.

"A wish for citizenship should come from the heart and should be grounded upon desire to take part in our Government, and not upon a hope of receiving a particular benefit under a single law. "Relief at this time would only mean

that some of such alien families could be reunited possibly a year earlier than they could otherwise.

"That the preference in the issuance of quota visas now accorded to persons skilled in agriculture be granted only on petition of responsible parties in the United States who are seeking to bring in skilled farm labor or to establish aliens as independent farmers in this country, such petitions to be approved by the Secretary of Labor as now provided in the case of rela-tives of United States citizens who are also accorded a preferential status under the Act of 1924. "That preference in the issuance of

immigration visas be extended to include skilled labor in cases where importation of such labor is authorized moved.

provisions of the general immigration law, and also to members of a learned profession, such preference to be granted on petition of prospective employers in the United States in the manner now prescribed for relatives of United States citizens who are already accorded a preferential status. In such cases it will have to be shown that labor of like kind cannot be found unemployed in the United States.

"That a non-quota status be accorded to aliens born in the United States or ship."

Speaking along general lines. Secretary Davis states also that he would recommend that the Secretary of Labor be empowered to legalize the residence in the United States of aliens who entered prior to the present quota law under a temporary status or concerning whose entry no record is available, provided that such aliens now meet the requirements of the immigration laws, except the provisions of the Immigration Act of 1924 which relate to quota limitation.

The vast majority of aliens who rived prior to the present quota law are not deportable on any ground, and it is believed that the anamolous situation thus created-they are privileged to stay, but cannot become citizensis against the interest of the Government, as well as the individual alien. As the basis for this action he rec-

ommends enrollment of aliens under direction of the Naturalization Service. This would facilitate naturalization procedure for aliens entitled to citizenship and would also assist in preventing the successful surreptitious entry of other aliens in the future.

The Secretary also stated that the recommendations which he is making are for improvements in existing laws and that the Department has now under consideration the preparation of suggested new legislation in the form of a permanent code. He expressed the opinion that the immigration laws were in such condition as to require a codification, and also stated that he had submitted to Congress a draft of a code of all existing legislation concerning aliens, but that the draft does not contain the new principles upon which the Department is now working.

When asked about what he thought of the National Origin provision of the law which was delayed in being put into effect by Congressional action in the last Congress, he stated that in the new treatment of the limitation of immigration which he is considering, there would be a revision of the quota so that the objections to both the census basis and the National Origin method of computation would be re-

Dr. Weizmann declared that he was now going to America to find the necessary innes. He was endeavoring to enlarge through the Jewish Agency mathe forces interested in the uphailding of Palestine. He was full of hope and confidence in the fature. He had faith in the creative capacity of the Jewish people and the influence of Palestine.

The essential problem now is to give work to the unemployed, Dr. Weiz-mann declared. Public works, he said, will be carried out by both the Zionist Executive and the Government, and the voung men will be given work instead of doles. The cutting of the Hebrew schools budget had been forced upon the Congress by the present difficult circumstances. He would do his best to enlarge the education budget but he could not make definite promises at the moment. With regard to the new customs agreement with Syriz, he hoped that the necessary changes would be introduced with a view to preventing any harmful effects upon the industry of Palestine.

Dr. Weizmann warned against ungrounded pessimism and despair. They might still have ups and downs but the final success of the Jewish upbuilding work was beyond doubt. Palestine Jewry was able to contribute much to the coming of better times by endurance and a dismified attitude.
