CECIL DE MILLE DEFIES JEWISH CRITICS OF HIS 'KING OF KINGS' PRODUCTION

In Arrogant Language He Charges Jews with Blame for Prejudice: Plans New Picture of Jewish Nature; Indifferent to Jewish Protest but Considerate of Klan, Rabbi Newman Relates; Metro-Goldwyn Withdraws Film Objected to by Irish in America; Callahans and Murphys' Regarded as Insult to Race; Producers Yield to Public Demand

(Jewish Daily Bulletin)

Los Angeles, Nov. 19 .- Cecil de Mille, producer of the film, "King of Kings" which was widely criticised in the Jewish press and from the Jewish pulpit for its tendency to revive anti-Jewish religious prejudice, took an arrogant stand in reply to this criticism in a statement he made in a press interview.

Setting himself up as an authority on the history of the beginnings of Christianity and declaring that he knows better what is good for the Jewish people, he charged the rabbis and editors of Jewish papers who have attacked the picture with the blame for any prejudice which may result. The critics' reaction to the "Kings of Kings" may lead Christians to see in this criticism a sign of "a guilty conscience."

"They will infer," he said, "that if Jesus were alive today these Jews I speak of would crucify him again."

In his statement Mr. De Mille declares: "No Christian has ever found a trace of Anti-Semitic prejudice or propaganda in the 'King of Kings' for the simple reason that Christians are fully acquainted with the New Testament history and therefore realize that my presentation of it is a fair one. Jewish editors and Rabbis in some instances have read Anti-Semitic ideas into their interpretation of my picture because they are not acquainted with what the New Testament tells us. They have out of their own minds invented a hostility that does not exist. "The danger now is that some Christian

METRO-GOLDWYN WITHDRAWS 'CALLAHANS AND MURPHYS.' FILM OBJECTED TO BY IRISH Producers of Picture Regarded Of-

fensive Yield to Public Demand

(Jewish Daily Bulletin)

Washington, D. C., Nov. 19.-The motion picture, "The Callahans and the Murphys," objected to by the Irish in America, has been withdrawn by the Metro - Goldwyn - Mayer Distributing Corporation, states the News Service of the National Catholic Welfare Council.

The decision to withdraw this film from circulation was communicated by Metro-Goldwyn to John A, Gallagher, editor of the "Standard and Times," Catholic weekly of Philadelphia.

The action, says the Catholic paper, was taken to comply with the wishes of Cardinal Dougherty, Archbishop of Philadelphia, who had delegated Mr. Gallagher, as editor of his official organ, to exert every means possible to have the film withdrawn, The immediate cause of the move for withdrawal was the scheduling of the picture for showing in some Philadelphia houses, although the larger theaters had refused to run it.

ANTI-JEWISH EXCESSES ACCOMPANY HUN-SEVERE GARIAN BILL TO AMEND NUMERUS CLAUSUS

Many Jewish Students Injured in Riots; Threaten to Brand Shield of David on Foreheads of Jewish Students and their Christian Friends

(Jewish Telegraphic Agency)

Budapest, Nov. 19 .- The introduction today of the bill long heralded by the Hungarian government to amend the numerus clausus law limiting the number of lewish students in Hungarian universities and colleges was accompanied by a series of severe antilewish riots in all Hungarian colleges.

The excesses, which started Friday, continued throughout the day and on Saturday. In the attacks perpetrated by the anti-Semitic students, many of their Jewish fellows were seriously iniured.

In manifestoes issued by the Hungarian Students' Organization, the anti-Semites threaten that if the bill is passed in parliament, the Jewish students will be boycotted and the sign of the Shield of David will be branded and those Christian students who taken by the Austrian Skiing Society.

PROF. BREASTED OUTLINES PLANS FOR ROCKEFELLER MUSEUM IN JERUSALEM

of Preliminary Negotiations Tells with Palestine Government (Jewish Daily Bulletin)

Chicago, Nov. 19 .- Additional facts with regard to the plans for the archeological museum to be erected in Jerusalem through the gift of \$2,000,000 Vice President by John D. Rockefeller, Jr. to the Palestine government were made public here by Professor James Breasted, director of the Oriental Institute of the University of Chicago and famous

Egyptologist. Negotiations preliminary to the raking of the gift by Mr. Rockefeller were carried on by Prof. Breasted with Lord Plamer, High Commissioner for Pal-estine, while Prof. Breasted was in Egypt directing work of the Oriental

Institute early this year.
"Since the Great War, the Palestine Government, under the British Mandate, has been courageously meeting its economic problems with a regime of strict economy," said Prof. Breasted in a press interview. "Yet from an already burdened treasury it has annually appropriated £16,000 to the administration of the Antiquities Department. As a result of the wise application of these funds and the steady accumulation of nearly discovered monuments, the Department has greatly expanded the already existent collection of antiquities.

"Palestine has never possessed a museum building and the funds required for an adequate building to house the collections have heretofore exceeded the Government's available means. The present gift is further expression of appreciation of this and other problems in the Near East, and of her desire to cooperate in meeting

BARON ROTHSCHILD GIFT FOR SCHOOLS CONSIDERED BY PAL-ESTINE HEBREW TEACHERS Baron's Terms Involve Change in Educational Personnel

(Jewish Telegraphic Agency)

Jerusalem, Nov. 19 - The Hebrew schools of Palestine, which were not opened the beginning of the season because of the situation created through the curtailment of the Zionist budget, may be reopened next week if the grant of Baron Edmund de Rothschild in the amount of £18,000 will be accepted by the school author-

In making his grant, Baron Edmund stipulated that the schools be given a religious character and that the instruction of religion occupy a more prominent place in the curriculum. The matter was taken under advisement by the Palestine Executive and by the executive of the Union of Hebrew Teachers which is an important factor in determing the character of the schools in Palestine.

It was stated that the acceptance of the terms of the Rothschild grant will involve considerable changes in he personnel of the Vaad Ha'chinuch, the board of education. It is expected that an understanding on this question will be reached.

The new museum building will not only provide ample facilities for displaying the collections now in hand but also for an anticipated expansion in the future as a result of discoveries being made each season by the numerous archeologist expeditions now excavating in Palestine. Mr. Austen St. B. Harrison, the able English architect at present attached to the Public Works Department of Jerusalem and previoushe associated with Sir Arthur Lutyens, the architect of the great Delhi group of British Government buildings in India and of the new British Embassy in Washington, has already submitted preliminary sketches for the museum. He proposes a building in the Romanesque style, characteristic of the Mediterranean from Sicily eastward and therefore entirely appropriate for Palestine. The building material to be used will be local fimestone which will blend harmoniously with both the ancient and modern structures of Jerusalme," Prof. Breasted said.

The sponsors of this plan asked the opinion of Mr. Marshall on its advisability. The inquiry elicited a reply. the text of which was made public yesterday by the American Jewish Committee following the twenty-first annual meeting of the Committee.

The secretary had communicated with Mr. Marshall, informing him that the club had been organized in July of this year and that within three months thereafter an active membership of more than 250 men had been built up.

"The objects of our organization the secretary wrote, "are to promote the welfare of the Jewish people, to take an active part in civic welfare and betterment, charitable interests, and to get behind those Jewish young men who are deserving of political recognition." He went on to inform Mr. Marshall that there had been some discussion "in regard to the use of the name 'Hebrew' in connection with a political organization" and the club was desirous of obtaining the views on that question of leading Jews. In response to the secretary's request that Mr. Marshall give his impartial opinion on the matter, he wrote the letter which follows:

"I am in receipt of yours of the 3rd instant, in which you ask my opinion as to the propriety of using the word 'Hebrew' in connection with a political organization. I am very glad to embrace this opportunity to express to you my views on this important subject.

"To my mind nothing can be more objectionable than to resort to such practice. It is undignified, it is un-American, it is un-Jewish. In this country, where there is a separation of Church and State, where freedom of conscience is guaranteed by State and Federal Constitutions, where every dweller in the land may unquestionably observe his religious belief, where we are all one people, to designate a political club as Hebrew, Jewish, Catholic, German, Irish or Italian, is an parties in accordance with our idea as evidence of shockingly bad taste and of to what best contributes to the welfare a lack of appreciation of what America of the country. Unqualified censure of those who what is their game, whose political with such a situation recoils in disgust. "I approve of political clubs, whether they be Republican, Democratic or independent, provided they are devoted to the serious study of political and governmental principles, to the education of their members in the organic law of the State and Nation and in matter of public concern. But when such a club is called either the Hebrew Republican Club or the Hebrew Democratic Club, it at once gives rise to the impression that the men in the club are influenced by sordid reasons and not by those elevated considerations which should lead to the formation of such an organization. The non-Jew at once entertains suspicion of such an organization and loses respect for its members. Even politicians gauge the club by the name which it adopts and draw inferences which are not complimentary to the sponsors.

"We Jews especially owe a duty to ourselves to occupy a dignified attitude toward public questions-not to cheapen our name, not to permit it to be dragged through the mud of ward politics. It should have to us a sacred connotation and should not be placed in danger of being soiled and contaminated. Morevoer, why should we Jews give rise to any inference that we have a special ax to grind, that our politics have a selfish tinge, and why should we, who in the past suffered because of our religion, now create even a suspicion that we are entering into politics under the banner of separatism? We are opposed to the Ku-Klux-Klan, we were opposed to the A. P. A. and to the Know Nothings, but we are imitating them when we call ourselves Hebrew Democrats and Hebrew Republicans, and Hebrew this and Hebrew

Schenck, president of the Corporation. wrote Mr. Gallagher. After discussing the various protests over the film, Mr. Schenck said in his letter: "Please state to His Eminence that we feel he would not make this request unless he felt compelled to do it. In spite of the fact that it entails financial loss to us, we are happy to meet the request of the Irish people and have given notice to our offices to withdraw the picture immediately."

On the next day, the following telegram was despatched to all branch managers of the corporation: "Withdraw 'Callahans and Murphys' from circulation immediately. Accept no further dates under any circumstances and do not supply this picture anywhere to anyone excepting those who may have it advertised for showing next week; telegraph acknowledgment your understanding and compliance foregoing.

Protests by Irish and Catholic individuals and groups against the film "The Callahans and the Murphys" began immediately upon the appearance of the picture, and have since intensified steadily in almost every part of the country. As a result, many motion picture theater owners have in recent months either cancelled showings of it at their own expense or have refused to book it.

Catholic groups and publications assailed the film throughout the country, with telling box-office effect. Its showing in Washington was protested by the Irish-American organizations of the District of Columbia, and a tentative body was formed to protest against any film unjustly caricaturing the Irish race. In Pittsburgh, following protests, receipts at the house where the picture was shown dropped sharply. The motion picture owners of Western Pennsylvania and West Virginia condemned the film and asked members of their organization not to show it.

In London, when the picture was introduced there, it received instant condemnation.

Attempts by the company to cut the film in such a manner as to eliminate distasteful parts failed, the protesters insisting that it was an insult in any form.

Jewish people' and 'civic welfare and betterment.' Does not the promotion of the latter promote the welfare of the Tewish people as fully as it deserves to be promoted?

"I do not know what 'charitable interests' have to do with a political club. l know that there are some political clubs which during election time seek charitable contributions from political candidates. To me this is a degradation of one of the noblest sentiments of humanity.

"And then to form a club for the purpose of having it advance the interests of 'Jewish young men who are deserving of political recognition.' You are playing with fire and with edged tools when you announce this as the ultimate purpose of your organization. This idea of getting political recognition because one is a Jew is, to me, unspeakably shameful. Men will get their deserts without that kind of boosting. "I earnestly hope that your organization will revise its purposes and change its name without delay. By doing so its members would honor the Jewish name instead of debasing it.

POLISH ZIONISTS URGE JERUSALEM EXECUTIVE TO ADMIT 250 CHALUZIM (Jewish Telegraphic Agency)

Warsaw, Nov. 19-An urgent request to admit into Palestine at least 250 Chaluzim from Poland was forwarded to the Jerusalem Executive in a joint petition of all Zionist groups in Poland.

The action was taken at a session of representatives of the Zionist organization of Poland, the Mizrachi, the Hitachduth, the Poale Zion, the He'-Chalutz and Hashomer Hazair.

This course was decided upon when the plight of many young men and women who have gone through a training of several years preparatory to their intended emigration to Palestine was described. The spokesmen for the He'Chalutz organization contended that if no outlet is provided for these trained young men and women the entire Chaluzim movement in Poland will be threatened with extinction.
