#### JEWS OF SYRIA ARE DENIED RIGHT OF GROUP REPRESEN. TATION IN PARLIAMENT

### Question of Number of Jews in Syria Cause of Dispute.

(Jewish Telegraphic Agency) Beirut, April 12-The Jewish population in Syria, administered by France under the mandate of the League of Nations, was denied the right to have parliamentary representation as group, according to a decision of the electoral commission of the Syrian Constitutional Assembly.

The reason for denving group representation to the Jewish population was given as insufficiency of numbers, the commission claiming that the Syrian Jews cannot elect a special lewish representative, since they number only 3,000. The Jewish community of Damascus protested against this ruling and submitted a memorandum in which it proves that the Jewish population in Syria exceeds the figure given by the commission.

The American Jewish Committee year book gives the lewish population for Syria and Lebanon at 35,000, estimated as of 1922.

#### SOVIET NAMES COMMISSION TO INVESTIGATE ANTI-SEM-ITISM IN STATE THEATRES (Jewish Telegraphic Agency)

Moscow, April 12-The revelations made by the Moscow Soviet press with regard to the existence of anti-Semitism in the Soviet state theatres, leading to the suicide of Krein, Jewish violinist, resulted in Government action.

A Government investigating committee was appointed to make a thorough inquiry into what is termed by the Soviet press, "Golovanovism," derived from the name of the Moscow opera director, Golovanov, who was principally blamed for the existing condition.

#### MOSCOW SYNAGOGUES FILLED DURING PASSOVER SERVICES

(Jewish Telegraphic Agency) Moscow, Apr. 12.-Synagogues

Soviet Russia's capital were crowded to full capacity during the Passover services. In Moscow alone half a million pounds of Matzos were sold for the holiday

Reports from Ukraine and White Russia state that the holiday celebrations passed quietly, there being no public anti-Passover demonstrations.

#### JEWISH COLONY EXISTED ON PACIFIC COAST BEFORE 17th CENTURY, HISTORIAN SAYS 47 Indian Dialects Contain Many

Words of Semitic Origin. (Jewish Daily Bulletin)

Vancouver, B. C., April 12-Bruce A. McKelvie, a British Columbia historian of note, has advanced the theory that a colony of Jews settled somewhere along the northern coast prior to 1600 A.D., probably coming in junks from China where they were numerous and powerful in the sixteenth century.

These Jews, apparently, did not intermarry with the Indians, so that there is now no ethnological trace of their settlement. Mr. McKelvie's theory is based on tribal customs, religious rites, legends, and the presence of many words of Jewish origin in native dia-

The first white men who came to British Columbia could not induce the natives to eat pork "because it was unclean meat." To this day the Siwashes refrain from keeping pigs and seldom touch pork.

In all the forty-seven dialects spoken in the province there are dozens of words of Semitic origin and with Semitic inflections, although the total number of words in a dialect may number only a few hundred.

The mitred helmet, the necklace, and the apron of the medicine man all suggest the ceremonial costume of the high priest of the Levites, Mr. McKelvie states.

#### TROTZKY FATALLY WOUNDED. RIGA PAPER REITERATES (Jewish Telegraphia Agency) Riga, April 12-The Russian mon-

archist daily, 'Sevodnia," published here, which first carried reports on April 1. later denied by the Soviet Government, that Leon Trotzky had been wounded in his exile, today insists that the report was accurate.

The newspaper declares that it is informed by recent arrivals from Moscow that Trotzky was fatally wounded by a seventeen year old member of the Comsomol, Communist Youth Organization, in Vierny, Trotzky's abode in exile. The youth is said to have surrendered to the police.

The opinion prevails in Moscow, the recent arrivals declare, that Trotzsky's death is being denied by the Soviet authorities for political reasons.

#### POLISH GOVERNMENT BARS MEMORIAL FOR THIRTY-SIX JEWISH MARTYRS OF PINSK 'Pinsk Affair' Was Subject of Several Investigations.

(Jewish Telegraphic Agency)

Warsaw, April 12-The erection of a monument to the thirty-six Jewish young men who were shot in 1919 without court proceedings, shortly after the occupation of Pinsk by Polish troops, was finally prohibited by the Polish Ministry of the Interior.

The decision to erect a monument in the Jewish cemetery of Pinsk where they are buried, was taken by the Pinsk City Council. The Wojewoda, district governor, of Pinsk vetoed the decision. The council then appealed to the Minister of the Interior, who confirmed the veto of the Wojewoda. It was declared today that the Pinsk city council will appeal to the supreme tribunal.

The memory of the thirty-six Pinsk Jews is held in great reverence by the Jewish population of Pinsk and surrounding towns, for their martyrdom in the cause of Jewish relief work. Their death was the result of their desire to assure relief for the war stricken Jewish population. They were

#### PITTSBURGH TRIAL BARES SOME OF KU KLUX KLAN'S ANTI-JEWISH OUTRAGES

(Jewish Daily Bulletin)

Pittsburgh, April 12-The testimony presented in the Federal Court here during the trial of the two hostile factions of the Pennsylvania Klan, in addition to unmasking the hideous activities of the hooded order, disclosed some aspects of the Ku Klux Klan's anti-Jewish acts during the period of its reign.

The courtroom was kept at a high pitch of interest as an Oklahoma "Black Rider," Frank S. Lanham of Sand Springs, formerly an Exalted Cyclops and Great Titan, told how two young Iews had been compelled to lash each other. Lanham spoke of the two Jews as "Icw hat salesmen from New York." "These two Jews came into Tulsa and flirted with some girls. They were arrested and then turned over to the night riders," he said. "Night riders took them to the outskirts of the town, and about 500 feet off the Hominy Road. They were given whips and were told to beat each other. That's

#### COLONISTS COMPELLED TO LEAVE CYPRUS AS ICA SELLS ITS SETTLEMENTS (Jewish Telegraphic Agency)

Jerusalem, April 12 - A group of lewish colonists settled in Cyprus on the land of the Jewish Colonization Association, will be compelled to leave their homesteads, a report received here

The emigration has become necessary since the Ica has, according to the report, sold the property to a group of Englishmen who intend to colonize forty Armenian families there.

The Jewish colonists have cabled their protest to the Paris board of the Ica, to Dr. Joseph H. Hertz, Chief Rabbi of the British Empire and other influential men.

#### BRITISH PRINCESS, MARY ON VISIT IN PALESTINE (Jewish Telegraphie Agency)

Jerusalem, April 12-Princess Mary. daughter of King George and Queen Mary of Great Britain, and her husband, Viscount Lascelles, were greeted at the station on their arrival here by Lord and Lady Plumer, British officials and a guard of honor of British troops.

#### HUNGARIAN ZIONISTS HOLD THEIR FIRST NATIONAL CON-VENTION IN BUDAPEST

(Jewish Telegraphic Agency)

Budapest, April 12-The first national convention of the Zionist Organization of Hungary was opened here on Monday, April 9. One hundred and five delegates were present at the opening session, which took place in the old parliament building. Dr. Straus, well known Orientalist, opened the convention.

By a unanimous decision the convention voted to send a message of greeting to Admiral Horthy, Regent of Hungary, and to Prime Minister Bethlen. The agenda is devoted mainly to a consideration of ways and means of building up the growing organization in Hungary. It was reported that the opposition to the Zionist Organization in the country is now limited to the Orthodox Landeskanzlei and to Dr. Paul Sandor, who continue their objections.

The liberal Jewish groups remain neutral.

#### JEWISH CANDIDATES CHOSEN IN CHICAGO PRIMARY VOTE (Jewish Dally Bulletin)

Chicago, April 12-City Clerk Morris Eller, Thompson-Crowe Republican candidate for Sanitary District Trustee was nominated at the primary elections on Tuesday. Sanitary District Trustee Michael Rosenberg, Democrat, was nominated to succeed himself. City Clerk Eller was also elected a delegate to the Republican national convention in Kansas City.

Congressman Adolph J. Sabath was elected a delegate to the Democratic national convention in Houston, Texas, Sanitary District Trustee Rosenberg was also elected a delegate to the Democratic convention, as were Judge Harry M. Fisher, all of whom are supporters of Al Smith for president.

Samuel L. Golan, Thompson-Crowe Republican, was nominated for Congress from the Sixth Illinois District, defeating Samuel Cossman. Republican ward committeemen elected include Morris Eller, Judge Michael Feinberg, and William H. Feigenbutz.

Democratic ward committeemen elected include Congressman A. J. Sabath, Michael Rosenberg, Alderman Joseph Mendel and I. A. Doff. Assistant State Attorney Louis N. Blumenthal was named Republican candidate for municipal judge.

#### STATE AND RELIGION ARE SEPARATED IN TURKEY BY NATIONAL ASSEMBLY VOTE (Jewish Daily Bulletin)

Washington, D.C., Apr. 12.—The United States Department of State was informed by cable from the American Ambassador at Angora that the Turkish National Assembly has voted to separate church and state

In passing the bill, introduced by Ismet Pasha, the constitution of the Turkish Republic was amended to omit all references to religion. The article in the constitution proclaiming Islam as the religion of Turkey was stricken out. Deputies of parliament will take their oath "on honor" instead of the original for-mula of "before God".

#### PROTESTANT BIBLE HOUSE DEDICATED IN JERUSALEM (Jewish Telegraphic Agency)

Jerusalem, April 11-The Protestant Bible House was dedicated here yesterday with the participation of many representatives of foreign lands who came here to attend the conference of the International Missionary Council

Bishop MacInnes, Anglican bishop of Jerusalem, presided over the dedication ceremonies. Dr. John R. Mott, executive secretary of the Young Men's Christian Association in America, and Lady Plumer were among the speakers. Rev. Ritson, secretary of the British Foreign Bible Society, declared in his address that the Bible now circulated in 605 languages and dialects. The Bible House was erected at a cost of £17,000.

#### KING OF SPAIN BESTOWS ORDER ON DETROIT LAWYER (Jewish Daily Bulletia)

#### DR. REVEL, FACULTY HEAD, OUTLINES PURPOSE AND POLICY OF YESHIVA COLLEGE

To Provide Harmonious Blending of General and Jewish Education.

Dr. Bernard Revel, president of the faculty of the Rabbi Isaac Elchanan Theological Seminary, in commenting on the decision of the Regents Board of the New York State University to grant a charter for the establishment of the Yeshiva College, the first undergraduate institution to be conducted under Jewish auspices in the United States, outlined the purpose and policy of the new institution.

In a statement he issued, Dr. Revel declared: "In the Yeshiva College of Liberal Arts and Sciences, sanctioned by the University of the State of New York, the Yeshiva will offer to a select body of qualified students as an integral part of its activity, a course of high scholastic standing in the general fields of learning and culture, an harmonious blending of the knowledge of our own culture and contribution to mankind with the equipment essential to leadership in life today, with the tools of study, the facts of life and the materials and spirit of general culture. The Yeshiva College will offer to the Yeshiva students, and in time also to other young men properly equipped who consider the knowledge of Judaism an integral part of their liberal education, this harmonious development of Jewish scholarship and culture beside modern culture and scholarship, an understanding of the Jewish spirit and ideals through which, with the knowledge of the centuries and of our own age, they may develop a complete Jewish-personality as loval sons of our people, equipped and ready to give of their best to Israel and to our coun-

"The Yeshiva College aims to foster this harmonious growth, in which the bases of modern knowledge and culture, in the fields of art, science and service will be blended with the bases of Jewish culture, to develop informed and devoted sons in the undying spirit and faith of Israel. The college aims at the inculcation of an abiding consciousness of the high ideals and the spiritual heritage of the Jewish people and at the development of intellect and character, through the pursuit of those humanizing studies by which life as a whole may be elevated and enriched, conducted in an environment that is spiritually sympathetic, producing a mind consistent in its outlook, and

GOVERNOR FULLER IN SHARP WAR WITH MASS. LEGISLA-THRE OVER 'JEWISH MEASURE' State Senate Overrides Governor's

Veto of Bill (Jewish Daily Bulletin)

Boston, April 12-Governor Fuller may declare war on the legislature following the action of the Senate which passed the Fox bill by a vote of 23 to 10 over the Governor's veto. The bill. introduced by Representative Fox of

Dorchester, would legalize the sale of foodstuffs on Sundays when Rosh Hashanah and Yom Kippur fall on Mon-

The action of the Senate caused the ire of Governor Fuller who declared last night that the action of the Senate was not legal, on the basis of the opinion of former Attorney General Parker rendered in 1904, that the constitution of the commonwealth requires that in order to override the governor's veto, the measure must be passed by a twothirds vote of the entire senate and not merely two-thirds of the representatives present at the session. Meanwhile, the action of the House

of Representatives is awaited. the belief of observers here that the House will sustain the governor. The Senate counsel, William E. Derman, is

the Senate was legal.

The question has aroused state wide interest. Several members who opposed the original bill, dissenting from the report of the Legal Affairs Committee, will wage a hard battle to defeat the measure.

Senator Bilodeau moved for the reconsideration of the measure in the Senate which prevailed by a majority. Representative Fox, who is a member of Governor Fuller's party, stated he was deeply disappointed at the governor's action.

It was learned that there have been rulings contrary to the Parker opinion, but the governor stated that the Parker opinion is the only one on record in Massachusetts. The dispute between the legislative and executive branches on this issue was discussed by the public and press. The belief was expressed that the governor's action was precipitated by the Lord's Day League.

ANDY COHEN, OF GIANTS. HAILED AS LONG SOUGHT JEWISH BASEBALL STAR Leads Giants to Victory in Opening

Game: 30,000 Cheer Hero The long sought Jewish baseball star seems to have been discovered in the person of Andy Cohen of the New York

Andy Cohen was the hero of the day at the game opening the 1928 baseball season when the Giants defeated the Boston Braves at the Polo Grounds, before a crowd of 30,000. Mayor Walker threw the first ball, inaugurating the season.

The first Cohen in big league baseball was carried off the field on the shoulders of the fans. He scored the first run of the year for the Giants after singling in the fifth inning. He won the game for the Giants by hitting for two bases with two Giants on base in the sixth inning. In the eight he singled and scored another run when Hogan hit for two bases.

Describing the rise of Andy Cohen from obscurity to fame. James R. Harrison, sport writer of the "New York

Times writes:

"Dubiously greeted as the successor of the great Rajah, Andy had his chance yesterday, and he didn't make a 'boot.' Here was a big New York crowd. Over attempting to prove that the action of there on the visiting bench was Hornsby. How would the youngster stack up against the grand old veteran? Would he falter and break, or was his hand firm

and his nerve steady? "Those were the questions that the crowd asked itself, and Andy Cohen supplied the answers. For the moment at least he is the baseball hero of New York. He will pull them in at the gate like a Babe Ruth-partly because he is, for the present anyway, the long-sought Jewish star on a New York team; partly because he is a youngster in a tough spot, and partly because he is a pretty

fine ball player in his own right.

"Nothing else seemed to matter very much in this ball game but the young Jewish lad, who came in one long stride from minor league obscurity to a job which had last been held by Rogers Hornsby.

"The fact that the Giants beat the Braves, 5 to 2; that they pulled up the flag and the band played the "Star-Spangled Banner," that Mayor Jimmy Walker was there to throw out the first ball-the fact even that another baseball season was being unfolded was unimportant compared with the triumph of

Andy Cohen.

"Between the covers of a book they may hoist the great hero to their shoulders and march off with him, but it isn't done in professional baseball. Wasn't done, that is, till yesterday, when the enthusiasm and joy of New York's blase baseball patrons bubbled and boiled over and they carried Andy Cohen around the Polo Grounds."

#### KINGS COUNTY HOSPITAL SUPERINTENDENT, DR. JONES REINSTATED, COLER SAYS

Commissioner of Public Welfare, Bird S. Coler, yesterday confirmed the report current that Dr. Mortimer D. Iones, medical superintendent of Kings County Hospital, suspended on charges of anti-Jewish discrimination that were substantiated in the report of Commissioner of Accounts, Higgins, had been reinstated to his position.

Dr. Jones was suspended by a special order issued on February 8 by Commissioner Coler. The commissioner explained vesterday that there was a misunderstanding with regard to Dr. Jones' status. He was merely given time to prepare a report in reply to the statements made in the report of the Commissioner of Accounts.

The Alliance of Women's Clubs of Brooklyn, it was reportd asked for the reinstatement of Dr. Jones. On Feb. 1, Mayor Walker, in commenting upon the findings of the Commissioner of Accounts, was reported as having intimated to the Welfare Commissioner that certain suspensions and transfers in the personnel of the Kings County Hospital would be necessary.

#### HIAS REPRESENTATIVE SAILS FOR ARGENTINE

Aaron Benjamin, honorary secretary of the Hebrew Sheltering and Immigrant Aid Society of America, sailed on the SS. Southern Cross for Buenos Aires. At Buenos Aires, Mr. Benjamin will join Dr. Louis Oungre of the Jewish Colonization Association and Dr. Myron Kreinin of the Emigdirect, and the three will proceed to many points of South America for the purpose of studying the immigration possibilities for Jews from middle Europe.

In addition to a study of economic conditions, the committee intends enlarging the work of local organizations and establishing shelters, employment bureaus and schools which will offer language and trade courses for Jewish immigrants. This is part of the campaign undertaken more than a year ago by Hias and the Jewish Colonization Association with a view of settling Tewish families who cannot remain in Europe and cannot come into the United States because of the immigration quota restrictions.

arrested while attending a meeting shortly before Passover in 1919, to arrange for the distribution of Passover aid. While the meeting was in session. a Polish officer entered the hall and declaring that they were Bolsheviks "conspiring against the Polish army." ordered his men to line them up against the wall of a monastery situated in the center of the town and shoot them.

The "Pinsk affair" was the subject of several investigations as a result of the outcry of Polish Jews against the severe anti-Jewish excesses which occurred in Poland in 1919. The city was visited shortly after the occurrence by the American Investigation Committee, headed by former Ambassador Henry Morgenthau and General Jadvin. It was also the object of an investigation by the Commission of His Britannic Majesty's Government, headed by the late Sir Stuart Samuel. The occurrence was also investigated by a special commission sent to Pinsk by the first Polish Sejm.

what we call 'lapjacking.' When they let up on each other or did not strike hard enough blows one of the riders stepped in and supplied the punishment," he testified.

A ruling by Judge W. H. S. Thomson dismissed the suit of the five banished members who sought an injunction restraining the Klan from doing business in Pennsylvania and asking an accounting of the twenty million dollars paid to the Klan by its members in the State. The judge ruled that the Federal Court has no jurisdiction in the case and that to obtain the injunction the plaintiffs must appeal to the State Attorney General for a revocation of the license.
