PLUMER TRANSJORDANIA'S HIGH COMMISSIONER. BUT RETAINS PALESTINE POST (Jewish Telegraphic Agency)

London, April 25. — Field Marshal Lord Herbert C. Plumer, High Commissioner of Palestine, has been appointed High Commissioner of Transjordania, an official announcement in the London Gazette today states.

Transjordania is a part of the British mandated territory and the appointment of Lord Plumer to the High Commissionership follows immediately upon the agreement concluded between Great Britain and Emir Abdullah, which granted the territory a measure of independence with certain reservations.

Lord Plumer will retain his position as High Commissioner of Palestine, administering the two countries.

ROBINSON, MEMBER OF OZET EXECUTIVE, ARRESTED JUST BEFORE LEAVING FOR BUREYA

Moscow, April 25. - M. Robinson, member of the executive committee of the Ozet, society for settling Jews on the land, which is sponsoring the Bureya colonization project, was arrested yesterday by the Soviet authorities.

Robinson's arrest caused considerable surprise in Moscow Jewish circles as it was effected one day before his scheduled departure for Bureva as a member of a special commission to supervise the inauguration of the settlement work. Prof. Bruck and Merezhin are the other members of the commission. Mr. Robinson was substituted by A. Raschkes, a Communist. The commission has departed for Bureva.

TWO GERMAN JUDGES ON TRIAL FOR PART IN FRAMING CASE AGAINST JEWISH MERCHANT

(Jewish Telegraphic Agency)

Berlin, April 25 .- The trial of Landgerichtsrat Koelling and Landgerichtsdirektor Hoffmann, who played a prominent part in the so-called German Drevfus case, involving the Magdeburg lewish merchant, Rudolf Haas, began today when disciplinary proceedings were brought against them. The trial will last six days.

Koelling and Hoffman are charged with initiating a press campaign against Haas and aiding in the "frame-up" against him, which resulted in his arrest on the charge that he had murdered his Christian bookkeeper, Helling. Haas was released after spending

many months in prison, when Schraeder confess d that he had murdered Helling and that he had been persuaded to throw the charge on Haas. At the outset of the proceedings Koel-

FELIX WARBURG SUBSCRIBES \$1,000.000 TOWARD COL-ONIZATION FUND FOR RUSSIA

His Subscription Is Largest Single Contribution Ever Made in New York for Jewish Relief and Reconstruction in Europe

and philanthropist, has subscribed \$1,000,-000 for the development of Jewish farm settlements in Southern Russia, it was announced by James N. Rosenberg, Chairman of the American Jewish Joint Agricultural Corporation.

"Mr. Warburg's contribution is a magnificent response to the recent \$5,000-, 000 subscription by Mr. Julius Rosenwald, of Chicago, for the promotion of Tewish agriculture in Russia," declared Mr. Rosenberg. "Mr. Rosenwald's gift was conditional upon another \$5,000,000 being collected in this country. Mr. Warburg immediately responded, setting a new standard for the Jewish community of this city. His \$1,000,000 subscription is the largest single contribution ever made by a New York citizen for Jewish relief and reconstruction in Europe." Mr. Warburg's subscription, like that of Mr. Rosenwald, is conditioned upon the full \$10,000,000 being subscribed."

Mr. Rosenberg pointed out that the subscriptions of Mr. Warburg and Mr. Rosenwald are toward a new and independent society now being organized for land settlement in Russia, and are not to be confused with the activities of the Joint Distribution Committee. The present program of the latter Committee in Palestine."

Felix M. Warburg, New York banker | Eastern Europe, Palestine and Russia requires the urgent collection of all the outstanding pledges made to the United Jewish Campaign.

"Between now and October 1, 1928," declared Mr. Rosenberg, "the Joint Distribution Committee requires substantial sums for the existing farm colonies in Russia, and the medical, trade school and loan activities there. Dr. Rosen, the Director of the Agro-Joint, has already made a most urgent plea to the Joint Distribution Committee for additional funds to take care of the flood of Jewish refugees from the towns who this spring have swarmed to the colonies, without formality of registration, and who must be provided for.'

Mr. Warburg personally visited the new Jewish colonies in Russia last year. He returned an enthusiastic believer in the land settlement work conducted in the Ukraine and the Crimea by the Agro-Joint, under the direction of Dr. Joseph A. Rosen.

In confirming the announcement, Mr. Warburg declared to the "New York Times" representative that "it was not his intention to divert interest from the plan of the World Zionist Organization to establish a Jewish national home in

DR LEO MOTZKIN CHOSEN TO DIRECT ACTIVITIES OF JEWISH RIGHTS COUNCIL

(Jewish Telegraphic Agency) Berlin, April 25.-Dr. Leo Motzkin, formerly chairman and secretary of the Committee of Jewish Delegations in Paris, was chosen to head the work of the Council on Jewish Rights, created at the Zurich conference last summer on the initiative of the American Jewish Congress.

This decision was taken at a session of the European members of the Execentive Committee of the Conneil preded over by Deputy Isaac Gruenbaum of Warsaw. This arrangement is to continue until the next plenary ses-Sion.

This decision has called forth surprise in the circles of the American Jewish Congress. Mr. Bernard G. Richards stated that it was the intention of the Congress to concentrate the work of the Commeil in Geneva, where Mr. Z. Abersohn is in change. The Berlin meeting, he stated, was held "rather unexpectedly and without saificient notice to the American mem bers."

It was stated that the relations between the Geneva bureau of the Council and the office of the Committee of Jewish Delegations in Paris, where Dr. Motzkin is in charge, were not harmonious in recent months. Much dup-lication in connection with the work

MRS. ARCHIBALD SILVERMAN RESIGNS HER POST AS VICE. PRESIDENT OF HADASSAH

Asserts That the Organization has Violated Its 1rust

Mrs. Archibald Silverman, a vice-president of the Hadassah, Women's Zionist Organization, yesterday announced her resignation from that office. Her step followed a meeting on Sunday of the National Board of Hadassah which adopted a resolution of "no confidence" in the present Zionist Administration and made other decisions which Mrs. Silverman characterized as a "violation" of Hadassah's

purpose. Mrs. Silverman, who has been identified with the Zionist movement in America for twenty-two years, said in her letter of resignation, which was addressed to Mrs. Irma Lindheim, president of Hadassah: "I am compelled by the course which events have taken in the Hadassah Organization to tender my resignation as a vice president of the organization.

"I am convinced that the action recently taken at the meeting of the National Board on April 22, which had been gradually prepared through the efforts of Hadassah leaders, is in distinct and conscious violation of the purpose for which Hadassah has been organized and the trust which has been reposed in this organization by the Zionists in America.

I believe that in addition to their unconstitutionality these acts have been conceived and carried out in a spirit of such bitterness and such personal animosity as to introduce into Zionist ranks a spirit of rancor and hatred unbecoming to Jews and to Zionists, and is inconsistent with an organization which has appealed to the country on grounds of womanly interest in the social welfare problems of Palestine."

LATIN CHARACTERS FOR YIDDISH REJECTED BY CHARKOFF CONFERENCE

Communist Organ Fears Loss of Influence on Jewish Masses (Jewish Telegraphic Agency)

Moscow, Apr. 25 .- A recommendation that Yiddish should be printed and written in Latin characters was rejected by the All-Soviet Jewish Cultural Congress

held recently in Charkoff. The Yiddish Communist organ "Emes" published an article warning against dan-gerous experimenting with Yiddish orthography on the ground that it made it more difficult to win new readers. It was necessary, the article pointed out, to have uniformity. Decisions should not be made by the authorities on language and the writers, but by the teachers, the cultural workers, and the readers themselves. The best rationalization of Yiddish orthography, it said, would be to replace the present Hebrew alphabet with Latin characters, which would practically solve all the problems of Yiddish orthography. but under present conditions, such a reform would be followed by very lamentable results. "All our influence on Yiddish cultural life would be at an end because the Yiddish language in Latin. characters would lose its mass of readers,"-the paper stated.

The substitution of Latin characters for Hebrew has been suggested in regard to the Hebrew language as weii-as Yiddish. Recently Ittamar Ben Avi, the editor of the "Dozr Havom," issued several Hebrew books printed in Latin char-

CODREANU, ROUMANIAN ANTI-SEMITE, ARRESTED 7 FOR ATTEMPTED MURDER

(Jewish Telegraphic Agency)

Bucharest, April 11. - Advocate Corneli Codreanu, who was acquitted of the Murder of Manciu, the Police Prefect of Jassy whom he shot because he had taken measures for the protection of the Jews, has been arrested for attacking and almost killing Engineer Beszan, one of the leaders of the Jassy anti-Semites, supporter of Professor Cuza against the claims of Codreanu.

Beszan recently made a gift of a site for the building of a Cuzist Students House in Jassy, and Professor Cuza accepted the Presidency of the Building Committee: Codreanu, who was formerly Professor Cuza's right-hand man, came into conflict with Beszan over this matter. Yesterday a group of students entered the building which is now in course of erection and attempted to remove some of the building material. Beszan stopped them. The students complained to Codreanu, who accompanied them to Beszan's home, where they threw themselves on Beszan with cudgels and other weapons and beat him, leaving him for dead. On recovering, Beszan made a written statement declaring that his as-sailants had intended to kill him. They had attempted to throw him out of a second floor window.

Professor Cuza was the first to report the assault to the police. After a long search Codreanu and his accomplices were arrested.

The press, in reporting the incident, complains of the action of the jury in acquitting Codreanu when he was on trial for the murder of Prefect Manciu, enabling him to employ his liberty for further acts of violence and demands that he should now be severely punished to show others that violence will not be suffered with impunity.

Jewish Center Idea Takes Root in San Francisco

(By our San Francisco correspondent) San Francisco, April 21.-The Jewish

Center idea is taking root fast in the San Francisco Jewish community. Not only have the past few months

seen a crystalizing of intensive plans for the organization of an adequate Jewish Community Center and the erection of a suitable building to house it. but the center policy, with its opportunity for Jewish intellectual, cultural and recreational activity, is being adopted by more of the local Jewish congregations.

In fact, there has been manifested by San Francisco religious congregations an increasing desire to make of the synagogue more than a place of worship and to regard it as a gathering place for the members of all ages seeking to come together for their cultural and social benefit.

This idea, of course, has been carried the Constitution of the Knesseth. out for years in the large Eastern cities but in the West the idea has been slow to take root and those congregations which have carried on cultural and social activities in conjunction with religious services have been hampered by lack of physical equipment.

For years Congregation Sherith Israel, under the guidance of Rabbi Jacob Nieto, has fostered intellectual and recreational activities for its members but now there is a desire to expand this field of endeavor and definite plans are under way to provide a temple house for this purpose.

It is planned to erect a three-story building at a cost of approximately \$100,000. A committee consisting of Harry K. Wolff, H. Sieroty and I. N. Eisenberg already has presented an architect's sketch of the proposed new building which will adjoin the temple.

MIZRACHI TO HOLD WORLD CONFERENCE; BUDGET HAS GROWN, LEADERS DECLARE

(Jewish Telegraphic Agency) Jerusalem, April 25.-A world confer-

ence of the Mizrachi will be held within the next few months. The place of the conference has not yet been decided. This announcement was made by Rabbi Berlin and Rabbi Fishman, leaders of the Mizrachi Organization and members of the recent Mizrachi delegation to America, at a press conference held here.

Rabbi Fishman spoke on the question of the Jewish Agency and the position of Zionism abroad. There is a wide field for Mizrachi activities everywhere, he said. A Mizrachi Organization has been established in Canada. Considerable interest is being shown by world Jewry in "Knesseth Israel" (the Jewish Communal Organization in Palestine).

Replying to a question, Rabbi Fishman emphatically denied the reports that Chief Rabbi Kook is favoring the separatist movement. Chief Rabbi Kook, he said, had never called upon anybody to leave the "Knesseth Israel," although he opposed women's franchise, provided for in

"I. This is not a 'secession' movement. Those participating are Zionists, devoted to the movement and interested in the organization, who far from seceding, seek a change in Z.O.A. administration and policies, and are determined to make their views known.

"2. This call signed by individuals representing many viewpoints and widely scattered is evidence that this conference s not accusted by personal motives but esponds to a situation recognized in many points of the country.

"3. This is a conference of American Ziomists who wish to deal with the administrative methods and the policies pursued by and through the Z. O. A. in Palestine and in the United States.

"4. This is not an attempt to reopen old connecessies. COMMUNIST PARTY ISSUES BOOK AGAINST ANTI-SEMITISM

Moscow, April 25 .- Articles by prominent leaders of the Soviet Government. decrying the existence of anti-Semitism in Soviet Russia, will be published in a special book against the tendency. by a decision of the Central Committee of the Communist party. The book will also contain statistical data about the situation of the Jews in Russia.

Another book, entitled "Against Anti-Semitism," by Sgorev, was issued today by the Government publishing house. This book reviews the history of the anti-Semitic movement in Russia and describes the present situation of the Jewish population. It also contains statistics concerning the number of Iews working in Soviet institutions and a review of the Jewish colonization work in Russia.
