WEIZMANN CALLS NATIONAL CONFERENCE TO DISCUSS

PALESTINE SITUATION President of World Z. O. Says Palestine Faces New Era of Progress

A national conference on Palestine has been called for Sunday, May 20, at the Astor Hotel, New York. The letter of invitation to the conference has been signed by Dr. Chaim Weizmann, president of the World Zionist Organ-

At the conference Dr. Weizmann will report on the latest situation in Palestine. Reports on the response to the United Palestine Appeal campaigns in Jewish communities throughout the country will be presented.

The calling of the conference has been necessitated by the present situation in Palestine, Dr. Weizmann stated. In his letter of invitation which has been sent to the leaders in the cause for the up-building of Palestine, Dr. Weizmann writes:

"During my stay in America, I have been calling the attention of American Iewry to the fact that Palestine faces a new era of progress. The pioneers are imbued with a new spirit of hope and ambition. They see around them new sources of strength. Industries are being revived, and new capital is beginning to flow into the country.

"The announcement has been made that, thanks to special contributions coming from American Jews. unemployment from which we have been suffering for many months, will shortly cease. The crisis is being liquidated, but everything depends upon securing from the Jews of America, the continued remittance of their quota for the Palestine budget. The holding of the present position depends upon arousing the consciousness of responsibility of American Jewry.

N. J. ZIONISTS TO PRESENT \$100,000 TO DR. WEIZMANN AT STATE RECEPTION

Newark to Subscribe \$50,000, to Launch Local Campaign (Jewish Daily Bulletin)

Newark, N. J., May 1.-New Jersey Zionist leaders are planning to present a check for \$100,000 when the president of the World Zionist Organization will visit here on May 17. The decision to tender a state reception to Dr. Weizmann was taken at a conference presided over by Philip J. Schotland, state chairman of the United Palestine Appeal. Of the \$100,000 the sum of \$50,000 will be subscribed in Newark.

A local campaign to raise \$110,000 for the U.P.A. will commence here simultaneous with the visit of Dr. Weizmann. Last year the sum of \$100,000 was raised in Newark

Newark's pledge of \$50,000 toward the \$100,000 to be presented to the world Zionist leader, was made by Bernard Miller, chairman of the Palestine Appeal in Newark.

The next largest share of the \$100,000 will be contributed by Jersey City, which has pledged the sum of \$20,000. Abraham Kantor, on behalf of Plainfield Zionists. pledged the sum of \$5,000; and like amounts were pledged by Philip Goldman, on behalf of Passaic; Louis Braines for Perth Amboy, and Abraham M. DEMANDS EQUALITY FOR WOMEN IN SYNAGOGUE (Jewish Daily Bulletia)

Chicago, Ill., May 1, - A proposal that women be permitted to join Jewish congregations as members of equal standing with men, was made by Mrs. Louis M. Epstein of Brookline, Mass., before the convention of the Women's League of the United Synagogue of America at the Stevens Hotel here, "It has become a disease among congregations to out build one another to such an extent that some have mortgaged their grandchildren" Mrs. Epstein said.

Rabbi A. M. Hershman, speaking on Jewish education, proposed that just as there is a ceremony of "Bar Mitzvah" for boys who at the age of 13 are declared fully responsible, so there should be a similar ceremony for girls. He laid some of the blame for the present situation on the shoulders of rabbis, who, he said, have become "lacks of all trades."

Others who discussed Tewish education were Dr. Alexander Dushkin, of the Board of Jewish Education of Chicago, who described the relationship of that body with the United Synagogue, and Rabbi Max Kadushin of Chicago.

Dr. Cyrus Adler reported that a committee has been organized at the suggestion of the highest officials of the Boy Scout movement of America to carry on religious activities among Jewish lads who are Boy Scouts, This committee, whose work is being privately financed, is composed of representatives of Orthodox, Reform and Conservative Jewish groups.

AMERICAN JEW GIVES HEBREW UNIVERSITY RARE LIBRARY

(Jewish Telegraphic Agency) Jerusalem, April 30 .- A valuable collection of 4,000 rare volumes has been donated to the Hebrew University Library by Marcus Fechheimer. In 1925

GERMAN JEWS PREPARE FOR PARLIAMENTARY ELECTIONS (Jewish Telegraphic Agency)

Berlin. May 1 .- The Jews should take an active part in the forthcoming parliamentary election campaign, Deputy Gertrud Klaussner says, writing in the "C. V. Zeitung," the organ of the Cen-tral Union of German Citizens of the Jewish Faith

All who are engaged in Parliamentary work, or follow it closely, she writes, know that Jewish questions are frequently involved. Attempts are often made to smuggle through clauses of an anti-lewish character in the bills before Parliament and Deputies who would justly repudiate the suggestion of anti-Semitism might, unless the danger were pointed out to them in time, be trapped into voting for legislation which conceals anti-Semitic tendencies. Deputy Klaussner mentions the Schechita question as an in-

The Central Union, she urges, should pay special attention to the books used in the public schools in order to see to it that wherever lews are spoken of it should be in a spirit of objectivity and not with anti-Tewish bias, which would affect the attitude of the pupils towards Jews in later life.

Work of this kind should always be conducted, but during an election campaign it should be intensified. The Central Union should make it its task to keep in contact with those political parties which are fighting anti-Semitism and to support them in every way against the anti-Semitic groups.

Asserts Opposition Seeks Control of World Zionist Organization as Well as of Z. O. A.; Relates History of Zion Commonwealth to Refute Criticism

In his statement Mr. Lipsky pointed out that Judge Julian W. Mack was a member of the Board of Directors of the American Zion Commonwealth when the Zionist Organization originally decided to sponsor the Commonwealth as a Zionist institution.

Mr. Lipsky declared the statements made by the opposition with regard to the administration of the affairs of the American Zion Commonwealth not only a distortion of the facts but "greatly misleading." He said that Mr. Samuel J. Rosensohn, one of the opposition leaders, had been chairman of the Finance Committee when all actions taken with regard to the American Zion Commonwealth were rati-fied, and that it was Mr. Rosensohn who made many of the suggestions with regard to rehabilitating the American Zion Commonwealth through the funds of the United Palestine Appeal.

The opposition element now is composed in the majority, of those men who had been ousted from the organization in 1921, when they had staged a fight against Dr. Chaim Weizmann, president of the World Zionist Organization, Mr. Lipsky stated.

As to the charge of extravagance in the present Zionist administration, the statement declared that the expenses of the United Palestine Appeal have been "far below the expenses of the Palestine Restoration Fund, the fund raising agency during Judge Mack's administration.

The statement proceeds: "In particular, the opposition is aiming at the frustration of the efforts of Dr. Weizmann, backed by the Zionist Organization of America, to build up the Jewish Agency as the instrument of a united Jewry for the upbuilding of Palestine."

"The criticism with regard to the American Zion Commonwealth is, to say the least, a distortion of the facts and grossly misleading," Mr. Lipsky stated. "The American Zion Commonwealth was organized in 1917 as a Palestine land-selling and developing institution. It was not conducted for the profit of its shareholders or of any individual. It has had the moral support of the Zionist organization as far

That the opposition element to the back as 1918, when Judge Mack was its directors. The American Zion made commendable progress up to 1926. It purchased Balfouria and developed it. It purpurchased Haifa Bay lands, which are the future development of Palestine. It is responsible for the purchase and development of Afule. During the course of its career, the American Zion Commonwealt has purchased more land than is now possessed by the Jewish National Fund, the principal national land-buying institution of the Zionist organization.

"Then the large immigration of 1925 ceased, and Palestine suffered an industrial and financial depression. The American Zion Commonwealth found itself with large tracts of unsold land, that could not be completed. Any number of American Jews had pur-chased land from the American Zion Commonwealth, and there was danger that title could not be delivered. In addition, the American Zion Common wealth had utilized all its credit in Palestinian, institutions. The American Zionist Administration was faced with the alternative of either letting the American Zion Commonwealth fall, or giving it cooperation and support in extricating it from its temporary difficulties

"It was the general opinion of almost all those who interested themselves in the matter that this was a responsibility not only of the Zionist Organization of America, but also an interest of the United Palestine Appeal, which would have suffered in prestige and in its collections had the many American purchasers been made to take a loss, or had their land not been delivered to them. It was therefore deemed advisable by all the authorities in the Zionist movement - including the London Zionist Executive, through Dr. Weizmann, and the Jewish Colonial Trust, through Dr. George Halpern. that it was the duty of the United Palestine Appeal to intervene and give its cooperation. Whatever money was authorized and advanced by the United Palestine Appeal is covered by the estimated assets, which when made liquid, exceed its liabilities. A plan is now being developed which will, when completed, in all probability return to the United Palestine Appeal the money which it has advanced to the American Zion Commonwealth.

Galveston Jewry Erects Community Center in Honor of Rabbi Cohen (By our Galveston correspondent)

Galveston, Texas, April 15.- Jewish community interests are centered in the construction of the Henry Cohen Community House, a building which is being erected to honor Dr. Henry Cohen, rabbi of Temple B'nai Israel, who will celebrate the fortieth anniversary of his services here June 1. The building is made possible through pledges of members of his congregation and will be a testimonial to the service that Dr. Cohen has rendered. not only to the Jews of Galveston, but to peoples of all denominations, here and elsewhere.

The laying of the cornerstone of the Henry Cohen Community House took place in January. It is expected that the building will be ready for occupancy in time for the anniversary celebra-

Temple B'nai Israel, which the community house will adjoin was erected fifty-seven years ago. The Jewish community was founded here in 1868. Four rabbis have served the congregation, Dr. A. Rosenspitz, Dr. A. Blum, who subsequently became a prison chaplain in New York; Dr. Joseph Silverman, rabbi emeritus of Temple Emanuel El in New York and Dr. Cohen.

Dr. Cohen assumed his duties here June 1, 1888 and after ten years was elected to office for life.

The Jewish community of Galveston, numbering about 1,000 is active in civic and communal enterprises. Jewish citizens are leaders in all civic projects, occupying important positions in civic and commercial places.

At present I. H. Kempner is president of the Galveston Cotton Exchange and John Neethe, a prominent attorney is president of the board of school trustees. Mrs. I. H. Kempner also has served as a member of the board of school trustees.

At one time Mr. Kempner was mayor of Galveston, at the same time five other Jews were head of civic institutions. Mr. Kempner was a memher of the board of city commissioners as finance commissioner, when the first commission form of government, which was subsequently adopted in other parts of the United States, was inaugurated here. Mr. Kempner is now chairman of the national advertising campaign committee, to advertise the industrial and resort facilities of Galveston.

This activity was an attempt on the part of the Zionist Organization of America, through the Palestine Securities to develop a market for the sale of the mortgage bonds of the General Mortgage Bank of Falestine. Quite a large campaign was developed for the sale of these bonds. An influential group of business men was interested in the Palestine Securities. After subscriptions amounting to about \$250,000 had been received, it was found that there were difficulties to get the mortgage bonds issued in terms of dollars instead of English pounds. It became necessary for efforts to be made, on the part of the directors of the Palestine Securities, to secure the translation of the bonds from pounds into dollars. There were considerable delays, owing to the difficulties of moving the Palestine Government to agree to the proposition. In the meantime, however, time was lost and the subscriptions that had been secured in good faith dwindled away, and at the end of the period, the Palestine Securities was as a result, left with a deficit. If there is any blame to be attached to this matter, it was due to delay in Palestine and not due to any act of the American Zion-
