P.E.C OBTAINS OPTION ON 25,000 DUNAMS OF LAND OF HAIFA BAY COMPANY Transaction Relieves Part of American Zion Commonwealth Problem (Jewish Telegraphic Agency)

Jerusalem, June 8 .- One part of the problem concerning the Palestine land stretches of the American Zion Commonwealth, now under criticism because of the financial difficulties in which it became involved, was solved when the Palestine Economic Corporation of New York obtained an option on 25,000 dunams of the land held until now by the Haifa Bay Development Company, a subsidiary of the Zion Commonwealth.

Mr. Mohl, on behalf of the Palestine Economic Corporation, which represents the Joint Distribution Committee and the former Palestine Development Corporation, signed the contract obtaining the option. The amount involved in the purchase was not made public.

In connection with the taking of the option on land in and around the Bay of Acre. Bernard Flexner, President of the Palestine Economic Corporation. made the following statement:

"Almost a year ago we were led to take up the question of acquiring this option with the purpose in mind of assisting, if possible, in the develop-ment of sound land policy in Palestine and preventing a ruinous speculative land development. At the time we became interested, an instalment of a mortgage of the Arab land owners was about to become due and the Haifa Bay Development Company was not in a position to make payment. We began at that time and have since been steadily occupied in digging out the facts with reference to this land. It has been an extraordinary, difficult task and it has required unremitting labor here in New York and on the part of our representatives, in London and in Palestine. London, June 8 .- At a brief session of the Executive of the World Zionist Organization which took place Thursday night, the impending proceedings of the Jewish Agency Commission were discussed. It was reported that the Executive adopted a resolution stating that it takes cognizance of the fact that Dr. Weizmann will represent the World Zionist Organization at the conferences and that the conclusions of the non-Partisan Palestine Survey Commission will be submitted to the Executive and to the Zionist General Council (Actions Committee) which is to meet the middle of July in Berlin.

In Zionist circles it was stated that before the Jewish Agency proper is convoked the recommendations of the experts' commission will be submitted not only to the Actions but also to a non-partisan Jewish conference which is to be called in the United States. Anti-Semitic Leader Objects to Christian Missionary Work Among Jews

(By our Berlin Correspondent)

Berlin, May 30 .-- A strong protest against missionary work among the Jews is made by Pastor Falck in the current issue of the anti-Semitic periodical "Hammer',, which is edited by Ex-Deputy Theodor Fritsch, member of the anti-Semitic International.

"The conversion of Jews," the Pastor argues, "makes it easier for Jewish blood to infiltrate into the Aryan races. The workers in the Jewish missions claim that it is written 'Go ye and teach all nations, baptising them.' But this means that messengers are to be sent to other nations to teach and baptise them. It does not in any sense apply to the Jews today. For the Jews sit in the midst of us like a spear head in our flesh. Conversionist work among the Jews only pulls the point deeper into ourselves.

"If the Iews had their national State in Palestine, or elsewhere, those who feel it heir mission to convert Jews into Christians might go out as mission workers among them there and establish here a Jewish-Christian Church. We hould not complain of that. But as hings are, with the Jews living in our nidst, there is no question but that a Christian Jew is able to penetrate into he German national entity sooner than a Mosaic Jew. This Jewish conversionist vork then only hastens the growing umber of mixed marriages between Jews nd Germans and spreads Jewish blood mong the German people. The Jews in he mass and as an entity-individual onorable exceptions only prove the rule -are not a desirable element in German national life. The memory of Barmat ind Kutisker makes it unnecessary to explain this at any length.

"The danger," the Pastor declares, "has been recognized in Church circles. There are many clergymen in Germany who would rather pay the amount generally raised in their churches for the Jewish missions out of their own pockets than commend these missions to their congregations. The Protestant Federation of Austria has adopted a resolution which says: 'This General Assembly of the Protestant Federation in Austria views with profound anxiety the peril of an ever growing dominant Judaism, a peril not only to the economic position of the German people but also to their spiritual and cultural life. This Assembly therefore calls upon all members of the Federation to fight against this enemy of the people. The fight is to be carried on particularly against the election of baptized Jews into the Protestant

ROUMANIAN ANTI-SEMITES MEET IN CONVENTION TO INCITE JEW HATRED

Peace Kept as Government Takes Strong Precautions (Jewish Telegraphic Agency)

Jassy, June 8 .- Another attempt to inflame anti-Jewish hatred in Roumania is now in progress as the all Roumanian anti-Semites conference went into session today.

In his keynote address Alexander Cuza, who has been propagating anti-Semitism and anti-Jewish terror for almost half a century, restated his program of rabid anti-Semitism and urged direct action.

So far, however, order was not dis-turbed. This was due apparently to the fact that strong detachments of police, gendarmes and military, patrolled the city. Particular measures to guard order were taken when the students and the delegates marched in a procession to the Metropolit church.

WOMEN'S CLUBS ADVOCATE BIBLE TEACHING IN SCHOOLS

(Jewish Daily Bulletin)

San Antonio, Tex., June 8.-A resolution urging all members of the General Federation of Women's Clubs to attempt to introduce the study of the Bible into the public schools was adopted at the biennial convention of the Federation here.

The resolution was introduced by the Tennessee delegation and urged the teaching of the Bible to combat the spread of atheism among children.

Mrs. Otto Kahn, of New York, and Mrs. Maggie Barry, of College Station, Tex., led the opposition. Mrs. Barry declared that "study of the Bible should have its greatest impetus in the home," and that children should be thoroughly grounded in it before entering school.

When the resolution was introduced the Tennessee delegation indicated that it wished to use it in an attempt to modify the drastic evolution law of that state which brought about the famous Scopes trial. Sponsors of the resolution pointed out that it was written by a teacher of philosophy and that no mention of evolution was made in it. There was considerable debate on the matter, but only twenty-five delegates voted against adoption.

CITIZENS COMMITTEE FORMED TO RESTORE PEACE CASE OF JEW, WHO SOLD IN ZIONIST RANKS

While Work for 'Peace and Reconstruction' Under Way, Charges are Renewed Against Administration; Election Instructions Now Point of Dispute

A move to restore peace within the account with enrolled but unpaid memranks of American Zionists is under way bers. Urge you increase membership. with the formation of a Committee on Peace and Reconstruction, which aims to clared "The Committee interprets this bring about a reconciliation between the proposal expressed in the words. We leaders of the Zionist opposition and the will credit your district and charge your Zionist administration, so as to avoid a account with enrolled but unpaid memtumultuous convention and possible rupture in the movement.

While no official information was available, the Jewish Daily Bulletin learns that the committee, which is headed by Dr. Louis I. Harris, Commissioner of Health of the city of New York, Prof. Mordecai M. Kaplan, Israel Matz, Emanuel Neumann and others, is at work. Negotiations for an amicable solution of the problem of introducing new forms into the administration of the Zionist Organization of America are said to be in progress both with the administration and opposition leaders. A statement on the part of the Committee and its suggestion for a solution will be forthcoming in a few days, it was learned.

Both parties involved in the controversy claim that victory will be theirs if the question is brought to a vote at the Pittsburgh convention. Early returns on the election of delegates to the convention indicate that at least two-thirds of the men delegates and a considerable number of the Hadassah delegates would support the present administration. The opposition leaders are confident that they would enlist the sympathy of at least one-third of the men delegates and are convinced that the overwhelming vote of the Hadassah delegates would also be in their favor. These estimates, it was declared by neutral observers, cannot be considered absolute as the total number of delegates who will be entitled to vote at the Zionist convention is still to be determined, in view of recent rulings made by the Administrative Committee.

While these peace negotiations are under way, a new charge against the Zionist administration was made by Johan Smertenko of the Committee for Z.O.A. Reorganization, opposition spokesman and formerly active in the New York League of Zionist Revisionists. Mr. Smertenko in a statement issued on behalf of the Reorganization Committee charged the Zionist administration with an attempt to "pack" the forthcoming convention in Pittsburgh. As evidence of this attempt, Mr. Smertenko quoted a telegram sent out on May 31 over the signature of Louis Lipsky to Zionist districts reading as follows:

"Records district membership now being printed for convention report. Please forward all membership dues immediately. Also lists including those members who enrolled but not paid their dues. We only those members who have actually will credit your district and charge your

In his statement, Mr. Smertenko debers' as nothing but an attempt to pad the membership roll in order to increase the number of delegates at the Convention. This is being done so that the Administration may have enough votes to carry out its effort to disfranchise the 104 Hadassah delegates

"The formal restrictions for the elections of delegates to the Zionist Convention called for the election of all delegates 'during the week beginning May 27th.' The advertised instructions show that the elections were to end Sunday. June 3rd. The telegram was clearly intended to influence the elections.

"The districts of the Z.O.A. are not legal entities; they have no assets: and the members cannot be held liable for their dues, etc. The regular published annual reports of previous years carry no charge accounts for membership. The statistics actually summarize the previously enrolled but unrenewed member-ship. Thus the report for 1927, page 13, states that the figure of 28,862 members then on the records 'does not include 10,020 members who paid in 1926 but have not as yet renewed their membership at May 31st,' and nowhere in the report is unpaid membership listed as an asset or account receivable, nor is there any charge account for such unpaid membership," he stated.

When the Jewish Daily Bulletin submitted the statement for reply, the Zionist Organization of America declined to make any statement other than to make public a copy of a form letter to all Zionist Districts throughout the country, as the telegram was sent to all Zionist

Districts throughout the country. The form letter, dated June 3, three days after the telegram, made clear that only such members as have actually paid their dues are entitled to participate in the elections and that the number of delegates to be elected can be determined only on the basis of the number of paid members. The letter, signed by Louis Lipsky and addressed to all chairmen and secretaries of Zionist districts after quoting the telegram as reproduced above, declared:

"It is essential that we have the records complete for the report to the Convention. Therefore we urge the Districts to take immediate steps to comply with the request contained in the above telegram.

DAUGHTER TO ARAB GROOM.

SENT TO MOSLEM COURT Court Rules He is Still Moslem Since Reentry to Judaism is not Recorded

(Jewish Telegraphic Agency)

Haifa, June 8.—The suit of the two sons of Aaron Natah against their father to annul the marriage of their ten year old sister to a Moslem Arab will have to be transferred to the Moslem court as a result of further complications which developed yesterday during the trial in the Haifa District Court

During the proceedings in the Haifa court, the father who sold his ten year old daughter for £30 in accordance with the custom prevailing among the Arabs. to the Moslem storekeeper, Assadi, as a bride for his son, sprang a surprise on his sons when he testified that he was no longer a Jew, having embraced the Moslem religion 26 years ago.

Natah produced a Turkish document. proving that his name was now Muhamed Salim Almuhadi and that he was of the Moslem faith.

Representatives of the Jewish community at Acre testified that Natah prays in the synagogue on Yom Kippur, and eats Matzohs on Passover, Rabbis of Haifa testified that Natah had declared to them nine years ago that he had re-embraced Judaism.

Notwithstanding, the court ordered the case be transferred to the Moslem court, because according to the documents. Natah is a Moslem. Although he again practices Judaism, his re-entry into Indaism has not been legally registered

Mr. Jabotinsky suggested the establishment of a Supreme Economic Council, comprising Zionists and non-Zionists, or a two-chamber Agency, one dealing with finance nad constructive work and the other the Zionist chamber, entitled to advise the government and the League of Nations on all matters affecting the Jewish national home in Palestine.

The unpaid members. whose names we have asked you to forward to the national office cannot be included in the total for the election of delegates.

"In order that your delegates may be seated at the Convention, it is essential that every District comply strictly with the above rules."

Israel Maltin, auditor of the Zionist Organization of America, in commenting on the figures given by Mr. Smertenko, declared: "The statement that the Zionist Districts carry no charge account is untrue. The Zionist Organization owes at all times, to every district, the two dollars refundable to the district on every regular member and the five dollars due the district on account of every sustaining member. At certain times of the year the Zionist Organization owes the districts as much as \$10,000. Last year, at the closing of the books the Zionist Organization owed to the districts \$5,734. In 1926, at the end of the fiscal year, the Zionist Organization owed to the districts \$3,350.87. To date, June 8th, the Zionist Organization holds in reserve for the districts approximately \$5,000 due to them on account of membership refunds."
