ECONOMIC DISCRIMINATION IN BUDAPEST CAUSES SUICIDE OF ENTIRE JEWISH FAMILY

No Day Passes in Budapest Without Recording Suicide of a Jew (Jewish Telegraphic Agency)

Budapest, June 13.-The suicide of a leading Jewish business man and his wife and daughter, as the result of economic ruin, has caused depression among the business men.

Joseph Preissach, his wife and child, ended their lives when they learned that Preissach's business had been ruined.

Not a day passes in Budapest without suicide of a Jew being recorded. The situation is attributed to the financial and economic policy of the Bethlen governmnt, which is carried on along lines of economic anti-Semitism, recalling the regime of the Grabski government in Poland in 1925, which set for its purpose the taxing of Jewish business men out existence.

Budapest, June 13.-Leopold Grueblatt, once a wealthy merchant, 77, and his wife, 73, committed suicide yesterday by taking poison.

The suicide was attributed to the couple's loss of financial means. short while ago their only daughter, a gifted artist, committed suicide when her parents protested against her planned marriage to a non-Jew.

ZION COMMONWEALTH WINS SUIT AGAINST ARABS

(Jewish Telegraphia Agency) Tel Aviv, June 13.-The American

Zion Commonwealth which founded the American Jewish colony Herzliah, won its case against thirteen Arabs of the Abukandil tribe.

The Arabs had refused to leave land on which they were living in the Herzliah colony, claiming that they held it under an agreement. The court ordered the Arabs to leave the property.

ROUMANIAN JEW, MAN WITH-OUT A COUNTRY, SETS SAIL FOR PALESTINE IN A CANOE Is Arrested on Danube, Fined Despite Group Increased to Fifty; Unwiling Canoe Owner's Plea

Vienna, June 13 .- The tragedy of many Roumanian Jews, who though nanot given a chance to make a living, was forcefully illustrated in a case which came up before the Roumanian tribunal at Szatmar.

The prisoner, Israel Mendel, 42, a Jewish artisan without Roumanian citizenship, was charged by the authorities with having stolen a canoe in which he set out along the Danube for the Black Sea en route to Palestine. He was arrested because he was not in possession of a passport and because it was suspected that the canoe was stolen property. The owner of the boat who appeared

in court, asked that no charge be pressed against Mendel as the prisoner is, he stated, a personification of the tragedy of the "man without a country." The state attorney concurred.

A dramatic scene was enacted when Israel Mendel took the stand in his defense. He admitted that he had stolen the canoe with the intention of sailing for Palestine because he had "no money to leave Roumania where I am prohibited from making a living.

The Jewish artisan related moving details of his experiences arising out of his legal status. "Although I was born in Roumania, my citizenship was not recognized and the police deported me twice to Hungary. In Hungary, how-

CHASSIDIC SECTS IN POLAND QUARREL OVER BURIAL HONOR WITHIN RABBI'S CHAPEL (Jewish Telegraphic Agency)

Warsaw, June 13. - Numerous followers of two Chassidic rabbis, descendants of the noted Chassidic Rebbe of Worka, Rebbe Mendel, who died sixty years ago, were involved in a serious quarrel leading to disturbances on the Jewish cemetery here. The fight arose over the question whether the honor of burial in the chapel erected over the grave of the Rebbe of Worka was to be accorded one of his grandsons, Levi Izchok, the twenty year old son of the Rebbe of Skierniewice.

ST. LOUIS ADVANCES \$50,000 TOWARD U. J. C.

The emergency call issued a month ago by David A. Brown, National Chairman of the United Jewish Campaign, "Borrow and Advance" in order to create a fund of \$3,100,000 to assure the continuation of the Joint Distribution Committee's activities without interruption during the summer, has again been answered with a substantial sum, campaign headquarters announced.

St. Louis, Mo., forwarded an advance of \$50,000, duplicating its action of a year ago. The St. Louis Committee is headed by Sydney M. Schoenberg. his sum constitutes St. Louis' quota r the \$3,000,000 fund.

Baltimore has sent in a check for \$20,000. The committee is headed by L. Manuel Hendler.

The amount of \$12,000 has been received from the Columbus, Ohio Zone, of which Edward J. Goodman is chairman. The State Committee for Iowa has sent \$11,000.

The advance sums already received from several States have been increased by additional amounts. Among others, the State of Connecticut, has to date contributed to the emergency fund a total of \$8,500, and the New York City Committee with David M. Bressler as acting chairman and Paul Baerwald as Treasurer, have supplemented their previous advances to the extent of \$60,000.

CANADIAN IMMIGRANT WELFARE SOCIETY REPORTS PROGRESS ON ACTIVITIES 4,219 Jews Entered Country During Fiscal Year

(Jewish Telegraphic Agency)

Montreal, June 13.-Some 4,219 Jewish immigrants have arrived in Canada within the last fiscal year, according to the report submitted by A. J. Paull, secretary, at the annual meeting of the Jewish Immigrant Aid Society Canada, A successful year in the work of the Organization was reported. included the handling of 123 applications by the Free Employment Bureau; the spending of nearly \$10,000 for relief and temporary assistance to Jewish wayfarers and immigrants; the serving of 2,012 meals at the ports of entry; and the meeting of 405 steamers during the course of the year.

The percentage of Jewish arrivals to Canada to the total immigration during the fiscal year of April 30, 1927, to May 1, 1928, is 3.63 per cent. Lyon Cohen, S. W. Jacobs, Jewish members of tht Canadian Federal Parliament and A. A. Heaps, another Jewish member of the Canadian Parliament, are taking an active interest in the work of the Hias.

ONLY 5% OF JEWISH SOLDIERS PREFER KOSHER DIET, POLISH WAR MINISTRY REPORTS

(Jewish Telegraphic Accept) Warsaw, June 13. - Only 51/4 per

cent of the total number of Jewish soldiers in the Polish army, when given the choice of the regular army diet or a special kosher diet, give preference to the latter, the Polish Ministry of War reported to the Sejm during the discussion on the budget of the Ministry yesterday.

The special kosher diet for Jewish soldiers was introduced at the urgent request of the Jewish deputies, the Ministry of War stated. It appears, however, that out of the 11,263 Jewish soldiers, only 588 partake of the kosher diet.

LABOR DEPARTMENT ISSUES REGULATIONS TO CONSULS ON IMMIGRATION RELIEF Cables Instructions on Recent Amendment to Immigration Law (Jewish Daily Bulletin)

Washington, D. C., June 13.-Cabled instructions will be sent to consuls abroad whereby exemption from the quota will be granted to children who have passed twenty-one years of age provided they were under twenty-one when they applied for visas, it was learned following a conference yesterday by Congressman Dickstein with immigration officals.

The law as recently amended by Congress provided for the exemption of children of American citizens up to twenty-one, but was silent on the question of the status to be accorded those who applied before they became twenty-one but who since have passed their majority. The instructions will also require the consuls to grant priority in the order applications were filed and to issue visas first to parents and children, deferring visas to the wives of aliens until after parents and children have first been acted upon.

An order putting into immediate effect the relief measure for separated families was issued by Commissioner of Immigration Harry E. Hull and approved by Acting Secretary of Labor W. W. Husband.

Commissioner Hull's order stated:

"Subdivision 1 of Rule 3 is amended to read as follows:

"'Subdivision 1-Non-quota Status Proof. Paragraph 1 - An unmarried child under 21 years of age, or the wife of a citizen of the United States shall not be regarded as a non-quota immigrant unless provided with an immigration visa designating the holder as such, and then only when the cit-izenship of the alleged father or husband and his relationship to the immigrant are established to the satisfaction of the examining immigration officer.

"'The husband of a citizen of the United States shall not be regarded as a non quota immigrant unless provided with an immigration visa designating the holder as such, and then only when the citizenship of the alleged wife and lawful marriage to her prior to June 1, 1928, are established to the satisfaction of the examining immigration officer.

In their bewilderment they have begun to worship Gods that their fathers knew not; they have flocked into other faiths and are worshipping fads and theories which are inimical to the great principles of our faith. The letter in full text follows: Sections 4 and 6 of the Immigration Act of 1924, as amended by Senate Joint Resolution No. 5, approved May 29, 1928, provide in part for the classification of certain aliens as follows:

Exempt from quota restrictions: . Alien wives of United States citi-

2. Unmarried alien children (under the age of 21 years) of United States citi-

3. Alien husbands of United States citizens, where marriage occurred prior to Tune 1, 1928.

4. Women who were citizens of the United States and who prior to September 22, 1922, lost their citizenship by reason of marriage to aliens, but at the

1. Fathers, mothers, or husbands by marriage occurring after May 31, 1928, of citizens of the United States who are 21 years of age or over.

2. Immigrants skilled in agriculture, the wives, and dependent children under the age of 18 years, of such immigrants skilled in agriculture, if accompanying or following to join them.

3. The wives and unmarried children under 21 years of age, of alien residents lawfully and permanently admitted to the United States.

For the purpose of securing non-quota or preferential classification in behalf of their wives, husbands, unmarried chil-dren under the age of 21 years, fathers or mothers-citizens of the United States should submit petitions for the issuance of immigration visas to this Bureau for consideration. A new petition need not be filed in behalf of children who were over the age of 18 and under the age of 21 years when and if a previous petition was approved in their behalf, nor is

EDITOR CHARGES GREEK TRAVELLERS CAUSED ANTI-JEWISH DISCRIMINATION Says American Greeks, Affiliated with

K.K.K. Responsible for Exclusion (Jewish Daily Bulletin)

Detroit, Mich., June 13.-Commenting on charges made by Prof. Leo. S. Honor of the Teachers' Institute of the Jewish Theological Seminary that he and other American Jewish passengers aboard the steamer Sinaia were subjected to the discriminations of Greek port authorities and were refused permission to land at Piraeus, George Laskaris, editor of "Progress," a Greek weekly published in Detroit, in a statement to a representative of the Jewish Telegraphic Agency, placed the blame on a group of American Greeks who claim affiliation with the Ku Klux Klan..

Mr. Laskaris explained that the steamer Sinaia had been chartered by 600 American Greeks who belong to the AHEPA, or American Hellenic Educational Progressive Association, who claim to be a branch of the Ku Klux Klan. Mr. Laskaris subscribed to the views of A. C. Macheras, consul-general of Greece in New York, who declared in his statement to the Jewish Telegraphic Agency that Greece does not discriminate against its Jewish subjects. He expressed the belief that the members of AHEPA incited port authorities against the Jewish passengers, and declared that the Government of Greece would not only discourage such action, but would punish offenders if informed about the discriminations.

"I am certain that it was not Greek law that discriminated against Professor Honor and his fellow companions, but the group of 'holier than thou' American Greeks who are so anxious to shout their superiority wherever they go, that the only method they could find at their disposal was to discriminate against Iews." Mr. Laskaris declared.

which is held in reverence by many Chassidim, for two graves, beside that of Rebbe Mendel. One of the plots was accorded to the late Rebbe of Otwock, Rebbe Benjamin, also a grandson of the Rebbe of Worka. Rebbe Benjamin died fifteen years ago.

The Rebbe of Skierniewice demanded the second plot for his only son, Levi Lechok, Followers of the present Rebbe of Otwock contended that the plot cannot be accorded to Levi Izchok, because it is contrary to the custom for an unmarried man to be buried in the Rebbe's chapel. They demanded that this plot be kept in reserve for the present Rebbe of Otwock.

The question was submitted to the Warsaw Rabbinate, which has jurisdiction over the cemetery. The Rabbinate ruled that the plot may be ac-

corded to Levi Izchok.

Learning of this decision the followers of the Rebbe of Otwock occupied the chapel and prevented the burial by maintaining a continuou watch, throwing stones and pieces of wood at all who came near. After a long struggle, the zealots were removed from the chapel and the burial took place at midnight in the presence of 5,000 persons.

ever, the authorities refused to give me a license to seek work as an artisa because I was an alien there. Back in Roumania I wandered for several year from village to village, seeking to avoid the eyes of the Siguranza (secret police). Now, floating down the river I fell into the hands of the gendarment, putting an end to my hope of reaching a country where I will be welcome," the prisoner concluded in tears.

The court sentenced Mendel to four days in jail and a fine of 200 lei for returning to Roumania without permission. As the charge of stealing the boat was not pressed, no sentence was imposed for this. Mendel will be turned over to the Siguranza for deportation to Hungary.
