#### Accusations of Personal Dishonestv Eliminated; Opposition Savs Such Charges Never Made

Probing into the charges recently made by members of the opposition, particularly those who took a leading part in the Washington opposition conference held under the chairmanship of Judge Julian W. Mack, was begun on Sunday by the court of inquiry appointed by Dr. Chaim Weizmann before his departure at the

## MANDATES COMMISSION ENDS PALESTINE DISCUSSION

Geneva, June 18.-The discussion on the report of the Palestine administration, submitted by the British Government, was concluded at the session of the Permanent Mandates Commission of the League of Nations.

Col. George S. Symes, former Civil Secretary, was asked many questions to which he replied. The petition of the Agudath Israel, Orthodox world organization, which is at variance with the Zionist Organization on the question of the internal organization of Palestine Jewry, was not considered by the Commission as the committee which submitted the memorandum requested a postponement until the next session.

Moscow, June 18.—By a decision of the Far Eastern Central Executive Committee, the Bureva region in Siberia alloted for Jewish colonization will be extended northward, making a total area of 3.895,000 hectares available for Jewish settlement.

The new area consists mainly of cedar forests and is watered by rivers. Six hundred and forty pioneers arrived at Tichonkove to settle on the new lands. One hundred and sixty proceeded immediately to Ekaterina-Nikolsk where they will work on the rice plantations.

Tractors and ploughs from America have begun to arrive. Cultivation will be started the end of June. It is planned to build large factories for cleaning the rice and extracting the

London, June 18. - The Board of Jewish Deputies, composed of reprecongregations in the United Kingdom, will be officially represented at the forthcoming annual conference of the Federation of English Zionists.

A decision to this effect, marking the official affiliation of that representative body of Anglo-Jewry with the Zionist movement, was adopted at Sunday's session of the Board. The session was the first since the recent election of new delegates of the various bodies. In these elections the Zionists scored a considerable victory. It was also declared that the decision is to be viewed in connection with the forthcoming participation of Anglo-Jewish bodies and particularly the Board of Deputies in the extended Jewish Agency for Palestine, D'Avigdor Goldsmid was re-elected president of the Board.

versities are Enforcing Limitations, Jewish Deputies Say

vent the illegal practice of applying a numerus clausus to Jewish students in Polish colleges and universities was made today by the Jewish deputies

in the Polish parliament. In Poland there is no law imposing

restrictions upon the number of Tewish students to be admitted to the untversities. The limitation, however, is being enforced by the authorities of the respective colleges. The government has frequently declared that it is unable to intervene in such cases as cacz, Carpatho-Russia, Czechoslovakia,

An urgent motion was therefore introduced by the Jewish deputies, asking for the enactment of a law regulating the relations between the educational institutions and the government, defining the status of the college authorities. #### ORDER BRITH ABRAHAM ADOPTS FRATERNAL RATE SYSTEM AT CONVENTION 800 Delegates Attend Forty-second Annual Sessions at Saratoga

Springs (Jewish Daily Bulletin)
Saratoga, Springs, N. Y., June 18.—

Facing the task of revising the constitution and the elimination of certain constitutional limitations hitherto imposed upon one class of the Order's membership, 800 delegates representing 456 lodges of the Independent Order Brith Abraham opened the first day's session of its forty-second annual convention at the Hotel Waldman here vesterday.

The principal issue before the del-gates was brought in the annual message of Grand Master Max Silverstein, when he urged the repeal of the law preventing present members or suspended members of Class "A" since 1924 from entering Class "B" or Class

Class "A" members, Mr. Silverstein explained, are insured under the postmortem plan which has met with the disapproval of numerous state insurance departments. In order to comply with the requirements of insurance deties in such a manner as to prevent their practice of discrimination.

partments, Class "B" was established in 1926. The members of this class receive \$500 insurance and pay fixed rates. Class "C" members are known as associate members and neither seek nor receive benefits of insurance.

Pointing out that the order has lost 7,892 members by way of suspensions during the past year, Mr. Silverstein declared many of these would not have left the order, but would have transferred to either Class "B" or Class "C" if the present restrictions had been removed.

The presidential message also re-viewed the accomplishments of the Order during the past year, placing special emphasis upon its activities in behalf of the persecuted Jews of Roumania, and its efforts to secure the victims of the mysterious shooting in enactment of a more humane immigration bill.

Supreme Court Justice Irving Goldsmith, representing the Mayor of Saratoga, welcomed the delegates. Fred Stoors, secretary of the Saratoga Chamber of Commerce also addressed the session.

Dr. S. Margoshes, editor "The Day", a speaker during the morning session dwelt on the problems confronting the Order and American Jewry and urged deliberate planning instead of drifting as a method of meeting these problems. He asked for more generous support of the American Tewish Congress and

# J.D.B. NEWS LETTER.

Good Issues Out of Evil Occurrences in Roumania

(By our Bucharest Correspondent) Bucharest, May 29 .- "Good issues out of evil." When the riots at Oradeamare and Clui broke out and students of Roumania destroyed synagogues and made mock of holy property, the Christian population was stirred, and in rage at the vileness of the vandals it berated them with startling epithets. The Jews, however, accustomed, hardened to these outbreaks, were silently bitter against the authorities, but they sensed the nature of the riot: they felt the devastations were great enough to reverberate, to have the necessary repercussions abroad, and they repeated, as they have always done, but with probably a little more assurance, their consoling phrase. "Good issues out of evil." In parliament at Bucharest following

the wreckage, Dr. Filderman, Senator and Vice-President of the Jewish Community, severely criticised the govern-ment for leniency toward the students, for its refusal to take immediate measures to quell the rioters, and courageously demanded a reply. He got one, and an apology too, from Mr. Duca, Minister of the Interior.

What little prestige the Liberal Government had abroad was shattered by this unexpected disastrous finality of the students' congress. The stilted aristocracy of Duca came down a peg and he excused himself in the name of the gov-M. H. Talsner, Dr. M. Einhorn, I. Riva kind, P. Maze, A. Spicehandler, Z. Iche first time in fifty years that a Min-Scharftstein, S. B. Maximon and B. Iche first time in fifty years that a Min-ister had publicly made an apology for a Jewish outbreak.

Unbelievable things were happening. Mr. Lapadatu, the Minister of Religions. came back from a visit to Oradeamare and Clui, and he was touched sufficiently to have voted in Parliament the sum of \$150,000 as a first compensation to rebuild the destroyed synagogues. Such a consideration was never expected. The state to date has paid about \$200,000 to synagogues and individuals. More is to

be paid.

The students returning to Bucharest from Oradeamare and Clui were preparing to hold a celebration. Four days after they had scandalized the world with their gruesome behavior and their mad devastations, they dared to foist upon the memory of the citizens of Rou-mania, most of whom are too indifferent to be anti-Semitic or anti-anything, the fact that five years ago they initiated their utterly idiotic demands for numerus clausus, that Jewish students dissect Jewish cadavers, that scholarships be withdrawn from Jewish students study. ing abroad, etc.

ENGLISH INSURANCE BROKERS CALL JEWS RECKLESS DRIVERS Gowish Belegraphic Agency

London. June 18 .- The one day insurance policies issued on bired motor cars are not to be granted to Jews. actors and bookmakers, according to instructions issued by insurance brokers here, the "Sunday Express" stated vesterday.

Garage owners were notified to this effect by the brokers. The paper states that in explaining these instructions the brokers charged: "The Jews when hiring cars, pack them with families and children and drive off for a joyous outing irresponsibly, without caring about the car because it is insured. A very high number of claims have been received from Jews. Therefore the companies must be careful."

The Government did see fit to begin a severe campaign to set the Christian students in their proper place; but the students refused to be set; they protested and demonstrated, on their own behalf and on behalf of their fellow students who were lingering in prison longer than they had enthusiastically and heroically expected. The authorities, tired of cuddling an unruly and misguided youth, proceeded further and dissolved their organizations. The students protested again, with a masked and not very sturdy display of bravado as they were wont, and they were forthwith reminded that it were better to withdraw silently, for some of the authorities of the State are anxious to do away with scholarships and canteens and boarding houses: "Students eager to learn a profession should pay for their studies," one of them said.

And now the Jews are legally recognized by the State, with definite privileges to function and be supported. So it looks as if some good has issued out of that evil at Oradeamare on December 6.

not of such a nature that could be taken up for review by the court of inquiry. The Zionist convention can decide on the matter. Others who represented the opposition were Lawrence Berenson, Robert Szold, Jacob de Haas and M. A. Zeldin. Others who represented the ad-Zeidin. Orice's wito l'episetieta in administration were Philip Wattenburg, Dr. A. J. Kalisky, Judge William M. Lewis of Philadelphia, Jacob Fishman, Nelson Ruttenberg, Mr. Medinitz, Bernard Rosenblatt and Meyer W. Weisgal.

Investigation of charges of personal dishonesty in financial matters was eliminated after the preliminary proceedings brought out the fact that such charges are not involved. At the opening of the session, Dr. Mordecai M. Kaplan, speaking in behalf of the Citizens Committee on Peace and Reconstruction, pleaded that the court of inquiry postpone its work in view of the efforts of the Committee to bring about peace between the warring groups. Dr. Kaplan quoted statements by Samuel J. Rosensohn and Tacob de Haas made at a conference of the Committee on June 14 at the house of the Society for the Advancement of Judaism to the effect that the word "dishonesty" employed in a pamphlet describing the proceedings of the Washington conference did not imply the charge against the administration members of personal dishonesty in financial matters.

"I want to disclaim it and I want to say that I am fully familiar with what has happened and I have never known any case where any person did actually do a business act for the purpose of personal profit," Mr. Rosensohn was quoted by Dr. Kaplan.

"As far as I know, no one ever charged or thought of charging dishonesty in the sense of taking money or property for his or their personal gain, money or property belonging to the Z.O.A., the U.P.A., or any other body against any member of the administration," Mr. de Haas was quoted by Dr. Kaplan.

Preliminary statements were made with regard to this aspect by Abraham Tulin for the opposition and Morris Rothenberg for the administration, the administration contending that the gen-eral public was given the impression, due to the charges made at the Washington conference and due to oral and written statements by opposition spokesmen, that the administration was accused of personal dishonesty.

Following a recess of ten minutes, during which the Judges conferred on the subject, Judge Lazansky declared that the court of inqury does not find it necessary to probe charges of a personal nature in view of the fact that such charges have never been made. He hopes a statement to this

effect will be issued. The committee! FAR EASTERN EXECUTIVE will go into the general charges formulated by the opposition in so far as they will not involve the entire volume of the administration business. Judge Lazansky limited the inquiry to the following three points: (1) American Zion Commonwealth; (2) Palestine Securities, Inc., (3) The allocation of funds for the Zionist publications, "The New Palestine" and "Dos Yiddishe Folk."

With regard to the Zion Commonwealth the salient point of the proceedings was the charge made by the opposition that Mr. Lipsky had on December 14, 1926, issued a guarantee to the Central Mercantile Bank in the amount of \$180,000, covering a debt incurred by the American Zion Commonwealth some time previous. Mr. Tulin, who presented the case of the opposition, charged that Mr. Lipsky issued the guarantee without having been authorized by the Administrative Committee and having denied the issuance after the charge was made at the Washington conference.

Morris Rothenberg and Mr. Lipsky in presenting the case of the administration, told of the close relation that existed between the Zion Commonwealth and the Zionist Organization and of the moral responsibility which the Zionist Organization has always had for the Zion Commonwealth, involving a vital interest of the Zionist movement both in the United States and in Palestine. The guarantee was issued by Mr. Lipsky on December 14, 1926 following the adoption of a resolution on December 7. 1926, by the United Palestine Appeal to secure a credit not exceeding half a million dollars to save the affairs of the Zion Commonwealth. The denial was issued in reply to the charge made by Mr. Berenson that Mr. Lipsky had signed notes in the amount of \$285,000. existence of the guarantee of \$180,000 was not remembered by Mr. Lipsky at

Judge Julian W. Mack, who was also invited to be present, in a letter to Judge Rozalsky declared that his engagements would have made it impossible for him to be present even if he had evidence to present. The letter stated further that Judge Mack personally made no charges of specific facts. He was satisfied to advise others who declared to him that they have such proof to appear before the committee.

## ROUMANIAN JEWISH GROUPS UNITE FOR JEWISH ACTION

(Jewish Telegraphic Agency)

Bucharest, June 18 .- Representatives of Jewish organizations in the Old Kingdom, Transylvania and Bukowina. have decided to act in unison in all internal matters affecting Jewish rights in the country.

The new situation was brought about at a conference of organization representatives which took place here and in which Dr. William Filderman, president of the Union of Roumanian Jews, Dr. Niemerower, member of the Senate, Senator Horiah Carp and Dr. Meyer Ebner of Bukowina, participated. Leon Fischer, vice-president of the United Roumanian Jews of America was also present.

The conference decided to create a central committee to coordinate the activities of the participant organizations and to plan joint action in all Roumanian Jewish questions.
