LORD PLUMER RESIGNS POST DUE TO SHARP DIFFERENCES WITH THE COLONIAL OFFICE

Rumer Sir Gilbert Clayton Will Succeed Him as High Commissioner

(Jewish Telegraphic Agency)

London, June 26-The retirement of Lord Herbert S. Plumer from the post of High Commissioner of the Palestine Government was announced by the Colonial Office today. Lord Plumer will retire from his post in the fall, following a three months' leave which will begin in July Rumors as to the possible successor

for the Palestine High Commissionership are current here, the name of Sir Gilbert Clayton, former Civil Secretary of the Palestine. Government, being

prominently mentioned.

London, June 26-Lord Plumer refused to serve another term as High Commissioner of Palestine owing to sharp differences with the Colonial Office concerning the division of costs for the Transjordanian frontier force be-tween the British Exchequer and the "Palestine government, states the London

Lord Plumer considers the present position intolerable, in view of the deficit of the Palestine budget of more than £1,000,000, which necessitates a reduction of 15 percent, in all services, the

Bucharest, June 26. - Jewish Boy Scouts will not be permitted to carry the Zionist flag in their parades, according to an order issued here by the Roumanian authorities.

The order states that the Zionist flag will not be permitted at any public occasions and then the Jewish Boy Scouts must carry only the Roumanian flag. The Department of Education is charged with the task of enforcing the order and imposing fines if it is disregarded.

The slate was agreed upon at a meeting of the Committee of Nine. in which the opposition, the administration and the Citizens Committee on Peace and Reconstruction, are represented. The Committee was in session Saturday evening until early Sunday morning at the house of the Society for the Advancement of Judaism. No official statement was issued by the Committee as to the composition of the slate. It was, however, stated on good authority that the Committee agreed on a Board of Directors who. with an administrative committee of forty and an advisory council of 150, would direct the affairs of the Zionist Organization of America.

Mr. Warburg stated he is completely satisfied with the results achieved. Perfect harmony existed between the Zionist and non-Zionist members of the Commission, which dwelt not on political topics, but only on economic questions. He is sure that if the expert plan is carried out, it will bring prosperity to the Jewish homeland.

Mr. Warburg called on Baron Ed-mond de Rothschild and discussed with him the economic problems of the Palestine upbuilding work. Baron Edmond was extremely interested in the report of the Commissioners. Mr. Warburg left for Germany.

#### BRITAIN PUBLISHES REPORT ON PALESTINE STATUS TO LEAGUE COMMISSION

No Unemployed Jews Became Public Charges: Sees Continuation

of Work

(Jewish Telegraphic Agency)
London, June 26.—The report of the British Government as the Mandatory Power for Palestine, submitted to the Permanent Mandates Commission of the League of Nations has just been

made public here-Palestine in 1927 suffered from financial stress, seriously affecting the Jewish settlement, the report states. This was aggravated by drought and

the earthquake. Public security was maintained in the country and the administrative reforms continued. There is no financial crisis in the country, but early improvement in the financial situation is improbable. During the next few years, the government faces the problem of how, without overburdening the people, to find the means to maintain an efficient administration and public security and meet its debts.

The Zionist subscription funds and private capital influx were smaller in connection with the decrease in Jewish immigration, because the latter stimulates Zionist enthusiasm everywhere. Nevertheless, further restriction of immigration is necessary because Palestine cannot absorb so many and there are not sufficient supplies available for the population's economic needs. The large immigration caused a rise in immovable property values and increased the cost of settling Jews and an abnormally high outlay of Jewish private capital investments.

The subsequent adjustment of the local supply and demand, resulted in a general decline in values, tighter credit and harder new investments Nevertheless, Zionism has already achieved remarkable results, this wrong to suppose that the economic progress, which was well aided by Jewish enterprise and capital, has been retarded, as the export values were greatly above those of 1926. For the first time since the war, more agricultural products were exported than imported. The orange area was almost doubled during the last four years, soap, flour and cement industries were expanded and increased their exports.

The tobacco industry is flourishing. Twenty new companies were incorporated and thirty new cooperatives registered. The quality of the agricultural products has improved.

The Zionist schools have been stressing Hebrew and unduly retard or ac-celerate other subjects. Their English is usually below the proper standard.

No unemployed Jew became a public charge directly, the report declares, as the Jewish Agency distributed an average of £7,000 monthly for unemployment relief.

#### GRATZ COLLEGE AND HEBREW EDUCATION SOCIETY MERGE

In his statement Dr. Solis Cohen. chairman of the new Board of Overseers, stated that as a result of this merger Gratz College will be expanded to include three departments, a normal course, a college course and a course leading to the degree of Bachelor of Hebrew Pedagogy. The merger was made possible by a special grant voted by the Federation of Jewish Charities.

#### HERBERT LEHMAN GIVES \$52,000 TO WILLIAMS COLLEGE

A gift of \$52,058 from Colonel Herbert H. Lehman of New York, of the class of '99, for the construction of a new dormitory to be named Lehman Hall was among the gifts announced at the commencement exercises of Williams College, Williamstown, Mass.

#### WEST B'NAI BRITH LODGES OPEN CONVENTION (Jewish Daily Bulletin)

Spokane, Wash., June 26. - The sixty-fifth annual convention of District Grand Lodge No. 4 of the Independent Order B'nai Brith was opened here Sunday at the Davenport Hotel with 250 delegates in attendance.

ORDER SONS OF ZION ELECTS NEW ADMINISTRATION AFTER A HEATED DEBATE

New Yorkers Win Leading Posts: Deplores Tactics in Zionist Controversy

(Jewish Daily Rulletin)

Long Branch, June 26. - Factional differences brought the convention of the Order Sons of Zion to a high pitch of excitement vesterday when election of officers took place. A new personnel, with two exceptions, will lead the organization next year. Five officers. all New Yorkers, were chosen unani-mously: Max Perlman, Nasi; Samuel Markiewich, Sgan Rishon; David Po-dolsky, treasurer; Samuel Weinstein, counsellor; Dr. Solomon Neumann. chief medical examiner.

Samuel Markiewich was chosen Egan Rishon after Louis Weiss and Louis Hochberg, both of Newark, withdrew as candidates in the interest of harmony. Hochberg withdrew with the proviso that neither Weiss nor S. L. Diener also of Newark, be named to the executive committee. Weiss, who was chairman of convention committee, asserted his withdrawal was due to the belief that he would be the only Newark candidate for the post of Sgan Rishon.

Choice of Sgan Sheini and Maskir or secretary, and ten members of Executive was determined by closed ballot. Louis Rimsky, New York, was chosen Sgan Sheini and Harry Pine. Newark lawyer, Maskir. twenty-nine have been placed in pulpits. With regard to the eight graduates of the last semester, two have accepted positions, two are about to be placed and four have no posts.
