ZIONIST ADMINISTRATION

HEADED BY LOUIS LIPSKY ELECTED AT FINAL SESSION

Struggle Persists to End; Jewish Agency Only Good Beginning, Wise Says

(Jewish Dally Bulletin)

Pittsburgh, July 4.-Swept by emotion bordering on hero worship, a majority of the delegates to the thirtyfirst annual convention of the Zionist Organization of America, ignoring the opposition charges and overlooking the recommendations of the judges' committee, returned to office the Zionist administration, with slight modifications, headed by Louis Lipsky as president. The presidential office under the newly amended constitution is shorn of administrative duties, it being confined only to the shaping of the organization policies. Before the nomination was presented.

Rabbi Max Heller of New Orleans read a statement in behalf of a committee representing a delegates' caucus, in which the nomination was urged. "We unreservedly commend the reelection of Louis Lipsky, not only because of the universal acknowledgement of his outstanding qualities of leadership, but because there is no other man in American Jewry who can fill his place. We wish the world to know that we have no cause to distrust much less to replace him."

Erza Shapiro of Cleveland, who presented the nomination in behalf of the nominations committee, termed Mr. Lipsky "the man who has risen from the ranks of Zionism," a "democratic Relief Until Spring Urgent; Crimean Prince in Israel."

In his address at the close of the convention, the re-elected president expressed his gratitude to the majority of the delegates for the loyalty to him that they have manifested and declared that he had been determined not to accept re-election, but that developments at the convention compelled him to do so. £15,590 RAISED FOR BALFOUR FOREST FUND

AT LONDON DINNER Ever Held at Guild Hall (Jewish Telegraphic Agency)

London, July 5. - Subscriptions amounting to £15,590 were made toward the Balfour Forest fund, at a dinner held in the Guild Hall here. the 700 distinguished guests, including Lord Birkenhead, Lord Melchet, the Marquis of Reading, Sir Herbert Samuel, James Rothschild, Col. George S. Symes and Major Shuckburg of the Colonial Office. Major Nathan presided at the gathering, the first Jewish gathering to be held in the Guildhall.

In a message received from Lord Balfour, who was prevented from attending because of illness, he declared he was profoundly touched by Anglo-Jewry's action, not only as an evidence of goodwill toward him but as a token of loval cooperation of Anglo-Jewry and the British people in the fulfillment of this great enterprise. Messages were received from David Lloyd George and Lord Plumer, High Commissioner of Palestine.

The Marquis of Reading, Chief Rabbi, Dr. J. L. Hertz, the Lord Mayor and Henry Mond, son of Lord Melchett, addressed the gathering.

FAMINE FEARED IN THE JEWISH COLONIES IN THE CHERSON DISTRICT

Crop Good

(Jewish Telegraphic Agency)

Moscow, July 5 .- Famine is expected in the Cherson colonies this winter, unless immediate relief measures are taken, declares the "Emes," Commun-ist Yiddish aily, in its issue today.

The Jewish Telegraphic Agency correspondent in Moscow returned today from a tour of the colonies. He found the Cherson district in great distress, the colonists living on short rations from the city. The fields are entirely parched through lack of rain. There is no hope for the settlers except from outside relief.

In Odessa and the Krivoy Rog districts the situation is a little better. Outside help is also necessary there until the spring crop is reaped. The crop in the Crimean colonies has good prospects.

STATEMENT ON THE TULIN INCIDENT AT CONVENTION

> In a telegram to the Jewish Daily Bulletin on July 5, Rabbi Silver declared:

"In your issue of July 5 your report. of the Pittsburgh Zionist Convention reads that Abraham Tulin had stated: to me that the reason Lipsky had declined to run again for president was because he does not dare to run, for if he runs the judges will have the district attorney on his trail. This is absolutely false. Nor did I make any such statement to Jacob Fishman. "Whatever I stated to Fishman was

in strictest confidence and in the nature of an inquiry. Fishman undertook to speak to Lipsky about it privately. He proceeded, however, to vio-

The pilgrimage to the Liberty Bell was undertaken under the auspices of the Jewish Education Association of New York and the Associated Talmud Torahs of Philadelphia. Before the departure for Philadelphia, a ceremony was held in the Pennsylvania Station, New York, presided over by Jonah J. Goldstein, Chairman of the New York Committee of the Jewish Education Association. The program included the presentation to the City of New York of a scroll containing a Hebrew translation of the Declaration of Independence. Arthur W. S. Hilley, Acting Corporation Counsel of New York, accepted the scroll.

The ceremonies in Philadelphia were held in Independence Square. Ben Rosen, director of the Associated Talmud Torahs, presided. Richard E. Weglein, president of the City Council of Philadelphia, accepted the Hebrew translation of the Declaration presented to the city of Philadelphia.

# AMERICAN IMMIGRANTS

The establishment of loan funds for Jewish immigrants in Argentine and Brazil was one of the results of the visit of the Hias-Ica-Emigdirect delegation to South America, a report received by the Hebrew Immigrant Aid Society of America states.

The loan bank in Buenos Aires will begin activities with a fund of \$10,000 and the one in Rio de Janeiro will have a starting capital of approximately \$2,000. Monies will be advanced from these funds to Jewish immigrants to aid them in buying tools and implements, starting them in business and giving similar assistance. One half of the capital has been contributed by Hias-Ica-Emigdirect and the other half given by the local committees in the two countries.

# OF CHALUTZ COLONY IN RUSSIA IMPRISONED

2.000 Students Participate in Inde- 30 Settlers Exiled to Siberia; Persecutions Threaten Its Dissolution (Jewish Telegraphic Agency)

Moscow, July 5.-The entire administration, including the chairman, of the Chalutz colony Mishmar, in the Jankoy region, were arrested by the Soviet secret police. They have been imprisoned at Simferopol.

Thirty colonists have been arrested during the past few weeks and exiled to Narym, Siberia. The secret police has been raiding the colony at least once every week during the night.

If the persecutions continue, the colony will probably dissolve during the summer. The authorities demand that the colony accept no new colonists without the sanction of the local Comzet, as a result of which the number of colonists has dwindled.

Mishmar is considered the best collective settlement in the entire Crimea, among both the Jewish and non-Jewish colonies. The government often sends farming students to the colony to study methods of agriculture. Mishmar is the only surviving Chalutzim colony in Crimea.

# NEW JEWISH MILITIA DISTRICT IN RUSSIA

## PROFESSOR A. A. MICHELSON ILL IN CHICAGO HOSPITAL (Jewish Daily Bulletin)

Chicago, Ill., July 3.—Professor Al-bert A. Michelson of the University of Chicago, noted scientist is ill at the Albert Merritt Billings Hospital, where he was taken a week ago, it was learned today.

Professor Michelson, who is 75 years old, is being treated for anemia and digestive trouble. His condition is reported as showing steady improvement.

# ROUMANIA OBTAINS LOAN FROM FRANCE, BUCHAREST HEARS

The Bucharest press published a report yesterday that France has agreed to advance Roumania 300,000,000 francs (about \$12,000,000) for the stabilization of the leu an Associated Press despatch from Bucharest states.

The matter, it was said, would be finally negotiated with representatives of the Banks of England and France this week, and it is expected that the German Reichsbank will also participate in the stabilization loan, the despatch states.

# OPPOSITION LEADERS COMMENT ON OUTCOME OF ZIONIST CONVENTION

Robert Szold and Jacob De Haas Air Views; Mrs. Szold Refuses Statement before Board Meeting

Robert Szold, Jacob de Haas and Mrs. Robert Szold when interviewed by the representative of the Jewish Daily Bulletin on the outcome of the Pittsburgh convention, said:

Mr. Szold: "The results, purpose and temper of the Zionist convention have been made public. If the known facts do not speak out loudly enough to be heard by the whole Zionist world, no comment of mine can add anything to the situa-

Mr. de Haas: "I am entirely satisfied with the outcome of the convention. It has demonstrated exactly that which I contended would happen when in March I joined the present opposition, namely, that vest-pocket districts, proxies, an administration controlled board of elections plus an administration controlled board of credentials would assure the administration a complete victory."

Mrs. Szold: "As an individual I should welcome the opportunity to express my reaction to the results of the Zionist convention. Since, however, anything that I say would be taken as the reaction of the National Board of Hadsash, I am unwilling to make any statement until after a National Board meeting."

Administration leaders could not be reached as this issue goes to press.

late a confidence and to spread a rumor for political ends. If I had wished to make a statement to the convention or to a caucus I could have done so without the assistance of Fishman.

"When I learned of the pernicious spread of the rumor, I requested some of the leaders of the administration and especially Lipsky to put a stop to it. I also requested Lipsky not to permit his final decision in the matter of being drafted for the presidency to be influenced by it. He promised to do so. This was 4:30 Tuesday morning. At 8 o'clock I left for Cleveland to officiate at a funeral of one of my members.

"That evening Lipsky telephoned me from Pittsburgh and told me that the matter had not been kept from the floor of the convention and that my name had been bandied about considerably. He also informed me of the vote of the convention on the new constitution and of his decision to permit himself to be reelected to the presidency. He asked me to be one of the vice presidents. I told him that in view of what had transpired I could not accept the office. I promised, however, to help him in the hard year ahead of him."

Commenting upon Rabbi Silver's telegram, Mr. Fishman declared: "Rabbi Silver is doubly mistaken. First I want to deny categorically that the statement he had made to me was in any way confidential. Second, I insist that Rabbi Silver attributed to Mr. Tulin exactly the words I quoted. However, this was not the determining factor of the convention decision to draft Mr. Lipsky. This decision was based upon an open statement that Mr. Tulin had made at a caucus of the opposition.

'Furthermore, I never spread Rabbi Silver's statement to me, though it was not confidential. As a matter of fact, I had left the hotel immediately after my talk with Rabbi Silver and returned about 3.30 in the morning to discover, to my amazement, that Rabbi Silver's statement of Mr. Tulin's remarks had become public, evidently because Rabbi Silver, and himself repeated the remarks to a number of delegates. I had nothing to do with it except to confirm, after it had become public, that Rabbi Silver also said the same words to me."

# URGE CONTINUED AID FOR TRADE SCHOOLS IN SOVIET RUSSIA Need Funds to Strengthen Position of Existing Schools and to

Establish Others
During the year 1927, eighty-five per
cent of the budget of the Jewish trade
schools in Russia was covered by the
government and other local sources.
The contribution of the Joint Distribution Committee toward the support of
these schools amounted to ten per cent

of the budget.

The importance of the Joint Distribution Committee's aid for the existence of the Jewish trade schools in Russia is pointed out in a report submitted to David A. Brown, National Chairman of the United Jewish Campaign. According to the report the greater part of the Joint Distribution Committee contribution, \$32,000 out of a total of \$\$55,000, was used to feed and clothe the pupils.

The Joint Distribution Committee, in cooperation with the Ica, Ort and Oze, subsidizes thirty-one Jewish trade schools in Russia of which four are in Minsk, four in Odessa, three in Kiev, two in Chernigov, two in Gomel, the remaining sixteen being scattered over a wide territory, mainly in the Ukraine. During the past year the schools had an enrollment of 3,829 pupils of whom 2,886 were boys and 943 girls. The majority of the pupils, 3,175, were Jews with 654 non-Jews in attendance. Of the total of 3,289, 1.893 were inhabitants of the cities and towns where the schools are located, the others having come from small towns that afforded no facilities for learning trades. In 1927 these schools graduated 492.

While in 1924 the Joint Distribution Committee contributed fifty per cent of the entire budget, its support at present is only ten per cent. The government's subsidy in 1924 amounted to only thirty-eight per cent while today it covers eighty-five per cent of the budget of the schools. The schools are however, not yet in a position to purchase new machinery, tools, pay their teachers full salaries, and make necessary repairs on buildings and the Jewish population has found it impossible to increase the number of trade schools in Russia at present, the report declares,

# CZECH JEWS WARNED NOT TO SPEAK HUNGARIAN
