certain suggestions for modification. Only Aur negative votes were recorded out of a total of forty-five. This report, as will be recalled, was drawn up by Messrs. Warburg and Frankel, representing America, Lord Melchett and Dr. Wassermann, representing Great Britain and Germany respectively, based upon the Palestine Survey made by non-partisan

The report and the recommendations were accepted by Mr. Louis Marshall in behalf of the American Non-Partisan Conference on Palestine and by Dr. Weizmann in behalf of the World Zionist Organization. The General Council is the body of Zionists which functions for the World Zionist Or-ganization in the interim btween congresses. Dr. Weizmann was forced to extend himself before the Council. to cajole and to threaten in behalf of the Jewish Agency, as he had to do before the Zionist Congress last year; but he carried the day, or the week, and triumphed in behalf of the upbuilding of Palestine as against the doctrinaire Zionists.

"Starting the discussions at fever heat, which threatened to wreck entente established between Mr. Marshall for the non-Zionists and Dr. Weizmann for the Zionists, late despatches indicate that the objections taken by the Council to certain recommendaions contained in the report are not of a very serious nature. The Joint Commissioners stated frankly that their report was "for the guidance of a reorganized Jewish Agency." This means that the non-Zionists are not bull-headed fanatics with regard to their proposals. Therefore, there will be discussion and compromise-and the reorganized Jewish Agency will, as we have often said, now proceed at a more accelerated pace."

### ZIONIST OPPOSITION ORGANIZES ASSOCIATION FOR Z.O.A. REORGANIZATION

# Will Call Another National Conference in Fall; Officers Elected

The Committee for Z. O. A. Reorganization, the body which directed the Zionist Opposition prior to and during the Pittsburgh convention, has organized itself into an "Association for Z. O. A. Re-organization," it appears from a release issued by the Committee

Judge Julian W. Mack was elected honorary chairman of the Association, Israel B. Brodie, chairman; Edward Friedman and Jacob de Haas, vice-chairman; Robert Szold, treasurer; and Isador Levinson, recording secretary, at a meeting of the General Committee held last Tuesday evening. The Association proposes to convene a national conference in the early fall for the adoption of a program and the election of permanent officers. The change in name was decided upon in view of the increase in the number of the group's adherants. "Since the Pittsburgh convention, the Association has received many new promises of support," the statement declares.

The newly elected officers were directed to complete the executive committee by the appointment of additional members. One of the interesting decisions of the meeting was the appointment of a committee of three to consider steps for transferring the remains of Theodor Herzl from Vienna to Palestine. Resolutions to this effect were adopted previously at Zionist Congresses and the Zionist Executive was recently criticised in the European Zionist press for its failure to carry the decision into effect.

The executive committee was also directed to appoint the following committees: a committee on platform; b. committee for the organization of Greated New York; c. committee for neudral organization; d. committee on pending economic problems in Palestin; e, standing committee on the economic problities in Palestine.

The-finance committee, appointed at a previous meeting, is composed of Robert Szold, Edward Friedman, David Surdut, Oscar Rosner and Michael Salit. Temporary offices of the Association are at 56 West 45th Street, New York.

### HUNGARIAN ANTI-SEMITES SATISFIED AS GOVERNMENT SLOWLY CARRIES OUT POLICY

# Anti-Semitic Leader's Astonishing Assertion Not Denied by

Authorities (Jewish Telegraphic Agency)

Budapest, Aug. 3.—The difference between the policy of the notorious Hungarian anti-Semites banded together in the Race Purifiers' Organization, and the policy of the Bethlen government lies merely in the pace of realization, declared Julius Goemboes, leader of the group at a meeting of the Race Purifiers.

The group has recently dissolved to join the government party. In explaining this action, Goemboes stated that the unification did not involve any change in policy or sacrifice of principle.

The interpretation put by Goemboes on the government policy as being calculated at a well-planned, slow but sure driving out of Hungary Jewry from the country's economic and political system, made a painful impression among Hungarian Jews, astonishment being expressed at the fact that neither the government nor the government party has contradicted Goemboes' statements.

## U. S. PHYSICIANS GIVE CHILD WELFARE FUND TO VIENNA

(Jewish Telegraphic Agency)

Vienna, Aug. 3.—A gift of five thousand dollars for a child welfare tundwas presented to City Mayor Seitz by the American Medical Association of Vienna, in which six thousand American physicians are members.

Accompanying the gift was a communication in which it was declared that the majority of the American physicins coming to Vienna proceed there mainly for the purpose of completing their studies at the internationally known otolaryngological clinic, which is headed by the famous Jewish "rofessors, Neumann, Hayek and Alexander.

The tribute to the work of the Jewish scientists expressed in the American physicians' communication made a deep impression in university and government circles. DROWN IN THE DANUBE, BELIEVING HIM A JEW

Population Indignant Over Criminal Prejudice

(Jewish Telegraphic Agency)

Vienna, Aug. 3.—A fourteen year old Christian boy, struggling in the current of the Danube River, was left to drown because of the anti-lewish prejudice of the group of his co-religionists who were swimming in the vicinity and witnessed the tragedy. They failed to come to his rescue because they were of the belief that the drowning boy was a Jew.

The incident occurred yesterday at Waitzen, on the banks of the Danube. A Jewish vacationist who was walking along the river bank called to a group of Christians swimming in the vicinity, pointing out the drowning boy. Because the call come from a Jew the swimmers believed the drowning boy was Jewish and swam away shouting, "Let the Jewish boy drown, there will be one less." The police later succeeded in recovering the body and his identity was established as the son of a poor Christian working woman, resident of Waitzen.

The local press comments on the incident. Indignation was expressed by residents of the town.

# JEWS FORBIDDEN TO BATHE IN MUNICIPAL BATHS

(Jewish Telegraphic Agency)

Budapest, Aug. 3.—The municipality of Csegled, Hungary, rejected the appeal of the Jewish population of the city to annul an old ordinance prohibiting Jews from bathing in the municipal baths whenever the weather makes it necessary. The ordinance permits Jews to go to the municipal baths only once a week.

The mayor-in replying to the appeal stated that the majority of the city council was opposed to abolishing the ordinance, although he personally does not believe in the wisdom of having a numerus clausus with regard to the city waters. The only solution, the mayor could offer was the erection next year of an additional municipal bath which would be free of this limitation. The city head added that he hopes that "sufficient Jewish contributions would be forthcoming to make the erection of the new baths possible."

# He Disclosed Facts of Assault upon American Girl

(J. T. A. Mail Service)

Jerusalem, July 2 .- Ehud Ben- Yehuda. Sub-Inspector of Police here as dismissed from his office after a Committee of Inquiry found him guilty on a charge of communicating to the press and to some friends the news regarding the assault committed on an American girl last month.

Mr. Ben-Yehuda published a letter in the "Doar Hayors" stating that for a long time he felt he was considered undesirable in certain quarters for insisting on the rights of the Hebrew language in his police work, and his position was very difficult in the Jerusalem police which is almost entirely Arab.

#### NAUMBERG LEAVES \$1,305,000 FOR JEWISH, CHRISTIAN AND NON-SECTARIAN CHARITIES

Late Fur Manufacturer Left Estate Press of \$5,000.000

The largest of the \$1,305,000 public bequests made by the late Aaron Naumburg will go to the Federation for the Support of Jewish Philanthropic Societies of New York City and the Catholic Charities of the Archdiocese of New York.

Mr. Naumburg, the president and treasurer of Jonas Naumberg Corporation, manufacturers of hatters' furs, died June 29 at Bagni Montecatini, Italy, leaving an estate estimated at more than \$5,000,000. He started to work fifty-six years ago, his first week's salary being \$3.

At the death of the widow \$1,000,000 reverts to the residue ,which will be divided among relatives and charities.

After deducting \$750,000 for various institutions, the remainder is to be distributed among Mr. Naumburg's nextof-kin. The Federation for the Support of Iewish Philanthropic Societies, which also receives \$250,000, will get one-hali of the residuary interest, and the Catholic Charities, to which an outright bequest of \$150,000 is made. receives one-fifth

#### PALESTINE FUNDS MAKE LARGE GAINS IN INCOME BY CONSOLIDATION

### Over \$3,000,000 Increase During U. P. A. Period

The income for Palestine funds in the three years of the existence of the United Palestine Appeal has been increased by over \$3,000,000 in comparison with a similar period prior to the organization of the United Palestine Appeal, according to an announcement by Morris Rothenberg, chairman of the Board of Directors of the United Palestine Appeal, The United Palestine Appeal includes the Keren Hayesod, Hadassah Medical Organization. Junior Hadassah, Jewish National Fund. Hebrew University and Mizrachi Institutions.

"In the period beginning October 1, 1925, and ending July 31, 1928." Mr. Rothenberg said, "the United Palestine Appeal has collected for all its constituent organizations the sum of 99.911.077.59, whereas in a similar period, ending July 31, 1925, which was prior to the organization of the United Palestine Appeal, the total collections of the various organizations amounted to \$5,750,334.57, thus showing an in-crease in favor of the United Palestine Appeal of \$3,160,743,02."

Hadassah was the largest beneficiary. It received for the medical work in Palestine a \$1,000.000 more in the last three years than in the corresponding period when it conducted an independent campaign. In the period from 1922 to 1925. Hadassah remitted to Palestine \$408.879.20, while during the three years from 1925 to 1928. when the United Palestine Appeal was the central fund-collecting agency for Palestine, the Hadassah medical orenization in Palestine received \$1,-197,155,64

Innior Hadassah also gained in receipts during the United Palestine Apreal period over \$115,000. The National Fund gained about \$400,000 while the increase of Keren Hayesod remittances amounted only to \$125,000.

A total of \$7.264.787.64 was remitted to Palestine during the three years existence of the United Palestine Appeal, as against \$4.833.738.43 which was the total remitted from 1922 to 1925. before the United Palestine Appeal This represents an increase in funds sent to Palestine during the United Palestine Appeal period of \$2,431,049.21, Mr. Rothenberg pointed out.

Jewish-Christian Fellowship Week Opens Wednesday in Mid-West

Racine, Wis., Aug. 2. — A Jewish-Christian Fellowship Week will be held here from August 8 to 14 on the campus of Racine College. The Mid-west Council for Social Discussion, which is sponsoring the conference, declared in its call to the meeting that "the gathering is not merely to further tolerance and good-will but rather mutual enrichment of Jews and Christians, plus team-play in furthering a better social order. Fellowship and discussion are the means to this end.

This conference will be conducted in a unique manner, which has proven to be usually effective. Instead of the leaders giving formal prepared addresses to be discussed by their audiences, the usual conference method, the conferees themselves set forth the problems and raise the questions that seem to them most vital. Then the authorities on the various subjects will be called upon to set forth what they consider to be the solution of these problems.

The Jewish-Christian Fellowship week will be held in conjunction with the Summer Conference of the Fellowship of Reconciliation, which in previous years held their conferences at Olivet and Hillsdale, Michigan.

Flood Spreading Over Far East Region

(Jewish Telegraphic Agency)

Moscow, Aug. 3 .- The flood caused by the cyclone sweeping over the far eastern area is increasing in the Michailosemenovsk and Ekaterina Nikolsk districts, the representative of the Jewish Telegraphic Agency here learned from government sources. In the latter district, where the Amur is now 860 centimeters higher than normal, communication has been cut off to the rice plantations where there are Jewish settlers.

The Bidzhan Lake and the Bira River have risen 35 centimeters. The flood is reaching the settlement Nadezhdinsk, In Chabarovisk hunger is reported, also a lack of wood and coal for the steamers.
