VIEW WAILING WALL INCIDENT YOM KIPPUR INFRINGEMENT OF JEWISH RIGHTS

Indignation Wave Continues; Palestine Communities Voice Protest
(Jewish Telegraphic Agency)

Jerusalem, Sept. 26.—The incident at the Wailing Wall during Yom Kippur services, when the Jerusalem police interfered with the worshippers who resisted the removal of a screen separating the men and women, is regarded as an infringement of the rights of the Jews to have access to the Western Wall of the Temple, known as the Wailing Wall, one of the Jewish Holy Sites in Palestine.

The excitement over the incident continued yesterday in Jerusalem, Haifa and Tel Aviv where public demonstrations to voice a protest against the action of the police were planned. These demonstrations were, however, prevented on the advice of the Vaad Leumi, National Council of Palestine Jews. A reception planned by the Tel Aviv municipality for Monday evening in honor of the officers of the British warships, Eagle, Royal Oak and Valiant, anchored in Jaffa harbor, was cancelled as a protest.

A delegation consisting of Col. Frederick H. Kisch, Dr. Joshua Thon, Chief Rabbis A. J. Kook and Jacob Meir, and Messrs. Kalvarisky and Meyuchas, conferred with Acting High Commissioner H. C. Luke for two hours, in the presence of the Director of Police and members of the government. The delegation demanded that those responsible for the brutal action against the worshippers be disciplined and that a radical solution of the Wailing Wall problem be reached. The government members promised to reply to the presentations shortly.

Berlin, Sept. 26.—Gustav Bradt, Sanitaetsrat, well known German Jewish leader, died yesterday while on a visit to Munich. He was fifty-seven years old.

Dr. Bradt, together with the late philosopher, Hermann Cohen, established the Academy for the Science of Judaism in 1917.

PAUL KNABENSHUE NAMED JERUSALEM CONSUL GENERAL TO SUCCEED HEIZER

State Department Denies Report of Beirut Consulate Transfer to Jerusalem

(Jewish Daily Bulletin)

Washington, September 26.—Paul Knabenshue, who has been United States Consul at Beirut, Syria, has been appointed Consul General at Jerusalem, succeeding Oscar S. Heizer, who is now in America on leave and who will be assigned to a post in some other country and will not return to Palestine, it is learned by the Jewish Telegraphic Agency correspondent from the State Department. Mr. Knabenshue has not yet assumed his duties, but will probably do so in the near future.

The State Department denied the Jerusalem report that the Beirut Consulate General will be transferred from Beirut to Jerusalem. The only transfer involved is that of Mr. Knabenshue to Jerusalem but the Beirut Consulate General will remain open with the successor of Mr. Knabenshue in charge. Mr. Knabenshue has been promoted from the rank of Consul to that of Consul General in connection with his transfer.

The State Department also denied that the jurisdiction of the Jerusalem Consulate will extend to Mesopotamia, Syria, and Lebanon. The jurisdiction will remain over Palestine alone, it was stated. It was learned, however, that there has been talk for some time of the creation of the post of Minister Resident, an official such as the United States formerly maintained in Egypt.

LABOR COOPERATIVE STORES FORCED TO CLOSE YOM KIPPUR

Warsaw, Sept. 26.—Several stores of the labor cooperatives which were opened on Yom Kippur morning were closed at noon at the insistence of Orthodox Jews. The staff of the stores had first declined to close. This resulted in a near-riot. The dining room of the cooperatives functioned as usual, serving meals to several hundred workers.

At a meeting of the Warsaw Kehillah Executive yesterday special allotments for holiday relief were made. The sum of 6,000 Zlotys was assigned for relief to impoverished Talmud students, and 3,000 Zlotys for Jewish writers and artists.

YESHIVA COLLEGE OPENS FIRST YEAR COURSE WITH THIRTY-FIVE STUDENTS

First College Under Jewish Auspices Starts Work

Scholastic studies in the Yeshiva College, the first college of liberal arts and sciences under Jewish auspices which combines Jewish and secular learning, were begun Tuesday, September 25 with the opening of the freshman year, Dr. Bernard Revel, president of the Yeshiva College faculty, announced.

The Yeshiva College, an integral part of the Rabbi Isaac Elchanan Theological Seminary, authorized recently by the Board of Regents of the University of the State of New York to offer courses leading to degrees of Bachelor of Arts and Bachelor of Sciences, was opened with an enrollment of thirty-five students. For the present, the college is open only to the students of the Yeshiva. The Yeshiva College is and hopes to remain a small college with a body of select students, Dr. Revel explained.

After the completion of the freshman year, an additional course will be added each successive year until the fourth year course is completed. Instruction

NEGOTIATIONS WITH KREUZER NOT YET COMPLETED

Washington, September 26.—It is true that negotiations have been pending between London Zionist Executive and George C. Kreuzer, Professor Elwood Mead's assistant, to become temporary head of the Zionist colonization department in Jerusalem, it was learned here by the correspondent of the Jewish Telegraphic Agency.

If negotiations are consummated, Mr. Kreuzer will obtain one year's leave of absence from the Interior Department for this work, which will principally involve carrying out Prof. Mead's recommendations in the Jewish Agency Commission report. Dr. Weizmann is expected to bring the negotiations to a conclusion upon his arrival in America.

JEWISH SCIENTIST GETS HIGH MOSCOW POST

TOLSTOY INTERVENED FOR JEWISH SCHOLAR VICTIM OF DISCRIMINATION

Professor Minor Received Moscow University Appointment Through Tolstoy

(Jewish Telegraphic Agency)

Vienna, Sept. 10.—A letter written by Tolstoy in 1884 to his friend the philosopher Nikolai Stralov, asking him to intervene with the authorities on behalf of Professor Lazar Minor, son of the then Chief Rabbi Minor of Moscow, who was being discriminated against by the Czarist Government, is published in the "Wiener Neue Freie Presse" in connection with the Tolstoy centenary.

In his letter, Tolstoy wrote: "This letter will be handed to you by a famous young scholar, Lazar Solomonovitch Minor, the son of my friend, the Jewish rabbi (Solomon Zalkind Minor, then Chief Rabbi of Moscow). Overcoming all obstacles put in his way because of his Jewish origin, he was at last on the point of being appointed lecturer at Moscow University when it was suddenly found that the appointment still had to be confirmed by the Minister. Would it not be possible for you to intervene on his behalf with the Minister or whoever it is who is responsible for the appointment? If it is possible, do so. I would make the journey myself and plead with the Minister, but I am afraid that I would only spoil things. This is a matter very close to my heart."

The intervention apparently succeeded, for Professor Minor obtained his appointment to the lecturership, which he held up to the time of the February revolution. He was then given his professorship which had been denied him till the revolution removed the disability against Jewish professors. Professor Minor is now seventy-eight years of age.

REGISTER CHICAGO STUDENTS AFTER YOM KIPPUR

Chicago, Sept. 26.—In response to a letter from Dr. Gerson B. Levi, president of the Chicago Rabbinical Association, Dr. C. S. Boucher, Dean of the Colleges, University of Chicago, explaining the arrangements made for all Freshman Jewish students entering the University to enroll other than on the opening day, September 24, which was the Day of Atonement.

Each Freshman is given an individual engagement card, Dr. Boucher explained, for enrollment during Freshman week. This engagement is set for a specific hour for each Freshman for registration, physical examination, library instruction and a tour of the University. Through the efforts of the college, all Jewish students were given engagements on other days than the first day of Freshman week, which enabled them to come to the University the day after Yom Kippur.

The Dean further explained, however, that an opening session for Freshman was held on Monday morning when the engagement cards were distributed. The Jewish students were enabled to secure their engagement cards on Tuesday morning, although Dean Boucher added that general information is given out at the opening session and "if he misses the opening session he will miss something of value."

FUR CHARITY CHEST VOTES

\$2,500 FOR HURRICANE RELIEF

In response to the call of the Red Cross the Board of Directors of the Charity Chest of the Fur Industry of the City of New York at a special meeting passed a resolution appropriating the sum of \$2,500 for the relief of the hurricane sufferers in the stricken areas.

WORSHIPPERS ATTACKED DURING KOL NIDRE SERVICES

(Jewish Telegraphic Agency)

Warsaw, Sept. 26.—Worshippers assembled in the synagogue at Busk, Eastern Galicia, were attacked during Kol Nidre services by a band of hooligans.

The band invaded the synagogue breaking windows and extinguishing the lights. The worshippers resisted the attack, until the police intervened, arresting many of the hooligans.

PALESTINE ARABS TO SEND NEW GROUP TO LONDON

Jerusalem, Sept. 26.—The Palestine Arab Executive intends to renew its anti-Zionist propaganda abroad in an intensive manner.

It was stated on good authority that the Executive plans to send a new delegation to London shortly.

GUGGENHEIN AND ROSENBERG DECLARE FOR HOOVER

Daniel Guggenheim and James N. Rosenberg declared themselves for Herbert Hoover in statements issued through the Republican National Committee in New York. Mr. Rosenberg, who was Vice Chairman of the American Jewish Joint Distribution Committee during the famine relief days after the World War saw personally what Mr. Hoover did, he said, in Russia, Austria and Poland. Herbert Hoover gave the word "tolerance" a new meaning to him, Mr. Rosenberg said.

"I was in Poland in the Winter of 1921 and saw the children of all religious denominations being fed by Mr. Hoover's American boys without being asked what church they went to," Mr. Rosenberg continued. "It is not difficult to proclaim tolerance. I saw Mr. Hoover practice it."

In his statement Mr. Guggenheim said:

"When the campaign started there were many in this State who seized upon two arguments as valid reasons for voting for Governor Smith. Both of them were protests; one was that a vote for Smith was a protest against prohibition, and the other was that a vote for Smith was a protest against religious intolerance. This latter argument was brought forward particularly by people of the Jewish faith whose race has suffered from religious persecution. However, as the campaign progresses the vital issues are being considered by all classes, and protests (no matter how strongly we may feel like protesting) are giving way to our more constructive thoughts."

SLAVE TRAFFIC PROHIBITED IN TRANSJORDANIA

Amman, Sept. 26.—Slave trade was prohibited in Transjordan, by an official communique published by the Legislative Council. The communique draws attention to the fact that according to the recently adopted constitution of Transjordan and international agreements, traffic in slaves is prohibited. The officials of the government of Emir Abdullah were urged to fight against slavery.

AMERICAN MINISTER VISITS WARSAW SYNAGOGUE

Warsaw, Sept. 26.—John B. Stetson, Jr. United States Minister to Poland, paid his respects to the Jewish community of Warsaw by visiting the Main Synagogue on Tomackie Monday afternoon during the Yom Kippur services.

The Minister, accompanied by two of his secretaries, spent three hours in the synagogue during the Mincha and Neilah services.

er, in explanation and justification of the order issued by him declared that if the screen had not been removed, the excited Moslem neighbors would have thrown stones at the worshippers.

The Hebrew press today published editorials voicing the unanimous demand that action be taken immediately for the redemption of the property surrounding the Wall. The "Doar Ha-yom," Jerusalem daily, reminds its readers that Sir Ronald Storrs, former Governor of Jerusalem, stated several years ago that there was a possibility for redeeming the property at a price of \$70,000.

In a statement issued by the Zionist Executive here, it is denied that any person or persons were injured during the clash with the police. It was also stated that the Zionist Executive intends to present the matter to the League of Nations in order to obviate a recurrence of similar events in the future, by a definite solution of the problem. It was pointed out that the same screen was used by the worshippers at the Wailing Wall on Rosh Heshanah and that no opposition was voiced at that time.

Palestine Communities Voice Protest
Jerusalem, Sept. 26.—Special session of the Kehillahs in Jerusalem, Tel Aviv and Haifa were held Tuesday afternoon at which time resolutions of protest were adopted against the action of the Jerusalem police in the Wailing Wall incident. A delegation headed by the Hebrew poet, Chaim Nachman Bialik, was sent by the community of Tel Aviv to Jerusalem to urge the Zionist Executive to intervene with the British Government and the League of Nations.

A plan was formulated for urging the Jewish communities throughout the world to hold manifestations to support the demand for the return of the Western Wall of the Temple to the Jewish people.

The Moslem Supreme Council, whose protest was said to have been the cause for the action of the Jerusalem police, in a statement to the correspondent of the Jewish Telegraphic Agency declared that it had drawn the attention of the Palestine government twice to an "existing agreement." The placing of tables, chairs and lamps, as well as the screen, were in contradiction to this agreement. The Moslem Supreme Council demanded the removal of the screen in order to prevent action by a Moslem crowd which had intended to occupy the space before the Wall on Yom Kippur morning before the arrival of the worshippers.

A Jewish resident of Jerusalem who was severely beaten by Arabs near the Wailing Wall last Saturday is now in the hospital in a grave condition. His assailants have been arrested.

Newark Faces Busy Season

(By our Newark Correspondent)

Newark, N. J., Sept. 25.—Local communal leaders are concerned with the raising of the 1929 budget for the Conference of Jewish Charities. In a New Year Message to the local Jewish community, A. Dimond, president of the Conference, stated that unless there is a 40 per cent increase in donations, the participating agencies in the Conference will be faced with a deficit for the ensuing year. The Conference is a constituent of the Community Chest which conducts an annual drive.

After stating that "the participating organizations of the Conference have made wonderful progress during the last year," Mr. Dimond declared: "The strides of our Jewish institutions make necessary a parallel growth of community responsibility. The new Beth Israel Hospital, which has three times the capacity of the old hospital, requires a budget which is increased by approximately \$500,000 in order to operate as a Class A institution. Additional budgets have been assumed by the West Side Ladies Relief Society amounting to \$8,332 and the Jewish Guidance Bureau of \$9,375. On account of these greater demands, together with the minor changes in the budgets of the remaining organizations, we need \$417,616.88 for the year 1929 as against \$288,017.19 for 1928, making a total increase of \$130,000.

"It does not call for further thought to awaken us to the situation. We are now confronted with a very serious problem. If we are to receive our budgetary requirements, it will mean that the next campaign will have to show results in excess of 40 per cent over the previous year. Otherwise it will mean an operating deficit for all our participating organizations and in view of the fact that we still have a deficit unpaid, it would be poor policy to increase our present deficit.

"More money can and should be raised. When we consider that for the year of 1928 we only had 2,265 subscribers, we are led to conclude that these subscriptions should be increased. In addition, thereto, we have approximately 13,000 names who have not subscribed towards the fund"

Mr. Dimond's statements accent the progress being made by the participating agencies is borne out by facts as is evidenced by the new \$4,000,000 Beth Israel Hospital, reputedly one of the foremost institutions of its kind in the East; the Newark Maternity Hospital which has instituted additional facilities and the Theresa Grotta Aid for Convalescents which this week broke ground for a new building in Caldwell. It is reported that its drive for the building fund will be on until November 1.

While mentioning drives, it may be

is temporarily given in the building of the Jewish Center, 131 West 86th St., New York City, until the new buildings of the Yeshiva College, now being erected at a cost of two and a half million dollars at 186th Street and Amsterdam Avenue, are ready for occupancy some time in November.

The Yeshiva College being a part of Rabbi Isaac Elchanan Theological Seminary is governed by the Board of Directors of the institution. In addition, an Advisory Board to be known as the Yeshiva College Council, has been formed and is composed of prominent educators and men of affairs, it was stated.

In a statement issued yesterday, Dr. Revel, outlined the policy of the college.

"The Yeshiva College dedicates its energies to the education of a select number of Jewish young men of promise, introducing them to man's cultural attainments in the fields of art, the natural sciences, and the social sciences. It aims to educate both liberally and Jewishly young men who have already been imbued with the spirit and the sanctity of Judaism and its teachings, who consider the legacy of the culture and the faith of historic Judaism an essential part of the equipment they wish to acquire during their college years. It seeks to inculcate, in the minds and hearts of its students, an abiding consciousness of the high ideals and the spiritual heritage of the Jewish people, and to develop intellect and character through the pursuit of those humanizing studies by which life as a whole may be elevated and enriched, conducted in an environment that is spiritually sympathetic, where the intellectual and the religious influence interact to produce a mind consistent in its outlook, and capable of seeing the essential harmony of life.

"For the present, the College is open only to students of the Yeshiva, who are taking their Jewish studies in the Yeshiva itself, where the method of intensive and independent study encourages intellectual initiative among the students, where the atmosphere of research and individual endeavor—properly guided and advised—inspires the student to sustained effort and progress. The Yeshiva College is, and hopes to remain, a small college, with a body of select students, so that this approach to the tutorial system will also animate the College work, and close personal contact between faculty and students will encourage thought and strengthen character.

"All around the Yeshiva College are the opportunities of the many voiced metropolis of America; its great museums and libraries, its scientific and scholarly associations, its manifold facilities for education, opening before

the student the stores of mankind's cultural accumulation; and its problems and complexities, bringing to the student the sense of high duty, the task of considered preparation of body, mind, and will for life's vital concerns.

"The Yeshiva College will emphasize the spiritual values of Judaism, its ideals of life and education, and the Jewish perspective upon learning and culture. An understanding of the backgrounds of Judaism, its contribution to human progress, will quicken the student's insight into its liberal studies. The Yeshiva College aims to foster this harmonious growth, in which the bases of modern knowledge and culture in the fields of science and service are blended with the bases of Jewish culture, to train young men in the spirit of intelligent and high-minded enthusiasm, of personal integrity, informed and devoted sons in the spirit and faith of Israel, bringing the contribution of Judaism to the scholarship, the culture and the spirit of mankind," Dr. Revel concluded.

ROMANIAN JEWS PLAN MEMORIAL FOR WAR HEROES

Bucharest, Sept. 26.—A memorial for the Jewish war heroes in the Rumanian army is being planned by the Union of Rumanian Jews.

A site for the memorial was chosen opposite the Main Synagogue of Bucharest.

A boom has been started by Democrats for Philip B. Perlman for Mayor of Baltimore in 1931.

Mr. Perlman's work as City Solicitor in the administration of Howard W. Jackson, former Mayor, following a term by the former as Secretary of the Maryland makes him an ideal candidate for the Mayoralty, his supporters urge.

The amount of \$15,500 was raised for the new synagogue planned by the Beth Israel Congregation of Wrentham, Mass., at a special meeting. Samuel Grace is president of the congregation. The required amount is estimated at about \$75,000.

It is planned that the new building will house an assembly hall, smaller meeting rooms, class rooms for a Hebrew School and a large main synagogue room.

The first week of the campaign in Detroit for \$100,000 for the Cleveland Jewish Orphan Home brought \$62,000. Adolph Finsterwald, chairman of the drive, expressed confidence that the entire sum will be raised.

The drive was endorsed by Fred M. Butzel and David A. Brown, both of whom are members of the campaign committee. Dr. Charles A. Smith is secretary of the campaign committee. Adolph "Daddy" Freund, who has been a member of the board of directors of the Cleveland Orphan Home for 60 years, is the honorary chairman of the campaign.

noted here that there is considerable talk of a drive for a much-needed larger and more modern structure for the Home for the Aged. At the last meeting of the governing board it was reported that the Home now has 101 inmates and four applications which have been filed, and that hereafter only those elders without other home or children would be admitted.

E. J. Londow, field secretary for New Jersey for the Jewish Welfare Board, who has his offices in Newark, announced this week that the seventeenth annual meeting of the New Jersey Federation of Y.M.H.A.'s and Y.W.H.A.'s will be held in Atlantic City, October 12, 13 and 14. Felix Fuld, Newark philanthropist, is president of the Federation.

Incidentally, reports filed with Mr. Londow for presentation at the convention indicate that the respective boys' and girls' summer camps maintained by the Federation, enjoyed their most successful season this year. According to reports more than 1,000 boys and girls took part in the program of activities.

Mrs. Felix Fuld recently added two benefactions to the welfare of the city. She announced that as was the case last spring so next spring she will make possible Philharmonic orchestra concerts for school children, with Ernest Schelling as conductor. The second benefaction is a grove of flowering Japanese cherry trees said to rival any similar group in the country, which she has presented to the Essex County Park Commission.

The collection comprises 28 varieties and more than 2,000 trees, rendering it numerically larger than the famous grove in Washington, D.C. which inspired Mrs. Fuld to make the gift.

As indicated from published reports, the various religious schools of the city are making progress in their registrations for the new semester which commences immediately after the High Holidays. One school, the Weequatic Section Talmud Torah, under the leadership of its president, Louis Weiss, is planning for the formation of a Parent-Teacher Association.

Anew educational activities, it is interesting to note that the New Jersey Normal School for Jewish Teachers commences with its third year of instruction, next month. A new addition to the curriculum for the next year includes a social service course to train professional and volunteer workers in community welfare.

Agudath Israel Synagogue Orthodox, is contemplating erecting a new house of worship to include a social center.

However, no action has been taken regarding this matter as yet. It was admitted that the aforementioned talk is due to the recognition of Jerusalem's importance as a Middle East center.

Mr. Knabenshue is forty-five years old. He was born in Toledo, Ohio and has been in the Consular Service many years having started his consular career in 1906 in Belfast, Ireland, where he served as Vice-Consul. He was also Vice-Consul in Cairo for a number of years and has been Consul in Beirut since 1919.
