JEWISH CO-OPERATIVE BANKS IN WARSAW REGION HOLD CONFERENCE

Sensational Charges Against Administration Made (Jewish Telegraphic Agency)

Warsaw, Oct. 4.-Sensational charges against the administration of the Jewish Cooperative banks in the region of Warsaw were made at the annual conference of the Association of Jewish Cooperative Banks.

One hundred and eight delegates representing 35,000 members of the banks attended the conference. The banks were established with the aid of the American Jewish Joint Dstribution Committee.

The banks have now a capital of two and a half million Zlotys, four million Zlotys deposits and two and a half million Zlotys of a credit capital from the Central organization of the Jewish cooperative banks, also a government credit of one million Zlotys.

During the first half of 1928 the banks have granted loans to the amount of

30,000,000 Zlotys. During the discussion of the annual report some of the speakers made sensational charges against the administration. It was asserted that members of the Zionist organization were given special privileges by the administration in credit facilities. It was likewise asserted that a large loan was granted to a certain private person in Warsaw and that this was not repaid. The greatest impression was made by the charge that members of the administration have concluded an agreement with a certain European life

LIQUOR AND ANTI-SEMITISM DRIVES HIM MAD Czech Head of Secret Police Arrested in Vienna on Disorderly Conduct (Jewish Tolographie Agency)

Vienna, Oct. 4 — Liquor and anti-Semitism drove Jan Haismann, Commandant of the Secret Police of Frague and head of the Propaganda Department of the Czech Ministry of the Interior, to such a frantic state that he came in contact with the law.

A man under the influence of intoxicants was arrested in the Vienna streets for molesting Jewish passersby. He refused medical examination shouting he would not submit to a Jewish doctor. He spent the night in jail, making violent anti-Jewish outcries. In the morning he was identified as Jan Haismann of the Prague Secret Police and head of the Czech propa-ganda department. SOVIET GOVERNMENT WOULD PERMIT HEBREW SCHOOLS. LUNATCHARSKY SAYS Obstacle is Difference of Opinion Among Jews

Moscow, Oct. 4.—The Soviet gov-ernment would permit the establishment of state schools with Hebrew as the language of instruction, in accordance with the Soviet law, provided the Iews would agree among themselves. declared Soviet Commissar of Education Lunatcharsky in an interview granted Israel Chipkin of the Jewish Education Association of New York, who is now on a visit here. The chief obstacle, Lunatcharsky continued, is the difference of opinion that prevails among the Jews. He is confident, however, that the Jews will solve the problem to their own satisfaction.

CHIEF RABBI LOEW COMPLETES 50 YEARS IN RABBINATE (J. T. A. Mail Service)

Budapest, Sept. 17 .- Rabbi Imman-Chief Rabbi of Szegedin and one of the two representatives of the Jewish faith remove the stain upon Polish science, in the Hungarian Upper House, has just completed fifty years of office as rabbi. Rabbi Loew is a descendant of the legendary Chief Rabbi of Loew of Prague and a son of the famous Rabbi Leopoid Loew, whom he succeeded fifty years ago as Chief Rabbi of Szegedin, the second city of Hungary.

Rabbi Loew refused to allow any special celebrations in honor of the event, but during the Friday night service in the synagogue at Szegedin Dr. Frankel delivered an address, praising Rabbi Loew's work,

Chief Rabbi Loew is the author of a large number of learned works, which were issued in 1900 in a collected edition. Among the best known of these is his "Flora of the Jews" and "Fauna of the Jews."

A few years ago his name was thrown into the limelight throughout the whole Jewish world, for reasons other than his scholastic achievements. He was accused by a Hungarian journalist of having given him an interview condemning the Horthy regime in Hungary. He was arrested on a charge of high treason and was for a long time kept in solitary confine- ization. ment in his home. DEMAND ACTION FOR JEWISH PHYSICIANS SEGREGATION

AT CONFERENCE Jewish Telerruphs Agences

Warsaw, Sept. 19.—The Association of Jewish Physicians in Poland has published an open letter in the press, drawing public attention to the anti-Jewish discrimination practiced at the Medical Conference held a few weeks ago at Ciechocinek.

"It is unbelievable," the statement says, "that such a thing could happen. Doctors were invited to attend the Conference, and when they came, they found that they had been divided into two sections, according to faith and origin. One section was accommodated in the main banqueting hall and the Jewish doctors were put into the smaller hall. We cannot allow this occurrence to pass in silence or with a shrug of the shoulders. It is a blatant manifestation of anti-Semitism and Chauvinism, an assault upon the most elementary principles of humanity. We demand that the Medical Association, which cannot approve of this anti-Semitic attitude on the part of a few individuals, should take action in the matter. A formal invitation to the Non-Zionist Conference, to be held at the Hotel Biltmore, New York, on October 20-21, was issued yesterday by Mr. Louis Marshall, Chairman, to several hun-dred representative Jews all over the country.

The text of the invitation follows: "Louis Marshall, Chairman, requests the honor of your presence at the Non-Zionist Conference to be held at the Biltmore Hotel, New York City, Saturday evening, October 20, and Sunday, October 21, for the purpose of acting on the report of the Palestine Joint Survey Commission, and to take measures for the organization of the proposed enlarged Jewish Agency."

GOVERNOR SMITH PROMISES STATE INVESTIGATION OF MASSENA INCIDENT

American Jewish Congress Makes Public Dr. Wise's Inquiry and Mayor's Reply: Apology Not Considered Adequate

A thorough investigation of the incident at Massena was promised by Governor Alfred E. Smith in a letter to Dr. Stephen S. Wise, president of the American Jewish Congress, Governor Smith's letter read:

"Albany, Oct. 3, 1928. "Dr. Stephen S. Wise,

"President of the American Tewish Congress.

"Dear Dr. Wise:

"I have not heard before this hour when your message reached me of the rumor of ritual murder which developed on Jewish Atonement Day at Massena, St. Lawrence County.

"As Governor of the State I cannot believe that this libelous myth has been resurrected and credited even for a moment by any one connected with the service of the state or any other civil service division. I can hardly believe that either the Mayor of Massena or a state trooper summoned a Rabbi to a police station on a religious holiday in connection with an absurd ritual murder charge to account for the disappearance of a child, which, I learn, was found again within a few hours of its disappearance.

"I wish to assure you that I will see to it as the Governor of the State of New York that this matter be investigated in the most thorough manner as to the connection of the state trooper. I have, however, no control over the Mayors of villages. The tration's explanation, A new executive Public Officers Law provides means of making charges against them.

Sincerely yours, Alfred E. Smith."

The American Jewish Congress made public yesterday a letter received from Mayor W. Gilbert Hawes of Massena. The letter read in part:

"I regret exceedingly that this misunderstanding has arisen. I hold no ill feeling against the Jewish people of this community and I know that there is no local prejudice or hostility. Our community has been co-operating in a common civic and industrial endeavor here and I hope that the exceedingly pleasant relations which have prevailed here in the past may continue without interruption.

"If I am chargeable with any act or word in this matter which has been offensive to the Jewish people I certainly regret it."

Henry Morgenthau, Jr. Replies to Quoted Report of Rochester Convention

Communication to the Editor:

I have read with a great deal of interest the report quoted in the Jewish Dully Bulletin on Wednesday, October 3rd, which gives a misleading and garbled version of the events at the Democratic Convention at Roche ter in which my name was associated with remors concerning a likelihood of my nemination for Lieutenant Governor. facts were not as stated in the report which you quote from "The Day," nor were any such statements made as contained in the report of "The Day." The facts were quite contrary.

For several weeks prior to the convening of the Democratic Convention at Rochester. Mr. Franklin D. Roo evelt of Dutchess County, where i also have my home, advocated my candidacy for Lieutenant Governor if the convention decided to select their candidate for Governor from New York City. On Monday, October let, I was very much surprised and pleased to learn that a conference of the leading Democrats held that morning had given out a statement to the newspaper corre pondents that I had been the choice of this conference for the position of Licutemant Governor providing that they could not pre-vail upon Mr. Franklin D. Roosevelt to run for Governor, In the early hours of Tuesday morning, Governor Smith finally secured the consent of Mr. Dosevelt to run for Governor. Unior the circumstances that we both come from the same county, there was no que tion of my running on the ticket with Mr. Roose-velt. Several days preyions I had telegraphed Mr. Rossevelt that if he did decide to run, I strongly urged him to in ist on Colonel He bert H. Lehman as his running mate. choice of Franklin D. Morseyelt and Colonel Lemman for the position of Governor and Lieutement Governor respectively. I believe that this combination of Roosevelt and Lemman will sweep in on one of the greatest majorities that the State has ever known The other imputations that I hold anti-

Zionest views contained in the story of "The Day" is contrary to the facts. While it is true that I have never taken any official part in the Zionist movement or participated in any of their conferences, I nevertheless view with the friendliest interest and sympathy the efforts of the Jews who have gone to Palestine to re-establish themselves, particularly in agricultural pursuits. I am the publisher of the American Agriculturist, a farm journal, and I realize that no movement is as de erving of commendation as the effort to bring the Jews into close association with oring the Jews into close association with the soil in order that they may derive their income from agriculture. No Jewish cause commands my esteem to a greater degree than the project of assisting the great masscountries in Eastern Europe to settle upon the land in Palestine and become self-supporting through agriculture. I do not see eys for eye with men who are so-called Political Zionists, but I feel deeply that the success of the Palestine movement will refound to the greater prestige and honor of the Jewish community.

(Continued from page 1) pecially to the Zionists working for the rebuilding of the Holy Land, General Allenby has endeared himself for all time. The names of Lord Balfour and Lord Allenby are recorded in golden letters in the history of the Jewish people, the veteran of history, whose dream and hope of centuries were realized through Great Britain's act of historic justice, as expressed through the Balfour Declaration and made possible through the genius and heroism of Field Marshall Allenby."

Lord Allenby's services were contrasted with Emperor Titus of Rome by Rev. Z. H. Masliansky, who said: "Two thousand years separate the opening of the gates of Jerusalem by Titus, the Roman, and the opening of the gates by Lord Allenby, the Brit-isher. The first one brought devastation and chaos to Jerusalem. With Allenby's coming, Palestine was re-

stored and revitalized."

The official greetings of the Zionist Organization were conveyed by Judge William M. Lewis, of Philadelphia, Vice President of the Organization. who said that Allenby's name was "linked up with the destiny of the Jew-

ish people.

In concluding, Judge Lewis said that "no welcome extended to Lord Allenby can exceed in genuine affection, in noble tribute and in deep gratitude that which I have the privilege of extending in behalf of the Zionist Organization of America. We hail you as a military genius, a distinguished diplomat, a pioneer of the spirit, and as the liberator whose achievement will, we pray, make possible the realization of the lofty visions of the Jew-ish prophets of old."

Nathan Straus, aged philanthropist, and Louis Marshall, noted jurist, also greeted Lord Allenby. Mr. Straus, despite the advice of his doctor, attended the reception because he wanted to express his admiration for the liberator of Palestine. Mr. Marshall, emphasized the important part that Lord Allenby had played in modern Jewish history and declared that "the names of Lord Allenby and Lord Balfour will be cherished by every right-minded Jew throughout the world, the one for the freeing of the Holy Land from the Turks, the other for the Balfour. In his address, Lord Allenby emphasized the great future which looms up for Palestine as a country. Commenting upon the Palestine campaign and the participation of Jewish soldiers in the liberating of that country, Lord Allenby said:

In any event, I need hardly point out to you what a hideous thing it is that this ancient and unspeakable libel should be resurrected in our country, with all the incalculable damage that it might do as a result of misunderstanding,

"Taking it for granted, as I do, that you desire as far as possible to repair the hurt that has been done, I most earnestly suggest to you that you do whatever may be necessary not mere-ly to contradict the base rumor of ritual murder, but point out in addition that no intelligent, decent person has ever again any credence to this charge which has been exposed whenever made, wherever made, and laid to rest time and again by the heads of the Christian churches.

"I should be very glad indeed to have full statement from you covering the entire affair and also word with respect to the course that you intend to pursue. "I am
