WEIZMANN EXPRESSES CONFIDENCE IN NON-ZIONIST CONFERENCE ON PALESTINE Comments on Melchett Statements.

Was Not Surprised Upon his arrival in New York on te steamer Ile de France late Tuesday giht, Dr. Chaim Weizmann, president. of the World Zionist Organization, reitrated his confidence in the outcome of the Non-Zionist Conference on Paletine convoked by Mr. Louis Marshall in October 20, which he will address.

When asked by the representative of the Jewish Daily Bulletin concerning Lord Melchett's statements on the Jewish Agency, Dr. Weizmann admitted that he was aware of the publication of these statements, but added that he was not surprised. "It is true Lord Melchett has not yet been invited to join the Jewish Agency," the Zionist leader said, adding that he will confer with Melchett on the subject during his stav in New York.

Commenting on Lord Melchett's spinion that the Agency must confine itself to diplomatic work, Dr. Weizmann stated: "It is impossible. Dipbmatic work in connection with Palestine must be carried out by one person. If one joins the Agency, one must undertake the entire work. The Agency must become the apparatus for all parts of the work which leads to the reconstruction of Palestine as the Jewish National Home. It is interesting that Lord Melchett's view is just the opposite of what is being de-(Continued on page 4)

SOVIET EXTENDS CREDITS TO JEWISH COLONIES (Jewish Telegraphie Agency)

Moscow, Oct. 17-The allocation of credits to the Jewish colonies for the year 1928-1929 was announced by the Soviet Government and the sum of 315,000 roubles appropriated for the first quarter. Of this sum, 182,000 mubles was appropriated for Biro-

The budget for 1928-1929 provides 125.000 roubles in unredeemable credits for the building of roads and schools and for medical aid: 190,000 in redeemable credits for houses, seed and livestock. In unredeemable credits, Biro-Bidian will get 102,000 roubles, White Russia 10,000, Ukraine 7,000, Caucasus, Dagestan and Ushekistan 2,000 each; in redeemable credits 8,000 roubles will go to Biro-Bidjan, 25,000 to White Russia, 10.000 to Crimea. 30.000 to Cherson, 28,000 to Krivoy Rog and 7,000 each to Zaporojye and Mariupol.

NEW YORK KOSHER BUTCHERS! THREATEN TO CALL STRIKE BEGINNING FRIDAY 8.000 Meat Sellers Protest High Prices Imposed by Slaughter

Houses The Jewish population in Greater New York will be unable to obtain

kosher meat beginning Friday, October 19, if the strike threatened by the Kosher butchers will go into effect. It was estimated that the kosher butchers in the metropolitan area number 8000

Several days ago the Kosher Butchers Organizations in Brooklyn and Harlem convoked meetings at which it was charged that the wholesale prices on Kosher meat have reached unparalleled heights and the owners of the slaughtering houses were responsible for the exorbitant prices. The butchers decided to call a strike. They plan to abstain from purchasing meat and will offer poultry to their customers. meeting of the kosher butchers in the Bronx held Tuesday at Hunts Point Palace, Southern Boulevard and 163rd Street, they decided to join the action. From four to five hundred butchers were present. It was predicted that the strike will last about two weeks.

The existence of a meat trust was said by some to be the cause of the high prices.

POLISH PRESIDENT GRANTS CLEMENCY TO RABBI

(Jewish Telegraphie Agency) Warsaw, Oct. 17-A decree of executive clemency was signed by President Moscicki releasing Hirsch Frenkel. assistant rabbi of Tarnopol, from military imprisonment for refusing to obey the order of his superior officer in the Polish army to shave his beard and earlocks.

START SABBATH OBSERVANCE DRIVE IN FINLAND (Jewish Telegraphic Agency)

Helsingfors, Oct. 17-A Sabbath observance campaign has been inaugurated by Orthodox Jewish leaders here. Signatures are being obtained from Jewish merchants who undertake to close their shops on the Sabbath.

FIRE DESTROYS JEWISH HOMES IN ROUMANIAN TOWN (Jewish Telegraphic Agency)

Bucharest, Oct. 17-Thirteen Jewish houses were destroyed in the township Targulneatz by a fire which broke out last night. The damage was estimated at 20,000,000 lei. The families. who were only partly insured, remained roofless.

SETTLERS IN BUREYA DIS-APPOINTED, PREFER CHARGES AGAINST OZET, SPONSOR Moscow Communist Organ Publishes Denial

(Lowish Telegraphic Agency)

Moscow, Oct. 17-Charges of mismanagement and brutality toward the Jewish settlers in Bureya, who went there under the auspices and with the encouragement of the Ozet, a society for the settlement of the Jews on the land in Russia, were made by the settlers at a meeting held in Chabarovsk on September 15, states a report in the Russian newspaper "Tichonkevanskava Zvezda.'

Fifty-five percent of the settlers who preceded to Bureya and who were mainly the hardest workers were compelled to return, due to this condition. The new arrivals tound in Bureya nothing prepared and were compelled to live in train cars, due to the lack of houses. The promises made to the prospective settlers that they would be able to earn five roubles a day on the rice plantations were proven false. They earned seventy-five and in some cases fifty Kopeks daily. The tracts of land given to them coud not be worked because of the lack of livestock. The horses which were theredied of the Sibirskaya Yazvo (Siberian pest) due to neglect, the settlers complained at the meeting. The charges of brutality were directed especially against the administrator in charge, Baskin, who refused to listen to the settlers' complaints and even resorted to physical violence in ejecting complainants from his office.

These charges were taken up today by the Moscow Communist Yiddish daily, "Emes." The newspaper, which sponsored the transmigration movement to Bureya, denies these allegations and as evidence cites a report of the same meeting received by the Mos-

MARRIAGE OF KAISER'S SON TO JEWESS REPORTED AND DENIED

(Jewish Telegraphic Agency)
Berlin, Oct. 17.—Eitel Friedrich, the second son of former Kaiser Wilhelm, was married to Mrs. Joseph Schwarz, the widow of the late Jewish opera singer, baritone of the Chicago Opera Company.

The bride of the ex-Kaiser's son is the daughter of Paul Eisenberg, a native of Brunswick, Germany. She was formerly married to Herman Silken, American millionaire coffee merchant, He has been married once before. On his death Joseph Schwartz left his widow an estate said to amount to \$5,000,000.

An Associated Press despatch from Baden-Baden, Germany states that Mrs. Sielchen-Schwarz of New York, at her chateau Marin Halden today, denied with the same vigor as six months ago rumors that she had been married to or intended to become the bride of Prince Eitel Friedrich, second son of the former Kaiser. "It is terrible nonsense," she said, "and most annoving."

Julius S. LEADING NON-ZIONISTS EMPHASIZE SIGNIFICANCE OF FORTHCOMING CONFERENCE

"Palestine deserves the support of Jews all over the world," is the view of James Marshall, son of Louis Marshall, who has taken an active interest in the movement to promote a united front among the Iews of America in connection with the proposed enlarged Jewish Agency. Mr. Marshall, in a special statement issued on the eve of the Non-Zionist Conference, to be held at the Hotel Biltmore on October 20-21, defines his attitude toward Palestine as follows:

"Although for a long time I doubted the wisdom of the entire Palestinian project and its possibility of attaining success, after visiting the country a year and a half ago and spending a month there and in the vicinity. I have no hesitancy in saving that Palestine deserves the support of Jews all over the world.

"Anyone who has come in contact with the people now in Palestine and seen the results of their heroic efforts and been witness to the vitality of their Judaism, cannot question the importance of this movement as a reavenating influence in the lives of the Jewish people in the Diaspora, While the land is too small to affect to any appreciable extent relief of the eco-Europe, the freedom of the Jews of Palestine from political and economic oppression will afford them the opporunity of developing new and broader aspects of their relations to other reoples and give new impetus to their intellectual and spiritual lives

"The historic background afforded by Palestine presents an element which is not present in any other land. The people there are conscious of this. Our support of their efforts will yield richly to us in greater self-respect and pride in the recuperative powers of our old

"The most important Jewish gathering ever held in this country," is the manner in which David A. Brown, na-tional chairman of the United Jewish Campaign, characterized the forthcoming Non-Zionist Conference.

"Since the inception of Zionism thirty years ago, since the inauguration of the first Jewish colonies in Palestine forty-five years ago, no step taken within Jewry has been so fraught with fruitful possibilities as the calling of the Non-Zionist Con-

Berlin, Oct. 17-Col. Josiah Wedgwood, British Labor M. P. and staunch supporter of the Zionist movement. gave detailed explanations of his idea that Palestine become the Seventh Dominion with the British Empire, advocated in his book, "The Seventh Dominion," published recently.

Wedgwood stated that the Seventh Dominion idea would become applicable after the expiration of the Mandate period, when Palestine should become a full-fledged Jewish dominion within the Empire.

In the discussion which followed, it is reported, it became clear that Wedgwood's idea is closely related to the demands of the Zionist Revisionists and it was decided to submit the matter for final endorsement at a forthcoming Revisionist Conference to be held in Vienna.

"The differences between the Zionist and non-Zionist Jews are, to my mind, as deep-seated as the differences between the Catholics and the Protestants. That this possibility has now become a probability and may in the near future become a reality is of surpassing import," concluded Mr. Brown.

"I doubt if Palestine can in any way solve the economic problems of East-

ern European Jewry.
"The upbuilding of Palestine is the concern of all Jewry and should not the opposing Jewish sections been so be delegated to any one organization.

SENDMENT OF THE NATURALIZATION LAW URGED BY LABOR DEPARTMENT h Facilitate Completion of Records and Issuance of Citizenship

Certificates (Jewish Daily Bulletin) Washington, October 17. - Amendset of the naturalization laws wherer crtificates of citizenship will be seed to the children of fathers who become naturalized during the minority of the chidren, is among a number of goposed changes in the naturalization aws suggested by Arthur E. Cook. scretary to the Secretary of Labor, in

an address made public by the Department of Labor here. "For years citizenship has been conirred upon a large number of foreign born persons without any action on their part whatsoever," Mr. Cook stated in his address.

They have derived their citizenship through their fathers who were natwalized or through their husbands at the time that the citizenship of the wife followed that of her nusband.

No certificates of citizenship have ever been issued or authorized by Congress to these citizens. They find themselves in great difficulties because of their inability to prove their claim to American citizenship Projected legislation provides that such individuls may apply for certificates of citirenship and, after proving their claim, American citizenship.

In discussing various other desirable amendments to the naturalization laws, Mr. Cook said that Secretary Davis has repeatedly recommended that this law be amended so that those who entered the United States prior to the quota law of 1924 may have the record of entry into the United States amended or created so as to permit the issuance of the necessary certificate from such record.

As the result of repeated recommendations, agitation, and number of bills presented to Congress, the Committee on Immigration and Naturalization reported a bill to the House of Representatives to enable those deserving aliens to perfect the record of their entry so that they may complete their applications for citizenship. It is hoped that this bill will pass both Houses of Congress at the coming session.

Another provision of the law may he referred to by way of illustration more readily than otherwise. We will consider three immigrants who landed in New York City something over five years ago and took out their first papers shortly thereafter. In two years two of them moved to Buffalo and at the end of another two years one of them moved to Jersey City. They recently applied for naturaliza-

Community Work Among Jewish Student Groups

(Jewish Daily Bulletin) Austin, Texas, Oct. 16 .- With the on-

ening of the current school session, the Patrons' League for the Jewish Students of the University of Texas began its second year of existence by announcing a program which includes lectures by istinguished speakers, the first by Dr. Stephen S. Wise.

When the Jewish student-body of the the 200 mark last year it was felt that the occasional and irregular attempts which had been previously made to care for the intellectual, moral, social and physical welfare of these students would no longer suffice, and the Patrons' League, a statewide organization, permanent in nature, was brought into being. During the past year the organization enrolled 105 members, consisting of former students, parents of students, and other friends of the university.

Among the league's accomplishments during the past year are: Supplementing the funds of Congregation Beth Israel of Austin so that the rabbi would be able to function for the student-body as well as the community; providing funds for the traveling expenses of rabbis and laymen who come to Austin to address to receive certificates attesting to their the Jewish students, furnishing prayer books at Temple Beth Israel for use by students; providing an opportunity for the students' presence at Passover Seders.

PALESTINE GOVERNMENT ISSUES OFFICIAL STATEMENT

ON WAILING WALL INCIDENT Deplores Shock to Worshippers: Points to Need for Consultation

with Government (J. T. A. Mail Service)

Jerusalem, Sept. 26.-The Government attitude with regard to the incident which occurred on Yom Kippur at .the Wailing Wall is set forth in an official statement, the text of which follows.

"On the evening of the 23d of September, the eve of the Day of Atonement, it says, 'a complaint was made to the Deputy District Commissioner, Jerusa-lem, by the Mutawali of the Abu Madian Wagi, in which the pavement and the whole area around the Western or Wailing Wall is vested, to the effect that a dividing screen had been affixed to the pavement adjoining the Wall, and that other innovations had been made in the established practice, such as the introduction of additional petrol lamps, a number of mats and a tabernacle or ark much larger than was customary. The Deputy District Commissioner visited the Wall during the evening service, and, acting in accordance with the practice established by Government, decided that the screen would have to be removed before the service on the following day. He gave instructions accordingly to the beadle in charge of the arrangements for the conduct of the services at the Wall, reserving his decision in the matter of the lamps, the mats and the ark. The beadle undertook to remove the screen and the Deputy District Commissioner gave him until early the following morning to do so.. The Deputy District Commissioner accented the beadle's assurance that his instructions would be carried out, at the same time informing the British Police Officer on duty that in the event of the beadle not complying with his undertaking the screen was to be removed.

"On the following morning the Police Officer visited the Wall and, finding that the screen had not been removed, asked members of the congregation present to take it away; they replied that they were unable to move it because of the holiness of the day The Police therefore removed the screen themselves. The worshippers in general, unaware of the circumstances that had gone before and see-ing only the police in the act of removing the screen which had been used to separate the men and the women, became excited and some of them endeavored by force to prevent the screen being taken away. Ultimately the screen was removed. The importation of the screen and its attachment to the pavement constituted an infraction of the status quo. which the Government was unable to permit. At the same time the Government deeply deplores the shock that was caused to large numbers of religious people on a day so holy to Jews. New York City has been made a citizen of the United States. The one who went to Buffalo and remained cannot secure his citizenship although he is wholly desirable as a citizen. He cannot find two citizens of the United States who have known him for the full five years he has resided in this country because of his removal from New York City to Buffalo. The law will not permit him to use two witnesses for the New York City residence and two for the Buffalo residence.

The one who went to Jersev City has secured his citizenship, for the law permits him to prove by depositions his residence outside of New Jersey. While the law does not permit the resident of Buffalo to prove his residence in the State in any other way than by two personal witnesses who have known him for five years, it will permit his brother who went to Jersey City to prove residence in New York City by one set of depositions and his residence in Buffalo by another set of depositions. This wholly unnecessary rigidity in the law has also been recommended repeatedly by Secretary Davis for modification.

"No Jewish Police Officer was present at the Wall on the occasion in question owing to all Jewish officers in Jerusalem being excused from duty for the Day oo Atonement. The Government will however, consider the desirability of a responsible Jewish Officer being included in future among the officers detailed for duty at the Wall on solemn Jewish holy

"In conclusion, the Government considers that the removal of the screen was necessary, but regrets all the circumstances attending that removal.
