#### FELIX WARBURG TO ATTEND BOSTON UNITED PALESTINE APPEAL CONFERENCE

#### Presence of Zionist Leader Seen as First Step in Unity Between Zionists and Non-Zionists

What is regarded as the most important outcome to date of the Non-Zionist Conference held on October 21 in New York City is the announcement made by Judge William M. Lewis, National Chairman of the United Palestine Appeal, that Felix Warburg, member of the Joint Palestine Survey Commission, and outstanding non-Zionist leader, who took a prominent part in the proceedings of the non-Zionist Conference, will be present at the National Conference on Palestine, to be held under the auspices of the United Palesunder the auspices of the Officer Pales-tine Appeal on Saturday evening, No-vember 10 and Sunday, November 11 at the Hotel Statler in the city of Bos-ton. Judge Lewis' announcement followed upon a meeting between Mr. Warburg and a delegation of national leaders of the United Palestine Appeal. The news that Mr. Warburg had accepted the invitation of the delegation to attend and address the United Palestine Appeal Conference was hailed with enthusiasm in Zionist circles.

In making public the fact that Mr. Warburg would attend the Boston meeting, Judge Lewis emphasized the importance of the philanthropist's pres-ence at the Conference, as indicating the desire of the Non-Zionist group to affiliate with the effort for promoting the work of upbuilding Palestine. his announcement, Judge Lewis said:

"It is a privilege to announce, on behalf of the United Palestine Appeal leaders who waited upon him, that Mr. Felix Warburg has accepted our invitation to be present at the United Palestine Appeal Conference to be held in Boston on Saturday evening, November 10 and Sunday, November 11. All those interested in the rebuilding of Palestine will be glad to note that Mr. Warburg will lend his prestige to the united fund-raising agency for Pales-

The document, which represents the appeal of the Jewish people to the nations of the world for the full protection of their right to their Holy Places in the land of their fathers, demands that the Mandates Commission take immediate steps to find a solution to

"On behalf of the Executive of the Zionist Organization, which is recog-nized as the Jewish Agency for Palestine in Article 4 of the Palestine Mandate, I have the honor to request that this petition may be transmitted through the proper channels to the Secretary General of the League of Nations for the information of the Permanent Mandates Commission.

"2. The petition relates to a deplorable incident which recently occurred in Jerusalem on the Jewish Day of Atonement, which has caused the most painful impression throughout the Jewish

"About 9 a. m on the Jewish Day of Atonement, falling on September 24, 1928, British police, acting on orders received from the Deputy District Commissioner of Jerusalem, broke through the crowded worshippers at the Kothel-Maaravi, generally known as the Wailing Wall, and effected the removal of a portable screen which had been set up the previous evening. Moscow, Nov. 1.—The leading Yeshiva in Soviet Russia, established in Nevel, District of Vitebsk, by Rabbi Schneurschn, the Lubawitscher Rebbe, and several elementary schools, Chedarim, were closed and their leaders arrested, states a report today of the Rosta, official Soviet news agency.

#### BERLIN PAPER DEFENDS ITS REPORTS ON ANTI-JEWISH RIOTS IN HUNGARY Correspondent of "Vossische Zeitung"

Berlin, Nov. 1-A controversy over the veracity of reports sent by the correspondent of the German Ullstein correspondent of the German Ullstein news agency has developed between the "Vossische Zeitung," leading Ger-man newspaper, and the "Pester-Lloyd," leading Hungarian newspaper, published in German. The "Pester-Lloyd," in a recent is-

sue attacked the Berlin newspaper as having published what it terms "ten-dencious untruths" concerning the anti-Jewish disturbances in Budapest last week. The "Pester Lloyd" declared that although it is opposed to the numerus clausus policy, it is in support

of the government.

In an article entitled, "May Truth be Reported?" the "Vossische Zeitung' replies to the Hungarian newspaper by advising it to better devote its energies to stopping the deeply humiliating occurrences in the Hungarian state uni-versities. "This is a worthier task for a Hungarian newspaper, than to attack reporters who are unfortunately compelled to spend their time on such reports.

Bruno Heilig, Budapest correspondent of the "Vossische Zeitung" and the Ullstein Agency, was expelled from Hungary on the charge of sending exaggerated reports abroad of the recent anti-Semitic student excesses.

#### McGILL 'COUNCIL' APOLOGIZES FOR SLUR ON JEWISH GIRLS (Tewish Daily Bulletin)

Montreal Nov. 1 .- An official apology for the slur against Jewish girl students at McGill University was made by the Executive of the Students' Council, the body which has complete jurisdiction over male student activities at McGill and over the "McGill Daily," in which appeared the offensive editorial against Jewish girl students.

The apology, printed in the "Daily," pointed out that the editorial, which did not represent student opinion at McGill, was due to the negligence of the executive editor, who did not see it before it appeared in print and was characterized as the narrow-minded and biased personal opinion of the editorial writer. The apology goes on to say that above all, McGill University does not want to provoke any racial animosity. The writer of the editorial, a girl student in the last year Arts, has had to resign from the "Daily," of which she was women's editor.

#### ZIONIST LEAVES BEOUEST TO HEBREW UNIVERSITY (Jewish Telegraphic Agency)

Cape Town, Nov. 1.—The will of the late Idel Schwartz, South African Zionist leader and member of the Zionist Actions Committee who died last week, contains a bequest of £1,000 for the Hebrew University.

Authorities without giving previous notification to any responsible Jewish authority.

"4. The Executive remind the Permanent Mandates Commission that this is not the first occasion upon which the Palestine Government have found it necessary to make aggressive use of the police at the Kothel-Maaravi. previous incident also occurred on the Day of Atonement when, in 1925, police were sent by the District Authorities to remove seats and benches placed at the Kothel-Maaravi for the use of aged and infirm worshippers during the Fast, as reported in paragraph 9 of the letter dated May 3, 1926 addressed by Dr. Weizmann on behalf of the Zionist Organization to the High Commissioner for Palestine, for transmission to the Secretary General of the League of Nations. On that, as on the present occasion, the order for police action was given by the Administrative Officer concerned, as a result of representations re-ceived from the Moslem authorities in regard to arrangements made for the conduct of Jewish religious services.
"5. The Executive feel confident that

it was the desire both of the Permanent Mandates Commission, and of the Mandatory Government to prevent any repetition of such an incident as occurred on the Day of Atonement in 1925. The fact that recurrence has not been prevented is evidence of the im-possibility of prolonging the present

state of affairs.

"6. In order that the Permanent Mandates Commission may appreviate what such an incident means to the Jewish people it is necessary to explain that the Day of Atonement is the most sacred day of the Jewish calendar. The Shmoneh Esrei prayer during which the incident occurred and the police broke in among the worshippers, is the most important prayer of the whole day of worship. The Kothel-Maaravi has ever been the most holy spot for the Jewish nation since the destruction of the Temple.

"7. On the other hand, the Jewish place of prayer at the Wall is not holy to any other nation or community, and while the Jews have for generations past undertaken the most arduous journeys in order to be able to pray at the Wall if only for a few moments, the Moslem neighbors have never used the site for prayer, and have not hesitated to desecrate it in the most offensive

"10. The situation thus explained is painful and humiliating to the whole Jewish world, and the Executive venture to think that it is unworthy both of the League of Nations and of the Mandatory Power, under whose joint auspices the administration of Palestine

is conducted.

"11. The Jewish people have always been anxious to secure for themselves proper conditions for free and undisturbed worship at the Kothel-Maaravi by direct arrangement with the Moslem authorities, with fair compensation for any proprietary rights affected. The Executive submit that the provision of such conditions for Jewish worship at the most sacred place of prayer for all Jewry, is an essential condition of civilized government in Palestine. That real freedom of worship is impossible under existing conditions is demonstrated by reason and confirmed by experience. The Executive therefore submit that the Mandatory Government should take all necessary steps to ensure that an arrangement eliminating the present obstacles to the free exercise of worship at this Holy Place shall be effected within the very near future.

This inquiry was sent to a large number of members of the National Committee of the United Jewish Campaign, to the members of the Executive Board of the Union of American Hebrew Congregations, to the members of the Central Conference of American Rabbis and the United Synagogue of America, to the officers and members of the Board of Directors of the Federations of Jewish Charities, to some members of the Union of Orthodox Rabbis in the United States and Canada, and the Corporate Members of the American Jewish Committee.

The pact concluded between the Zionists and non-Zionists is hailed in these responses as a great step forward toward Jewish unity. United action on Palestine will benefit not only the rebuilding work in Palestine, but also other Jewish causes, since it is expected that it will result in greater harmony within the Jewish community.

Louis Marshall and Dr. Chaim Weizmann were lauded as the prime movers in this event of historic importance.

Because of the numerous problems affecting the future of Palestine that will be considered at Boston it is exceedingly important that every Jew and Jewess concerned with the development of the Jewish Homeland should add the benefit of his or her experience and counsel to the proceedings. I am certain that Mr. Warburg will show the way to an overwhelmingly successful meeting in Boston which will inaugurate a period of greater activity for Palestine among American Jews."

The news that Mr. Warburg would

The news that Mr. Warburg would attend the Boston conference came as a complete surprise to Zionists in New York. This will be the first time since the United Palestine Appeal was founded four years ago that Mr. Warburg mil take part in any of its gatherings. Though Mr. Warburg has made large contributions to a number of Palestinian enterprises on various accasions, he has never affiliated himself with the official Zionist fund-raising agencies, except that he gave \$50,000 last year to the United Palestine Appeal, for the relief of unemployment in Palestine.

It is expected in iZonist circles that other non-Zionists will follow Mr. Warburg's example. National headquarters of the United Palestine Appeal report that the attendance at the Boston Conference, as indicated by acceptances of the invitation, will be the largest in the history of national gatherings sponsored by the organization.

#### GERMANY PLANNED JEWISH HOME IN PALESTINE IF VIC-TORIOUS, SAYS BERNSDORF

Negotiations Carried on During Last Year of War with Grand Vizier

(Jewish Telegraphic Agency)

Berlin, Nov. 1-The establishment of a Jewish National Home in Palestine was the intention of the German Imperial government if the war had ended differently, declared Count you Bernsdorf, former German Ambassador to the United States, in an address he made at a public meeting held under the auspices of the German Keren Havesod last night.

During the last year of the World War, negotiations were carried on in Constantinople with the Grand Vizier concerning this subject. He had always objected to the plan because of the contention that the Arabs would massacre the Jews, said Bernsdorf, who was German Ambassador to Constantinople at that time. Count von Berns-dorf further stated that he was now devoted entirely to the propagation of the ideals of the League of Nations. being the representative of the German government to the League, but so long as his strength and ability will allow him, he will devote himself to further the Palestine work.

Warsaw, Nov. 1-A national conference of Keren Hayesod workers in the Republic of Poland will be held here on November 5. Representatives from .442 cities are expected to attend. Messages to the conference were received from Lord Balfour, Emile Vandervelde, Wyndham Deedes, Col. Josiah Wedgwood, Herriot, Lord Melchett, Justin Godard and Sholom Asch.

Leib Jaffe, Director of the Keren Hayesod, who is now on a visit here. in connection with the conference, was received today by the speaker of the Polish Senate, Szymanski, The Speaker recalled in the conversation his visit to Palestine thirty years ago and was gratified to hear of the progress made in the country.

#### GERMAN OFFICIALS AGAIN CONFISCATE PAPER CIRCU-LATING RITUAL MURDER

Hitler Organ Seized for Anti-Semitic Drawing

(Jewish Telegraphic Agency)

Cologne, Nov. 1-Another attempt was made by the Hitler organ, "West-deutscher Beobachter," to circulate a ritual murder tale in connection with the trial of the schoolboy Hussman, in Essen, for the murder of his schoolmate Daube, both non-Jews.

The newspaper published a drawing which it claimed depicted a Jewish ritual murder. The police confiscated the issue, as it did several days ago when the paper carried a similar draw-

Hussman is a member of the nationalistic student organization. This organization, it is understood, is making efforts to bring about his acquittal.

Barring the Jew from the Bar in Lithuania

(By Our Kovno Correspondent)

Kovno, Oct. 10 .- Should the new law on which the Lithuanian Ministry of Justice is said to have been working for several months past become actual law. the future of the Jewish aspirants to a legal career in this republic will look very gloomy, if any future career should still be possible altogether under such conditions. There is a wellfounded rumor among the law students of the Lithuanian State University in Kovno that the new law aims to restrict the number of people entering the legal profession in general, but the present writer has been able to learn that the real object of the new measure is to restrict as much as possible the quota of Jewish law students.

Under the existing law, it has been quite easy to enter the legal profession in Lithuania. In the first place, there is the fact that the curriculum at the law department of the University is much less exacting than many other curricula at the same institution of learning. After obtaining his diploma, any graduate of the law department was able to enter the profession, upon complying with a few easy formalities. After serving for seven and a half vears as "Assistant Lawver." he could at once become a full-fledged member of the Bar. Under the new scheme, however, this is to be made far more difficult. It is planned that, in addition to the diploma of the university, each applicant for membership in the profession shall be required to do practical legal work for a term of 2-3 years in some court, and this without any pe-cuniary compensation. The only compensation to be granted for this work shall be the reduction of the term of practice as assistant lawyer from seven and a half to some shorter term of

Officially, the justification of this new arrangement is the following: The curriculum of the law department of the Lithuanian State University lays far too much stress upon purely theoretical knowledge and neglects actual practice. The diploma of the graduate cannot, therefore, be regarded as sufficient proof of adequate professional preparation for work in the law courts. In Germany and France, for example, the applicant for membership in the legal profession is required to pass through a certain amount of practice 1-2 fore admission. In Germany, for instance, every lawyer is required not only to have done three years work at the law school, but also three years practical work in some law court, and here, too, he is expected to pass certain examinations known as pass certain examinations known as "Referendar-Pruefung" and "Assessor-Pruefung." In France, too, they must do practical work in some law office and then pass examinations in the subjects practiced. Naturally enough, the Lithuanian Ministry of Justice is able to meet all objections by pointing to such examples in these two countries.

HEBREW UNIVERSITY MARKS OPENING LECTURE COURSES AND WATTENBURG HALL

One Hundred and Six Students Enrolled as Registration Continues (Jewish Telegraphic Agency)

Jerusalem, Nov. 1.—A joint celebrasity yesterday marking the opening of this semestre's lecture courses and the dedication of the Wattenburg building to house the Einstein Institute of Mathematics

Dr. Judah L. Magnes, Chancellor of the University, in his address welcomed the new lecturers, Professors Roth. Dizendruck and Fekete. One hundred and six students are registered at the University and admission continues. Five Arab students worked in the chemical laboratories during the Summer. The School of Oriental Students is being enlarged and a Moslem lecturer will be added.

A scholarship in Arabica has been established in honor of Lord Plumer, retiring High Commissioner of Palestine, the Chancellor announced.

Among the other speakers were Norman Bentwich, Palestine Attorney Gen-eral, M. M. Ussishkin and Dr. Fekete.

#### GERMAN COVERNMENT CONDEMNS DESECRATION OF JEWISH CEMETERIES

Federal Minister of Justice Expresses Regrets of Government (I. T. A. Mail Service)

Berlin, Oct. 19 .- "The Federal Government, in whose name I speak, joins with you in your indignation and grief that it has been possible for Germans to do such things," Dr. Koch, the Federal Minister of Justice, said in addressing the mass demonstration held here today under the auspices of the Union of German Citizens of the Jewish Faith, to protest against the repeated descerations of Jewish cemeteries and of synagogues in Germany.

"We all, who are assembled here," the Minister said, "know that those are Germans who in language, customs, culture and community of fate belong to the German fatherland. We are at one in condemning outrages committed by German citizens against German citizens in their places of worship. when enmity is carried on even against the dead, then it is something which exceeds the bounds of anti-Semitism. is then no longer a conflict between Germans of the Jewish faith and anti-Semites, but a conflict between human beings and beasts. You may be convinced that the Federal Government as the guardian of public order and peace, and in the interests of Germany's good name abroad, will do its duty in regard to such outrages, for it is most deeply hurt and humiliated by these vandalistic offenses against right and decency. You have done right, therefore, to send your protest out into the world. The Government joins you in every way in this protest."

Judge Otto A. Rosalsky published a statement in the "Jewish Morning Journal," in which the whispering campaign against Mr. Ottinger was attacked. Judge Rosalsky declares in his statement that the accusations directed against the Republican candidate that he had not taken an active part in Jewish communal affairs are without foundation. Mr. Ottinger took an active interest in the work of the Jewish Education Association and in Jewish welfare activities and on many occa-sions addressed Jewish congregations in temples and synagogues.

The natural desire of any professional class to reduce competition to a minimum prevails also among the members of the legal profession in this country, and it is pointed out that about 30 per cent of the entire student body at the State University is to be found in the law department. The annual out-put of law graduates is about 100, and whilst about one half of this number enter some government institution other than legal, the rest of the graduates swell the ranks of the legal profession.

This influx of new lawyers would not be so serious a problem, it is said, if the distribution would be better than it There is still has been heretofore. enough room for lawyers outside of Kovno, in other parts of Lithuania. The trouble is that most of the new members of the profession prefer to remain in the capital, of course, where the are situated and practice is more convenient for this and many other reasons easy to understand. The consequence has been, it is alleged, that harmful competition has been created in the ranks of the profession at the capital, harimful not only to the pecuniary in-terests of the older members of the Bar,

The Chancellor states that he is most anxious to explain to public opinion in America and the rest of the civilized world that the university authorities had nothing in common with the reactionary student movement or the numerus clau-

but tending also to lower the prestige of the profession generally, as the law-yers of Kovno are forced to take all opportunities that may present themselves, without looking too closely at the ethics of the profession.

Such are the official and semi-official explanations of the proposed law. But there is still one other explanation, and this one, it is quite safe to say, is the most plausible and obvious one, and it fits perfectly into the general trend of recent Lithuanian measures directed against Jewish competition. This explanation is that it is proposed to eliminate at one stroke practically all Jews from the study of jurisprudence at the Lithuanian State University. However the new law may affect the careers of Lithuanian law students, it is certain that it will make the study of law practically useless to Jewish students, and this is the real object of the new law.

Scanning the lists of practising law-yers in Kovno for January 1, 1928, we observe that 13 out of the 62 are Jewish, that is to say, about 20 per cent. But when we glance at the roster of assistant lawyers, we find that there are more than 50 per cent Jews among them. These figures are highly instructive. This ratio between Jews and non-Jews is by no means accidental: at a time when a majority of non-Jewish lawyers are occupying responsible posts in the law courts and in the administration, the Jewish jurists, having no opportunity to enter these institutions, were forced to seek their livelihood in legal practice elsewhere. This preponderance of Jews in the profession, however, is against the tastes of their non-Jewish colleagues, and there can be no doubt whatever that this is the real motive behind the new scheme of restriction.

As it will take 7 instead of 4 years, under the new law, to reach the stage at which one may enter the legal fraternity, it is clear that no poor Jewand that means nearly every Jew-in Lithuania will be able to afford the expense of waiting so many years before earning his living in his chosen profession. In this manner we are faced with what amounts in practice to a complete, unmitigated Tewish "Numerus Clausus."
