INDIAN MOSLEM LEADER LASHES GREAT BRITAIN'S RULE IN PALESTINE

Not Jews Are Our Enemies But British Imperialism, Says Mohamed Ali
(Jewish Telegraphic Agency)

Jerusalem, Nov. 23—Harsh criticism against English rule in Palestine and the Moslem countries generally were uttered by Mohamed Ali, Indian Moslem leader, who is on a visit here at the invitation of the Moslem Supreme Council.

The Indian leader, who was admitted to the council after the intervention of the Moslem Council, was the guest of honor at a reception given last night by the council. The Mufti welcomed him officially.

"Not the Jews are our enemies, but British Imperialism which aims to seize all Moslem lands," declared Mohamed Ali, whose arrival here was connected with the Arab-Jewish controversy over the Wailing Wall. "Great Britain rules Palestine not for the sake of the Arabs nor for the sake of the Jews, but for her own interest," he declared in a two hour address on political and religious questions.

"The Koran, the Old Testament, as well as the New Testament, aim at the same thing: to reform our character," he stated in discussing the religious issue. Moslems should send their youth to study in the European universities, but adopting Western civilization, they must always keep their own culture and traditions," he declared.

JEWISH STUDENTS AGAIN ATTACKED IN BUDAPEST (Jewish Telegraphic Agency)

Budapest, Nov. 23—Four Jewish students of the Veterinary institute were attacked by their fellow students last night.

Taking advantage of the darkness in the adjacent park, anti-Semitic students assailed four homegoing Jewish students with sticks and clubs. Three escaped uninjured, while the fourth was taken to the hospital with severe head wounds.

INTRODUCTION OF MACHINES THROWS JEWS OUT OF WORK (Jewish Telegraphic Agency)

Warsaw, Nov. 23—The introduction of modern labor saving devices and machines in the Polish industries, making rapid progress, throws thousands of Jewish workers out of employment.

Statistics gathered by the Polish branch of the Ort concerning this phase were presented at a press gathering by Dr. Silberfarb, chairman of the Ort. The Jewish worker, he stated, finds it difficult to adapt himself to the new conditions. To cope with this situation the Ort is trying to train the worker along modern lines and has opened a number of training centers.

SHARP MEASURES TAKEN AGAINST ANTI-SEMITISM IN RUSSIAN FACTORY

Dismiss Those Responsible for Attack on Jewish Folk Worker
(Jewish Telegraphic Agency)

Moscow, Nov. 23—The Bobruisk District Committee voted to discharge the secretary of the local Communist party, Svislotschsk, in charge of the workers at the glass factory, Octiab, for failure to protect Miss Barsbay, Jewish worker, from the indignities she suffered at the hands of her fellow workers. All those members of the Comsomel, Communist youth organization, who either actively or passively participated in the attack, will be excluded from the party. The committee also rebuked the Bobruisk newspaper for its tardy report of the incident.

Drastic measures against anti-Semitic practices are urged by the "Pravda," in an editorial in which anti-Semitism is termed a counter-revolutionary weapon.

JEWISH DEPUTY CLASHES WITH THE HUNGARIAN EDUCATION MINISTER

Student Riots Re-echo in Stormy Debate in Parliament
(Jewish Telegraphic Agency)

Budapest, Nov. 23—The recent anti-Semitic student riots in Hungarian universities and colleges re-echoed strongly in a stormy debate in the Hungarian parliament Thursday afternoon.

A sharp clash occurred between the Jewish deputy Pakots, Liberal leader, and Count Klebelsberg, Minister of Education. The discussion turned on a matter of no particular importance pertaining to students. Taking the floor on the subject, Count Klebelsberg referred to the interpellation on the numerous clausus introduced recently by Deputy Pakots. The Minister censured the tone and the contents of the interpellation and charged that it had caused damage to Hungary's good reputation abroad and "to the interests of the Jewish students." The Minister addressing himself to the Liberal leader, exclaimed: "You better choose some other subject, leave youth questions alone."

Deputy Pakots, given the floor on personal privilege, made angry reply. "My political work is not and cannot be influenced by the views of the Minister. I do as my conscience dictates and cannot be persuaded to act otherwise." Addressing himself directly to the government member, Deputy Pakots charged Count Klebelsberg with direct responsibility for the continuous crisis in the Hungarian colleges and universities. "You know exactly who are the instigators of the riots. Don't compel me to be indiscreet."

FURTHER LEGISLATION ON IMMIGRATION PLANNED. JOHNSON ANNOUNCES

Says Amendment Diminished Waiting List of Wives and Children
(Jewish Daily Bulletin)

Washington, Nov. 23.—Congressman Albert Johnson, Chairman of the House Immigration Committee, announced following a conference held of five members of the Committee that as other members of the Committee reach Washington for the opening of the forthcoming session of Congress, they will be formed into sub-committees for the study of specific problems relating to immigration legislation. Further meetings of the Immigration Committee will be held at the call of Chairman Johnson.

Yesterday's conference confined itself principally to a consideration of the proposed restriction of immigration from all nations of the Western Hemisphere.

In addition, however, the conference also decided to ask the State Department for a report of the statistics showing the number of the wives and children who have been admitted under the amendment to the immigration law enacted at the last session of Congress. Congressman Johnson stated, that according to his information, the foregoing amendment has diminished the waiting list of wives and children of naturalized aliens seeking admission.

HEALTH DEPT. CLOSES FORTY JEWISH BAKERIES (Jewish Telegraphic Agency)

Warsaw, Nov. 23—Forty Jewish bakeries were closed in the city of Brest-Litovsk by an order by the health department of the municipality.

The closed bakeries were operated by old-fashioned methods. The introduction of new mixing machines and ovens is now being planned. The Jewish bakers, impoverished and unable to make the investment required for installation of new equipment, will be driven out of the trade.

ANOTHER JEWISH CEMETERY DESECRATED IN GERMANY. (Jewish Telegraphic Agency)

Berlin, Nov. 23—Another Jewish cemetery was shamefully desecrated in Germany.

Unknown vandals invaded the Jewish cemetery at Cöpenick, near Berlin, last night, doing much damage, overthrowing five large memorials.

Steps have been taken by the Berlin police authorities to apprehend the culprits. Suspicion exists that members of a youth organization who were seen in the vicinity on an excursion yesterday afternoon are responsible.

USE OF YIDDISH IN RUSSIA IS DECLINING. COMMUNIST CONFERENCE HEARS

Question Considered at Special Conference in Kiev

(Jewish Telegraphic Agency)

Kovno, Nov. 23.—The position of the Yiddish language in the Soviet Union was considered at a special congress held in Kiev, according to a report received here. Although the growth of Jewish cultural institutions is proportionate with the growth of the number of Jewish workers in the industries, interest in Yiddish is continuously weakening, the delegates, active members of the Jewish Section of the Communist Party, heard.

Yiddish is seldom used at meetings of the workers, the reports stated, the Russian language usually prevailing at these meetings.

The same condition also exists in the Communist Jewish schools in Kiev where tuition in Russian is given to 900 pupils and in Yiddish to only 70. The Yiddish circles of the Comsomol, Communist youth organization, have decreased from 5 to 1. Speakers at the congress also declared that in Charkov and Odessa the situation is similar to that in Kiev.

WELFARE FEDERATION FORMED IN WASHINGTON

Washington, Nov. 23.—The principal Jewish charitable and welfare organizations of Washington, at a mass meeting held here of the members and contributors of these organizations decided to create a joint chest under the name of the Jewish Welfare Federation. They further decided to join the City Community Chest, which will shortly launch a campaign for at least \$1,000,000. The charitable and welfare organizations representing various religious groups and philanthropic bodies are included in the Community Chest,

COUNCIL ON JEWISH RIGHTS INTERVENED FOR AID TO MOS- LEM AND JEWISH INSTITUTIONS

Caused 1,200,000 Liras to Be Given for Quake Damages

A release issued by the American Jewish Congress in reference to the Jewish Telegraphic Agency despatch reporting the decision of the Bulgarian Government to allot 1,200,000 liras for rebuilding the schools in Tartar and Paardjik, demolished in the earthquake, declares that representations were made by the Council for the Rights of Jewish Minorities, at Geneva, in this connection.

According to information previously received by Mr. Zevi Abersson of the Geneva Bureau of the Council, the action just taken is the direct result of the representations he made, asking for an investigation of the matter last August, the American Jewish Congress states. Mr. Abersson then sent letters to the Bulgarian Minister of Foreign Affairs, and M. Dimitri Mikoff, Permanent Representative of the Bulgarian Government to the League of Nations at Geneva, and head of the Legation of Bulgaria at Berne, Switzerland. The letter to the Bulgarian Minister, dated August 16, was forwarded through the courtesy of M. Mikoff.

In his letters Mr. Abersson referred to reports that the requests of Jewish and Moslem communities affected by the earthquake had been refused.

"According to information which circulated in the Jewish press and stirred Jewish public opinion, the Direction of the Relief funds for the victims of the earthquake which affected regions of southern Bulgaria appears to have refused to accede to the requests of Jewish and Moslem communities affected by the earthquake, soliciting a fair part of the funds destined for reconstruction of school and worship buildings, he wrote. "The Direction of the Relief funds is said to have replied that the buildings belonging to the Jewish and Moslem religious communities, which have suffered from the earthquake, shall not be repaired with the funds of which the Direction is disposing."

"We are convinced that the Bulgarian Government, which has constantly extended its protection to all its nationals without distinction of race, language or religion, will be the first to disapprove any discrimination in regard to Jewish and Moslem communities of Bulgaria in the distribution of assistance to the victims, and that the Government will cause an enquiry to be held in regard to the matter."

KENWORTHY RAISES NEW QUESTION OF WAILING WALL IN HOUSE OF COMMONS

Will Do All Within Power to Stimulate Action

(Jewish Telegraphic Agency)

London, Nov. 23.—The new infringement of the status quo of the Wailing Wall was brought to the attention of the government by Lieut-Commander Kenworthy, in a question raised yesterday in the House of Commons.

Kenworthy asked the Colonial Secretary whether the government is aware of the further infringements of the status quo by the Moslem Supreme Council. He pointed out that a Muedzin calls Moslems to prayer five times daily from a roof over the wall, and that the Moslems have established a hospice in the house adjacent to the Wall.

Lieut-Commander Kenworthy stated to a representative of the Jewish Telegraphic Agency that he intends to do all in his power to bring to the attention of parliament and the government the facts in the case of the Wailing Wall so as to prevent further occurrences.

DAVID A. BROWN TO SPEAK IN BEHALF OF U. P. A.

David A. Brown, chairman of the \$25,000,000 United Jewish Jewish Campaign, will speak for the United Palestine Appeal, according to an announcement made by the U. P. A. headquarters in New York.

Mr. Brown's first speech will be delivered today, Sunday, at the opening of the United Palestine Appeal campaign in Syracuse, N. Y.

Syracuse, Nov. 23.—Jewish leaders from every city in the state will meet in Albany on December 9 to attend the Emergency Relief conference for expediting the collections for the United Jewish Campaign.

Lieutenant-Governor Elect Herbert H. Lehman, David A. Brown, national chairman of the United Jewish Campaign, David M. Bressler, chairman of the drive in New York city, and Bernard B. Given, state chairman, will be the principal speakers. Mr. Given will report on the status of the campaign in all up-state communities, which have pledged close to \$1,000,000 in the drive.

Reading, Pa., Nov. 23.—Assistant District Attorney Emanuel Weiss was chosen as chairman of a drive to be made January 6 to 13 to raise \$5,000 as Reading's contribution to the United Jewish Campaign and the United Palestine Appeal. William Hirsch, representing the United Jewish campaign and Benjamin L. Rubinsohn, chairman of the United Palestine Appeal for this district, were the chief speakers at the dinner where plans for the drive were formulated.

The Jewish Welfare Board, the national organization for Y. M. H. A.'s, and Jewish Community Centers is aiding these institutions in plans for the observance of Chanukah, by the presentation of plays, recitations and addresses.

AMERICAN JEWISH UNITY ON PALESTINE PRAISED AT GERMAN MEETING

Pro-Palestine Committee Holds Impressive Gathering at Dresden
(Jewish Telegraphic Agency)

Dresden, Nov. 23.—The unity of American Jews on the question of rebuilding Palestine was here open to a model to be emulated by the Jews of Germany at a public gathering held last night here under the auspices of the German Pro-Palestine Committee composed mainly of non-Jewish leaders and statesmen.

Representatives of the Saxon government and of the Federal government welcomed the meeting which was attended by 900 leading men and women. Nahum Sokolow, Chairman of the Zionist Executive, delivered the principal address. The Prime Minister of Saxony, Haussman, in speaking of the aims of Zionism, stated that it was his opinion that the movement to rebuild Palestine was of world wide, historic significance. The Jews of the world are now facing the fulfillment of another mission. In addition to their original mission of bringing the Orient to the Occident, they are now to serve as the builders of a bridge between Europe and Asia. All Jewry and in particular, German Jewry, should follow the example of American Jewry in uniting for the purpose of rebuilding the Holy Land, he stated.

UNITED SYNAGOGUE HOLDS CONFERENCE TODAY

Delegates from 700 congregations, sisterhoods, and Young People's groups associated with the United Synagogue of America will meet today, Sunday, at the Hotel Astor at a conference called by the United Synagogue. Among the subjects to be discussed is the relation of the synagogue to daily life and to the community.

The welcoming address to the representatives will be made by Dr. Elias Margolis of Mount Vernon, National Chairman of the United Synagogue Campaign for \$500,000. Among the speakers will be Leo J. Goldberger, Chairman, Greater New York Campaign; Mrs. Samuel Spiegel, President of the women's League of the United Synagogue; S. Herbert Golden, President of the United Synagogue of America.

Dr. Cyrus Adler, President of the Dropsie College and the Jewish Theological Seminary of America, will deliver the principal address at the dinner to be held in the evening.

OZET SPENT 5,000,000 ROUBLES ON COLONIZATION

Moscow, Nov. 23.—The Ozet, society for the settlement of Jews on the land is now doing seventeen per cent of the work in the colonies, besides the work in Bira-Bidjan, according to a report presented by Mr. Dimantstein at the first White Russian Ozet Conference held in Minsk. The total sum spent on the Ozet work up to the present is 5,000,000 roubles.

Australian Rabbis Refute Anti-Jewish Attacks

Melbourne, Australia, Sept. 23.—Leaders of Australian Jewry were engaged in a public controversy with the Rev. Dr. James Black, Minister of the Independent (Presbyterian) Church of Edinburgh, Scotland, who visited here.

The Rev. Dr. Black, who came to attend the annual meeting of the Council of Churches, called forth a noisy protest of several ministers of Jewish congregations of Melbourne when he launched an anti-Jewish attack in an address he delivered at the Council meeting.

"Jews who have lost their religion and know no God are the greatest social problem of today," declared Dr. Black in his address. "I was sent to the Conference of the World Missionary Council at Jerusalem to represent the Jews. It was a remarkable thing to send a Scotchman to represent Jews but I represented Christian work among Jews, which is a different thing. We have often forgotten that the greatest enemy of the Christian Church is Judaism and that there are fifteen million Jews in the world, Jews whose ancient hatred has been untouched by Christianity."

"The liberated Jew is your modern agnostic; he is a great danger because he is the most talented man in the world. The Conference at Jerusalem had prayed that the whole Christian Church should work for a solution of this problem."

A letter protesting against Dr. Black's statements, signed by the ministers of the several Jewish congregations here, was published by the daily press.

"Dr. Black's statement," declares the letter, "that Judaism is the greatest enemy of the Christian Church and that there are fifteen million Jews in the world whose ancient hatred has been untouched by Christianity, is, to say the least, unfortunate. The history of our people from the dark ages onward shows that the ancient Christian love and charity were often forgotten by Christians in their treatment of Jews. In obedience to the commands in the Book of Leviticus and elsewhere, to love one's neighbor as oneself, the Jews have ever tried to live in peace and accord with their neighbors, unless prevented by clerical fanaticism or blind prejudice. We Jews have not the monopoly of agnostics. We think that Dr. Black and his zealous colleagues would serve the cause of humanity and Christianity much better were they to seek to extend the platform of social, philanthropic and moral endeavor on which the members of all religions could ultimately and unitedly stand."

A reply to the protest made on behalf of the Jewish community by Rabbi Joseph H. Darglow and Rabbi Mestel was published by Rev. Black in the Melbourne "Argus":

AMERICAN COMMUNITIES' RESPONSE TO RELIEF APPEAL SHOWN IN LIST OF RECEIPTS

Payment on Pledges Ranges from 78 Per Cent to 50½ Per Cent

Details of the progress of the collection of the pledges made by American Jews for the meeting of the budget of the Joint Distribution Committee were made public by the United Jewish Campaign headquarters in New York.

In many parts of the country, communities are making efforts to complete their collections ahead of schedule time. Many communities have already paid their obligations in full; others, the report states, are well on their way to that goal as, for example, Indiana and Oregon with 78% of the total pledges fully paid; New York City with 76%; Chicago 75%; the State of Louisiana 75%; Wheeling, West Virginia Zone, 75%. There are comparatively few communities behind in their payments, most of them being paid up according to schedule. But this, as has been pointed out, is not enough to meet the requirements.

"Only when every state in the country has collected every dollar subscribed will the Joint Distribution Committee be able to carry out the obligations that it has assumed in behalf of American Jewry," the report declares.

Among the cities and states which have made payments ahead of schedule and those running according to schedule are:

GIVES MT. OLIVES' SITE FOR PROTESTANT BIBLE CENTER

Philadelphia, Pa., Nov. 23.—A tract of land on the Mount of Olives facing Jerusalem has been donated to the Travel Institute of Bible Research, by a woman who desires to remain anonymous, the "Sunday School Times" announced. An undenominational Protestant Bible study center will be erected on the site as soon as sufficient funds are available, the land will be converted into a garden with retreats for prayer and meditation. Bibles and hymn books in all languages will be provided.

The land borders on what is believed to be, in Christian tradition, the site where Jesus wept over Jerusalem, and is a short distance east of the Brook Kidron and the garden of Gethsemane. The purchase of this tract is said to be the first instance in history that land on the Mount of Olives has been owned by a Protestant church organization.

ference held last April was fully entitled to group Judaism along with other world religions as non-Christian and even anti-Christian," said Dr. Black in his statement.

"They are anti-Christian just as Christianity, in its essence, is anti-Judaistic. If we believe our religion is the truth, we must hold it to be the truth against all others."

Dr. Black quoted the testimony of European Rabbis, "who mournfully lament that the wonderful liberation that has come to Jewry in Europe has had a most unsettling effect and their wonderful opportunity of entering universities had added to this danger."

"In the course of my address to the Victorian Council of Churches," he said, "I pointed to the menace of the irreligious Jew in central Europe and I instance the fact that the leaders of social chaos have been agnostic Jews—Bela Kun in Hungary and Trotsky in Russia and others of his breed. These are facts, and if the Rabbis who protest do not like facts, I have nothing further to say."

Suggesting to Dr. Black that "there is to our mind a great field of endeavor still open to teach Christians in Eastern Europe the elementary lessons of justice, fair play and Christian charity, as also to win back Christian agnostics to their faith," the Jewish clergy and Christians, which is the answer to Dr. Black's "explanation."

"A religion may claim to possess the truth and yet not necessarily be against all other religion," says the declaration. "Least of all should this be the case in the relationship of Judaism and Christianity, which is that of parent and daughter." Granted that the Jewish youth of mid-Europe is forsaking the synagogue, a supposition which does not necessarily mean the total abandonment of the Jewish people nor an utter hopelessness of the youth's reattachment to the Jewish faith and that consequently it is becoming a social menace, the natural suggestion and remedy should be the strong advocacy and pious hope of their return to the Jewish fold from which they have sprung rather than attempted conversion to another faith.

"The truth of the matter in East and Mid-Europe is that social dangers and instability are to be apprehended not from Jews, whether religious or agnostic, but from the constant irritation, economic boycotts, educational restrictions. We refer to the Numerus Clausus, which is constantly renewed to debar Jews from universities, the passive countenancing of outrages against Jews provoked by the Government and rulers in those parts of the world. Trotsky is as much a Jew as Lenin is a Christian," the rabbis' declaration concludes.
